The quotations received against this Enquiry will be opened on the same date at 14.30 hours in the presence of such of those tenderers who are present at the time of opening the Quotations.

- 1.0. PRICES:** Prices should be in firm Rupees and should include customs and import duties if any railways freight to destination all other taxes should be clearly mentioned.
- 2.0. PAYMENT:** 100 % amount of the price will be paid to the contractors bills on the arrival of the materials within 60 days from date of delivery at site in good condition. NO PAYMENT WILL BE MADE AGAINST DOCUMENT NEGOTIATED THROUGH BANK.
- 3.0. ANY LOSS OR DAMAGE:** During transit to site it should be made good by the contractor free of charge provided the same is reported within 15 days of the arrival of the material at site
- 4.0. ACCEPTANCE:** It is not binding on the purchaser to accept the lowest or any tender.
- 5.0. Sample:** After finalization, the successful bidder (L1) must be furnished the sample of the product for the item quoted within 10 days from the date of receipt of letter through e-mail.
- 6.0. VALIDITY:** 90 Days from date of Opening of Tender.
- 7.0. DELIVERY:** The delivery period is 60 days at Central Store /Thalaiyuthu from date of receipt of Proof approval.
- 8.0. LIQUIDATED DAMAGES:** If the contractor fails to deliver the items / materials within the time specified, in the contract the purchaser shall recover from the contractor as liquidated damages of a sum of half percent (0.5%) of the contract price of the undelivered items/materials for each calendar week of delay. The total liquidated damages shall not exceed ten percent (10%) of the completed price of the units/materials so delayed. The date of supply will be reckoned as date of delivery for this purpose.
- 9.0. Technical Specification:** Supply of Tinned Copper Fuse Wire 12 SWG of size material confirming to latest ISS Specification

10.0. Bid qualification requirement :

- a) The tenderer should enclose the attested copy of GST, PAN & Previous P.O. copy for the same/ relevant stationary items in the outer cover for a value not less than 25% of tender value i.e., Rs.39,900/-.
