2.0) BID QUALIFICATION REQUIREMENTS:

- (i) The Diesel driven Van/Jeep (Sumo/Xylo) or equivalent offered for hiring should be registered in the name of the tenderer.
- (ii) The vehicle should be registered in Tamil Nadu and the date of first registration of the vehicle should be within **SEVEN years** on the date of opening of tender.

Attested copies of documentary evidences for the above including RC book, Fitness certificate, Insurance, Pollution certificate, Road /Vehicle tax, Contract carriage permit of the Vehicle have to be enclosed in outer cover. If not available, the tender will be summarily rejected.

- 3.0) The tender documents for the above work can be obtained in the Office of the Superintending Engineer/Mech/USTPP/Uppur after remitting the cost of specification by cash at Cash Section/USTPP/Ramanathapuram. 4.0) i.) If the tender set is to be sent by post a sum of **Rs.100/= (Rupees one hundred only)** should be paid extra in addition to the cost of tender specification. The Tamil Nadu Generation and Distribution Corporation Limited will not be responsible for any sort of postal delay or loss in transit.

ii.) The tender received after the due date of time will not be considered.

iii.) Quotation sent via E-mail shall not be accepted.

5.0) GOODS AND SERVICE TAX:

It may be noted that consequent to the roll out of GST with effect from 03.04.2024, TNPGL has registered under GST Act. The GST Registration of TNPGL is 33AKCT7598K1Z1.

6.0) The cost of specification once paid will not be refunded under any circumstances. The tender received after the due date and time and without Earnest Money Deposit, will not be accepted. Tender sets are not transferable.

7.0) Earnest money deposit specified should be in the form of demand Draft or Banker's cheque drawn in favour of **TNPGL USTPP COLLECTION ACCOUNT, RAMANATHAPURAM** and obtained from any one of the Nationalized/ scheduled Banks in India. In case of cash payment towards Earnest money deposit, it should be deposited with the cash section/USTPP/ Ramanathapuram and the receipt obtained thereon should be enclosed in the tender outer cover. The earnest money deposit in form of cheque will not be accepted.

8.0) Tenders should be sent in wax (Arakku) sealed double covers. Tender price offer should be put in a wax (arakku) sealed inner cover. Receipt for having paid the earnest money deposit, proof of holding permanent EMD, SSI certificate in lieu of earnest money deposit along with undertaking in non-judicial stamp paper (Rs.200/-) and proof towards BQR conditions should be put in the wax (arakku) sealed outer cover. The outer cover should be superscribed with the tender specification Number, name of the work, due date and EMD deposit details.
