1.0 The scope of work under this contract is to Provide a Petrol/Diesel driven Van/Jeep/Car/ on hire basis for official use of for Executive Engineer/ Operation /230KV KITS PARK SS for a period of **One year** on all days from 08.00 Hrs to 20.00 Hrs for regular use and during night hours/anytime (if necessary) to attend to emergencies and breakdowns of EHT substation related works as directed by EE/Operation/230KV Kits Park SS.

1.1 The tenderer should quote the rates for all covered in the schedule enclosed. The rates should be quoted in figures and words without room for any ambiguity. The rates should be quoted for Petrol/Diesel driven vehicle on daily basis only.

1.2 It should be noted that any revision in the rates after opening of tenders will not be considered. The rate should be firm till the completion of the contract. i.e. one year from the date of utilization.

1.3. The tenderers can download the tender specification free of cost from TNEB website.

1.4 Tender should be sent in "**DOUBLE COVER**" System. Tender Offer should be put in a sealed cover (inner cover). 3. The vehicle should have been registered as a transport vehicle.
4. The registration number of the hired vehicle shall be only in black on a YELLOW back ground.
5. In case of petrol driven vehicle certificate of undertaking should be furnished to run the vehicle on par with diesel rate in terms of distance coverage.

SECTION – III

INSTRUCTION TO TENDERERS

REJECTION OF TENDERS:

I. Tenders will be **SUMMARILY** rejected if

General Instructions:

- 2.0** If the tenderer has any doubt in the meaning of any portion of this specification, he should at Once submit particulars thereof to the Superintending Engineer/ OPERATION/ SOUTH/ CHENNAI in writing in order that the doubts may be cleared before the submission of the tender.
- 3.0** The EMD will be refunded to the successful tenderer only after completion of the contract satisfactorily. The successful tenderer in whose favour the order is issued should on demand pay, in addition, a Security deposit as per clause 4 section (IV) of this specification. If the successful tenderer fails to remit the Security deposit amount or backs out of his tender bid, the EMD remitted by him will be forfeited.
- 4.0** In case of unsuccessful tenderers, the EMD will be refunded from the common pool account created by the Finance Department, Government of Tamil Nadu after finalizing the tender. The EMD will not carry any interest.

NAME OF WORK: Providing 1 No. Petrol/ Diesel driven Van/Jeep/Car vehicle for the official use of Executive Engineer / Operation / 230KV KITS PARK SS @ 12Hrs per day for a period of one year

1.0 SCOPE:

The Scope of work under this contract is to "Provide 1 No. Petrol/ Diesel driven Van/Jeep/Car vehicle for the official use of Executive Engineer / Operation / 230KV KITS PARK SS @ 12Hrs per day for a period of one year ON ALL WORKING DAYS from 8.00AM TO 8.00P.M and on holidays when the vehicle is requested go to areas under his jurisdiction in Tamil Nadu for inspection, etc.

2.0 RATES:

The tenderer should quote the rates for all modes covered by the enclosed schedule. The rates should be quoted in figures and words without room for any ambiguity. The contractor may visit area before quoting. The rate should be quoted for diesel/ petrol driven Vehicle/ Jeep/Car only.

It should be noted that any revision in the rates after opening of tenders will not be considered. The rate should be firm till the completion of the contract.

3.0. GOODS AND SERVICE TAX (GST)

The claim of GST on vehicle hiring contracts will be admitted only after due fulfillment of the following conditions.

The contractor should have registered with GST cell of central excise department, ministry of Finance, Government of India.

The document any evidence for having paid the service tax has to be produced.

The GST shall be reimbursed only for the amount paid in respect of this contract with effect from the date of such registration or from the date of contract whichever is later.

Interest on GST at any cost shall not be reimbursed by board as the default to pay the service tax in time is entirely attributed to the contractor/Firm.

However, the GST is to be restricted only to the hire charges excluding the cost of fuel being a reimbursement.

The contractor shall furnish sufficient proof (Attested Xerox Copies) along with the bills claimed by them. Only on receipt to the above certificate the reimbursement of GST will be made.

4.0 SECURITY DEPOSIT:

The successful tenderer will have to pay a Security Deposit of 5% of the value of the contract inclusive of 1% of EMD already paid, within 30 days from the date of receipt of order in the form of DD/BANKERS CHEQUE. The Security Deposit does not bear any interest. The security deposit will be refunded only after completion of the contract period in all respects. Failure to comply with the terms regarding SD set out in the work order within the stipulated time by the successful tenderer will result in cancellation of Work order without any further reference to the contractor and also EMD shall be forfeited. Belated payment of SD shall not be accepted.

5.0 If the successful tenderer fails to execute necessary K2 Agreement within 30 days on Rs. 200/- Non-judicial Stamp paper after his tender is accepted, the Earnest Money deposited will be forfeited. His backing out will be noted while considering any of his future tenders.

6.0 DESCRIPTION OF VEHICLE:

- 6.1. Petrol/Diesel driven Van/Jeep/car or Similar Vehicle only required to be provided.
- 6.2. The Van/Jeep /car offered to the use of TANTRANSCO should have been registered in the contractor's own name.
- 6.3. If another vehicle is provided by the contractor as an alternate arrangement due to repair of contracted vehicle the contractor should produce consent letter from the person Agreeing to lend his vehicle as an spare vehicle for hiring to TANTRANSCO.
- 6.4. The vehicle should have been registered as a transport vehicle
- 6.5. The Registration Number of the hired vehicle shall be only in Black Colour on a Yellow back ground.
- 6.6. The vehicle shall be covered by third party risk insurance under Motor Vehicle Act Of 1939 to safeguard the interest of the Board against all risks involved in hiring of the vehicle.
- 6.7. Vehicle which is owned by the family members of TNPDC/ TANTRANSCO/ TNGECL/ TNGCL employees should not be engaged for hiring.
- 6.8. The vehicle should be in the best running condition with good up holster. The vehicles should be made available at this office for inspection to ascertain the condition of the vehicle at the cost of tenderers.

7.0 PERIOD OF CONTRACT

To adopt the procedure of awarding of rate contract of hiring of vehicle for a period of **one year**. The period of contract may be in force up to **1 year** from the date of agreement. The contract will be terminated without any notice if the vehicle is not regularly provided by contractor as per term so if the contract. The TANTRANSCO also reserves the right to terminate the contract without assigning any reason therefore.

8.0 PAYMENT

100% Payment will be made against your bill submitted at the end of each month within a reasonable time after deducting L.D and other recoveries, if any. Proportionate cut in hire charges will be enforced for the days on which the vehicle is not supplied. The payment will be made by within a reasonable time. The Bank charges involved in making the payment will be deducted to the account of the Tenderer.

9.0 LIQUIDATED DAMAGES:

If the contractor fails to provide vehicle as per the contract, the Board shall recover from the contractor as liquidated damages, a sum of half percent (0.5%) of the contract value for failure to provide vehicle for each day of non-supply. The total liquidated damages shall not exceed ten percent (10%) of the contract price. The hire charges per day will not be paid for the non-supply of vehicle and the expenditure incurred towards hiring of vehicle on that day will be recovered from the succeeding bill of the contractor.

10.0

At the end of each month, the successful tenderer shall submit a statement, in triplicate detailing his claims for the service rendered during the preceding month to the concerned to whom the vehicle is allotted for arranging payment.

Monthly charges payable:

1. The monthly charges payable in the year will be = Hiring charges + Diesel/Petrol charges + Retention/Night halt charges

Where car hiring charges = Hiring charges per day X No. of days utilized
Distance travelled X Diesel cost in month under consideration

Performance factor

11.0 SUCCESSFUL TENDERER'S RESPONSIBILITY:

The contractor shall be responsible for the safe operation of the vehicle. For any loss or damages to the vehicle or to the personnel traveling, due to the carelessness of the driver or for any other causes, the contractor will be responsible for all losses and the department will not take any responsibility on that account.

At the time of any accident to the vehicle, it is the full responsibility of the contractor to see that necessary compensation etc. is settled besides arranging medical aid.

The contractor shall be solely responsible for any accident to his employee or the public, from any cause what so ever and he shall indemnify the Electricity Board against damage to property or injury to person resulting from any such accidents and shall take all steps to ensure insurance charges against all such claims.

The contractor should see that the trip sheets are to be written daily and got attested by the officer to whom the vehicle is allotted.

- i) The vehicle should be available on all working days and including on all holidays and shall be parked within the office premises of concerned officer to whom the vehicles is allotted.
- ii) vehicle should be made available on holidays for any emergency works.
- iii) In case of the vehicle is requisitioned during night, the vehicle should be made available. A spare vehicle must be substituted within half an hour in case of breakdown of Vehicle within Head Quarters and within two hours outside Headquarters.
- iv) The spare vehicle substituted should also have the first registration within 10 years. If the spare vehicle not supplied within the above stipulated time, any suitable available vehicle will be engaged by the Board and excess cost incurred due to the above engagement will be recovered from the monthly bills.
- v) The contractor shall be responsible for any violation of the provisions of the contract by him/her or the Driver.
- vi) The Driver's License, transport permit, quarterly tax receipt, trip sheets written up to-date, R.C. Book, Insurance Policy Etc, should always be available with Driver of the Vehicle either in Original or a Xerox Copy of the same.
- vii) During transit, if the vehicle is seized by the law GL/Chennai authorities of the Govt., the contractor should immediately arrange for the transport of men and materials from the vehicle seized to the Head Quarters of the Officers to whom the vehicle is allotted at the tenderer cost. If it is not done, the cost for the above will be recovered from the contractor from his bill.
- viii) The contractor and the sub-contractor if any, whom the contractor proposes to engage should be pre-registered in the Board for hiring of vehicle.
- ix) Diesel/Petrol/Oil etc. required for the vehicle to be hired shall be supplied by the contractor. The contractor is not transferable.
- x) The contractor shall have a telephone in his office and residence so that he can be contracted for provision of vehicle during night and other emergency conditions. The contractor and his staff should observe strict discipline and decorum while on duty.
- xi) The successful tenderer has to **execute an agreement** in Non- judicial stamp paper for Rs. 200.00 purchased in Tamil Nadu state.
- xii) If the vehicle is not require in working days which will be informed well in advance for those days no rental charges and etc will be paid.

12.0 CONTRACTOR'S FAILURE:

The vehicle should have to go to areas, within the jurisdiction of Tamil Nadu whenever emergency arises. If the contractor fails/refuses to do so, the contract will be terminated.

If the contractor fails to fulfill the terms and conditions of the contract or unable to continue the work, the board has got the right to engage other agency for the work and the result an excess expenditure if any incurred by the Board will be recovered from the contractor either from his security deposit or from the outstanding bills. The contract is liable to be terminated if the tenderer withdraws or not taking up. The works with in a week after executing the K2 Agreement. In either case, the Security deposit will be forfeited.

13.0 IDENTITY CARDS:

The contractor should provide identity cards to each driver and such identity cards should be got countersigned by the **concern officers**.

14.0 MOTORVEHICLE TAX & PERMIT:

The motor vehicle tax shall be paid by the tenderer and permit to run the vehicle in Tamil Nadu shall be obtained by the tenderer.

15.0 COURTSUITS:

No suit or any proceedings in regard to any matter arising in respect of this contract shall be instituted in any Court, Save in the High Court, **Chennai** or District Court at **Chennai** or Sub-Court at **Chennai** or at the District Munsif Court at **Chennai**. It is agreed that no other court shall have jurisdiction to entertain any suit or proceeding even though, part of the cause of action might arise within their jurisdiction. In case any part of the cause of action might arise within the jurisdiction of any other courts in Tamil Nadu and rest within the jurisdiction of court outside the State of Tamil Nadu, then it is agreed to between the parties that such suits or proceedings shall be instituted in a court within the state of Tamil Nadu shall have jurisdiction even though any part of the cause of action might arise within the jurisdiction of such courts.

The successful tenderer shall furnish an undertaking as per schedule in a non-judicial stamp paper of Rs.500/- agreeing to the above condition".

16.0 POWER TO RELAX:

Notwithstanding anything contained in any of these regulations, **Superintending Engineer/Operation/South/Chennai** shall have the right to relax or waive any of the conditions stipulated in the tender specification.

17.0 VALIDITY OF TENDER:

The tender shall be valid for THREE MONTHS (NINETY DAYS) from the date of opening of the Tenders.

18.0 INDEMNITY BOND:

19.0 INCOME TAX

The claim of service tax /GST on vehicle hiring contracts may be admitted only.

1.0 When the term on contract specifies that such statutory levies are the boards account.

2.0 Upon the production of documentary evidence for having paid the same.

3.0 The contract should have registered with service tax cell of central excise department, ministry of finance government of India or appropriate authority.

- 4.0 The Service tax / GST shall be reimbursed only on account for the account paid in respect of this contract whichever is later.
- 5.0 Interest in service tax/ GST at any cost shall not be reimbursed by board as default to pay the service tax in time is entirely attributed to the contract /Firm.
- 6.0 Apart for above any requirement under GST has to be Complied with.
- 7.0 Income tax applicable will be recovered from the total amount of bill. PAN should be furnished on demand.

20.0 **DISCIPLINE:** The contractor and his staff should observe strict discipline and decorum, while on duty. The contractor should provide identity cards to each driver and such identity cards should be got counter signed by the Superintending Engineer/Operation Circle/South/Chennai.

21.0 **JURISDICTION:** Area covered under the Jurisdiction of Operation Circle / Chennai South, Chennai North / and Sriperumbudur

22.0. GENERAL CONDITIONS:

1. Vehicles offered to the board for use should have been registered in name of the contractor and the date of first registration of the vehicle should be within 10 years period on the date of opening of tender. The contractor should provide substitute vehicle in case of break down. If the substitute vehicle provided for hiring by the contractor is not owned by him/her then he/she should produce a consent letter from the owner of vehicle (Sub contract) agreeing to lend the vehicle for hiring to the Board. The contractor and the sub-contractors if any whom the contractor process to engage should be pre-registered in the Board for the hiring of vehicles.
2. The vehicle should be available on all days between 8.00AM to 8.00PM. If the vehicle is not required to the vehicle holding officer for any holidays or any other days for any reason, the proportionate hire charges will not be given to those days.
3. In case the vehicle is requisitioned during night, vehicle should be made available.
4. The vehicle supplied should be in good running condition.
5. A spare Vehicle must be substituted within one hour in case of breakdown of Vehicle.
6. The owner should make his own arrangements for the accommodation of the driver.
7. Repairing tools and stepney should be available in the Vehicle.
8. The vehicle should be provided as per the instruction/direction of the vehicle holding officer.
9. Wherever the vehicle is taken out on camps warranting night halts outside the headquarters of the Executive Engineer no Bata shall be paid to the tenderer. The number of such halts outside will be limited only to the minimum necessary extent warranting the officers tour programme. Number of days halt outside the head quarters per month cannot be given previously. The halts are to be made anywhere in Tamil Nadu.
10. The total K.M. run by the vehicle will be calculated from the headquarters of the Executive Engineer/Operation/Kadapperi SS to their work site and back to headquarters and not from the garage to garage of the Tenderer.
11. The tenderers should quote their rates only on the schedule furnished.

21. Any notice to the contractor shall be deemed to have been served sufficiently and properly if the Notice is given directly in writing or left at his/her usual or last known place of abode or business, as well as displayed on the notice board of this office.
22. In case of dispute the decision of the Superintending Engineer/Operation/South will be final and binding.
23. The tenders shall certify that the vehicle which are made available against this contract are not owned by any family members of the Tamil Nadu Electricity Board employees.
24. The Board has absolute power to cancel the contract at any time without notice.
25. Vehides, which are owned by the family members of the Board employees, are not acceptable.
26. Toll fees have to be borne by the contractor for any number of visits.
27. Any notice to the tenderer shall be deemed to be sufficiently served if given or left in writing at his/her usual or last known place, or abode of business, as well as the notice board of the office.
28. The contractor and his Staff should observe strict discipline and decorum, while on duty.
