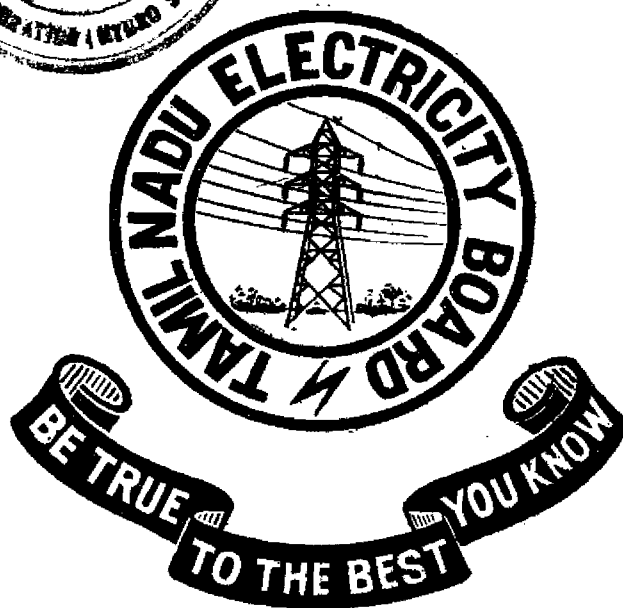
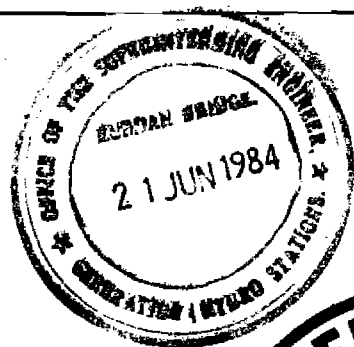

## *From the Chairman's desk :*

Some of the Unions in the Tamil Nadu Electricity Board have been making much of the transfers ordered in the Board. I would like to invite their attention to the following news item in the Financial Express of the 25th May about the happenings in the Electricity Board in a State run by a ministry led by the Communist Party of India (Marxist), namely, West Bengal :

**“Industrial relations in the Bengal power sector has taken a curious turn with the formation of the joint council of power workers unions and associations EXCLUDING unions affiliated to the Centre for Indian Trade Unions (CITU), the labour wing of CPI (M). Enough indications were given by different speakers at the power workers’ convention here on Wednesday regarding intensified movement against the Left Front Government’s alleged irrational labour policy regarding power sector employees....**

**Leaders of the council said that the State Power Minister, Mr. Prabig Sen Gupta refused to give any plausible reasons for the transfers, chargesheets and suspensions. So far about 50 workers had been suspended or chargesheeted while another 1,000 have been transferred.”**

It is for the Unions in the Tamil Nadu Electricity Board to draw the necessary inferences from this.

Transfers, disciplinary action etc., are the indispensable prerogatives of any management. These prerogatives will have to be exercised as often as necessary to keep the administration in trim. More so in a gigantic and complex organisation like our Electricity Board which has 87,700 employees on its rolls whose work and conduct impinge on the day-to-day lives of fifty two lakhs of consumers in the State and on the entire public at large and on the economy of the State. No one in any Government department or any public undertaking, from the highest to the lowest, can claim immunity from transfers and disciplinary action. If some unions choose to exaggerate or distort or misrepresent such actions for subserving their own vested interests, there is nothing much that can be done about it. The only fitting answer to such dishonest propaganda is to relentlessly persist in doing whatever has to be done in the best interests of the Board. **This is precisely what will be done.**

## PART—I

### News and Notes

#### **1. Employment assistance to dependants of employees retiring from service on medical invalidation.**

At present, dependants of only those employees of the Board who die in harness are eligible for employment assistance in the Board. It has now been decided to extend this concession also to dependants of employees who retire from service on medical invalidation before attaining the age of 50 years. Orders on this have been issued in B.P. Ms. (FB) No. 51 (Adm. Branch) dated 31—5—1984.

#### **2. Deputation of Board's Engineers for Post Graduate course at Board's cost.**

The Board has decided to depute eight Engineers of the Board (three Assistant Divisional Engineers and five Assistant Engineers) to the Master of Engineering Course full time in the year 1984—85 at the Board's cost. Orders in this regard have been issued in B. P. Rt. (FB) No. 5 (Adm. Branch) dated 31—5—1984.

#### **3. Detection of Energy theft and Malpractices.**

A massive drive had been launched in 1983—84 for the detection of energy theft and malpractices. As a result, 361 cases of energy theft and 4748 cases of malpractices were booked in 1983—84. This is as against 40 cases of energy theft and 398 cases of malpractices booked in 1982—83 and 23 cases of energy theft and 183 cases of malpractices booked in 1981—82. The revenue assessed in these cases was Rs. 209 lakhs in 1983—84 as against Rs. 48 lakhs in 1982—83 and Rs. 15 lakhs in 1981—82.

#### **4. Transfer of employees.**

Orders have been issued in May 1984 transferring 1096 persons belonging to State Cadres in the exigencies of administration. Consequently, it has become possible to give postings to 657 persons who had sought 'request transfers', many of whom had been waiting for long years, to places of their choice.

In respect of System Cadres, the Superintending Engineers concerned have ordered similar transfers.

#### **5. Reduction of surplus staff at Ennore Thermal Power Station.**

With effect from 1—6—1984, the sanctioned strength of Ennore Thermal Power Station has been reduced from 2126 to 1407. Out of the difference of 719 posts, 426 posts are already vacant and, consequently, 293 men have been declared surplus and transferred out.

#### **6. Reduction of surplus staff at Basin Bridge Power House.**

With effect from 1—6—1984, the sanctioned strength of Basin Bridge Power House has been reduced from 1657 to 478. Out of the difference of 1179 posts, 445 posts are already vacant and, consequently, 734 men have been declared surplus and transferred out.

#### **7. Committee on Energy Utilisation in Industries.**

The Committee on Energy Utilisation in Industries constituted in B.P. Ms. (Ch) No. 56 dated 3—3—1984 has submitted its report. This is published elsewhere in this Gazette.

### 8. Performance of Tuticorin Thermal Power Station :

The performance of Tuticorin Thermal Power Station in May 1984 was as follows :

Unit III was under shutdown from 6-5-1984 to 29-5-1984 due to failure of one phase of Generator—Transformer and oil leak in generator barrel.

### 9. Extension of supply to lighting services—Acceptance of meters from consumers.

Since there has been a constraint in having adequate stocks of meters and extension of supply to lighting services has been held up in many cases on this account, it has been decided to accept new single phase meters from the consumers concerned on payment of cost and supply extended on that basis (*vide* Memo. No. 317/Adm. Br./PA (T) S2/84-1 dated 31-5-1984.)

### 10. Energisation of pumpsets 1984-85.

For the year 1984-85, Government have communicated the following decisions in regard to the policy to be followed in energisation of pumpsets :—

- (i) The existing priorities on giving power connection to pumpsets be continued.
- (ii) All pumpsets installed in Cauvery Delta, where monopoly procurement is done, should be given power connection, on special priority basis.
- (iii) All pumpsets for which power lines have already been laid as on 1-4-1984 be given power connection, on priority basis.
- (iv) Applications seeking power connection to pumpsets registered on or before 31-3-1976 and in respect of which notices have already been issued, be given power connection immediately.

The overall target for the State will be 20,000 for 1984-85.

### 11. Electrification of Huts 1984-85.

It has been decided that power supply should be extended before 31-3-1985 to all eligible hut applications pending now and received before 28-2-1985. The applications as and when received, if eligible, will be given supply within a month from the date of receipt.

### 12. Resources position : 1984-85.

The resources of the Board based on the approved Budget Estimate for the year 1984-85 will be as follows :—

(B) The gap in Revenue will, therefore be Rs. 69.23 crores.

The gap in resources will be (A+B) Rs. 265.96 crores. To this has to be added a resources deficit of Rs. 40.79 crores on the revenue side and Rs. 25 crores on the Capital side carried over from 1983-84 making the total deficit in 1984-85 as Rs. 331.75 crores. As against this, the Government assistance provided in the State Budget for 1984-85 is only Rs. 220 crores leaving an uncovered gap of Rs. 111.75 crores.

### 13. Progress in issue of Provident Fund Accounts slips to Board employees.

In view of complaints from employees of bad arrears in the issue of Provident Fund Accounts slips, a special drive has been launched to clear the arrears.

In B. P. Ms. (Ch.) No. 3 (Audit Branch) dated 20-11-1983, orders were issued to bring the Funds work upto-date in the issue of Accounts slips to Board employees by the target dates indicated below:—

2. Memo. No. 33248—R1/81—1 dt. 19—1—82.

With reference to the orders in para 4 of B. P. Ms. No. 288 (S. B.) dt. 3—12—79, as subsequently amended, the Divisional/Executive Engineers, among others, are entitled to two increments (including the normal increment falling on the same date or thereafter) on their completing 10 years service in the same post.

2. With reference to the orders in para 9 in the Annexure to B. P. Ms. No. 255 (S. B.) dt. 19—11—79, as subsequently amended in Board's Memo. No. 33248—R1/81—1 dt. 19—1—82, stagnation increments beyond the maximum of the scale at the rate of last increment should be given annually for the employees, the maximum of whose scale of pay does not exceed Rs. 2000/- p. m. As per the orders in para 2 of Board's Memo No. 33248—R1/81—1, dt. 19—1—82 (i) the stagnation increment should be permitted after an employee completing one year of service (Service that counts for increment) after he reaches the maximum of the scale and thereafter annually, (ii) the stagnation increment will not be admissible while allowing two increments as per the orders mentioned in para 1 above and (iii) the two increments as per the orders mentioned in para 1 above should be only within the scale of pay of an employee.

3. The former General Superintendent/Tuticorin Thermal Power Station has raised a point for clarification with regard to the date from which stagnation increment is to be sanctioned to an officer who had been granted two increments or one increment for completion of ten years service and reaches the maximum of his scale of pay.

4. It is hereby clarified that in as much as the two increments for completion of ten years service includes the normal increment, falling on the same date or thereafter also, the service upto the date of normal increment, cannot be counted for allowing the stagnation increment. The stagnation increment should be allowed only after one year of service qualifying for increment from the notional date of normal increment. An illustration is given in the Annexure.

Consequent on the review of staff strength for Regular Work Establishment cadre in Ennore Thermal Power Station, the Superintending Engineer/Purchase and Administration/Ennore Thermal Power Station has submitted proposals for suppression of Regular Work Establishment posts. The issue has been examined in detail and it has been decided to permit the retention of such of the Regular Work Establishment posts as will be required for O & M of the Power Station and for other requirements, in supercession of all previous sanctions and to suppress/transfer the remaining posts as the case may be, based on needs. **Proceedings :**

Consequent on the reduction of the installed capacity of Basin Bridge Power House from 60 MW to 30 MW it became necessary to review 'the cadre strength of staff' both in State Cadre and Regular Work Establishment. The Superintending Engineer/Basin Bridge Power House has submitted proposals in this regard and based on review, orders have been issued in B. P. Ms. (Ch) No. 289 (Administrative Branch) Dated 28—4—'84 regarding suppression of state cadre posts. The position relating to Regular Work Establishment staff has been examined in detail and it has been decided to sanction afresh, such of the Regular Work Establishment posts as will be required for O&M of the Power House and for other requirements and permitted to be retained, in supersession of all previous sanctions and to suppress/transfer the remaining posts as the case may be based on needs. The following orders are therefore issued in regard to retention/suppression of Regular Work Establishment posts to Basin Bridge Power House.

2. Sanction is accorded to the continuance of the temporary Regular Work Establishment posts last continued upto 29—2—1984 in B. P. Ms. (Ch.) No. 114 (Administrative Branch) Dated 8—3—'83 less the sanctions transferred to systems/circles already beyond 29—2—'84 and upto 31—5—'84. The action of the Chief Engineer/Ennore Thermal Power Station and Basin Bridge Power House in having authorised the Superintending Engineer/Generation/Madras Electricity system/Basin Bridge Power House to continue the posts beyond 29—2—'84 in anticipation of approval is hereby ratified subject to the orders issued in this B.P. 3. I am directed to state that in the Government Order cited, orders were issued as to how to regulate the House Rent Allowance and City Compensatory Allowance in respect of deputationists working in a place outside the State. It has been brought to the notice of the Government that some of the Government servants deputed to Government of India undertakings are drawing pay at the Central rates and allowed to draw House Rent Allowance/City Compensatory Allowance/at the State rates and vice-versa. This is not in order. To remove any ambiguity in the matter, I am to request that the existing para. 6 in G.O. Ms. No. 461, Personnel and Administrative Reforms, dated 16—4—1980 may be recast as follows :—

**6. City Compensatory Allowance and House Rent Allowance :**

The Government direct that the House Rent Allowance and City Compensatory Allowance shall be regulated as follows :—

- (a) If the deputationist opts to remain in the scale of pay attached to him under the Government of Tamil Nadu while on deputation to a post **outside the State of Tamil Nadu**, the House Rent Allowance and City Compensatory Allowance shall be at the rates applicable to such scale of pay in that State where the deputationist is working.
- (b) If the deputationists opts for the scale of pay attached to the deputation post, the House Rent Allowance and City Compensatory Allowance may be allowed at the rates authorised by the borrowing Institutions/that Government.

Fundamental Rules—Government servants suspended while on deputation—Payment of subsistence allowance—Clarification—Orders issued.

**Order :**

A point has been raised as to who should bear the subsistence allowance of a Government servant who is under foreign service and suspended for the offences committed by him either in the Government service prior to his deputation or for the offences committed by him in the foreign service, till the case is disposed of, irrespective of the length of time taken for the disposal of the case.

2. It is considered that the suspension may be due to :

- (i) the lapses committed by the Government servant in Government service prior to his appointment in foreign service ;
- (ii) any criminal misconduct not connected with his office work but during the course of his service in the Govt.
- (iii) the lapses committed by the Government servant while in foreign service itself ; and
- (iv) any criminal misconduct not connected with his office work but during the course of his employment in the foreign service.

3. The Government after careful consideration direct that in the cases referred to under items (i) and (ii) above, the foreign employer shall pay the subsistence allowance initially and the Government shall reimburse the amount of subsistence allowance already paid, to the foreign employer later. In the cases referred to under items (iii) and (iv), the foreign employer shall pay the subsistence allowance till the case is disposed of. However in the cases referred to in para. 2 (iv) above, if the foreign employer does not want extension beyond the existing period of deputation the Government servant would be deemed to have been reverted to Government service on expiry of deputation period and the subsistence allowance paid by the foreign employer beyond the period of deputation will be re-imbursed by the Government later.

Recruitment—Employment assistance to the dependants of employees who retire from service on medical invalidation—Consideration in deserving and genuine cases—Ordered.

### Proceedings :

Dependants of employees of the Board who die in harness are eligible for employment assistance under the Board. This is subject to various conditions including that the family is in indigent circumstances and that the applicant is fully qualified for the post in question. It has been represented that this concession may be extended also to dependants of those employees of the Board who retire on invalidation on medical grounds. This has not been agreed to so far. This is particularly because of the possibility that some employees may get themselves retired on medical invalidation with a view to take up other types of employment since openings for such employment are widely available for persons experienced in the work of the Electricity Board and such persons may also get the undeserved benefit of having their dependants employed in the Board.

2. On further representations, the matter has now been re-examined. It is felt that while extreme care and caution have to be exercised to guard against any possible abuse of this concession, genuine cases where the employee has been left with no alternative but to seek voluntary retirement on major grounds of incapacity deserve to be viewed with sympathy. Accordingly, it has been decided that while there is no need to frame a general scheme as in the case of employment of dependants of deceased employees, cases of dependants of employees retired on medical grounds may be considered on merits and provision of employment to the dependants considered in exceptional cases.

3. The procedure for submission and scrutiny of applications, from dependants of deceased employees prescribed in B.P. Ms. (CH) No. 411 Administrative Branch dated 22—7—83 will apply to the above cases also subject to the modification that the enquiry shall be conducted personally by an officer not below the rank of a Divisional Engineer. He should particularly take care to visit the invalidated employee and make sure that it is a genuine case where he has been totally disabled so as to deprive him of his earning capacity.

4. The other conditions as in the scheme for provision of employment to dependants of deceased employees will apply to this case also especially that the family is in indigent circumstances, that the applicant possesses the qualification for the post in question etc. This concession is subject to the further condition that the employee should have retired from service on medical grounds before attaining the age of fifty years.

5. Orders will be passed by the Full Board on each case.

The Accounts Officer, General Construction Circle (West), has suggested in his letter 3rd cited that Accounts slips may be issued to the subscribers transferred from other Systems/Circles without waiting for the Ledger cards from the Systems/Circles from which they are transferred with a note in the Account slips that on receipt of the ledger cards, the opening balance would be included in the year in which the Ledger Card is transferred. He has made this suggestion with a view to avoid delay in issue of Account slips for the period for which postings and reconciliation have been completed. However, the above suggestion cannot be implemented for the reason that issue of Account slips without incorporating the opening balance due to non-receipt of the Ledger Cards may put some impediments to General consolidation of accounts and also in exercising control over the incorporation of the opening balance in the Account slips etc. In otherwards issue of Account slips without incorporating the opening balance may lead to incorporation of the balances more than once in the Account slips. However, the following further Guidelines are issued in regard to issue of Account slips in respect of those, who are transferred from other Systems/Circles.

(i) Account slips in respect of the subscribers transferred from other systems/Circles should not be issued without incorporating the opening balances. In the monthly Progress Report, a note may be incorporated, indicating the No. of cases for which Account slips have not been issued due to non-transfer of ledger cards.

(ii) Before transferring a ledger card the System/Circle from which the ledger card is to be transferred should ascertain the period up to which Account slips have been issued by the System/ Circle to which the subscriber has been transferred.

(iii) If the System/Circle to which ledger cards are to be transferred and it has made further Progress in regard to issue of account slips, postings etc., the System/Circle from which ledger card is to be transferred should carry over the balances in the accounts of the subscribers till the accounting year for which postings are in Progress in the System/Circle to which ledger cards are to be sent and should see that the ledger cards are transferred in March Final account of that year.

**Illustration :**

Take for example, a subscriber has been transferred in 10/79 from System 'A' to System 'B'. The system 'A' from which the subscriber has been transferred has issued Account slips only upto 1978—79 and the postings for the year 1979—80 are in progress whereas the system 'B' to which he has been transferred has already issued Account slips upto 1982—83 and postings for the year 1983—84 are in Progress. In this case, the system 'A' should carry over the balances in the Accounts of the subscriber in its Broad sheet till the accounting year 1983—84 and transfer the ledger card with instruction to incorporate it on 3/84 Final Accounts as postings for the year 1983—84 are in progress at System 'B'. On receipt of the ledger card, the System 'B' should incorporate the opening balance in 3/84 Final Accounts and allow interest for the accumulations as per the normal procedure.

(iv) If the System/Circle to which the ledger card has been transferred is in arrears in issuing account slips, it should keep the ledger card transferred by the System/Circle in safe custody till postings for the month in which the subscriber joined duty are taken up. The opening balances transferred from the Systems/Circles should be incorporated in March Financial Accounts of that year and interest allowed after incorporation of the opening balances as per the normal procedure.

**Illustration :**

Take for example, a subscriber has been transferred from system 'A' to 'B' in 10/83. The System 'A' has issued Account slips upto 1982—83 whereas the system 'B' has issued account slips only upto 1980—81. In this case, the system 'B' should keep the ledger Cards in safe custody on its receipt from system 'A' till postings for 10/83 in which the subscriber joined duty in the system are taken up and the opening balance incorporated in 3/84 (Final) accounts.

(v) In respect of cases, where Account slips have not been issued for want of opening balances but issued subsequently after incorporating the opening balances on its receipt from the system/Circle from which the subscribers were transferred and after allowing interest on the accumulations, year-wise abstract of the ledger balances for the years for which Account slips have not been issued may be exhibited in the Account slip.

(i) To provide infrastructure facilities to rehabilitate 71 Adi-Dravidar families on 96.97 acres of Bhoodan land in Jariusilampatti Bhoodan village in Madurai district at a total cost of Rs. 9,67,848/-

(ii) To provide infrastructure facilities to rehabilitate 20 Adi-Diravidar families at a cost of Rs. 3.76 lakhs on 40 acres of land in Shantipuram Viralimayanpatti in Madurai Dist.

In addition to the above, the Collector of Madurai has sent proposals for provision of Animal Husbandry Schemes, fedder cultivation, leather workshop, Community building and managerial expenses to the tune of Rs. 5.68 lakhs.

2. The Managing Director, Tamil Nadu Adi-Diravidar Housing and Development Corporation, Villupuram has however, recommended for the sanction of Rs. 1,99,700 from Special Central Assistance fund for the schemes listed in Annexure-I, to this order towards Jari Usilampatti Bhoodan Rural Development Project. As regards Viralimayanpatti, Shanthipuram Rural Development Project the Managing Director has recommended for the sanction of Rs. 88,750 as subsidy from Special Central Assistance as detailed in Annexure-II to this order.

3. The above proposals were placed before the Secretaries, Committee convened under the Chairmanship of Chief Secy. to Government on 22—8—83. The Committee approved the scheme with 50% subsidy from Special Central Assistance.

4. In pursuance to the decision of the Secretaries Committee above, the Government sanction the payment of a sum of Rs. 2,49,700/- (Rs. Two lakhs forty nine thousand and seven hundred only) as 50% subsidy from the Special Central Assistance fund available with Tamil Nadu Adi-Dravidar Housing and Development Corporation for the provision of infrastructure facilities for the seven schemes as in Annexure—I to this order so as to rehabilitate 71 Adi-Dravidar families in Jari Usilampatti Bhoodan village, Madurai district. The Government also sanction the payment of a sum of Rs. 88750/- (Rs. Eighty eight thousand and seven hundred and fifty only) as 50% subsidy from Special Central Assistance fund available with Tamil Nadu Adi-Dravidar Housing and Development Corporation for the provision of infrastructure facilities as detailed in Annexure-II to this order to rehabilitate 20 Adi-Dravidar families in Shanthipuram, Viralimayanpatti of Nilakkottai taluk. The Managing Director, Tamil Nadu Adi-Dravidar Housing and Development Corporation, Villupuram is requested to release the amounts sanctioned above in three instalments to the respective Rural Developments Project. The second and Third instalments should be released only after obtaining utilisation certificate of the 1st instalment. The beneficiaries should be Hindu Adi-Dravidars.

In the memo. under reference 1 instructions were issued that for cluster of hut services, check meters should be provided.

In the memo. under reference 2 the attention of system Superintending Engineers was drawn to the above instructions to make a review and take suitable action if abnormal consumption has been recorded.

But inspite of the above instructions in practice it is seen that in almost all O & M sections in most of the cases for cluster of huts check meter has not been provided.

It may be noted that if five or more number of huts are situated in one locality, it may be deemed as cluster of huts and for such localities check meters should be provided. In order to provide check meter for all existing cluster of huts for which supply has already been affected, the section officers may be instructed to provide at least one check meter for one cluster of huts per month per section. In future all cluster of huts shall be provided with metering arrangement at the time of effecting the supply to these huts. Providing of check meters should be monitored by System Superintending Engineers.

The territorial Divisional Electrical Engineers and Assistant Divisional Engineers should review monthly the average consumption of hut as recorded by the check meters and should take appropriate action if there is any abnormal consumption. The Superintending Engineers/Operation & Maintenance during their inspection of O & M Sections should make a review of the above and ensure that appropriate action is taken wherever called for.

According to the orders issued in the reference first and second cited, the Corporation of Madras should continue the maintenance of the street lights. In the reference third cited, the Tamil Nadu Electricity Board has submitted a proposal for retransferring to the Electricity Board the responsibility of maintenance of street lights in the following 12 panchayats taken over by the Corporation of Madras for the reasons stated below.

1. Villivakkam, 2. Kodambakkam, 3. Saligramam, 4. Virugambakkam, 5. Thiruvanmiyur
6. Velacherry, 7. Thirumangalam, 8. Erukkancherry, 9. Kodungaiyur, 10. Kolathur, 11. Kanagam Taramani, 12. Koyambedu.

The street light fixtures in those areas are mounted on the Tamil Nadu Electricity Board poles unlike in other areas of the Corporation of Madras. For any rectification of street light work dual control is involved both by the Tamil Nadu Electricity Board for switching off supply and by the Corporation of Madras for replacement of defective street lights. Difficulties are encountered to ensure cent percent co-ordination between the two bodies in view of the lack of adequate manpower for street lights in Electricity Board and of adequate spares in the Corporation of Madras. The Tamil Nadu Electricity Board has, therefore, proposed that the responsibility of maintaining the street lights in the above 12 areas may be transferred to Tamil Nadu Electricity Board, Subject to the following conditions :

- (i) Tamil Nadu Electricity Board will take over the street lights now fixed on Board LT lines in the extended areas of the 12 erstwhile panchayats from 1-1-83 and maintain street lights as being done in the case of the street lights in panchayats in rural areas.

(ii) The Madras Corporation will bear the entire cost of spares for replacement as well as labour charges as in the case of panchayats in rural areas.

(iii) The Madras Corporation will deposit the required funds for the purchase of spare parts etc. for the replacement of street lights in the extended areas of 12 erstwhile panchayats.

(iv) The Madras Corporation will supply the required spares upto 31-12-82 to attend street light rectification.

(v) The switching 'ON' and 'OFF' of street lights in the extended areas of 12 Panchayat will continue to be attended to by the Corporation of Madras.

(vi) The Madras Corporation will, however, arrange to lay their own LT lines in the extended areas of Madras Corporation as in the case of Madras city within a period of five years and provide street lights in the erstwhile 12 Panchayat areas.

2. The Commissioner, Corporation of Madras has agreed to the proposal of Tamil Nadu Electricity Board.

3. In the circumstances, the Government approved the proposal of the Tamil Nadu Electricity Board and, accordingly direct, that the responsibility of the maintenance of street lights in the above 12 erstwhile panchayat areas be retransferred to the Tamil Nadu Electricity Board subject to the conditions mentioned in para 1 above.

In accordance with the modifications ordered to sub-para 5 of para 14 of the Tender Regulations in the B. P. cited, all tenders received in time should be opened even if there is any objection to the consideration of any tender, with the objection recorded and put up to the competent authority to decide the tender for taking a final decision on the consideration of the tender.

2. Cases have come to notice where the Tender Opening Committee has not opened tenders for non-payment of Earnest Money Deposit, part payment of Earnest Money Deposit, non-submission of quotations in double covers, non-purchase of specifications etc., on the ground that there was no objection raised for not opening such tenders. This is not correct.

3. It is clarified that all tenders received within the time schedule fixed for submission of tenders should be opened by the Tender Opening Committee and the rates read out irrespective of any defects/deficiencies in the Tender.

4. The Tender Opening Committee should, however, record all the defects and deficiencies noticed in the Tender and bring it to the specific notice of all present at the time of opening of Tenders. The following revised procedure may be adopted in order to analyse the performance of various components and to prevent pilferage.

- (1) The new fittings received should be assembled and tested in section office.
- (2) Paper seals with A.E./J.E.'s signature with date and office seal should be affixed on (a) Choke (b) Starter (c) Tube & (d) Condenser  
The seals may be so affixed that rotation of the Starter & Tubes are made impossible.
- (3) After "Locking" the fittings, security sealing using sealing wire and A.E./J.E.'s "Sealing plier" may be provided at two locations. Where clips for close sealing are not available, an overall looping of wire at appropriate points may be adopted.
- (4) The field staff shall merely collect the completed fittings and erect them at site and in case they do not burn they have to merely return it and not tamper with any sealing.

The Tamil Nadu Elec. Board in its proceedings cited have approved the quantum of initial security deposit to be collected from the prospective H. T. and L. T. consumers.

2. The Tamil Nadu Elec. Board is faced with certain problems in effecting supply to quarries, where the continued operations of the quarrying unit is dependent upon the availability of raw materials like—rocks etc. and the validity of the quarrying licence. Since the supply is given in a remote place in the shed erected, it is likely that the quarrying operations will be discontinued by the consumers, on account of the aforesaid factors and the supply will have to be disconnected even before the agreement period. In such cases, it has become difficult to locate the whereabouts of the consumer to realise the arrears.

3. With a view to obviate the above difficulty, it is considered necessary to collect adequate security deposit at the time of effecting supply by way of initial security deposit so as to cover the entire tariff minimum for the service for the period of agreement viz., 2 years plus 1 month notice period.

4. In the circumstances, the Tamil Nadu Electricity Board directs that the collection of initial security deposit from the prospective L.T. consumers, requiring supply for quarrying operations be collected to cover the appropriate Tariff Minimum charges for the entire sanctioned load for the full agreement period of 2 years and 1 month notice period and the amount so collected shall be reviewed at the end of the agreement period and the excess amount if any over the normal security deposit payable by the consumer, based on the highest actual consumption during the preceding period, shall be refunded.

### REPORT OF THE COMMITTEE ON ENERGY UTILISATION IN INDUSTRIES

#### Preamble :

On the 27th February 1984, the Chairman, Tamil Nadu Electricity Board held discussions with various representatives of industries to ascertain their views on the policies and practices governing power management in the State and to pave the way for better interaction between the Board and the industries. It was then decided to constitute a Committee with eight Sub-Committees on Energy Utilisation in Industries and orders were issued accordingly in B. P. Ms. (CH) No. 56 (Technical Branch) dated 3—3—84. The following are the terms of reference of the Committee.

- (i) To suggest optimum requirement of demand and energy for industries as correlated to unit production.
- (ii) To formulate modalities for energy audit of industries.
- (iii) To suggest appropriate measures for conservation of energy in industries.

The Sub-Committees constituted covered the following sectors :

- (i) Aluminium and Oxygen
- (ii) Caustic soda.
- (iii) Cement
- (iv) Chemicals and Fertilizers.

- (v) Textiles
- (vi) Steel
- (vii) Heavy Engineering Industries
- (viii) Light Engineering Industries

The main committee is headed by the Chairman/Tamil Nadu Electricity Board and consists of senior engineers of the Board and a representative from each of the Sub-Committees and has the Superintending Engineer/Industrial Energy Management (Cell) as its convenor.

The Sub-Committees consist of representatives from leading industries belonging to the category concerned and has a Superintending Engineer of the Board as member-Convenor. The list of members of the Committee and Sub-Committees is appended to this report. The eight Sub-Committees after detailed study of representative industries and after a series of sittings, formulated their views and forwarded these to the main committee during the first week of May 1984. These were circulated to all the members of the main committee and detailed discussions were held at the meetings of the main committee held on 22-5-84 and 30-5-84. This Report has been finalised accordingly.

### **1. Power cut policy—Optimum requirements of demand and Energy**

With a view to examine whether during periods of power cut it would be possible to correlate the quotas fixed with the optimum requirements of each industry, the committee made a detailed attempt to ascertain the optimum requirements of demand and energy for each unit of production. The committee has found that the assessment of optimum energy requirement per unit of production is unduly cumbersome and in most cases, impracticable for various reasons such as the following :—

- (i) Many of the industries are having more than one product line.
- (ii) The product mix in each industry may change from time to time.
- (iii) The methods of manufacture and the technology adopted may undergo changes from time to time affecting the energy consumption pattern upwards or downwards.
- (iv) While some industries manufacture all their ancillary and auxiliary requirements and undertake all their preliminary and intermediate processing themselves, some other industries in the same line of manufacture entrust these items of work to sub-contractors. This makes a comparison of energy requirements of different industries in the same field meaningless.

For these reasons the committee finds that it is not practicable to fix energy or demand quotas during periods of power cut based on optimum requirements however scientific this might appear to be at first glance. This is particularly so because if such quotas vary from case to case in the same industry or group of industries it is likely to be assailed as arbitrary.

2. The Committee has accordingly come to the conclusion that the present policy of fixing quotas during periods of power cut based on the utilisation during a prescribed period in respect of each consumer is the only practicable method notwithstanding its imperfections. Even though under the existing procedure, there is some possibility of some industries boosting their demand and consumption during non-power cut periods, the committee considers such cases to be of marginal proportions. The Committee recommends that the present procedure may be improved upon in the following manner :—

- (i) The base period may be the average of any three consecutive months advantageous to the consumer during the preceding five years.
- (ii) The base demand may be the average of the maximum demand in KW registered during the same three months period as under (i) above.
- (iii) Demand quota may be fixed on KW basis and the billing done on KVA basis. This is to give an incentive to the industries to improve their power factor.



(iv) Powers may be delegated to Superintending Engineers and Regional Chief Engineers for condoning any excess in demand quota upto 2% and 5% respectively.

(v) Industries such as steel, fertilizer etc. which cannot operate with a demand quota below a particular level may, if they so desire, be permitted to work without demand cut for a reduced number of days on a commuted basis.

(vi) Cut on Oxygen industries may not exceed 15% both on demand and energy.

(vii) Higher quota may be allowed for seasonal industries like tea with corresponding reductions during the rest of the year.

(viii) Industries may be advised to instal automatic alarm systems to warn against aberrant shooting up of demand. Such installations may be permitted to be synchronised with the metering arrangement of the Board.

## II. Energy Audit

Energy Audit enables the industries to identify areas of inefficiency so that corrective action could be taken. The Committee, while fully endorsing the need for energy audit in industries to make the best use of the available power, feels that it will be desirable to leave this to the units concerned rather, than imposing it upon them from outside. The role which the Board can play in bringing about the desired level of consciousness for energy audit would be by providing suitable incentives and through dissemination of information and constant dialogue with groups of consumers.

The individual industries may be advised to send half yearly energy audit reports to the Board in the format appended.

## III. Energy Conservation

Conservation of energy both in the short and long term should be an essential feature of every industrial operation. The committee looked at several methods available for conserving energy, and many of these could be achieved through changes in operating conditions/minor modifications and those which would require substantial expenditure on machinery etc. Some of the areas where energy could be conserved are noted below:

- (i) Replacement of graphite anodes by titanium anodes in industries adopting electrolysis.
- (ii) Savings in lighting and illumination through scientific design of lighting systems.
- (iii) Choice of proper process parameters.
- (iv) Proper sizing and design of drive systems. Wherever possible motors should be selected to operate as close as possible to their maximum efficient point.
- (v) Improvement of power factor through correction capacitors.

## IV. General

(i) The Committee recommends that as far as practicable, the anticipated power shortage should be evenly spread throughout the year so that industries are not subjected to steep cuts during the later parts of the year.

(ii) The present system of 'Banking' of energy with the Board may be continued.

(iii) Captive diesel generating sets may be permitted to be paralleled with the Board's grid subject to the Industry installing suitable safety devices and indemnifying the Board against possible damages, accidents, etc.

(iv) The Committee finds that the deliberations of this Committee and of the sub-Committees apart from helping in the formulation of the above views have been extremely useful for a proper understanding of various problems by the representatives of both the Board and the industries and this exchange of views has been most beneficial to both sides. The Committee accordingly recommends that this committee and its sub-Committees may be continued on a permanent basis and periodical meetings arranged to facilitate a constant dialogue and interaction.

- (i) In respect of industrial services, 100% check should be done by the Anti-power theft squads.
- (ii) In respect of Agricultural and other services, Superintending Engineers/Operation and Maintenance may be requested to distribute the verification work among the Divisional Engineers in their systems. 100% verification should be done by the Divisional Engineers personally.

On completion of 100% verification, the same may be confirmed before 15—7—84.

**Sub :** Electricity—Extension of supply to additional loads in L. T. Agricultural and Industrial Services—Separate priority to be maintained orders—issued.

**Ref :** CE/Distribution's Memo. No. ER1/A2/R1/(G)/Agl. 121/dt. 12—9—78

The orders issued in memo. cited on extension of supply to additional loads in existing Agricultural Services are cancelled.

The following instructions are issued for disposal of applications for L. T. additional loads in existing Agricultural and Industrial services.

1. Additional load applications in respect of Agricultural and Industrial services should be received and registered separately in the Operation and Maintenance sub-division (Assistant Divisional Engineer) office.

2. Separate priority registers should be maintained for L. T. additional loads in Agricultural and industrial services tariff-wise. The priority will be the date of receipt of application.

3. Field inspections should be made by the Assistant Divisional Engineer and the applications should be classified into two categories under each tariff viz (i) involving mere service connections and (ii) involving improvements.

4. In respect of cases which involve mere service connections the Assistant Divisional Engineer will issue notice to the party to get ready within 30 days from the date of receipt of notice. In exceptional cases this time limit may be extended upto 90 days by the Divisional Engineer/Operation and Maintenance on specific request in writing from the party duly recommended by the Assistant Divisional Engineer. Once the consumer reports his readiness and records his readiness in the readiness register the same should be verified and supply should be effected immediately. This will apply to both Agricultural and Industrial services.

5. In respect of additional load applications requiring improvements 90 days notice to get ready with the installations and to register the readiness within the notice period should be issued by the Assistant Divisional Engineer. Estimates should be get prepared before issuing the notices and notices should be issued taking into account the priority of the applicant, the pending works on hand, availability of required materials etc., It should be ensured that there is no undue delay in issuing notices and effecting supply for the additional loads. If the party does not get ready and enter in the readiness register within the notice period of 90 days the applications should be deemed as cancelled. The consumers should be informed of this condition in the 90 days notice itself.

As soon as the consumer reports his readiness the same should be verified and action should be taken to carry out the improvements and effect supply within a reasonable period as per the readiness priority.

This will also apply to the request for additional loads both agricultural and Industrial services.

6. Additional loads should not be permitted to circumvent the priority of application for power supply by splitting and shifting the existing services to new wells after availing additional loads.

7. By sanctioning and effecting additional loads in the existing agricultural and industrial services the interests of new applicants should not be affected.

Circular Memo. No. 317/Adm. Br./PA (T)/S2/84-1, (Administrative Branch) dated 31-5-1984.

**Sub: ELEC. — Extension of supply for lighting services — acceptance of single phase meter from consumers — instructions — Issued.**

It has been brought to the notice of the Board that effecting of lighting service connections is delayed for want of single phase meters. It has, therefore, been decided to accept new meters of single phase 5 amps and 10 amps ratings, offered by the prospective consumers requiring lighting services.

2. The Superintending Engineers of Operating Systems are informed that the following procedure should be followed for the acceptance of new meters from the prospective consumers requiring L.T. service connections for lighting purposes :

(i) New single phase meters of 5 amps and 10 amps ratings may be accepted from the consumers requiring supply for lighting purposes under L.T., on the written approval of the Divisional Engineer/O & M., who should ensure that such meters are not available in stock in any of the stores. The meter should be required to be given along with the purchase bill or cash receipt to establish that the meter is a newly purchased one.

(ii) The new meter so offered by the consumer shall be valued at the rate shown in the purchase bill **but not exceeding** such rate as may be fixed by the Board from time to time with reference to the prevailing market conditions and a refund shall be made to the consumer of such price. The ceiling price shall be Rs. 83-50 (Rupees eighty three and paise fifty only) until further orders.

(iii) The meter shall be tested by the Board free of cost and accepted only if it is alright.

(iv) If the meter offered by the consumer is found to be defective and not suitable for use the same shall be returned to the consumer and the service connection shall not be effected till the replacement of the defective meter by another new meter and payment of appropriate testing charges as prescribed in the terms and conditions of supply for testing meter.

3. The following accounting procedure shall be followed for regularising the transaction :—

(i) The meters after satisfactory test in M.R.T. should be accounted through stores transaction by presenting an adjustment devolution and requisition. The devolution should be credited to the miscellaneous deposit (i.e.) 096 account of the consumer concerned and the requisition should be debited to the concerned service connection work order under the classification of Board side. Both the devolution and requisition should be presented duly valued at the rate of Rs. 83-50 only. The meter should be devoluted to the Stores by the Section Officer/Operation and Maintenance by furnishing the account head "096 Miscellaneous Deposit of (name of consumer/area)". The meter should be drawn by the Section Officer by a requisition quoting the service connection work order No./Date. Both the requisition/Devolution should contain the details of meter, make I. R. etc. Such consumers' meters should be accounted for in separate folio both in priced ledger/quantity ledger and not to be clubbed into departmental meters' folio.

(ii) For refunding the cost of the meter supplied by consumer after effecting the service connection, the following procedure shall be followed.

(a) Pre-receipted stamped hand receipt duly signed by the consumer should be obtained by the Section Officer/O & M concerned. The Hand Receipt along with triplicate copy of devolution acknowledged by Store-Keeper and original bill produced by consumer should be forwarded with the covering letter furnishing the following details to the Asst. Divisional Engineer/O & M :—

- (1) Name of consumer and address.
- (2) Service Connection No. /Name of Distribution.
- (3) Meter make and No. capacity amps.
- (4) Date of testing at MRT and initial reading.
- (5) Departmental No. assigned.
- (6) Devolution No./Date.
- (7) Name of the Store where devoluted.
- (8) Requisition No./Date.

4. The Asst. Divisional Engineer will countersign the Hand Receipt and forward the same to the Superintending Engineer for pass order and payment by crossed cheque through the Junior Engineer/Asst. Engineer concerned.

5. A register of payment of cost of consumer's meter should be maintained both at Section Office and at Central Office (APS) in the forms appended hereto. While forwarding proposal for releasing the cost of the meter supplied by the consumer, necessary entries should be made in the Section Office without fail. Similarly, while passing the Hand Receipt for refund of amounts to the consumer, necessary entries should be made in a register maintained in APS of the Central Office. The fact of refund should also be noted in the devolution SRB. It should be ensured that refund of cost to the consumers in these cases are promptly made.
