Chaos reigns. Especially so in the world of ideas. In the social, economic and spolitical fields, values have become a forgotten dimension. Mammon presides in every heart and every home. The cult of success at any cost, the smug assumption that nothing succeeds like success, has become an obsession. Given the semblance of an opportunity, there is no kind of venality that is not made to look respectable. The majority are so engrossed in their daily choras that they have neither the time nor the will to apply themselves to the larger issues that disturb Community's conscience, search for and find solutions or insist on their acceptance. If they become aware of these issues it is only through the mass media which are themselves instruments of various sectarian interests, open or disguised. The limited few who addreas themselves to the larger issues do so, mostly, not in any dispassionate pursuit of Truth but to achieve their own parochial objectives. Thair thrashing about only makes what is murky, murkier still. Every debate, however vital or sacred the theme, is soon reduced to a farce by a preponderance of falsehood and even more despicable half-truths. "The best lack all conviction while the worst are full of passionate intensity".

In the midst of this gloom stands the intellectual. Alone. Alienated. He has become an endangered species. This cannot be allowed to remain so if we are to survive as a free, robust, self-sustaining and vibrant society. The intellectual has to find his voice again. He has to train his search-light on all the areas of darkness. He has to raise our general level of consciousness so that all of us become participants and not so much of plastic clay to be kneaded and moulded at will by the cunning few.

We tend to use the words 'intellectuals' and 'intelligentsia' as synonyms. But, writers like Andre Beteille (Ideologies and Intellectuals) have sought to make a distinction between the two. Beteille points out that the term 'intellectual', as used in Anglo Saxon countries, has a narrower connotation than the term 'intelligentsia' more commonly used in the communist countries to denote those engaged in 'non-manual' types of work as distinct from peasants and factory workers. Western sociologists, on the other hand, use the term intellectual not to denote the difference in the type of work but "a peculiarly close and intimate relationship with the values cherished by society as a whole or by particular sections of it." Who is an intellectual? What attributes mark him out from the rest?

The intellectual is not confined to any particular social or professional class. Traditionally, some vocations and environments used to be considered the strongholds of intellectuals. Poets, writers, scholars, scientists, journalists, university men, all of them had, at one time or the other, been looked upon as 'intellectuals'. The qualities of an intellectual, as distinguished from intellectual qualities, are no longer confined to these groups alone. Nor are all those in these groups, or even the large majority of them. intellectuals in any sense of the term. Universities, for instance, can hardly be depended on any longer to provide the climate for mature thinking, cool deliberation and free debate in the manner in which Oxford end Cambridge were considered at one time. Or, take dournalism. A profession that once had an abiding and near-unanimous commitment to certain moral values and the courage to be selfless and relentless in its pursuit of truth has now, for the most part, become the unashamed handmaiden of power-brokers of many thues or the clever-clever art of boosting sales through the purveyance of trash. They prosper on the guilibility of a public who believe that words printed on pulp are gospel truth, and the glossier the paper the more sacred their contents. Today, therefore, there is no particular area that is the exclusive preserve of the intellectuals. We have to look for them in every field and nurture them wherever they are found.

Many intellectuals misjudge their role as that of attacking the Establishment for the only reason that it exists. For them, 'any stigma will do to beat a dogma'. Some of them take on lavishly idealistic stances, riding the moral high-horse as it were, in disregard: of the raalities and compulsions of life. This has made them suspects in many eyes. The more charitable amongst us dismiss them with a shrug of our shoulders as some minor nuisance or as the inevitable Don Quixotes tilting at windmills. Intellectualism has, nodoubt, to be velue-based. But that should not make it namby-pamby or imprison itself in en ivory tower. When intellectual activity ceases to be socially relevant and pragmatic, it loses its credibility and its utility; it may even become a danger to society. Take, for instance, an issue of topical interest: terrorism. When, in the name of civil liberties or under cover of political dissent, an intellectual, even by implication, holds a brief for terrorism or condemns the attempts of the State to quell it, he greatly harms the common good. He forgets that modern day terrorism can no longer be explained away as nothing more than an explosive manifestation of suppressed dissent. It has become an amorphous mixture of various anti-social, criminal, anti-national and extra-territorial forces. This kind of terrorism organised with military perfection, equipped with enormous funds, armed with weapons of mass destruction and ruthless and indiscriminate in using such weapons cannot be doused with lavender water. It cannot be curbed by out-dated codes of procedure which had been drafted to suit a time when a fledgling sub-collector could, with a light hand, maintain law and order by merely binding over persons for good behaviour. It calls for a wholly new vocabulary, a wholly new set of laws and radical procedures for their enforcement. Intellectuals who fail torealise this are aiding and abetting the destruction of society and of the country.

The intellectual should also develop the objectivity to look beyond proximate compulsions. To quote the words of Lewis A. Coser (Men of Ideas: A Sociologist's View), he should have "a capacity for detachment from immediate experience, a moving beyond the pragmatic tasks of the moment." His comprehension should take in one sweep the ground under his feet and the far horizon.

The intellectual is the conscience-keeper of the community. To perform this role, he has to be alert and sensitive. The average person shies away from conflicts and confrontation. He wents the tenor of his life to be as undisturbed as possible. For this reason he accepts a great deal of injustice without demur. He is complacent. But the intellectual cannot afford this comfort. He has to be sensitive to all the aberrations in the environment in all their nuances and vocal in his protest against them. Many major disasters in the social, economic and political fields could have been averted if only the had been vigilant enough and had raised his voice at the right intellectual much before they assumed their fearsome dimensions and became invincible. time Following the example of psychologists who speak "of the threshold of a man's... consciousness in general to indicate the amount of noise, pressure or other stimulus which. it takes to arouse his attention at all", William James in his Varieties of Religious Experiencesays that we could also speak of a 'pain threshold', a 'fear threshold' and a 'misery threshold'. Extending this further, I feel we could also speak of a 'completency threshold', the level of disturbance necessary to shake a man out of his complacency and into some sort of action. The 'complacency threshold' of the average individual is fairly high. But the intellectual cannot be true to his role unless he has a very low 'complacency threshold'.

The intellectual is not afraid of marching on alone if it becomes necessary. To use Thoreau's language, if the intellectual "does not keep pace with his companions" it is because "he hears a different drummer". The intellectual believes with Andrew Jackson that "one man with courage makes a majority". Referring to Paulinus who, "aware that the Roman civilization had collapsed, chose to tend a particular shrine, to keep alive one clear lamp amidst gathering darkness", Malcolm Muggeridge says: "A non-conforming man is:

in a very similar case to Paulinus. He, too, has seen the treasures of civilization sacked, and, what is worse, perverted, and the barbarians sweep forward in a seemingly irresistible rush; he, too, has come to doubt the applicability to contemporary circumstances of the values, baliefs and loyalties which guided the conduct of his forbears; he, too, has been disconcerted and appalled by the apparently limitless capacity of his contemporaries to be deluded, and to content themselves with bread and circuses when their very existence is threatened. And he, too, must choose his shrine, must light his lamp, and keep it burning". In this expansive sense, the intellectual also has to be a non-conformist. His non-conformism, however, should not be a blind creed or a case of neurotic contrariness; it should be issue-specific. Otherwise, his purpose is lost. While his non-conformism is contemplative and critical it should also be creative.

It is true that the intellectual should have no hesitation to battle alone if need arises. But that does not mean that he should necessarily be and always be a lone wolf. When great issues are involved, fundamental values are at stake, danger is imminent, an individual can do little if he acts in isolation. He should join hands with others of similar disposition, forge common bonds and speak and act in concert. Only then can he hope to make an impact.

The inflows during June and July '87 from the south west monsoon were only 305 m.u. as against the ten year average inflows of 1277 m.u. and last year inflows of 924 m. u. during the corresponding period. The inflows received during June and July '87 are the lowest during the last 25 years.

VI. Training:

The following special training programmes were conducted during July '87:-

- (i) A three day course on 'safety' to RWE Staff of Madurai Region was conducted from 7—7—87 to 9—7—87 at Madurai.
- (ii) Supervisory Development Programme for the newly recruited Junior Engineers II Grade of Madurai and Trichy Regions was conducted from 20—7—87 to 30—7—87 at Madurai.
- (iii) A one day training programme on 'Filling up of H.T. bills, worksheets and formats' was conducted at Madras on 20—7—87 for the benefit of Accountants/Assistants incharge of H.T. billing in Systems.
- (iv) In order to train Assessors in the reading of meters and related matters, instructions have been issued that classes be conducted for all Assessors at the Divisional Distribution Offices and the training completed by 31—8—87.

VII. Formation of Administration Cadre:

In order to facilitate building up of skills, the common clerical cadre in the Board has been bifurcated into an Administration Cadre and an Accounts Cadre. The Administration Cadre will deal with administration, establishment including claiming of pay and allowances and miscellaneous items of work viz., items of work other than finance and accounts including revenue. This Cadre will consist of Junior Assistant, Typist/Steno-typist, Assistant, Administrative Supervisor, Assistant Administrative Officer and Administrative Officer. The Accounts Cadre will deal with finance and accounts including revenue. This Cadra will consist of Junior Assistant, Typist/Steno-typist, Assistant, Accountant, A.A.O. and A.O. (B.P. Ms (FB) No. 62 (Secretariat Branch) dt. 23rd July, 1987).

VIII. Bi-monthly metar reading:

Negotiations have been held with the various Unions in the Board to work out the modalities of changing over the present system of monthly assessment and collection of current consumption charges in respect of LT services to once in two months. An understanding has been reached with the Tamil Nadu Electricity workers' Federation, Tamil Nadu Minvariya Anna Thozhilalar Sangam, Tamil Nadu National Electricity Workers' Federation (INTUC), Tamil Nadu Minvariya Janata Thozhilalar Sangam and Tamil Nadu Electricity workers' progressive Union (TMTM). The proposals have been sent to the Commissioner for Labour for arriving at a settlement under Clause 12 (3) of 1.D. Act, 1947.

With a view to enable transfers of other Class II Officers also within the station, it has been decided to amend the above Service Regulation.

Chairman Circular Memo. No. SE/Plg/DB/545/81-118 (Technical Branch) dt. 1-7-87

Sub: MIS—Standardising returns and registers—avoiding duplication—consulting CE/Planning before introduction—instructions issued.

Data Bank, under the control of the Chief Engineer/Planning is entrusted with the work of evolving Management Information System (MIS). Accordingly it is standardising the various returns to be submitted by different officers and also the registers to be maintained in various offices.

- 2. In a vast organisation like Tamil Nadu Electricity Beard, it always happens that different agencies introduce new returns/registers defeating the purpose of standardisation. To avoid introduction of multiplicity of returns/registers, it is essential that only one agency in the Headquarters co-ordinates introduction/modifications of returns and registers and issue of instructions.
- 3. In accordance with the above decision, it is instructed that any agency which wants to introduce new returns/registers or propose modifications to the existing forms should get the approval of the Chairman. Proposals for such introduction or modification of new returns/registers may be sent to the Chief Engineer/Planning.

service particulars of employees—Clarification—Issued.

Ref: Vigilance Cell U.O. Note No. 2208/SS1/87-1, dt. 2-2-87.

Vigilance clearance is given by the Vigilance Cell whenever it is sought for by the Superintending Engineers, Chief Engineers and others for the purposes mentioned in para 1 of the U.O. Note cited. To enable the Vigilance Cell to give the required clearance the service particulars of the officials concerned for 10 years are called for by the Vigilance Cell. But the contents of the U.O. Note cited have been misunderstood by the receipients of the U.O. Note to mean that Vigilance clearance should be obtained compulsorily with reference to para 1 of the U.O. Note cited before a case is considered for promotion. Accordingly, proposals are being sent to Vigilance Cell for vigilance clearance for each and every case of promotion quoting item (iii) of para 1 of the U.O. Note cited.

- 2. It is clarified that Vigilance clearance is not necessary when a case is considered for promotion. The case can be processed with reference to available materials before the Appointing Authority. It is also clarified that only in cases where vigilance clearance is considered absolutely necessary in a particular case for any specific reason then it need be sought for. Only in such cases service particulars may be sent by the officers who seek such clearance.
- 3. Item (iii) in para 1 of the U.O. Note cited relating to Vigilance clearance for consideration of the cases of employees for promotion to the next higher category etc. is hereby deleted.

Management Information System for (i) Distribution systems and Head quarters Offices concerned (ii) General construction Circles and the Head Quarters concerned (iii) Generation Circles (Hydro) and Headquarters concerned and (iv) investigation circle was introduced in the circular Memos. 1 to 4 respectively cited under reference.
- 1.2. To overcome difficulties expressed by monitoring cell and Head Quarters offices in putting up the reviews for all systems/circles, MIS for common functions like (i) Materials Management (ii) Stores Accounting (iii) Finance and Accounting and (iv) Personnel was introduced in reference 5 for all offices not covered by circular 1 to 4 referred above.
- 2. Considering that the Management Information System has to be dynamic and it is to be updated, feed-backs were obtained from Distribution systems. Detailed discussions were held with the Accounts Branch, Audit Branch and Headquarters Offices. Subsequent to the introduction of MIS, commercial Accounting procedure has been introduced and certain functions have been computerised. As a result, it has become necessary to delete the returns listed in Annexure—II, modify the returns listed in Annexure—III.
- 3. In regard to the return DI/M/146, the following revised procedure is to be followed:—Certain information regarding energisation of pumpsets and electrification of Adhi Dravida colonies has to be reported to Government on the 1st date of the succeeding month. As it is practically impossible to furnish details for a particular full calendar month so as to reach the Covt. on the 1st of succeeding month, the adopted policy of giving the information in the monthly return for the entire month, has to be deviated in this case. For this purpose, the monthly return should contain the information from the 25th of the last month to 24th of the present month. Accordingly, the formet. DI/M/146 "Electrification of Hamlets, Adhi Dravida Colonies and Pumpsets" should be sent by ADE/08M on 25th itself, closing the figures on 24th. He should also mark an advance copy to Superintending Engineer/Operation and Maintenance concerned so that he can send the information to Superintending Engineer/RE & ID on 27th itself. It should be ensured by the Assistant Divisional Engineers/Operation and Maintenance that the figures given in the returns DI/M/101 "Progress in effecting service connections and details of pending applications", DI/Q/103 'status of Tariff War services end connected load", DI/M/106 'Electrification of Hamlets' DI/M/107 'Electrification of Adhi Dravida colonies' tally with the figures given in DI/M/146. In other words, the data furnished in these 4 returns should also relate to 25th of the previous month to the 24th of the succeeding month.
- 4. (i) The deletions/modifications and introduction of new formats may be noted, for sending the future returns.
- 4. (ii) Out of seven registers of returns proposed for Distribution systems four registers of returns have already been received from the printers and allotment has been made. Allotment for the other three registers of returns will be made after they are received from the printers.
- 4. (iii) The formats for the various returns are under printing and they will be issued after they are received from the Printers.
- 4. (iv) It may be ensured that in the case of returns where there are changes in the format as indicated in the annexure-II, only the revised formats as printed and supplied should be used.

In the B.P. cited, orders have been issued that in the case of appointment/promotion to higher posts from selection grade of lower posts carrying identical time-scale of pay as that of the ordinary grade of the higher post, pay should be fixed **either** under S.R. 33(b) with reference to the notional pay in the ordinary grade of the lower post with 5% increase in pay **or** at the stage in the ordinary grade of the higher post after adding one notional increment to the pay drawn in the Selection grade scale of lower post, at the option of the individual.

2. A point has arisen as to how the pay should be fixed when the individual draws personal pay in the Selection grade of the lower post and has exercised option to fix the pay at the stage in the ordinary grade of the higher post after adding one notional increment to the pay drawn in the selection grade of the lower post. It is clarified that in such cases, pay shall be fixed at the stage in the ordinary grade of the higher post after adding one notional increment to the pay drawn in the Selection grade scale of the lower post as ordered in the B.P. cited and the "Personal pay" drawn in the selection grade of the lower post shall be allowed to continue till the individual gets his next promotion or selection grade in that post whichever is earlier.

I am directed to state that of late number of cases sacking relaxation of the provisions of Fundamental Rule 49 are being received from Haads of Departments. Proposals which are not in accordance with the provisions of Fundamental Rule 49 are not admissible and cannot be accepted by the Government. It is also noticed that to avoid lapse of post held on additional charge after five

months, certain departments are transferring the officer to the post which he is actually holding on additional charge and ordering additional charge arrangements of the same officer on the post from where he is transferred. Government take a serious view of such highly objectionable action of Heads of Department.

- 2. All Heads of Departments are informed that-
- (i) in case, it is considered necessary that a Government servant should hold charge of another post or posts and that he is to be remunerated under Fundamental Rule 49, it is necessary that he should be formally appointed by the competent authority to hold charge of that post or those posts; and
- (ii) in case, if the sanction for a post lapses for having been kept under additional charge arrangements for more than five months, it should not be filled merely to avoid its lapse. Such posts should be allowed to lapse. The proper course would be to seek Government orders to revive and fill such posts by regular incumbents as quickly as possible by taking necessary steps at appropriate level.

Sub: ESTABLISHMENT—Tamil Nadu Electricity Board—Disciplinary Proceedings of Class I and Class II Officers—Recording in case card—Instructions issued.

At present no systematic review of progress of disciplinary case is being done. There is no easy procedure to ascertain quickly the present stage of disciplinary proceedings against a particular official, except referring to bulky files. To obviate these deficiencies it has been decided to introduce a case card for recording comprehensive information of Class-I and Class-II Officers involved in disciplinary cases. In pursuance of this decision, the following orders are issued:

- (i) Soon after disciplinary proceeding is initiated against a Class-I or Class-II Officer, a Case Card shall be opened to register the details.
- (ii) The case card shall be in the form in the Annexure to this Memorandum. Part A of the card relates to fixed information and Part B the monthly progress of the case in brief.
- (iii) These cards shall be arranged in alphabetical order and categorywar.

2. There shall be a systematic review of progress of disciplinary case every month. All the case cards of the officials should be submitted in one lump for each category for inspection by higher officers every month. If, on inspection, the reviewing officer notices inordinate delay such as failure to give explanations for more than two months, failure to conduct enquiries for a long period, delay in office in processing the explanations and enquiry reports, he shall give suitable direction to the official concerned to expedite the matter. If a case is disposed of, the nature of punishment and the original reference number imposing punishment should be recorded in the case card and it may be transferred to closed cases. For the present, the cerds need not be got printed. The format shall be prepared in roneo sheet.

A point has been raised for clarification as to whether an employee of the Board, who had already availed the House Building Advance from the Board may be permitted to purchase a plot and construct a house thereon in the name of his wife by availing loan from a Co-operative Housing Society. The very aim of the Co-operative Housing Society is "one house for one family", and a person can become a Member of the Society only when he/she or his/her spouse or their minor children do not have any house. Co-operative Housing Societies do not grant housing loan to such a person whose spouse had already availed a housing loan. It is therefore clarified that granting of permission to an employee to purchase a plot and construct a house thereon in the name of his/her spouse by availing loan from a Co-operative Housing Society, does not arise, if that employee has already availed house building Advance from the Board.

The community 'Kasikkara Chettiar' has been included in the list of Backward Classes as SI.No. 75 in the annexure to the above G.O. The Secretary, Ayira Vysya Kasukkara Chettiar Ilaignar Sangam, Madural and others have requested that the entry of their community name 'Kasikkara Chettiar' in the Government order may be changed as 'Kasukkara Chettiar'. The Director of Backward Classes has also reported that it is seen from the Second Backward Classes Commission records that the representations received from the various branches of the Ayira Vaisya Kasukkara Chettiar, the name of the community has been spelt as, 'Kasukkara Chettiar and therefore recommended that name of the community may be, amended as 'Kasukkara Chettiar' in the list of Backward Classes.

2. In G.O. Ms. No. 1962, Social Welfare Department, dt. 1—8—84, the Government issued orders amending the community in SI. No. 38 in the annexure to G.O. Ms. No. 72, Social Welfare Department, dt. 1—2—80 as follows:—

Kannada Saineegar, Kannadiyar (Throughout the State) and Dasapalanjika (Colmbatore, Periyar and the Nilgiris Districts.)

But while issuing the revised list of Backward Classes based on the report of Tamil Nadu Second Backward Classes Commission in G.O. Ms. No. 1564, Social Welfare Department, Dt. 30—7—85, the above community has been included as follows:—

71. Kannada Saineeger, Kannadier and Dasapalanjika (Coimbatore, Periyar and the Nilgiris Districts)

The Secretary, Temil Nadu Kannada Saineegar Samuga Sangam has represented that the existing entry would create an impression that the people belonging to this community in the districts of Coimbatore, Periyar and the Nilgiris Districts alone will be treated as Backward Classes and therefore requested to make the position clear and elso to avoid unnecessary hardship to their community people, the existing entry relating to their community 'Kannada Saineegar' against Sl. No. 71 in the annexure to G.O. Ms. No. 1564, Social Welfare Department, dt. 30—7—85 may be amended as ordered in G.O. Ms. No. 1962, Social Welfare Department, dt. 1—8—84. The Director of Backward Classes has also recommended the above amendment.

- 3. The community 'Kammalar or Viswakarma' has been included in the list of Backward Classes against SI. No. 68 in the annexure to G.O. Ms. No. 1564, Social Welfare Department, dt. 30—7—85 as noted below:
 - 68. Kammalar or Viswakarma, Viswa Kammala (including Thattar, Porkollar, Kannar, Karumar, Kollar, Thatcher, Kalthatcher, Kamsala and Viswabrahmin.)

The Director of Backward Classes has suggested that for the entry , Viswakammala' the entry 'viswakarmala' as in G.O. Ms. No. 437, Social Welfare Department, dt. 15—5—72 may be adopted in order to avoid difficulties of the community people in getting certificates etc.

Ref: B.P. Ms. (Ch.) No. 27 (Sectt. Branch) dated 19-1-1985.

In B.P. Ms. (Ch.) No. 27 (Secretariat Branch) dated 19—1—1985 consolidated instructions had been issued regarding punctuality in attendance, movement control etc. Annexure IV of this order contains a list of Duty Officers and Reserve Duty Officers.

- 2. In partial modification of the orders referred to in para 1 above, the following instructions are issued:
 - (i) The Duty Officers for the High Rise Building shall be in the rank of Superintending Engineers and Divisional Engineers working in the High Rise Building.
 - (ii) Instead of two permanent Duty Officers and one Reserve Duty Officer for each floor one Duty Officer may be posted for three floors.
 - (iii) The Chief Engineer/Civil Design shall have an alphapetical list of all officers of the rank of Superintending Engineers and Divisional Engineers in High Rise Building.
 - (iv) The posting of Duty Officers shall be from the alphabetical list starting from first floor.
 - (v) The Duty Officers shall be posted in rotation every week. The posting for every week shall commence from the next officer in the list to be posted. A copy of the posting order may be sent to Organisation and Methods Cell.
 - (vi) If an officer posted as Duty Officer is not available on a particular day, he must inform the Chief Engineer/Civil Design in advance so as to post the next officer in the list in his place.
 - (vii) The feasibility of having a notice board at the entrance of each floor to exhibit the names of Duty Officers, may be considered.
 - (viii) Apart from the weekly report (in Form No. DO-1-87) of the Duty Officer to Establishment Officer on employees, the Duty Officer shall submit a separate 'Office upkeep' report to the Chief Engineer/Civil Design with a copy to the Secretary, covering the following aspects and with suggestions:
 - (a) Whether the premises are maintained in a clean and tidy condition.
 - (b) Whether the rooms constructed are exclusively used for the purpose for which they were constructed/allotted.
 - c) Whether the almirahs and racks contain only the required papers neatly arranged, without the unnecessary records, papers etc.
 - (d) Any other matters which the Duty- Officers wishes to bring to the notice of Chief Engineer/Civil Design.
- 3. The follow up action on the Duty Officers' 'Office upkeep' report on item (viii) above shall be as below:
 - (i) The Secretary, after perusal of the 'Office upkeep' report, may send it to the Receptionist who will maintain a register and record the observations and suggestions of the Duty Officer.
 - (ii) The Chief Engineer/Civil Design shall take necessary action on the 'Office upkeep' report and send the action taken report to the Secretary. This action taken report will be returned with the orders of Secretary to the Receiptionist, who may record in the Register concerned, the action taken and whether the action is completed. If it is not completed within a resonable time further action may be taken on the orders of the Secretary. Such files may be submitted to Secretary through Executive Engineer/Building Division.
 - 4. The above orders will take effect from 1-8-1987.

Proceedinge:

At present, a clerical cadre consisting of the categories of Junior Assistant, Typist including Steno-Typist, Assistant and Accountant exists in the Board Office Accounts Branch, Offices of the Regional Chief Engineers/(Distribution), O&M Systems and Generation, Project and Construction Circles. The personnel in this cadre attend to works relating to finance, accounts including revenue, administration, establishment including claiming of pay and allowances and miscellaneous items of work.

- 2. The works relating to finance and accounts are areas of work distinct from administration and establishment. In view of the need to adopt improved accounting systems in the Board and on account of the expanding activities of the Board, the works relating to finance and accounts require specialisation and expertise. Further, the present clerical cadre personnel are required to pass the Account Test for Subordinate Officers, Part-I, Accountancy (Lower Grade) and Accountancy (Higher Grade) and it is considered that the qualification of Accountancy is not necessary to the personnel posted for works relating to administration and establishment.
- 3. Taking into account the factors mentioned in para 2 above, the Board has decided to form an Administration cadre out of the existing clerical cadre, treating the remaining clerical cadre as Accounts Cadre, and evolved proposals. The matter has been discussed with the Unions. The Unions representing an overwhelming majority of workmen have agreed to the Board's proposal for formation of an Administration Cadre. Accordingly, the Board passes the following orders:—
- (1) An Administration Cadre to deal with administration, establishment including claiming of pay and allowances and miscellaneous items of work i.e. items of work other than finance and accounts including revenue, in the offices of the Regional Chief Engineers (Distribution), Central Offices, Divisional Offices and Sub-Division Offices in O&M Systems and Generation, Project and Construction Circles be formed.
- (2) The Administration Cadre will consist of the following categories with the scales of pay indicated against each:—

(I) Junior Assistant

Rs. 620--20--720--25--845--30--995 (with admissible special pay for Typist and

(ii) Typist/Steno-typist

Steno-typist).

(iii) Assistant

Rs. 710-30-860-35-1035-40-1235.

(iv) Administrative Supervisor

(v) Assistant Administrative Officer

(vi) Administrative Officer

- (3) While initially forming the Administration cadre, the posts in the categories of Junior Assistant, Typist, Steno-Typist and Assistant shall be filled from volunteers in the corresponding categories in the present clerical cadre and the posts of Administrative Supervisor shall be filled from volunteers from Accountants in the present clerical Cadre by obtaining option. The employees in the present clerical cadre mentioned in para 1 above shall be allowed time upto 30—9—87 for exercising option to get themselves absorbed in the Administration Cadre. In the absence of option within the time limit, it will be deemed that the individual has opted for the Accounts Cadre. The option once exercised shall be finel.
- (4) The Typists and Steno-Typists in the Accounts Cadre and the Administration Cadre will be utilised for any typing and stenography work in the respective offices.
- (5) If the number of optees to the Administration Cadre is more than the requirements in that cadre, the optees, who are seniors will be given preference in absorption in the Administration Cadre. If the number of optees is less than the requirements in a category in the Administration Cadre, tha remaining posts will continue to be manned by personnel of the Accounts Cadre till the posts are filled.

- (6) The posts of Assistant Administrative Officers and Administrative Officers in the Administration Cadre will be filled, while initially forming the cadre, by permanent absorption of the Officers in the Categories of Personal Assistant and Personnel Officer.
- (7) The seniority of the various categories in the Administration Cadre will be on the same basis as in the present clerical Cadre. After the formation of the Administration Cadre, promotion to higher categories in the Accounts Cadre and Administration Cadre will be from the feeder category of that particular cadre only.
- (8) Instead of the requirement to pass three tests, the Junior Assistants/Typists/Steno-Typists in the Administration Cadre will be required to pass only one test viz. Account Test for subordinate Officer-Part I, which will be pre-requisite for promotion to the higher category of Assistant. An Establishment Test for the Junior Assistents/Typists/Steno-Typist of the Administration Cadre will be introduced in due course.

A large number of Junior Engineers II Grade have been posted to 110KV/66 KV Sub-stations as Operators. It is essential that these persons are exposed to the current practices on Operation and Maintenance of Sub-stations. Further, procedures for line clears, outlines of protective devices, Operating procedures of breakers and transformers, safety procedures and first-aid are also to be taught to these personnel. Hence, the Deputy Director/Transmission and Sub-station Training Institute/Madurai in his letter under reference cited has submitted a proposal for conducting short-term courses on operation and maintenance of Sub-station equipments for a duration of 2 weeks. He has suggested conducting of 4 such programmes in a year after completion of each training programme for Engineers being conducted presently and by temporarily cancelling the regular programme during that period. As such 4 programmes of two months for Engineers and 4 programmes of two weeks duration for Junior Engineers II Grade will be conducted in a year.

Proceedings:

The Terms and Conditions of Supply of Tamil Nadu Elecy. Board has been amended in B.P. Ms. (FB) No. 112, (Adm. Br.) dt. 31—12—85 with effect from 1—1—86 providing inter-alia as follows:

- (i) The power-factor for the month shall be the ratio of Kwh/KVAh recorded during the month as defined in the Terms and Conditions of Supply. The power-factor shall be calculated upto 2 decimal places. The power-factor of consumer's installation shall not be less than 0.85.
- (ii) Where the tested or recorded or computed power-factor of the installation is less than the stipulated limit of 0.85, a compensation charges at the rate of 1% of the total power supply bill for that month excluding duties and taxes, if any, for every 0.01 reduction in power-factor will be levied.
- 2. At the time of the amendment, it was expected that all the existing arithmetic type of meters would be replaced by geometric type of meters. The Board has placed an order for supply of 900 nos. of Geometric type of meters to meet the present and future demand. However, adequate number of geometric type of meters are yet to be supplied and consequently all the arithmetic type of meters could not be replaced by 1—1—1986 when the amendment came into force.

The implementation of the formula of KW/KVA continued to present practical difficulties in the absence of replacement of the existing services with arithmetic type of meters. Number of representations have been received from the consumers provided with arithmetic type of meters, contending that compensation charges connot be levied from them by applying the formula of KWh/KVAh especially when the arithmetic type of meters have not been replaced by Geometric type of meters.

- 3. In the circumstances, the Board directs-
 - that action should be taken to replace all the existing arithmetic type of meters by geometric type of meters without any further delay and the works should be completed immediately;
 - (ii) that for such of those H.T. consumers not provided with geometric type of meters, power factor should be determined on the basis of Kwh/KVAh OR KW/KVA, whichever is advantageous to the consumers, as was done prior to 31—12—85; and
 - (iii) the claim for low power-factor compensation should be made on the above bssis and refund/recovery if any should be made immediately.

In this office reference 1 cited, legal notices were asked to be issued to Cement producers for the interest on advance payment due from them for delayed supply.

The fact that the cement manufacturers are not settling the interest dues was also referred to the Development Commissioner for Cement Industry. A copy of the reply received from the Development Commissioner for Cement Industry was also communicated to all the Superintending Engineers in reference 2 cited.

The Superintending Engineers are requested to draw the attention of the Cement producers to the instructions issued by the Government of India in their circular dated 29—11—1986 for early settlement of dues.

Failure to pay the interest dues by the Cement producers may also be reperted to the Regional Development Commissioner for Cement Industry to deal with them suitably and the matter may be pursued till the interest is realised.

Sub: Payment of interest in case of delayed supplies.

Reference is invited to various communications regarding the subject matter, vide our circular letter dated 6th March 1984 it was reiterated that complaints were still continuing from

Government Departments, Public Sector Undertakings and Private parties that cement producers are not paying interest on the advances received by them inspite of repeated requests in this regard. The situation regarding payment of interest, has unfortunately, not improved. It is imperative that interest should be paid by the cement producers in ell cases, of their own, where supplies do not mature within 30 days of the receipt of advance, without the party having to put in formal claim for this purpose.

The matter of payment of interest had been agreed to in a meeting of the Apex Monitoring Committee of the C.M.A. and it was on the representation of the C.M.A. that the earlier instructions under which interest had to be paid if the supplies did not mature within 15 days were modified and C.M.A.'s request for increasing the period to 30 days was accepted by Government. It is a mater of great concern that cement producers are not complying with these instructions despite reiteration and understanding given in this regard that the aforesaid instructions will be complied with. It is once again emphasized that all cement factories should pay interest in all cases, as mentioned above and there should be no complaints about non-payment of interest. It may be pointed out that any default regarding non-payment of interest in the circumstances mentioned above would be looked into very seriously and concerned authorities would be constrained to take appropriate remedial action.

Recently there has been an incident when an Asst. Divisional Engineer/Shift of a major 230 KV Substation was not able to identify whether a 230 KV line breaker in his substation was in closed condition or tripped condition. This is very unsatisfactory and shows a complete lack of interest on the part of the substation personnel to study the station layout and equipment details in respect of the substation which they are supposed to operate.

All the Superintending Engineers are requested to see that operating instructions at all the substations are updated and the personnel in charge of the major sub-stations are properly trained and made to be conversant with the equipments they are expected to handle. Senior Officers inspecting the substation should test the alertness and competence of the sub-station operators and staff. Any slackness or disinterestadness on the part of sub-station staff in this regard may be taken note of very seriously and D. P. should be initiated against such staff.

The Regional Chief Engineer/Distribution/Coimbatore in the reference cited has requested to clarify whether the request for shifting of an existing Agricultural Service to a new location for sindustrial purposes in the same village and distribution be permitted.

The issue raised by Regional Chief Engineer/D/Coimbatore, has been examined and the following instructions are issued.

The Tariff is for the purpose for which the supply is being utilised. Hence, the request for the shifting of the service and also change of Tariff from Agriculture to industrial purpose may be remitted. The service connection charges at the new location for the Industrial Service should also be collected. However, the consumer should give an undertaking that he would not request for shifting of this service for reconversion from industrial to Agricultural service for any location whatsoever at a future date. Fresh agreement for the industrial Tariff should be obtained.

B. Vijayaraghavan, Chairman, Sub: Supply of Cement to Projects/Systems—Monitoring of despatches from Cement factories—Responsibility of local Superintending Engineers—Regarding.

The quarterly cement indents are furnished to the Director/Central Electricity Authority/New Deihi every quarter well in advance for allotment of cement to Tamil Nadu Electricity Board based on the field Indents. The Director/Central Electricity Authority/New Delhi is allotting the cement during the last week of March, June, September and December of every calendar year for the respective-quarters. On receipt of the allocation from Central Electricity Authority/New Delhi the reallotment consigneewise with destination details are intimated to Regional Development Commissioner for Cement Industry/Madras for arranging to issue authorisation to consignee Superintending Engineers. The Regional Development Commissioner for Cement Industry, Madras is issuing authorisation on cement factories directly to consignee Superintending Engineers for placing orders. The consignee Superintending Engineers are placing orders on receipt of authorisation along with advance payments within the due dates on the cement companies for despatch of the allotted quantities within the quarters.

Of late, It is seen that cement supplies are [leng being delayed by the cement companies and the authorisation issued for the quarter are being allowed to lapse. In certain cases, the cement companies even refuse to accept the cheques issued by Superintending Engineers towards the advance payment for cement supplies. This has created a situation of severe shortage in cement supplies to Tamil Nedu Electricity Board affecting the progress of the projects as well as O & M works in the systems. It has therefore become necessary that a close liaison should be established with the cement factories by the local Superintending Engineers in whose jurisdiction the cement companies are situated. The metter was also discussed during the Regional Chief Engineers' Review Meeting on 26—6—87 wherein the Chairman instructed that the Regional Chief Engineers should closely follow up the despatch of cement and the local Superintending Engineers made responsible for despatches of cement to the various projects and O&M systems.

To enable the system Superintending Engineers, follow up the despatches of the cement compenies, the quantum of allotment to the verious cement factories by the Regional Development Commissioner for Cement, Madras will be intimated by the consignee Superintending Engineers every quarter elong with details of the date of payment of advance, mode of transport requested, and programme of supply schedule etc. It will be the responsibility of the local Superintending Engineer to ect as a Liaison Officer and ensure that cement despatches are made regularly to the system Superintending Engineers without delay. If there is any difficulty experienced by them, they shall immediately report the fact to the concerned Regional Chief Engineer who will call for the representatives of the cement companies and discuss the matter. The Superintending Engineers who will act as Liaison Officer are as indicated below:—

It is noticed that in some cases contractors who are awarded works sub-let their works to sub-contractors without the prior approval of the Board. At the time of awarding a work on contract the vendor rating of the contractor is taken into consideration. But this becomes meaningless when the contractor later farms out the work to sub contractors whose financial status and vendor rating may not be to the satisfaction of the Board. It is therefore directed that hereafter in all the specifications a clause should be incorporated requiring the contractors to submit along with their tender offers, a panel of names of sub-contractors, if any, whom they propose to engage for execution of the work together with their financial status, experience etc. It should be made mandatory that only those approved by the Board from out of the panel are engaged for the execution of the work.

As per Regulations 9.5 and 10.5 of the Tender Regulations issued under B.P. Ms. (FB) No. 28 (Accounts Branch) dt. 8—11—85, where the Competent Authority to decide a tender is the Tender Committee or the Board, the Chief Engineer has to obtain the prior approval of the Tender Committee for floating the tender and for the specification to be issued.

- 2. In its 323rd meeting held on 20—4—87, the Tender Committee has recommended that in respect of consumable items which are essentially required for running of Thermal Stations, no approval of the Tender Committee need be obtained for floating of tenders and for the specifications and the tenders may be called straightaway by the Chief Engineer/General Superintendent and put up to the Competent Authority for approval after analysis of tenders.
- 3. The Board, after careful consideration of the recommendations of the Tender Committee, directs that the existing Regulations 9.5 and 10.5 of the Tender Regulations be amended as below:—

Regulations 9.5: "Prior approval of the authority competent to approve the tender should be obtained before floating of Tenders. However, in respect of consumable items essentially required for running of Thermal Stations, where the authority competent to approve the Tender is the Board or the Tender Committee, the approval of the Tender Committee for floating of the Tender need not be obtained and the Tender may be called for straightaway by the Chlef Engineer/General Superintendent and placed before the Competent authority for approval after analysis of tenders".

Regulations 10.5: "Where the Competent authority is the Board, the specification should be got approved by the Tender Committee and in all other cases the specification should be got approved by the competent authority. However, in respect of consumable items essentially required for running of Thermal Stations, where the authority competent to approve the Tender is the Board or the Tender Committee, the approval of the Tender Committee for the specification need not be obtained and the Tender may be called for straightaway by the Chief Engineer/General Superintendent and placed before the competent authority for approval after analysis of tenders".

Proceedings:

Operation and Maintenance Estimates are sanctioned by Chief Engineers subject only to Budget provision. For execution of such operation and maintenance works, contracts are awarded by Superintending Engineers and Executive/Divisional Engineers. In some cases, the work mainly involves providing of labour, and the labour component is 50% or more of the Tender value. However, there are no separate powers in the Tender Regulations prescribing the limits upto which various officers could approve contracts of this nature and the existing powers for works contracts are being utilised for such contracts.

2. The Tender Committee in its 320th meeting held on 24—3—87 has recommended the following proposals for delegating powers to the officers of the Board in respect of operation and maintenance contracts where the labour component is 50% or more of the Tender value.

All Systems/Circles (except Madras Electricity Systems and Thermal Stations):—

In exercise of the powers conferred by Section 3 of the Tamil Nadu Essential Articles Control and Requisitioning Act 1949 (Tamil Nadu Act XXIX of 1949), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Restriction on consumption of Electricity Order, 1976 as issued in G. O. Ms. No. 1111, Public Works, dt. 24—7—76.

The amendments shall come into force from 1-7-87.

Amendments

In the said order,

- 1. In clause 7, the sub-clause (v) and (vi) shall read as:--
- "(V) On specific requests from H.T. consumers, additional energy quota in a particular month will be sanctioned by the Tamil Nadu Electricity Board subject to corresponding reduction in the quota for the subsequent month or months upto 30—6—88. Prior sanction should be obtained from the **Board** before the quota already fixed is exceeded for such additional quotas."
- "(VI) H. T. consumers will also be permitted to surrender in advance their energy quota not required by them in a particular month and utilise the energy quota so surrendered in the subsequent month or months before the end of 30—6—88 provided that intimations of such surrenders are filed before the Chairman, Tamil Nadu Elecy. Board before the 15th of the month to which the quota relates."
- 2. The Government also ratify the action of the Chairman, Tamil Nadu Elecy. Board in having permitted the H. T. consumers, who have applied, either for advancement or postponment of quota beyond 30—6—87, in anticipation of approval of the Government.

Order:

According to the orders issued in the G.O. first read above, the Director, Motor Vehicles-Maintenance Department will fix the rates for retreading annually or at shorter intervals depending upon the market conditions and communicate the same to Transport, Engineering Corporations and Heads of Departments and others. The Managing Directors of the Transport/Engineering Corporations should adopt the rates as fixed by the Director, MOTOR Vehicles Maintenance Department.

2. The Director, Motor Vehicles Maintenance Department has now stated that when the Tenders were called for, for fixing the rate for tyre retreading for the year 1985—86 M/s. T.V.S. have quoted the higher rate than the rate approved last year for A.R.C., A.B.T. But now they have quoted lesser rate than the rate approved by this Department for 1985—86. This may perhaps be workable for Tvl. Sundaram Industries who have got their own rubber processing plant but certainly not workable for others who purchase tread rubber the cost of which was gone up. Therefore, the Director has stated to the rate at present quoted by T.V.S. cannot be taken as a reasonable cost for this year. Taking the rate approved last year, as the base the increase in cost of materials of Rs. 3/- per Kg. can be allowed to the Transport Corporations. He has further stated that Tvl. M.R.F. Limited, Madras who were addressed to get the details of the increased cost of tread rubber have stated that a sum of Rs. 3/- (Three only) per Kg. is the increase between 1985—86 and 1986—87. The Director Motor Vehicles Maintenance Department has therefore proposed that the rates shown in para 3 below which is inclusive of this cost increase of Rs. 3/- can be allowed for the Transport Corporations to undertake retreading/recapping work for year 1986—87. He has therefore requested the Government to approve the rates for treading and recapping of tyres as suggested by him for the year 1986—87 applicable to all the Transport Corporations. As the rates proposed by the Director, Motor Vehicles Maintenance Department were not agreeable to the Transport Corporation, a discussion was held by Deputy Secretary (transport) with the Managing Director of Thiruvalluvar Transport Corporation and Managing Director, Pallavan Transport Corporation and the Director, Motor Vehicles Maintenance Department have agreed to fix the rates as proposed by the Motor Vehicles Maintenance Department.

3. The Government therefore accept the proposal of the Director, Motor Vehicles Maintenance Department and approve the following rates for retreading and recapping of tyres for the year 1986-87.

Sub: Maintenance of equipments in the distributions and sub-stations and lines.

- 1. Periodic reviews of failure of sub-station equipments, distribution transformers and break-downs to EHT lines have indicated that substantial number of failures/breakdowns could be avoided by improving the maintenance. Copies of these reviews were being sent to all field Officers for implementing the suggestions, but, I find that the reviews remain academic exercises and the suggestions are neither implemented nor the implementation is monitored. The Audit, while reviewing the maintenance registers in some of the Systems, have pointed out that the maintenance registers for distribution transformers etc. are not properly maintained. This does not augur well. This is causing concern. I am sure you appreciate that Board will be put to considerable loss if the maintenance works are not carried out as per periodicity and the consumers will be put to considerable inconvenience.
- 2. The periodicity for maintenance, the type of maintenance works that are to be carried out, the monitoring system and the responsibility for carrying out maintenance works are well defined and several instructions requesting the field staff to adhere to these maintenance procedures have been issued in the past. The code of technical instructions clearly specifies the maintenance procedures and periodicity for the various equipments used in the Board. The instructions issued in letter No. 268/IEC/78—9 dated 26—3—1979 and IEC/9/80—34 dated 21—2—81 deal with the maintenance works to be carried on distribution transformers and the formats for maintenance registers for distribution transformers and equipments in substations. The remedial measures to prevent breakdowns due to pollution are dealt with in detail in Memo. No. SE/SSCD/ADE I/FTPP/Pollution/D 104/83 dated 26—4—83.
- 3. While enough instructions have been issued on the maintenance practices and monitoring systems, the successful implementations of those instructions solely depend on the dedication with which the maintenance staff do the maintenance works and keep records of the same. The sole responsibility to ensure this rest on the inspecting officers from ADE to CE. The inspecting officers should make it a point when they go on inspection of substations/sections/distributions to call for the maintenance registers and verify whether the maintenance works have been carried out according to the periodicity and whether the maintenance registers are written up properly, or not. It is not possible to monitor this aspect effectively from the Headquarters nor it is necessary. I, therefore, request you to carry out effective inspections and impress on the SEs/DEs/ADEs to carry out similar inspections and ensure that the maintenance works are carried out as per periodicity and the various registers in support of having carried out the maintenance works are maintained without default.
- 4. I request you to send a report on the action taken by you. If you have any suggestion to improve maintenance works, please feel free to write to me on the same or discuss this at the next RCE meeting.

CIRCULAR MEMO. No. SE/TR/EW/A3/F.LA/D./193/87, (Technical Branch) dt. 13-7-1987.

Sub: Establishment of sub-stations—Acquisition of land belonging to Hindu Temples— Procedure to be followed—Regarding.

It becomes necessary to acquire lands belonging to Hindu Temples for establishment of substations by Tamil Nadu Electricity Board in some cases where no other suitable private patta land or Government Poramboke lands are available. In this connection a copy of G.O. Ms. No. 1639/Revenue dated 26—9—1984 is enclosed for reference and guidance.

- (2) In such cases where the temple lands are to be acquired the following procedure may be followed.
- (i) The Executive Officer or the Managing Trustee/Trustees of the Temple concerned may be contacted initially and possibility of sparing the temple land to Tamil Nadu Electricity Board for establishment of substation on payment of land cost may be ascertained first.

- (ii) Acquisition of lands belonging to Hindu Temples may be done either by direct purchase by Tamil Nadu Electricity Board under Section 34 of Hindu Religious and Endowments Act 1959 (Tamil Nadu Act 22 of 1959) or by acquisition through the Revenue Dept., Covernment of Tamil Nadu under the Land Acquisition Act 1894 as is done in the case of acquisition of patta lands belonging to private parties.
- (iii) In the case of direct purchase, the HR&CE has to ascertain the land cost from the District Revenue Officer and Registration Office concerned and the land can be taken possession only after Notification in dailies by HR&CE, hearing and disposal of objections, if any, and after the payment of the land cost, resulting in delay on taking possession of the land. The Tamil Nadu Electricity Board has also to incur extra expenditure by way of Registration Fees and stamp Duty. Hence, acquisition through Revenue Department under the Land Acquisition Act may be followed.
- (iv) After ascertaining the possibility of sparing the temple land from the Executive Officer, Managing Trustee/Trustees of the Temple concerned as meintioned in para 2 (i) above, a proposal should be sent by the system Superintending Engineer to the Revenue Department, (RDO/DRO of the area) to acquire the temple lands under the Land Acquisition Act, 1994 giving the details viz. name of the substation for which the temple land is required and its necessity, the SF. No. Vitlage, Extent of land, Temple to which the lands belong to, clear topo plan of the land to be acquired etc. A copy of the proposal may be sent to Commissioner, HR&CE and also to Superintending Engineer/Transmission.
- (v) After sending the land acquisition proposal to Revenue Department, the Revenue Authorities may be requested to address the Commissioner, HR&CE Department/Madras to issue 'No objection Certificate' to acquire the temple lands under Land Acquisition Act.
- (vi) On receipt of the request from Revenue Department, the HR&CE Department will call for the remarks of the Executive Officer/Managing Trustee of the temple and issue the consent/No objection for the acquisition of temple lands under Land Acquisition Act to the Revenue Department (RDO/DRO of the area).
- (vii) After obtaining the consent/No objection to acquire the temple lands from the Commissioner HRSCE Department, the Revenue Department, will formulate the draft 4(1) proposal and submit to Government for approval and publication in the Govt. Gazettee and in News Papers.
- (viii) The HR&CE normally gives permission to enter upon the land pending finalisation of the land acquisition proceedings by the Revenue Department only after approval and publication of draft 4(1) Notification by Government. However, in specific cases of urgency, the HR&CE may consider to permit the Board to enter upon the land after issue of 'No objection certificate' to acquire temple lands and before approval and publication of the 4(1) Notification by Government. Hence, after issue of the 'No objection certificate' the Regional Chief Engineer may request the Commissioner, HR&CE/Madras stating the urgency and to permit the Tamil Nadu Electricity Board to enter upon the land pending finalisation of the Land Acquisition proceedings by the Revenue Department. A copy of the letter to HR&CE may be sent to the Chief Engineer/Transmission and Grid Operation and Superintending Engineer/Transmission/Madras-2 for follow up the matter at the Head Quarters level.

All efforts may be taken for expeditious completion of the acquisition of temple lands required for the establishment of sub-stations.

As per para 3 of Annexure VIII-Part II of the B. P. first cited, each Agricultural service with a flat levy will be computed as one sixth of a service, but each Agricultural service coming under 1+1 formula of payment will be computed as one service.

In the memo, second cited, Superintending Engineers/Operation and Maintenance were delegated with powers to permit instalment payment of the Belated Payment Surcharge in not more than 12 monthly instalments to Agricultural Consumers who cleared the arrears by paying under 1+1 formula.

2. It is represented that since the Belated Payment Surcharge is also allowed to be paid in monthly instalments, those services paying the instalments should be continued to be computed as one service till the Belated Payment Surcharge Payments are over. The Superintending Engineers/Operation and Maintenance are requested to compute each Agricultural Service for which Belated Payment Surcharge payments are made as one service till the monthly instalment payments are over.

Sub: Electricity—R & C—computed quota Review on Violation of conditions

for three shift operation of the industry-Reg.

Ref: Memo. No. IEMC/DE2/F. R & C/D. 458/85, dt. 28-9-85,

In the memo, cited above, detailed instructions were already given with reference to the computed quota and its applicability. From the analysis of the representations from the consumers received over the period eversince the issue of the above instructions it is found necessary that the instructions so issued shall be more specific to obviate ambiguities and to facilitate correct implementation. Hence in continuation the following instructions are issued.

- 1. If the three shift industries getting computed quota are found on inspection, working less than three shifts without prior permission, normal quota shall be reverted to for the first time. On representation by the consumer with valid reasons, the same shall be considered and the computed quota restored.
- If it is repeated the second time, the quota shall be fixed with reference to the baseconsumption for a period of two months and later restored. In case, it is repeated for the third time, the computed quota shall be got restored after a period of three months and so on.
- 3. If shifts are reduced with permission, the computed quota applicable shall be revised to the appropriate level. Generally, advance information shall not be possible unless they are pre-planned. Hence, this need not be insisted upon. Any adjustment of the quota on this score due to small inevitable delay in communication arising during the month, it shall be done in subsequent month's quota.
- For complete closure of work for various reasons, prior permission shall not be insisted upon and no revision of quota shall also be necessary.
- 5. If the industry comes under the category of continuous process listed in the R & C orders, it shall be straightaway taken as three shift industry.
- 6. For other cases, classification of three shift industry shall be done first by the statement of the industry and subsequently got verified by surprise inspection. If found otherwise, and contested, it shall be decided on special inspection on merits. The decision of the Chairman shall be considered as final.
 - 7. This procedure shall be followed from the date of issue of this orders.

All System Superintending Engineers are requested to follow the above instructions and to send their report, whenever such industries who have been permitted computed quota resort to working less than three shifts per day to Superintending Engineer/Industrial Energy Management Cell so as to enable him to arrange for revision of quota to the appropriate level immediately.

In this office Circular Memo. No. 317/Adm. Br./PA (T) S2/84—1, dated 31—5—84, instructions were issued to accept new meters from the prospective consumers requiring service connections, subject to refund of the cost of the meter, as prescribed therefor.

- 2. A point has now been raised whether the consumer who supplied meter to Board may be given supply under priority, over-looking the other consumers who were already in the line but refuse to supply meter at their cost.
- 3. The consumers who are not inclined to buy the meter subject to reimbursement of the cost thereof as per Board's rules may not be many. However, if all the other works are completed as per priority and the service connection is kept pending only for want of meter, a Notice in writing about the facility of purchasing and supplying meters to the Board, subject to the reimbursement of the cost thereof as per Board's rules may be issued to the consumer. The consumer may also be informed of the non-availability of meter and consequential delay. Thereafter the supply may be given to the party who has supplied the meter.

production of enjoyer certificate—Orders—Issued.

In Chief Engineer/Materials Management's D.O. Letter cited, it was requested that field officers might be requested to issue notices to the consumers (who had declared unauthorised additional loads in their Agricultural services under the two Voluntary Disclosure Schemes) to produce necessary documents before 15—4—87 and cancel the applications of those consumers who did not produce the required documents, records etc. before 15—4—87.

A number of representations have been received from the consumers expressing their inability to obtain and produce the enjoyer certificates before the due date viz. 15—4—87.

In viaw of the above the following orders are issued:

- (i) The due date for producing the enjoyer certificate shall be extended upto 14—8—87.
- (ii) Notices should be issued, for all the cases which were cancelled for not producing the enjoyer certificate, (before 15-4-87 as per notices issued to tham earlier) to produce the same before 14-8-87 by Registered Post with Acknowledgement Due. It should be clearly indicated that their applications will be cancelled without any further notice if the enjoyer certificates are not produced by them before 14-8-87 and further representations whatsoever in the matter will not be entertained.

Regularisation of all such cases should be completed by the field officers before 15—9—87 and the fact shall be reported by the Regional Chief Engineera/Distribution dami-officially to Member/Distribution.

B, Vijayaraghavan, Chairman. Sub: - Elecy. - Payment of Security Deposit - Lease holders in 'SIPCOT' Complex.

As per the Terms and Conditions of Supply, the initial Security Deposit payable by a consumer who is not the owner of the premises and who is unable to produce the consent of the owner, is double the normal rate of Security Deposit subject to a minimum of Rs. 150/– per service for domestic services, Rs. 300/– per service for other L. T. services except Power-loads, and Rs. 300/– per H. P. for Power-loads.

In normal circumstances, the higher deposit must be collected in the cases of Lease-holders in SIPCOT complex:

- 2. It is represented by 'SIPCOT' that plots are allotted on 99 years lease and the allottee pays the full premium of the cost of the plot except a token balance of Rs. 100/- to be paid at the rate of Rs. 1/- per annum as lease rent for 99 years and that the allottees in such cases are virtually owners of the plots for all practical purposes.
- 3. In view of what is stated in para 2 above these consumers should be treated as owners and the enhanced security deposit from these consumers should not be insisted upon, provided the consumer produces a letter from 'SIPCOT' stating that the consumer is an allottee of the plot on 99 years lease and has paid the full premium of the cost of the plot except a token balance of Rs. 100/- to be paid at the rate of Rs. 1/- per annum as lease for 99 years.
 - 4. The receipt of this circular should be acknowledged to the P.O./Tariff.

As per last pare in page 4 of the annexure to B. P. second cited, the list of firms/contractors registered by a Registration Officer should be circulated to all the Superintending Engineers of systems/circles of the Board. But it is seen that most of the Superintending Engineers are not following the instructions. Hence all the registration officers of project, generation, system end head quarters are instructed to circulate the list of registered suppliers/contractors to all other Superintending Engineers, Chief Engineers and Regional Chief Engineers. Also, when new registration of firm is made, the same also may be communicated then and there to all officers. This will help the Superintending Engineers, Chief Engineers and Regional Chief Engineers to get better offer among bidders.

It was enough if a supplier/contractor is registered at any one office in Board and he will be eligible to participate in tenders invited by all other officers of the Board.
