VI. COLLECTION OF SECURITY DEPOSIT FROM AGRICULTURAL CONSUMERS:

In Memo. No. SE/IEMC/EE3/AEE2/D 135/92 dt. 5—8—92, it has been clarified that no security deposit need be collected from agricultural consumers (except coming under SFS) in view of the free supply to them.

VII. INDUSTRIES EXEMPTED FROM POWER CUT IN ADDITIONAL TALUKS DECLARED AS INDUSTRIALLY BACKWARD:

- In Memo. No. IEMC/EE2/A1/F.P.C. GI—Backward Taluk/D. 1174/92 dt. 5—8—92, the Board has ordered that in continuation of the instructions already issued in the references cited for extending the concession of exemption from power cut to industries located in the industrially backward taluks of Avinashi, Srivilliputhur, Rasipuram, Pudukottai, Sattankulam and Palayamkottai as below:—
- (1) New H.T. industries, including existing industries converted from Low tension to High tension supply set up in the above 6 taluks prior to the date of declaration of these taluks as backward (viz.) 6—4—92 shall be exempted from power cut for a total period of five years from the date of availing H.T. supply or from the date on which the taluks were declared as beckward area whichever is earlier. The period of exemption shall be restricted to five years.
- (2) New H.T. industries and industries converted from Low Tension to High Tension supply set up in the above six taluks after declaration of these taluks as industrially backward areas shall be exempted from power cut for a period of five years from the date of availing H.T. supply or from the date of declaration of the taluks as industrially backward whichever is later.

VIII. RECEIPT OF L.T. DOMESTIC AND COMMERCIAL SERVICE CONNECTIONS/REVISED INSTRUCTIONS:

In Memo. No. SE/IEMC/EE3/AEE2/139/92 dt. 11—8—92, the Board has issued revised instructions in regard to the receipt of applications for L.T. domestic and commercial services with effect from 1—9—92.

 - (d) a subject of Bhutan; or
 - (e) a Tibetan refugee who came over to India before the 1st January 1962 with the intention of permanently settling in India;
 - (f) a person of Indian origin who has migrated from Pakistan, Burma, Srilanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Thanganayika of Zanzibar) Zambia, Malavi, Zaire and Ethiopia with the intention of permanently by settling in India.

1NCENTIVE—Units 4 and 5 of Stage III, Tuticorin Thermal Power Project—Commissioned—Payment of incentive to Staff of Tuticorin Thermal Power Station—Orders—Issued.

PROCEEDINGS:

Units 4 and 5, Stage III of the Tuticorin Thermal Power Project was commissioned and inagurated on 30—4—1992. It has been decided to sanction an incentive of one month pay plus dearness allowance to the staff of the Tuticorin Thermal Power Project and Tuticorin Thermal Power Station in recognition of their good work.

- 2. The Tamil Nadu Electricity Board directs that an incentive of one month pay plus dearness allowance relating to the month of commissioning of Units 4 and 5 of Stage III of the Tuticorin Thermal Power Project viz. April 1992 be granted to the employees borne on the rolls of the Tuticorin Thermal Power Project, Tuticorin Thermal Power Station and also Government servants working in these Circles on deputation who are stationed at the project site for one year or more during the period from 1-5-1987 to 30-4-1992, provided they were on duty at the rate of not less than 300 days (including holidays and casual leave but excluding other types of leave) in a period of 12 Calender months while working in the Project and/or Power Station during the above period. For example, if an employee was borne on the rolls of the Project/Power Station and was stationed at the Project site for 20 months, he should have been on duty for not less than $300 \times 20/12 = 500$ days (only completed months in the Project/Power Station should be taken into account). The employees of the Board borne on the rolls of the Tuticorin Thermal Power Project and/or Tuticorin Thermal Power Station and stationed at the Project site for a period less than 12 calendar months but who had been on duty for not less than 300 days (including holidays and casual leave but excluding other types of leave) shall also be granted the incentive.
- 3. The Board also directs that 'PAY' for the purpose of the incentive shall include all special pays. In the case of the employees who are eligible for the incentive but left the Project/Power Station prior to April 1992, incentive shall be on the basis of the admissible pay plus dearness allowance for the month in which they left the Project/Power Station.

Sub: Tamil Nadu Electricity Board—Maintenance of Provident Fund Accounts in Head Quarters Units—Transfer of Ledger Cards—Further instructions—Issued.

Ref: (Permanent) B.P. (Ch.) No. 127 (Technical Branch) Dt. 24-7-92.

In the above Board Proceedings orders have been issued for the transfer of ledger cards from the Board Office Audit Branch to the Heads of Offices, Madras for the maintenance of General Provident Fund Account in respect of the subscribers working in each office.

2. Detailed instructions with regard to the maintenance of General Provident Fund Account of the subscribers have been issued by the Board from time to time with reference to General Provident Fund regulations. However, as ordered in the Board Proceedings cited, the following instructions are issued for strict adherence.

WORKING INSTRUCTIONS:

- (1) The Board Office Audit Branch will hand over all the Ledger Cards to the respective Head Quarters Offices.
- (2) All the first date pay bills and supplementary pay bills affecting General Provident Fund deductions be drawn only by the Computer Centre.
- (3) Credit Schedules for the remittances made at Cash Section of Audit Branch towards General Provident Fund will be sent to Computer Centre through the Drawing officers concerned.
- (4) With regard to posting of Debits and credits for the period from 4/92 to 7/92 the Audit Branch has to allocate the same and send it to the Computer Centre through Drawing Officers (vide para 2 (1) of Board Proceedings) for postings.
- (5) As regards withdrawals, the Computer Centre will have to obtain the debit particulars from the Head Quarters Officers concerned.
- (6) The Drawing Officers have to send the bills drawn based on the Temporary Advance sanction and Part Final Withdrawal sanction to the Audit Branch (Pre-Audit Section) for issue of cheque after passing the same as is being done in other payments. The Fund Account maintaining Authority in Head Quarters Offices has to enter the sanction and also drawal of Temporary Advance and Part Final Withdrawal in the Ledger Cards without omission before presenting the bill for the payment.
- (7) The Computer Centre will have to prepare officewise monthly Broad Sheet with reference to the postings made as per the debit particulars obtained and as per the recoveries made in the Pay Bills, Supplemental Bill and remittances made at Cash Counter of Audit Branch. The Broad Sheet may be furnished every month to the Drawing Officers concerned for reconciliation with a copy to Audit Branch for information. The Drawing Officers will have to verify the monthly Broad Sheet with reference to pay bills recoveries and payments made towards Part Final Withdrawal and Temporary Advance.

- (8) After completing the postings of credits and debits by the Computer Centre for 12 months in a year (the recoveries made from April pay paid in April to March pay paid in April) the Computer Centre has to send the Yearly Broad Sheet to the Fund Account maintaining authority of each Head Quarters Offices. After verification, the Fund Account maintaining authority has to confirm the figures in the Broad Sheet so as to issue the Account Slip by the Computer Centre. On receipt of the Account Slips from Computer Centre the same may be attested by the concerned Drawing Officers of Head Quarters Units and issued to the subscribers. A copy of the Yearly Balance Sheet may also be furnished to Audit Branch.
- (9) The Fund Account maintaining authorities of the Head Quarters Offices have to send the Ledger Cards of the employees if transfered to other circle along with the Last Pay Certificate duly posting the General Provident Fund credits and debits in the Ledger Cards upto the date of relief of the subscriber as per Accounting Manual with intimation to Computer Centre. Similarly the Fund Account maintaining authorities of the circles will also have to send the Ledger Cards direct to the Head Quarters Offices along with Last Pay Certificate (instead of sending the same to the Board Office Audit Branch) with intimation to Computer Centre. The fund Account maintaining authority while transferring the Ledger Cards should indicate the opening balance, credits posted upto the date of transfer, withdrawals if any made upto the date of transfer, as closing balance in the column provided in the Ledger Card.
- 3. The allotment of General Provident Fund Account No. will continue to be attended to by the Audit Branch. The Fund Account maintaining authorities will send the application and nomination to the Board Office Audit Branch for admission and allotment of Account Numbers.
- 4. With regard to Final settlement cases, the cases received upto 31—7—1992 will be finalised by the Board Office Audit Branch. In respect of cases received from 1—8—'92 the Final Withdrawal Applications may be processed and sent with the Ledger Cards to the Board Office Audit Branch for verification and issue of authorisation.

PROCEEDINGS:

The Government of Tamil Nadu in the orders cited have amended Rule 15-B of Tamil Nadu General Provident Fund Rules and enhanced the House Building Advance from 1,25,000/ to Rs. 2,50,000-by allowing any assistance in this regard from any other Government Source, the sum so withdrawn under the Sub-Regulation shall not exceed Rs. 2,50,000/- or 75 times of monthly pay whichever is less.

AMENDMENT

In exercise of the powers conferred under Clause (a) of Regulation 3 of the Tamil Nadu Electricity Board General Provident Fund Regulations, the Board directs that the following amendment shall be made in the said Regulations:

"In the proviso under Regulation 18-B(1) for the figure Rs. 1,25,000/- in both the places where it occurs the figure Rs. 2,50,000/- shall be substituted".

2. The amendment ordered above shall come into force with immediate effect.

- 2. A point has been raised by the Chief Internal Audit Officer as to
 - (i) Whether first month recovery towards 1% House Building Advance Special Family Benefit Fund has to be effected on the date of disbursement say on 26—10—87, if the first instalment of House Building Advance is paid on 26—10—87 and if so, whether such recovery should be effected by means of deduction from the amount payable towards House Building Advance or by cash remittance by the employee on 26—10—87 itself.
 - (ii) Whether the second month recovery is to be made in October 1987 pay payable in November 1987 or November '87 pay payable in December '87.
- 3. It is hereby clarified that if the first instalment of House Building Advance is paid on the last week of the month say on 26—10-87 to the individual and if the 1% Special Family Benefit Fund recovery could not be included in October pay payable in November pay, the individual shall be directed to remit 1% House Building Advance Special Family Benefit Fund in cash immediately. After receipt of the 1% of the amount, the Sanctioning Authority shall disburse the first instalment of the House Building Advance to the individual. In such cases 1% Special Family Benefit Fund normal recovery shall be continued in November pay payable in December.
- 4. The Sanctioning Authorities shall be requested to adhere to the instructions issued in para 3 above scrupulously.
 - 5. Receipt of the Circular Memo. shall be acknowledged.

FAMILY PENSION—Grant of Family Pension in the order of birth to the Children of the deceased Board Employees/Pensioners—Orders issued by the Government—Adoption to Board—Orders issued.

PROCEEDINGS:

According to Rule 49 (8) (iii) of Tamil Nadu Pension Rules 1978, if sons and unmarried daughters are alive, unmarried daughters shall not be eligible for family pension unless sons become ineligible for the grant of family pension.

- 2. The Government of Tamil Nadu have now issued orders for the payment of Family Pension in the order of birth to the children of the deceased employees/pensioners irrespective of the sex of the children.
- 3. The Tamil Nadu Electricity Board has carefully examined the question of adopting the above orders of Government of Tamil Nadu in respect of Board employees/pensioners and has decided to adopt it in respect of Board employees/pensioners with effect from the date of issue of orders. The Tamil Nadu Electricity Board accordingly directs that the eligible male/female children (including the male/female children suffering from disorder or disability of mind etc. referred to in the proviso to sub-rule (6) of rule 49 of Tamil Nadu Pension Rules 1978) of the deceased Board employees/pensioners now be entitled to family pension in the order of their birth inrespective of the sex of the child and the younger of them will not be eligible for family pension unless the elder above him or her becomes ineligible for the grant of family pension. In cases, where the family pension is payable to twin children, the same will be payable to such twin children in equal shares. In the event of any of such children ceasing to be eligible for family pension, his/her share of family pension will not lapse but will become payable to the other such child and when both such children become ineligible for family pension, the family pension will become payable to the next eligible single child or twin children as the case may be.
 - 4. This order will take effect from the date of issue of this order.

Sub: Tamil Nadu Electricity (Taxation on Consumption) Act 1962—Amendment to Section 3 of Act—Additional levy of 4% tax introduced—Collection and remittance—Modified instructions issued.

In the references cited instructions were issued that the Electricity Tax introduced from 1—9—1991 to be remitted to Chief Electrical Inspector to Government after getting Funds from this office.

Of late it is observed that the remittances are not uniformly made by the Distribution Circles. To avoid unnecessary Transfer of funds to Circles from Headquarters, it has been decided that the remittance of Electricity Tax will be done at the Headquarters office, after getting the particulars from the Distribution Circles. Accordingly the following instructions are issued:

The Superintending Engineers of Distribution Circles will pass the hand receipt for the Tax amount to be remitted and forward the same along with Letter of Authority in duplicate as is done in the case of suppliers bills to Chief Financial Controller/Revenue by name cover. The passed hand receipts with Letter of Authorities should reach Chief Financial Controller/Revenue on or before 20th of each month along with the monthly returns which are in vogue. Any delay in submission of the passed hand receipts along with Letter of Authority and monthly return in time will entail delay in remittance and attract penal levy of interest and the responsibility for the delay will rest on the Superintending Eugineers of the concerned Distribution Circles.

The Chief Financial Controller/Revenue will consolidate and send all the hand receipts along with Letter of Authority to the Financial Controller/General on or before 25th of each month for drawal of the cheque for the consolidated amount in favour of Chief Electrical Inspector to Government. The Deputy Financial Controller/Central Payment after release of the cheque will pass on the duplicate copy of the Letter of Authority to the concerned Superintending Engineer duly incorporating the cheque No. Amount, etc. as is done in the case of suppliers bills. After the remittance of the tax amount the fact will be intimated to the Chief Electrical Inspector to Government with copy to all the Superintending Engineers of Distribution Circles.

The hand receipts for the assessment of Electricity Tax made in July '92 and amount to be remitted before September 30th should reach the Headquarters before 20—9—1992 and similarly be adopted for the future months also. If any of the Distribution Circles which has already remitted the Electricity Tax to be remitted before September should intimate the fact to this office and no passed Hand Receipt send for the same amount already remitted.

ORDER:

As per Clause (a) of Sub-Section(1) of Section—3 of the Tamil Nadu Electricity (Taxation on Consumption) Act, 1962 (Tamil Nadu Act 4 of 1962), there shall be levied and paid to the Government every month an additional tax on consumption of energy.

- 2. The Government of Tamil Nadu have announced a new industrial policy in the national context of an economy being in a state of transition. In order to promote rapid industrial development, the Government among others, have announced full exemption from payment of additional tax on the consumption of energy for a period of three years for all the new units.
- 3. The following Notification will be published in an extra-ordinary issue of the Tamil Nadu Government Gazette, dated the 30-7-1992.
- 4. This order issues with the concurrence of Finance Department, Vide its U.O. No. 79515/P.W.D./92, dated 23-7-1992.

NOTIFICATION

In view of the shortage of Single Phase and Three Phase meters and to clear the large number of pending domestic applications, the Superintending Engineers of Distribution Circles are requested to accept new Single Phase meters upto 31—3—93, and 3 Phase meters upto 31—10—92 from prospective consumers.

- In both the above cases, acceptance of consumer's meters should be stopped immediately, on receipt of the meters against the orders from the Headquarters.
- 3. They are informed that the refund against the cost of the consumer's meter may be made at Rs. 170/- for Single Phase meter and Rs. 380/- for Three Phase meter as indicated in this office. Circular Memo. No. 1154/IEMC/PO(T)/Tariff-I(2)/89—8, dated 16—4—90 by following the procedure in vogue.
- 4. The procedure outlined in Memo. No. 317/SE/IEMC/PO(T)/Tariff-I(2)/84—5, dated 11—10—89 may be followed for acceptance of the consumer's meters, testing them, overlooking the priority in giving service connection, accounting and in refund of the cost of the meters.

In the meeting of the Consultative Committee of Parliament attached to the Ministry of Power and NES held on 12—2—92, the Member of Parliament had shown serious concern about frequent theft of conductors and other materials resulting in prolonged interruptions in power supply due to delay in replacement of stolen components. They have requested to take appropriate action to minimise the theft of conductors etc and ensure expeditions replacements.

In this connection, attention is invited to the memo, cited, wherein instructions have been issued for prevention of theft of wires.

The Chief Engineers (Distribution) of all regions and Superintending Engineers of all Distribution Circles are requested to adhere to the above instructions strictly.

The Chief Engineer of Distribution Regions are requested to review the cases of theft of materials once in a quarter and identify the areas frequently prone to theft and take necessary steps.

They are also requested to ensure that the replacement of stolen conductors are done without any delay so as to minimise interruptions. The Member of Parliaments of the Parliamentary Constituences in their region may be apprised of the position in this regard.

Orders issued.

It has been brought to the notice that in some Distribution Circles, the security deposit is being collected from agricultural applicants and in some Circles the security deposit is not collected. Thus no uniform procedure is adopted.

As per clause 14.03 of Terms and Conditions of Supply of Electricity, applicants for supply of electricity for agricultural service connections, other than those eligible for free supply shall pay security deposit equivalent to six months' levy of lumpsum charges notified by the Government from time to time.

As supply of electricity to all agricultural consumers (except coming under SFS) is free of charge at present, security deposit need not be collected from agricultural applicants.

As per the instructions issued in the Circular memo. 2nd cited, the Section Officers (Assistant Engineer/Junior Engineer) are receiving and registering L.T. domestic and commercial service connection applications from 1—10—88 onwards.

Further the Circular memo. 3rd cited, instructions were issued to check and review the receipt and processing of applications in the Sections by the Assistant Executive Engineers inview of frequent complaints on the delay in the registration of applications and their piling up without any entry in the register in Section Office.

With a view to ensure that all the applications given by the applicants for power supply to L.T. domestic and commercial services are brought to account immediately, it has been decided that in the first instance, the applications for the above category shall be received by the Assistant Executive Engineer/O&M and acknowledgement given to the applicants immediately on its receipt. Thereafter, these applications duly numbered, may be sent to the concerned Section Offices (Assistant Engineer/Junior Engineer) for registration and further follow up action in the Section to effect supply. The following revised instructions are therefore issued.

- (1) All L.T. applications for domestic and commercial service connection (LT TF. I and LT TF. IX) shall henceforth be received, in the Office of the Assistant Executive Engineer/O&M. If any application, is received in Junior Engineer/Assistant Engineer's Office, it shall be sent to AEE/O&M immediately.
- (2) Immediately on receipt of the application, the Assistant Executive Engineer shall sent an acknowledgement to the applicant in the model form enclosed. The applications shall also be serially numbered section-wise and entered in a register in his office.
 - (3) The applications shall be sent to the Section Office within three days of receipt.
- (4) On receipt of the applications at Section Office, the same shall be registered in the Section Office as per procedure indicated in the Cir. memo. 2nd cited and further action taken.
- (5) Cancellation of application due to non-compliance of Board's terms shall be done by the Assistant Engineer/Junior Engineer's with due intimation to the applicants and with copy to the Assistant Executive Engineer/O&M concerned.
- (6) Further course of action in investigation and sanction of estimates as per the powers delegated shall be done by the Assistant Engineer/Junior Engineer.

- In the reference second cited instructions were issued to accept three phase meters also from the consumer. In both the cases previously instructions were issued to refund the cost of meter by cheque to the consumer.
- 3. In the reference second cited orders were issued to refund the cost of meter by adjustment in current consumption bills.
- 4. The following procedure may be adopted for refund of cost of meters by adjustment in current consumption bills.
- 5. A letter may be obtained from the consumer agreeing to get the cost of meter adjusted in current consumption bills instead of advanced stamped receipt by the Assistant Engineer/Junior Engineer concerned.
- 6. The letter along with triplicate copy of devolution acknowledged by Store Keeper and the original bill for the meter should be submitted to the Central Office through Asst. Exe. Engineer concerned with a covering letter containing the following details and requesting refund through current consumption bills.
 - (1) Name and address of consumer.
 - (2) Service Connection No. and Name of Distn./Sector/Street.
 - (3) Details of meter.
 - (4) Date of Test by MRT.
 - (5) Departmental No. assigned by the Board.
 - (6) Devolution No. and details of Stores where devoluted.
 - (7) Requisition No. & Date.
 - (8) Approval Memo. No. for acceptance of meter.
 - 7. The Asst. Engineer will countersign and forward the letter to the Central Office.
- 8. The Central Office will prepare and pass the hand receipt and refund the meter cost by adjustment through journal to the current consumption charges of the service connections by debiting A/c. No. 47.602 Deposits from consumers and Crediting A/c. No. 23.1 Sundry Debtors for sale of power (L.T.). Necessary intimation of such adjustment in the current consumption charges will be sent to the consumer with a copy to the Asst. Engineer/Asst. Exe. Engineer and Asst. Accounts Officer, quoting the JI. Vr. No. and month of account.
- 9. The Inspector of Assessment on receipt of the intimation will make an entry in the Green Meter Card to give credit against the future assessments. The Assessor will make entries in the White Meter Card at the time of next assessment and will give credit to the consumer. The adjustment should be done in the service connection in which the meter is installed.
- 10. In the Revenue Branch the Assistant in charge of ledger accounts will post the credit in the consumer ledger and will watch the adjustment in current consumption bills.
- 11. The other instructions in para 5, 6, 7 under the heading refund of the cost of meter issued in Memo. No. 317/SE/IEMC/PO(T)/Tariff-I(2)/84—5, Dt. 11—10—89 should be continued to be followed.

V. Jayaraman, Chief Financial Controller (Revenue). Sub: H.T. Industries—Sanction of additional demand to H.T. Industries who are in arrears of payment of assessment charges made under excess lighting and non-industrial loads—Instructions—Issued.

Some of the consumers who are in arrears of payment of charges made under excess lighting and non-industrial loads, apply for additional demand in their existing service connection. It is seen that in such cases, sanction/processing of the additional demand is not considered by the concerned Chief Engineers/Superintending Engineers due to the reason that there are arrears due from them on account of the excess lighting and non-industrial load.

The matter has been examined and the Chief Engineers and Superintending Engineers are informed that in as much as a final decision in the matter of excess lighting and non-industrial load is yet to be taken by the Board, the additional demand applied for in such cases, may be sanctioned and supply extended, after obtaining necessary undertaking from such consumers to the following effect:

"The Company shall undertake to accept the decision of the Board as final with regard to the payment of the arrears of assessment charges made under excess lighting and non-industrial loads, without prejudice to the Board's right to claim the Belated Payment Surcharge if any, when a final decision is taken in the matter and that they will abide by such decisions".

Other conditions for sanction of additional demand may be followed.

An instance has come to notice wherein a malpractice case detected by the Anti Power Theft Squad, the consumer has filed a case against the Board and obtained an interim injunction order restraining the Board from disconnection of Power supply. The consumer has however paid 50% of the compensation charges for the above violation. The consumer has preferred an appeal. A point has been raised whether final assessment notice may be issued in that case.

The matter has been referred to Legal Cell of the Board and the opinion of the Legal Cell is reproduced below :

"If there is no injunction against conducting an enquiry towards final assessment and a final assessment order, then a final assessment order may be issued. But the electricity supply to the service connection cannot be disconnected for not paying the finally assessed amount. The final assessment order shall also not contain any wording regarding disconnection of electricity supply in the event of non-payment of such finally assessed amount".

In the light of the opinion of the Legal Cell, the Superintending Engineers of Distribution Circles are requested to take necessary action as above in all such cases under their control.
