(vii) Delegation of powers to C.Es relating to agricultural Pumpset connection:

In Memo. No. SE/RE&I(D)/R E II/D No. 6683/92 dt. 8--10--92 the Board has delegated powers to C.Es, in regard to new agricultural services.

- (a) condonation of delay beyond the period of one year and upto five years from the date of issue of 90 days notice.
- (b) revocation of cancelled applications—upto five years from the date of cancellation.
- (c) appeal for effecting services against missing/untraceable applications.
- (d) any other issue.

(viii) Celebration of Board's Day and institution of Medal Schemes:

In B. P. (FB) No. 57, Secretariat Branch dt. 13—10—92, the Board has ordered institution of medal schemes for employees of Board as below:—

- (a) Chairman's Power Medal for meritorious service-100 Nos.
- (b) TNEB Medal for Distinguished service—Maximum ten per year.

(ix) Festival Advance to Pensioners:

In B. P. (Ch) No. 174, Secretariat Branch dt. 17—10—92, the Board has ordered enhancement of the festival advance to all pensioners from Rs. 300/- to Rs. 500/- irrespective of the amount of pension drawn.

(x) Payment of Bonus and ex-gratia for 1991-92:

In B. P. (FB) No. 61, Secretariat Branch, dt. 17—10—92 the Board has sanctioned 8.33% of Bonus and an ex-gratia of 6.42% or Rs. 825/- whichever is higher to the employees covered by the Bonus Act.

(xi) Removal of power cut:

In G. O. Ms. No. 1450, P. W. D., dt. 19—10—92, the Govt., have removed the restriction of limiting the demand to the base level for H. T. industries above 130 KVA.

(xii) Adhec festival advance to employees not covered by Bonus Act:

In B.P. (FB) No. 66, Secretariat Branch, dt. 24-10-92 the Board has ordered payment of an adhoc festival advance of Rs. 500/- to employees not covered by the Bonus Act.

(xiii) Tariff concession to new tourism projects:

In G.O. Ms. No. 1438, P.W.D., dt. 14—10—92, the Government have ordered that tariff concessions as applicable to New HT industries may be given to the following tourism projects availing supply under HT Tariff VII.

- (a) One, two and three star hotels with investment less than Rs. 100 lakhs set up out-side Madras Metropolitan area and outside the corporation limits of Coimbatore and Madurai or
- (b) restaurents approved by Government of India or Government of Tamil Nadu.
- (c) amusement parks or golf course recognised by the Tourism Department, Government of Tamil Nadu.

(xiv) Retention of Board's quarters:

In B.P. (FB) No. 71, Secretariat Branch, dt. 26—10—92, the Board has permitted retention of rent free quarters by employees retired/transferred and dependents of deceased employees in all categories upto three months and for periods beyond three months at market rate of rent. The C.Es. have been delegated with powers to allot the quarters as above.

(xv) Delegation of powers to Chairman:

In B.P. (FB) No. 68, Secretariat Branch, dt. 24—10—92, the Board has delegated powers to Chairman upto Rs. 5 lakhs for according administrative approval for purchase of Computers, software and entrusting computerisation works like data entry, processing, development of software and has directed that such proposals should be routed through C.E. Planning.

In B.P. (FB) No. 72, Secretariat Branch, dt. 26—10—92, the Board has enhanced the monetary powers for sanction of estimates for extension works only as below:—

(xviii) LTC-Availing of package tour by T.T.D.C.

In B.P. (Ch) No. 195, Secretariat Branch, dt. 30—10—92, the Board has ordered that under LTC. the Board employees can avail the package tours conducted by the Tamil Nadu Tourism Development, Corporation.

PROCEEDINGS:

Board's Engineers of Thermal Power Stations, Hydro Power Stations and Transmission Circles were deputed to Power Engineers Training Society/Neyveli for long-term training programmes organised by Power Engineers Training Society/Neyveli on Thermal/Hydro/Power System Engineering, in the B. Ps. 1 to 5 cited. They were sanctioned a training allowance of Rs. 400/-- (Rupees four hundred only) per month in lieu of Daily Allowance.

- The Board's Engineers have represented that the lump sum allowance of Rs. 400/- was sanctioned to Engineers deputed in the year 1985. The cost of living had increased considerably during the last 6 years. T.A. Regulations were also revised. Whereas the lump sum training allowance has not been revised. Hence, they have requested enhancement of lump sum training allowance to Rs. 1200/- per month in lieu of Daily Allowance.
- 3. The Board's Engineers deputed for training at Power Engineers Training Society/Neyveli are accommodated in Power Engineers Training Society Hostels at nominal charges. Boarding charges are on co-operative basis. Orders were issued in B.P. MS (FB) No. 50 (Secretariat Branch) dated 9 - 6 - 88 that special allowance payable to the employees who participate in the training programmes sponsored by the training division of the Government of India (Personnel and Training Department) should be calculated as follows irrespective of the period of training courses:

Local participants (for Residential Training Programmes)

Out station participants. . Actual expenditure on boarding and lodging plus 1/4th full Daily Allowance, . Actual expenditure on boarding and lodging only.

4. Tamil Nadu Electricity Board after careful consideration of the representation directs that the Board's Engineers deputed for long-term training programmes organised by Power Engineers Training Society/Neyveli (Government of India Undertaking) and who were hitherto sanctioned with a lump sum allowance of Rs. 400/- (Rupees Four hundred only) per month in lieu of Daily Allowance may be permitted to draw the actual expenditure on boarding and lodging plus 1/4th of Full Daily Allowance eligible irrespective of the training period.

PROCEEDINGS:

The Tamil Nadu Electricity Board constituted on 1—7—1957 by the Government of Tamil Nadu under Section 5 of the Electricity Supply Act 1948, is the biggest undertaking in Tamil Nadu where more than one lakh employees are employed. Since its formation, the Tamil Nadu Electricity Board has grown into very large proportions and it serves more than one lakh consumers spread all over the State. Board's Officers and staff serving in the various fields in different offices are expected to maintain high standard of integrity, show conspicuous devotion to duty etc. Such officers and staff who exhibit exemplary devotion to duty and do meritorious service require recognition and with this objective, the Tamil Nadu Electricity Board has approved to institute awards of the following two Medals Schemes:—

- I. "Chairman's Power Medal" for meritorious Service.
- 11. "Tamil Nadu Electricity Board Medal" for Distingunished Service.
- 2. The Rule governing the two Schemes are in the Annexure.

3. The Chairman Power Medal will be awarded to a maximum of 100 employees per year as indicated below:

- 4. The Tamil Nadu Electricity Board Medal for Distinguished service will be awarded to a maximum of ten employees per year which will be common to all the categories of employees in the Tamil Nadu Electricity Board.
- 5. For the year 1992, the awards will be presented on 5—11—1992 at Madras for which the Officers in Column 7 above will send their recommendations to the Secretary before 25—10—1992 and the names should be finalised by 5—11—92. From the year 1993 and subsequent years the awards will be presented on 15th August for which the Officers in Column 7 above will send their recommendations to the Secretary before 15th of June and the Committee will make its recommendations by 15th July each year. The award will be presented at different centres each year by rotation to be ordered separately.
- 6. A Committee consisting of Accounts Member, Member (Generation), Member (Distribution) and the Secretary will finalise the list of awardees and the Secretary, Tamil Nadu Electricity Board will obtain orders of the Chairman in respect of "Chairman Power Medal" and of the full Board in respect of "Tamil Nadu Electricity Board Medal" by placing before the Board, the recommendations of the Committee consisting of Chairman, Accounts Member, Member (Generation) and Member (Distribution).
- 7. A brief function named as "Boards Day" will be arranged for the award of Medals and the awardees will be permitted to claim Travelling Allowance and Daily Allowance to and from as per rules in force applicable to such category to which they belong from the place of their work to the place of the function for receiving the awards.
- 8. The Chief Public Ralations Officer will arrange for the function and the expenditure for this purpose including cost of Medal, Certificate and cost of award will be sanctioned in Board Office Secretarian Branch.
- 9. The names of recipients of Medals will be published in the Tamil Nadu Electricity Board Gazette.
- 10. The Medal will be liable to be forefeited when the holder is guilty of disloyalty and such other act of misconduct as in the opinion of the Chairman brings disrepute to the Tamil Nadu Electricity Board.
- 11. The Award of Chairman Power Medal will not be a bar to subsequent award of Tamil Nadu Electricity Board Medal. The employees of the Board will be eligible for the grant of medals only once in their service.
- 12. The Chairman, Tamil Nadu Electricity Board will be the authority to sanction expenditure connected with the implementation of the Medal Schemes.

The Organisation and Methods Cell of Board Office Secretariat Branch has made a detailed study to assess the requirement of Man Power for supervising the works relating to manufacturing the RCC and PSC Poles. The study report containing various suggestions have been placed before the Chief Engineers (Distribution) meeting held on 27-8-92 for consideration. During the meeting, it was decided to adopt the report of the Organisation and Methods Cell and follow the suggestions made therein. Accordingly, the following instructions/guidelines are issued for guidance and strict adherence:

- (i) The requirement of Poles will be approximately 2000 for each Circle for their extension programme and the same shall be met by starting One P.S.C. Yard, two or three R.C.C. Yards in each Circle. These yards shall be located where there is copicus water and easy availability of raw materials.
- (ii) The existing P.S.C. Yards at Samayapuram, Mettur, Samayanallur and SIPCOT, Ranipet (Vellur) shall be expanded by providing additional beds so that more number of Poles can be manufactured.
- (iii) The Defunct yards which are of no use to the Management shall be closed and the staff diverted wherever they are required.
- (iv) All the Raw Materials such as Grills, Cement and H.T. Wire, etc. shall be made available to the P.S.C. Yards and R.C.C. Yards throughout the year.
- (v) All the P.S.C. and R.C.C. Yards shall be provided with Vibrators.
- (vi) The Technical Audit Engineers shall be directed to visit P.S.C. and R. C. C. Yards as often as possible to check the quality of the poles manufactured.

Ms. (FB) No. 24, Secretariat Branch, Dated: 10—1—80, the Board adopted the orders of the Government of Tamil Nadu for providing employment to one member in each family displaced on account of acquisition of lands for the establishment of any project under the Tamil Nadu Electricity Board. The term one member in each family shall mean such member as nominated by the land owner/cultivating tenant.

- 2. Lands have been acquired in two stages in Lower Mettur Hydro Electric Project as detailed below:—
 - (i) Land acquired for Dam Area.

- 118 families
- (ii) Families affected due to submerging in barrages I to IV 93 families
- 3. Out of 118 displaced families, 87 families have been considered earlier for employment assistance.

- 4. Subsequently the Superintending Engineer/Lower Mettur Hydro Electric Project has sent a proposal for 76 persons who have been displaced on account of acquisition of their lands for construction of Lower Mettur Hydro Electric Project and persons who have been affected on account of submerging areas. Out of the above 76 persons, 27 persons (Twenty seven) are eligible for employment assistance under the Scheme (ie.) 17 persons are qualified and another 10 persons have nominated their relatives who are qualified totalling to 27 persons and the remaining 49 persons are not qualified for being considered for employment assistance. The matter has been cerefully examined and the Board directs that
- (1) the 27 persons listed in Column 3 in the Annexure-I to these proceedings be selected for appointment as Helper (Trainee) subject to the following conditions:
 - (a) The period of Training in respect of the above 27 selected condidates shall be three years on consolidated wages at the rate indicated below.
 - (i) Rs. 500/- p.m. for the first year.
 - (ii) Rs. 650/- p.m. for the second year.
 - (iii) Rs. 800/- p.m. for the third year.
 - (b) The appointment shall be given to only one person in each family displaced on account of acquisition of lands for the Project Works, subject to the declaration by the head of the family that no other member of the family is employed anywhere else including private concern.
 - (c) The acquired land should have been the only major source of sustenance for that family which fact should be certified by the Superintending Engineer concerned.
 - (d) In cases where the family does not have a male member or a member not physically fit either due to age or physical infirmities, the family may nominate his/her relative for appointment and such nomination is one time affair and shall not be revoked or altered when once the said nomine is appointed.
 - (e) The qualification should be verified from their original educational certificates before issue of appointment order.
 - (f) Only persons physically fit and suitable for job be considered for such appointment.
 - (g) The trainees so appointed be absorbed as regular Helper/Office Helper on satisfactory completion of three years training.
 - 5. Orders of allotment in respect of 27 (twenty seven) persons will be issued separately.
- 6. In respect of 49 candidates indicated in Annexure. Il to these proceedings who are not qualified, the Superintending Engineer/Hydro Project/Bhavani is requested to inform those land owners to nominate qualified persons preferably who possess minimum general qualification (i.e.) S.S.L.C. In supersession of the orders issued in the Board's Proceedings cited, the Tamil Madu Electricity Ecard directs that the employees retired/transferred and the dependant of the deceased employees in all categories can occupy the quarters upto three months at the rate of rent last paid by them and for occupation of quarters beyond three months the market rate of rent shall be collected.

- 2. The Tamil Nadu Electricity Board also directs that the facility of rent free quarters need not be extended to employees who were removed or dismissed from service.
- 3. The employees in all categories who occupy rent free quarters in Projects, Generation Circles etc. shall also be allowed retention of such rent free quarters upto **three** months and beyond the period mentioned above, the market rate of rent shall be collected.

- 4. The Tamil Nadu Electricity Board further directs that the Chief Engineers concerned shall be delegated with powers to allot the Board's Quarters for the above categories of employees.
- 5. The authorities who are to exercise these powers shall also ensure that sanction of retention of quarters is not detrimental to the interests of the employees entitled to occupy such quarters.
- 6. All cases pending upto the date of issue of these orders shall also be decided as per these orders by the respective Chief Engineers.

In the Board's Proceedings first cited, a time schedule was prescribed for examining and disposing of disciplinary proceedings cases. A flow chart to watch the progress of disciplinary proceedings cases was also prescribed in the Board's Proceedings second cited, and all the officers were requested to ensure that the time schedule prescribed should be adhered to strictly. Inspite of this, there is an inordinate delay in dealing with disciplinary proceedings cases. While going through certain files, the Chairman has found that the files which were submitted for orders to continue the suspension for which there is no justification. The employees are being continued under suspension for a long period which is highly unjustified and incorrect, and hence it is hereby directed that all disciplinary proceedings authorities shall under no circumstances continue the suspension unless it is one of the rarest of the rare cases only where there is no other alternative. In all other cases the disciplinary proceedings authorities should take necessary action to finalise their findings and issue necessary orders before the expiry of the initial period of suspension.

2. The above orders shall be followed along with existing instructions scrupulously. Deviation if any will be viewed very seriously.

Per. B. P. Ms. No. (FB) 7 (Accounts Branch), dt. 20-3-92.

Proceedings:

The National Thermal Power Corporation (NTPC) is supplying power from the Ramagundam Super Thermal Power Station (RSTPS) as per central formula since December 1984. The NTPC have erected/erecting 400 KV transmission lines for evacuation of power from RSTPS and under central Transmission Project I (Southern Region).

2. NTPC is insisting payment of transmission charges in respect of the 400 KV transmission lines erected under the Central Transmission Project I (CTP—I S. R) and the withheld coal transport charges.

(i) Nagarjunasagar—Gooty line:

NTPC has indicated cost of Rs. 86.58 lakhs towards monthly transmission charges from 21—4—91 the date on which this line was declared for commercial operation. This amount is checked and assessed tentatively at Rs. 62.99 lakhs. But Andhra Pradesh State Electricity Board (APSEB) have worked out the charges as Rs. 61.397 lakhs. The Board after careful consideration approves that from 21—4—91 the transmission charges be paid to NTPC at the rate of Rs. 61.397 lakhs as a tentative basis subject to confirmation of capital cost and 0 & M charges incurred by NTPC. The monthly transmission charges has to be shared by the beneficiaries in the Southern Region in the ratio of actual drawal of power every month until further review by the Board.

(ij) Gooty-Bangalore line:

NTPC have indicated cost of Rs. 53 lakhs towards monthly transmission charges from 10-7-91, the date on which this line was declared for commercial operation. This Transmission charges was checked and assessed tentatively at Rs. 43.70 lakhs and APSEB has worked out the charges as Rs. 42.638 lakhs. The Board after careful consideration approves that the transmission charges may be paid to NTPC from 10-7-91 at Rs. 42.638 lakhs subject to confirmation of capital cost and of O & M charges incurred by NTPC. The monthly transmission charges has to be shared by the beneficiaries in the Southern Region in the ratio of actual drawal of power every month until further review by the Board.

(iii) 400 KV Ramagundam-Chandrapur inter-regional line:

- (a) The first and second circuits of this line were declared for commercial operation from 23—11—90 and 29—12—90 respectively. The transmission charges for this inter regional line have to be shared by the Western and Southern regions in the ratio of 50:50. NTPC has indicated the share of monthly transmission charges for the Southern Region to be Rs. 30.75 lakhs. This charges are assessed at Rs. 27.73 lakhs. The Board after careful consideration approves that the monthly transmission charges of Rs. 27.73 lakhs be paid to NTPC. The monthly transmission charges has to be shared by the beneficiaries in the Southern Region in the ratio of actual drawal of power every month until further review by the Board.
- (b) In addition to the transmission charges, NTPC has also claimed idle charges for this line. Based on a meeting on 26—6—91 the State Electricity Boards (SEB) in the Southern region agreed to pay the idle charges from 1—12—90 for circuit I and 1—1—91 for circuit II respectively. The Board after careful consideration approves that the idle charges be paid to NTPC as and when claimed including the pending bills for January and February 1991.

(iv) Transport charges of coal:

NTPC transports coal by means of trucks etc. if sufficient coal is not transported through the Merry-Go-Round System. NTPC claimed an amount of Rs. 5 lakhs for the period from March 86 to May 88 being the additional expenditure incurred for transport of coal through trucks etc. This amount though claimed by NTPC was not paid by the Board. However the Board is admitting such transport charges of NTPC from June 88 onwards. NTPC is now insisting the payment of the withheld amount of Rs. 5 lakhs for the earlier period. Board after careful consideration approves to release the withheld amount of Rs. 5 lakhs in line with the decision taken for payment of transport charges from June '88.

- 2. While furnishing the details regarding the evaluation of tenders it may also please be indicated that the order is proposed to be given at the lowest price. If it is not so, the reasons for the same may please be furnished.
- 3. It may also be clearly indicated that the prospective supplier/firm to whom the purchase order is to be placed has agreed to supply the equipment in question according to the specifications. If it is not so, the justification for the various deviations should also be furnished.
 - 4. Three copies of each letter should also be positively sent to this office.
- 5. It has also been seen that the Indian Agents of the various firms are asking for IAC @ rates higher than that prescribed by the Govt. of India. It is expected that in such a situation all the SEBs/Power Utilities will make all possible efforts to reduce IAC within the prescribed limits.
- 6. It is also requested that as far as possible, immediately after forwarding the import proposals, the concerned Engineer/Officer may also kindly be deputed to this office for discussion and giving necessary clarifications so as to enable us to dispose of the proposal promptly.
- 7. The check list giving details of various documents required to be furnished along with the import proposals has already been sent to you.

I hope that in future your organisation will keep the aforesaid points in view before sending the various import proposals for FE release to this office so that this office is able to dispose of your proposal promptly.

According to existing rules, the enclosures to application for Family Pension (Form No. 14) such as two specimen signature of the applicant, two passport size photograph of the applicant, etc. are to be attested by two Gazetted Government servants or two or more persons of respectability in the town or village in which the applicant resides.

- 2. The Government have considered the desirability of stipulating the condition of getting attestation from one Gazetted Government Servant/person of respectability in the town/village/instead of two and decided to issue orders accordingly, I am therefore directed to state that hereafter it is enough if the attestation in the application for family pension (Form No. 14) is done by one Gazetted Government Servant or one person of respectability in the town or village in which the applicant resides.

The quantum of bonus and ex-gratia payable to the employees of the Tamil Nadu Electricity Board for the accounting year 1991—92 has been carefully considered. The matter was discussed with the representatives of Unions who demanded higher bonus and ex-gratia.

- 2. The Tamil Nadu Electricity Board hereby directs that the employees of the Board be paid, for the accounting year 1991—92, a bonus calculated at the rate of 8.33% of the salary or wage earned by them during the said accounting year, or Rs. 100/- (Rupees one hundred only) whichever is higher, subject to and in accordance with the provisions of the Payment of Bonus Act, 1965 as amended upto date.
- 3. The employees of the Board (monthly paid and full-time employees paid from contingencies) Helpers and Office Helpers (Trainees) appointed on consolidated salary and also the employees of the State Government, Central Government and others, who had worked on deputation under the Board during the accounting year 1991—1992 and drawing a salary or wage not exceeding Rs. 2,500/-p. m. will be eligible for the bonus sanctioned in para 2 above.

The Board, with the concurrence of the Government of Tamil Nadu, also directs that the employees of the Board and the deputationists entitled to get bonus with reference to the orders in paras 2 and 3 above shall also be paid ex-gratia at the rate of 6.42% of the salary or wage earned by them during the accounting year 1991—92, or Rs. 825/- (Rupees eight hundred and twenty five only), whichever is higher.
- 5. 'Salary or Wage' for the purpose of payment of bonus and ex-gratia will include only the following:—
 - (a) Basic pay/Leave salary.
 - (b) All classes of special pay (including Shorthand and Typewriting special pay).
 - (c) Personal pay.
 - (d) Additional pay for additional charge.
 - (e) Additional deys' wages paid for work on National Holidays and Festival Holidays.
 - (f) Dearness Allowance.
 - (g) Personal Compensatory allowance given for protecting loss of pay; and
 - (h) Deputation allowance.

The term 'Salary or Wage' will not include over-time pay and allowances and will not include any pay and allowances other than these mentioned from (a) to (h) above. Salary or wage for the leave surrendered by an employee during 1991—92 should not be taken into account for computation of bonus.

- 6. All employees, who have worked in the establishment for not less than thirty working days in the accounting year 1991—92, are entitled for the payment of bonus and ex-gratia.
- 7. Where an employee has not worked for all the working days in the accounting year 1991-92 the minimum bonus of Rs. 100/- (Rupees one hundred only), if such bonus is higher than 8.33% of his salary or wage for the days he has worked in the accounting year 1991—92 shall be proportionately reduced.
 - 8. (i) In respect of such of those employees for whom ex-gratia amount calculated on their earnings at 6.42% for the full year worked out to less than Rs. 825/- ex-gratia amount of Rs. 825/- (Rupees eight hundred and twenty five only) shall be paid.
 - (ii) In respect of those for whom the ex-gratia amount worked out at 6.42% for the period they had worked was less than the pro-rate amount calculated on the basis of Rs. 825/-, in such cases the maximum ex-gratia amount as indicated below shall be paid:

A number of representations are being received at the Headquarters from the Public/Applicants for pumpset connection on matters relating to application for extension of supply to new agricultural pumpset connections.

2. In order to reduce the hardship to the applicants in approaching the Headquarters office for redrassal of their grievances in getting a new agricultural service and to minimise the administrative time-taken for their disposal, after due & careful consideration, the powers now exercised by the Member (Distribution)/Chairman are delegated to the Chief Engineers (Distribution) to deal with the representations relating to new agricultural services as indicated below:

(i) CONDONATION OF DELAY IN REPORTING READINESS.

Powers for condonation of delay in reporting readiness in different spells subject to a maximum period of one year is being exercised by Superintending Engineers of Electricity Distribution Circles as outlined in Circular Memo. No. Addl. CE/IEMC/EE3/AEE2/636/91, (Technical Branch), dt. 22—3—1991.

All cases of delay in reporting readiness beyond the period of one year and upto five years in different spells from the date of issue of 90 days notice may be examined individually and decided based on the merits of the case.

(ii) REVOCATION OF CANCELLED APPLICATIONS AND RESTORATION OF ORIGINAL SENIORITY.

Representations received upto a period of five years from the date of cancellation of application, may be considered on merits of the cases individually and orders passed.

(iii) APPEAL FOR EFFECTING SERVICES AGAINST MISSING/UNTRACEABLE APPLICATIONS.

Any appeal petition—contesting the orders passed by the Superintending Engineers/Electricity Distribution Circle in accordance with the procedure ordered in Memo. No. SE/RE &1(D)/D/C. 143/87 (Tech. Branch) dt. 7—10—87 may be desit individually and the case disposed finally on the basis of merits of the case.

(iv) ANY OTHER ISSUES.

TRIBAL WELFARE—Tribal Sub-Plan for 1992—93 — Electrification of Tribal Hamlets during 1992—93 by Conventional Method—Orders—Issued.

From the Chief Engineer (Planning), Tamil Nadu Electricity Board, Madras, letter No. SE/RE & I(D)/RE. 2/D. No. 1324, dt. 17—8—92.

ORDER:

As part of implementation of Integrated Tribal Development Programme schemes during 1992—93, proposals at the cost of Rs. 50.00 lakhs for electrification of 7 tribal hamlets have been incorporated in the Tribal Sub-Plan document for 1992—93. This was accepted by Government of India. A sum of Rs. 30.00 lakhs has been provided in the Budget Estimate for 1992—93 towards this scheme. The Chief Engineer (Planning), Tamil Nadu Electricity Board has sent revised proposals for electrification of 14 Tribal hamlets at a total cost of Rs. 40.00 lakhs. He has requested the Government to sanction a subsidy of Rs. 30.00 lakhs (at the rate of 75% of the total cost) towards the electrification in 14 Tribal hamlets in Salem District.

- 2. The Government accord sanction for incurring an expenditure of Rs. 28.50 lakhs (Rupees twenty eight lakhs and fifty thousand only) towards the cost of electrification of 14 Tribal hamlets in Salem District by the Tamil Nadu Electricity Board through conventional method of electrification as detailed in the Annexure to this order.
- 3. The Government also accord sanction for incurring an expenditure of Rs. 1.50 lakhs (Rupees One lakh and fifty thousand only) towards the maintenance of the Diesel Generator sets already installed in tribal hamlets of Kalrayan Hills and maintained by local bodies concerned.
- 4. The Director of Adi-Dravidar and Tribal Welfare is requested to draw the amount sanctioned in para 2 above and place it at the disposal of the Tamil Nadu Electricity Board/Madras-2.
- 5. The Director of Adi-Dravidar and Tribal Welfare is also requested to draw the amount sanctioned in para 3 above and place it at the disposal of Director of Rural Development, Madras.
- 6. The expenditure should be debited to "2225. Welfare of Scheduled Castes, Scheduled Tribes and other Backward Classes 02—Welfare of Scheduled Tribes 796—Tribal Areas Sub-Plan Schemes in the Eighth Five Year Plan-II State Plan JI. Electrification scheme in Tribal Villages 16—Major Works —" (D. P. Code 2225—02—796 JI 1600)."
- 7. The Tamil Nadu Electricity Board is requested to furnish an utilisation certificate to the Director of Adi-Dravidar and Tribal Welfare for the amount released.
- 8. This order issues with the concurrence of the Finance Department vide its U.O. No. 403/DS (JB)/92, dt. 3-9-92.

- 1. One Star, two star and three star hotels with investment less than Rs. 100 lakhs to be set up in Tamil Nadu excluding the Corporation limits of Madras, Coimbatore and Maduraj.
- 2. Amusement Parks.
- 3. Approved Tour Operators (for A.C. Coaches).
- 4. Golf Courses.
- 5. Restaurants approved by Government of India/Government of Tamil Nadu.
- 2. The Tamil Nadu Electricity Board has reported that the "New Tourism Projects", viz. Star hotels, amusement parks, Golf Courses and restaurants approved by the Government of India/Tamil Nadu set up outside Madras Metropolitan area and outside the Corporation Limits of Coimbatoge and Madurai are coming under High Tension Tariff-VII. The Electricity Board has, therefore, suggested that these "New Tourism Projects" may be added after High Tension Tariff-VII under "Part A—High Tension Supply of the Schedule to the Tamil Nadu Revision of Tariff Rates on Supply of Electrical Energy Act, 1978, for the purpose of extending tariff concessions on par with "New Industries".

In exercise of the powers conferred by section 4 of the Tamil Nadu Revision of Tariff Rates on Supply of Electrical Energy Act, 1978 (Tamil Nadu Act I of 1979), the Governor of Tamil Nadu hereby makes the following amendments to the Schedule to the said Act:—

AMENDMENTS

In the said Schedule, under the heading "Part A-High Tension Supply", under the sub-heading "Tariff Concession for High Tension Industries coming under High Tension Tariff I" in item (i), in sub-item (a)—

- (1) for the expression "Explanation 1—"the expression "Explanation—" shall be substituted;
- (2) After the Explanation as so amended the following sub-item shall be inserted, namely:-
- "(aa) The tariff concession shall be applicable to expansion of industry also to be set up in any city, municipality, township or Panchayat union limit other than the Madras Metropolitan area in which the main industry is functioning, provided the assets, other than cash, of the existing industry are not transferred and shown as the assets of the expansion;

Provided that the tariff concession shall be applicable only once, to a new industry or on expansion of the industry in the area comprising the satellite town of Maraimalai Nagar New Town developed by the Madras Metropolitan Development Authority, irrespective of the fact whether such industry has availed of such concession outside the area of Maraimalai Nagar earlier or not, and also whether such industry is considered new investment or not;

Provided further the concession for the expansion of industry shall not be applicable to the existing industry availing the concession for the additional load in the High Tension Service for its expanded activity beyond the period of three years or five years, as the case may be, as specified in item 1(a) and the proviso thereto, respectively.

Explanation:— The term "expansion" shall mean an increase in production which results in an increase of 25 per cent or more in the consumption of electricity by the industry with reference to the highest electricity consumption of such industry in the three completed financial years preceding the application";

- (3) Explanation 2 including the proviso thereto shall be omitted;
- (4) for the expression "Explanation 3" the expression "(ab)" shall be substituted.
