The following clarificatory orders are issued on the various points raised by Officers from field with regard to maintenance and payment made under imprest account:-

- (a) It shall be borne in mind by all Imprest holders that the imprest is meant for meeting only urgent and unforeseen expenditure that may occur in the day to day business of office and that which cannot wait for a day or two. All other items of expenditure for which separate powers of sanction exist in the Board should not be met under imprest.
- (b) The orders in para-4 (ii) of (Per.) B.P. (F.B.) No. 17, S.B. dt. 8—3—91, limiting the expenditure to Rs. 100/- (Rupees one hundred only) in individual cases that can be met from the "Imprest" by the Imprest holders on their own responsibility or with proper sanction was issued with a view to restricting the expenditure from Imprest on a day to day basis and for creating vouchers. In cases of expenditure over and above this limit, sanction may be accorded by the authority delegated with powers in B.P. Ms. (Ch.) No. 128 (Tech. Br.) dt. 24—6—83 and in (Per.) B. P. (F.B.) No. 64, S. B. dt. 10—8—94.
- (c) In view of the clarification in sub-para—(b) above, the orders issued in Board's Memo. No. 30024/0 & M Cell—I (4)/91—1 dt. 30—5—91 are hereby cancelled so that restriction in individual cases of payment under imprest shall apply to all offices uniformly.
- (d) The following items of expenditure shall also be booked under imprest, in addition to the items of expenditure specified in B.P. Ms. (Ch.) No. 4 Adm. Br. dt. 4—1—85:
  - i) Expenditure on battery charging
  - ii) tyre changing
  - iii) tube punctures
  - iv) small dynamo repairs
  - v) Minor repairs to vehicles
  - vi) tyre retreding charges
  - vii) purchase of spares to vehicles and other tools and plants.
  - viii) expenditure towards maintenance of computer and its accessories and related equipments.
  - ix) purchase of castly life saving medicines for emergency purpose and urgent repairs of the equipments in the Dispensary.
  - x) expenditure towards taking xerox copies on urgent matters.

- (e) The Chief Medical Officer and the Executive Engineer Computer Centre shall be authorised to exercise the powers delegated to the Superintending Engineers and Executive Engineers respectively in B.P. Ms. (Ch.) No. 128, Tech. Br. dt. 24—6—83.
- (f) Procurement of fuel is not a petty item of expenditure to be booked under imprest in a routine way. As it is an anticipated item of expenditure necessarily to be incurred, it shall be met by making permanent arrangement for the purpose. However, in extraordinary circumstances, payment under imprest can be resorted to but not exceeding the limit of powers delegated in B.P. Ms. (Ch.) No. 128, T. B. dt. 24—6—83 and in (Per.) B.P. (F.B.) No. 64, S.B. dt. 10—8—94.
- (g) In case of all other predictable items of recurring expenditure which are not covered by any delegation, temporary advances shall be opened specifying the purpose and the expenditure shall be strictly for the purpose specified in the sanction.
- 2. All the Chief Engineers/Superintending Engineers are requested to follow these instructions strictly and also advise the imprest holders under their control to adhere to the above instructions.

> Sub: Disciplinary Proceedings—Initiation of action on the Report of "Commission of enquiry" and "enquiring authority" in Disciplinary cases-Instructions issued.

An instance has come to the notice of the Government where a "Commission of enquiry" was appointed to enquire into grave irregularities against Government officials and certain aspects of the Commission's findings were not brought to the notice of the Enquiry Officers entrusted to enquire the charges framed in the said case to enable him to explain divergence of views from the findings of the "Commission of enquiry". So, the reasoning behind the findings of the Enquiry Officers can be deemed to be their explanations to the divergent views.

- 2. The procedures before a Commission of enquiry and the enquiring authority in a disciplinary case are not the same. They are under different legal provisions and start from different corners. While an enquiry commission tries to ascertain the facts, a departmental enquiry analysis the specific imputations. Once the imputations could not be proved and there are no grounds for alternative imputation, it is desirable that the matter be allowed to come to a close. In order to avoid the above contingency it is necessary that important aspects of the Commission's findings should be brought to the notice of the Enquiring Officers and they have to be asked to explain divergence of views, if any, so that the reasonings behind the findings of the enquiry officers can be deemed to be their explanation to the divergence of their views. In the above circumstances, it is desired that wherever disciplinary action is initiated under Rule 17(b) of the Tamil Nadu Civil Services (Classification, Control and appeal) Rules against officials on the basis of the reports or findings of "Commission of Enquiry" such reports of relevant chapters thereof should from the imputations leading to the charges and should be communicated to the accused officers. In cases where minor punishments are warranted, explanation may be called for under rule 17(a) of the said rules on the basis of the findings in the report/relevant chapters thereof, which should be communicated to the delinquents.
- 3. All the disciplinary authorities may therefore be instructed to ensure that the procedure Indicated in para 2 above are strictly observed without fail.

The Unions and the Trainees have represented that the wages offered to them may be enhanced as the net amount after incurring expenses towards conveyance to reach the office from their residence is very meagre. It is also represented that the training period of three years may be reduced to one year.
- 3. After careful consideration, the Board has decided to reduce the training period as one year and to enhance the wages as Rs. 750/-P. M. for the said period in respect of Office Helper (Trainee) and Helper (Trainee) with effect from 1—9—94.
  - 4. Accordingly the Board hereby directs that:
    - 1. the training period of three years prescribed for Office Helper (Trainee) and Helper (Trainee) be reduced from three years to one year and the wages of Trainees enhanced from Rs. 500 to Rs. 750/- (Rupees seven hundred and fifty only) per month with effect from 1—9—94 (payable in 10/94).

Sub: Maximum—Inventory level to be—maintained for the year 1994-95 - Communicated.

A statement showing the Inventory level to be maintained by the Circles for the year 1994-95 as approved by Chairman, Tamil Nadu Electricity Board is enclosed for strict adherence. This level is the maximum i.e. the ceiling. The inventory level in Circles should be well below the maximum at any point of time during the year 1994 - 95.

- 2. The total inventory as on 1—6—1994 is Rs. 353.65 Crores. This was Rs. 344.65 Crores on 1—6—1993 and Rs. 295. 76 Crores on 1—6—1992. This shows that in the last two years, Rs. 57.89 Crores worth of inventory has been added at the average of Rs. 2.41 Crores per month.
- 3. It is seen from the inventory maintained that the Circles have not shown any importance of the circulars issued by this office to maintain the inventory level to the bearest minimum. The stocking of materials in the stores yard for imaginary use and in disproportionate quantities has also been objected to by Reserve Bank of India and commented upon by Public Undertaking Committee in their reports.
- 4. In the earlier years it was construed that a circle is permitted to hold stocks upto the maximum level fixed for the year as a matter of routine and this practice should be discontinued with immediate effect. Every purchase should be made carefully and prudently based on the actual requirement for works.
- 5. It is requested to ensure that an effective control over the reduction of inventory of the circles by inspecting the Stores and reviewing stock position personally. The maximum inventory level should not exceed the limit prescribed for 1994—95 and any proposal for revision (or) ratification of the excess stock held in the Circles will not be entertained. It is the responsibility of the Superintending Engineers concerned to keep the inventory level below the bearest minimum.
- 6. Receipt of this letter may be acknowledged to the Financial Controller/Purchase, Office of the Chief Financial Controller, Madras-2.

The above orders of the Government were adopted to Board employees in (Permanent) B. P. (Ch) No. 170 (SB) dated 25—6—94. It was also ordered in the Board Proceeding that the employees who are recruited on or after 25—6—94. (date of B. P.) would be paid only the monthly medical allowance of Rs. 30/- per month and they would not be eligible for Medical Reimbursement Scheme. It has also been clarified in Board's Memo. fifth cited that the employees continuing under Medical Reimbursement Scheme would only be permitted to choose this Medical Allowance Scheme.
- 3. In supersession of their earlier orders the Government of Tamil Nadu, have in their G.O. Surplus/Obsolate/Unserviceable/Scrap meterials, condemned vehicles and Plant and machineries etc. are disposed off through open tenders/Public auction following the procedures laid down from time to time in this regard. The sale amount (cost of materials) should be collected within 21 days (twenty one) from the date of receipt of the confirmation of the sale by the bidder/tenderer as per clause 29.4 (i) of the Tender Regulations vide Permanent B.P. (F.B.) No.17 (Accounts Branch) dt. 5—8—1991. It should be clearly indicated both in the specification and in the sale order that failure to comply with the requirement shall entail forfeiture of the Earnest Money Deposit.

During unavoidable circumstances Superintending Engineer may grant extension of time upto seven days from the date of payment of sale price and the Chief Engineer may grant further extension of time upto seven days thereafter and Board Level Tender Committee may grant any further extension of time as per clause 29.4 (ii) of Tender Regulations.

It is observed that number of proposals are received from the field Chief Engineers/Superintending Engineers seeking approval of the Board Level Tender Committee to grant further extension of time beyond the extension period granted by the Chief Engineers. In order to effect quick realisation of sale value it has been decided to collect interest charges for the delay beyond the extension of time granted by Chief Engineer.

The Superintending Engineer/Tirunelveli Kattabomman Electricity Distribution Circle in his letter cited above has requested clarification as to whether the extra levy of 25% has to be charged or not in respect of SC No. A. 577, Tenkasi which was effected on 13—12—82 with a connected load of 360 Watts under L.T. Tariff—IX, and an additional load of 2 KVA and 0.5 HP to provide a welding set and drilling m/c was effected subsequently on 18—2—92.

As there is no provision for charging extra levy of 25% for provision of welding set under L. T. Tariff-IX and considering the fact that there is loss of revenue, if the Welding set is continued to be permitted in the service under L.T. Tariff—IX, since the rate per KWhr under L.T. Tariff-IV + 25% is more than that under L.T. Tariff-IX, it is informed that the consumer may be advised to avail a separate service for Welding set after segregation of loads within a reasonable period (say two months) failing which the entire consumption of the service will be liable to be billed under L.T. Tariff-IV + 25% until such time separate service is availed for welding set.

The additional tax already paid from 31—7—92 onwards may be refunded through future current consumption bills and the tax paid between 20—1—92 to 30—7—92 may be regulated as per G. O. Ms. No. 47. Energy Department, dt. 29—11—93 (ie) to be set off against the future additional tax on energy to be collected.

#### ORDER:

In the G.O. first read above, the Government ordered exemption in respect of additional tax payable under the Tamil Nadu Electricity (Taxation on Consumption) Act, 1962, by any new industrial undertaking established in the State of Tamil Nadu for a period of three years from the date of commencement of the manufacture or production of the principal product. The G.O. was given effect from 30—7—1992.

- 2. In the Government order fourth read above, it was ordered that additional tax on the consumption of energy levied during the period from 20—1—1992 (ie. the date of announcement of New Industrial Policy) to 30—7—92 be set off against the future additional tax on energy to be collected from new units which enjoy the concession with reference to orders issued in G.O. first read above.
- 3. In his letters third and fifth read above, the Chairman, Tamil Nadu Electricity Board has recommended that this tax exemption may be given to new Industries who have completed three years prior to 30—7—1992, but who have not completed 5 years of tariff concession period, for the balance period of 5 years beyond 30—7—1992. He has requested that the G. O. may be amended so as to provide for tax exemption for new Industrial units for the balance period of five years beyond 20-1-1992 for whom five year tariff concession has been extended by the Tamil Nadu Electricity Board.
- 4. The Government have carefully considered the suggestion made by the Tamil Nadu Electricity Board. The new Industries started before New Industrial Policy but enjoying 3/5 year new Industry tariff concession did not suffer tax prior to September 1991 when the tax on consumption was introduced. The Government consider that exemption of additional tax on consumption be allowed for the unexpired period of 3/5 years and they accordingly direct that the concession granted in G.O.(1) read above, as amended in G.O.(4) read above, be extended to the new Industries for whom Three/Five years Tariff Concession was extended by Tamil Nadu Electricity Board, for the unexpired period of 3/5 years beyond 20—1—92 as the case may be.

As per the existing norms, High Tension Control and Metering Cubicles have to be provided by the Board for high tension service connections if the sanctioned demand exceeds 1000 KVA at 11 KV and 2000 KVA at 22 KV.

- 2. The Rule 50 of Indian Electricity Rules 1956 as modified from 8—2—86 says that an OCB should be provided by a H.T. consumer at the point of supply if their aggregate transformer capacity is above 1000 KVA for 11KV system and 2500 KVA for 22 KV system, but limited to 2000 KVA only for 22 KV system. The Rule 50 of I.E. Rules 1956 further states that if the point of commencement of supply and the consumer apparatus are near each other, the Circuit breaker near the point of commencement of supply shall be considered sufficient.
- 3. After terminating the Board's point of supply in the H.T. consumer's premises, the consumer has to avail supply within 15 feet from the termination of Board's point of supply by erecting necessary structure/Breakers.
- 4. As a H.T. consumer should provide Circuit Breaker at the commencement of point of supply providing another control and metering Cubicle within 15 feet becomes superfluous.
- 5. (i) After careful consideration of the above, it is hereby ordered that the provision of Control and Metering Cubicle by Board, in H.T. services with a sanctioned demand above 1000 KVA who are insisted to provide an OCB at the commencement of point of supply as per the modified I. E. Act, may be dispensed with.

- (ii) H.T. metering sets with H.G. Fuse unit shall only be provided in H.T. services above 200 KVA availing supply from 11 KV to 33 KV level.
- (iii) The control and metering cubicles already installed in H.T. services as per the earlier norms shall be permitted to serve its useful life after which these may be replaced with H.T. metering sets along with H.G. Fuse units. However upto 200 KVA at 11 KV and 22 KV, metering on Low Tension side shall be provided.
