The maximum grid demand and consumption during June '94 were 4033 MW on 28-6-'94 and 86.305 MU on 23-6-'94 respectively. The average grid consumption in June '94 was 83.583 MU per day.

The monthwise generation and relief figures for the water year 1993-94 (July '93 to June '94) are furnished in Annexure-I.

II. Hydro Inflows:

The Hydro inflows during June'94 were 704 MU against 251 MU in June '93 and against the ten year average of 515 MU. The total inflows from July '93 to June '94 were 3884 MU against 3797 MU during the same period last year and against the ten year average of 3179 MU.

No. 12/SE/IEMC/EE(T)/Tariff-I(3:/94-2 dt. 2-6—'94, the Government has withdrawn the tariff concessions to new steel industries who got sanction of the load on or after 18—5—'94. It has been ordered in the Memo. No. 2—6—94 that Steel Industries who are availing tariff concessions as en 18—5—'94 and for whom the tariff concession period is not yet over, additional load to such industries shall not be sanctioned till the concession period.

IX. Study of Part Time B.E. Degree Course:

In B.P. (CH) No. 197 (Admn. Branch) dt. 2—6—'94, the Board has permitted to study part time B.E. Degree course at A.C. College of Engineering and Technology, Karaikudi for the employees of T.N.E. Board serving at Sivaganga in Pasumpon Muthuramalinga Thevar Elecy. Distn. Circle.

X. Scraping of Category of General Superintendent:

In B.P. (FB) No. 30, Secretariat Branch, dt. 9—6—1994, the Board has ordered abolition of the post of General Superintendent thereby making Superintending Engineer/Mechanical post as feeder category to the post of Chief Engineer/Mechanical.

XI. Retention of Usilampatti Division in Madurai E.D.C.:

In B.P. (CH) No. 196, Admn. Branch dt. 1—6—94, the Board has ordered retention of Usilampatti Division in Madural Elecy. Distn. Circle.

XII. Hydro and Wind Farm Allowances:

In B.P. (FB) No. 31, Secretariat Branch dt. 10—6—94, the Board has sanctioned allowances for the field staff of Hydro Power Stations and Wind Farms upto the level of Executive Engineers who are actually serving in the respective fields for more than a year (i.e.) from 1—5—1994.

XIII. Rivision of Pay Scales—Impounding of D.A. for those whose Pay Crosses Rs. 3,500/-

In B.P. (FB) No. 33, Secretariat Branch dt. 15—6—'94 the Board has ordered impounding of DA arising consequent on the revision of pay scales for those employees whose pay crosses Rs 3500/- for the period 12/92 to 4/94 and this may be recovered in 60 monthly instalments with effect from the pay bill of July 94'. For those employees who have less than sixty months for superannuation it will be recovered in higher equal proportionate instalments spread over the remaining period of service.

XIV. T.A.—Classification of Grades of Employees Consequent on the Revision of Pay Scales:

In B.P. (CH) No. 161, Secretariat Branch dt. 23—6—'94, the Board has modified the classification of employees for the purpose of drawal of TA.

XV. Medical Allowance—Enhancement:

In B.P. (CH) dt. 170 Secretariat Branch dt. 25—6—'94, the Board has enhanced the Medical Allowance for those who opt out of medical reimbursement scheme from Rs. 15/- to Rs. 30/- per month with effect from 1—4—1994.

XVI. Applicability of Tariff in Respect of Hospitals under the Control of Municipality/Corporation/Panchayat Union/Government Veterinary Hospitals/Leprosy Sub Centres:

In B.P. (FB) No. 173, Technical Branch dt. 18-6-94 the Board has ordered application of HT Tariff II/LT Teriff VII for hospital under the control of Municipality/Corporation/Panchayat Union, Government Veterinary Hospital and Leprosy Sub Centres.

XVII. Delegation of Powers to Executive Engineers of Construction and Project Circles and Assistant Accounts Officers of Project Circles;

In B.P. (FB) No. 37, Secretariat Branch dt. 27—6—'94 the Board has enhanced the monetary limit for passing of fuel bills to Rs. 10,000/- for Executive Engineers of G.C.Cs. and Projects and for A.A.Os. of Project circles.

XVIII. Medical Allowances to Pensioners/Family Pensioners:

Sub: Tamil Nadu Electricity Board—In-ordinate delay in handing D.Ps. cases by the Enquiry Officers—Periodical Progress Reports—Format—Prescribed.

In an enquiry conducted by Vigilance Cell, Tamil Nadu Electricity Board or by the Directorate of Vigilance and Anti Corruption, if the allegations against employees of the Board are substantiated, the Chief Engineer/Superintending Engineer or the Head of Office concerned is required to initiate departmental action on the erring staff and the matter is followed up by Vigilance Cell. In B.P. Ms. No. 142, (S.B.) dated 13—4—87 a time limit has been prescribed for disposal of DP cases.

2. Abnormal delays have been noticed time and again in dealing the DP cases against the erring Board staff. In many cases of D.Ps. no progress was seen for months together and many D.Ps. are kept unseen, uncared and un-attended which is not a good sign to correct the erring staff. Added to that, there is no agency to review such related D.Ps. critically. In order to change such state of affairs, each Superintending Engineer shall with effect from June '94 furnish a quarterly statement of D.P. cases that have reached enquiry stage in the format to Vigilance Cell so as to make a very critical review of such long pending D.P. and to pull-up the enquiry officers who have been delaying the cases for months together and to cause expeditious disposal of the D.Ps. The first quarterly report for the period ended 30—6—94 shall be sent by all Superintending Engineers and heads of offices so as to reach IGP/Vigilance before 10th July, 94.

Sub: OFFICE PROCEDURE—Instructions based on Tamil Nadu Electricity Board Office Manual—Issued.

Ref: (Per.) B. P. (Ch.) No. 298 (Sectt. Branch) dt. 31-12-1991.

The Tamil Nadu Electricity Board, Board Office Manual was published in 1991 and all the offices of the Tamil Nadu Electricity Board were instructed to follow the procedures laid down in the Manual. During 1991, a revised comprehensive Manual incorporating all instructions/orders issued from the date of formation of Tamil Nadu Electricity Board has been prepared, printed and sent to all

offices for strict adherence of the procedures. Then training classes were conducted to all the staff who were attending to Administrative works relating to a paper from receipt to disposal. During the training, it was found that the provisions laid down in the Tamil Nadu Electricity Board Office Manual have not been followed in the field offices. Moreover, it appears that the Controlling Officers have also not insisted and shown any interest in following the procedures laid down in the Office Manual. In these circumstances, it has become imperative to indicate the following important points for strict adoption in day to day paper work in all the offices of the Tamil Nadu Electricity Board:

- (i) Arising references which originate from a file should be assigned a "Current Number" and registered in the Personal Register.
- (ii) Whenever a draft D. O. letter is put up to the officer, only "Dear Thiru/Tmty/......" should be written as per existing orders.
- (iii) The closed papers whenever put up for reference should bear one flag only on the cover or the wrapper of the closed paper and affixed with the help of a paper fastner. No flag should be affixed to the running files whenever the pages are to be referred to.
- (iv) All tappals received in an office should be assigned a number from a common numbering machine which is set to print twice the same number, one on the tappal and the other on the Tappal Distribution Register.
- (v) (a) Whenever "Current Numbers" are assigned over the tappal, the following reference should **not** be written in the Master Control Register by the Tappal Junior Assistant:—
 "Date SI. No. From whom Subject Ref. No. To whom"
 - (b) Important tappals, Court cases, D. O. letters etc. received from Headquarters office should be entered in a separate register maintained by Personal Clerks/Personal Assistants/Executive Assistants/Stenographers etc. and they should be handed over to the concerned sections after getting acknowledgement from the section.
 - (c) The Master Control Register should be maintained as indicated below: -

Entries should be made every day.

- (vi) (a) A fly leaf containing year, name of section, seat, subject, name of section head, name of Assistant and the date from which they are 'working should be typed and pasted on the first page of the Personal Register.
 - (b) All columns in the Personal Register should be entered. The SI. No. should be assigned in red ink, only to the fresh currents. The programme of submission of Personal Register, Reminder Diary, Call Book Register etc. should be pasted in the inside cover of the Personal Register. Certificate regarding carry over of the pending items from the old Personal Register to the new Personal Register should be furnished by the Section Officer/Section. Head on the first page as soon as the pending items are carried over during February every year.
- (c) While registering the current, the following should be followed:—
 Current No. in Col. (2), the date on which it was received by the dealing Assistant/
 Junior Assistant in Col. (3), a brief subject in Col. (4) from whom received with reference number and date in Cols. (5) and (6) should be entered in blue ink or black ink. Whenever, file is submitted and returned to the section, the dates should be invariably entered in Cols. (7) and (8).

Whenever any reference is issued, if it is first reference calling for certain details it should be entered in Cols. (9), (10) and (11) in blue ink or black ink. Simultaneously, when further action to be taken should be indicated in pencil in Col. (15) such as "R. D.*/Dt." or "N. R.@/Dt." and in the Reminder Diary under such date the "C. No. and year" should invariably be entered.

When a reply is received, if it is an interim reply, it should be entered in Cols. (12), (13) and (14) in red ink (or) if it is a final reply it should be entered in blue ink (or) black ink. As soon as final orders are issued/final reply is sent, this should be entered in blue ink (or) black ink in Cols. (9), (10) and (11) simultaneously making entry under Col. (15) the form of final issue with date such as "L-3/Date" in red ink. As soon as it has been written, the "Current No." in Col. (2) should be rounded off in red ink.

- (vii) The final reply if it is a letter it should be issued only as indicated below:—
 "Lr. No. 234/Adm. I (2)/94-3 dt.............." and not as "Lr. No. SE/KEDC/EA/
 SI. No. 22/D. 20/Postings and Transfer/500/92-93 dt............" as being done now.
- (viii) Whenever a regular note is submitted for approval, the "C. No." should be written on the top left hand corner of the front page and top right corner of the back page. The Section, Assistant No. such as "Adm. 1 (2)" should be written on the top right hand corner of the front page.
- (ix) If any previous papers are put up, such papers are to be referenced in pencil in the left hand side margin. For drawing attention to any reference from put up paper in current file, they should also be referenced in pencil in margin.
- (x) Whenever query is raised, such query should be answered in continuation of the note if there is a note file. If there is no note file to answer the query, a note file should be started.
- (xi) The current file pages are to be numbered in red ink and the note file pages in blue or black ink. The paragraph in the note file should be continuously numbered.
- (xii) As soon as any interim reply is sent or final order is issued it should be invariably entered in the note file as "Issued as Lr. No......etc." and it should also be referenced in pancil in the margin.
- (xiii) Verbattum repetition what has been stated in the current should not be done in the note file. Routine note (O.N.) should be written in the current where the space is available.
- (xiy) As soon as final reply or final order is issued after making entry in Cols. (12), (13) and (14) in blue ink and in Col. (15) in the abbreviated form in red ink and after rounding off the current number in Col. (2) in red ink the papers to be docketted and closed and sent to the Record Clerk for safe custody in the Record Room.
 - (xv) The Record Clerk will acknowledge the closed paper in the Col. (16) itself with signature and date.
- (xvi) The letter form is to be issued to address the officers of the State/Central Government or any other Public Sector departments, consumers etc. After body of the letter is completed on the right side "Yours faithfully" should be mentioned in all letters.
- (xvii) The fair copies in all routine cases can be signed by the Section Head concerned.
- *(xviii) The Memo. form should be used only when communicating any order from the superior officer to the lower level Office/Office/individual.
 - (xix) In issues (Fair copies) such as Memo. or U.O. Note etc. it should not be indicated as "Sd/-" above the name and designation of the officer who has approved the draft. After indicating the name and designation of the officer, the address entry to whom it is to be sent should invariably indicated at the left hand side and then "True copy:: Forwarded:: By order" should be typewritten and the copy should be authenticated by the Section Head. The format indicated vide para. 8.06 of the Tamil Nadu Electricity Board Office Manual should be followed.
 - (xx) Required number of fair copies alone should be taken by the Typist and when the draft is extensively corrected, the Typist can type an extra copy. If number of fair copies to be taken exceeds ten, it should be stenciled.

- (xxi) Copies of order on disciplinary proceedings cases should be signed by the officer who has imposed the penalty as Disciplinary Proceedings Authority.
- (xxii) No paper for despatch should be retained for more than 24 hours. Letters both official and D.O. should be despatched before 4.30 p.m. on the day of receipt itself.
- (xxiii) On the cover, the despatcher should invariably put "OIGS".
- (xxiv) Whenever franking machine is used, bearest minimum of required stamps aloneshould be kept for urgent use and register for franking machine and stamp accounts should be maintained.
- (xxv) The Personal Register should not be used as despatch register, Master Control Register etc.
- (xxvi) All the docket sheets indicated in the Tamil Nadu Electricity Board Office Manuals should be printed and supplied.
- (xxvii) A current should be disposed off within five days from the date of receipt by the Assistant/Junior Assistant. If not disposed off within five days it should be brought to the notice of the Officer-in-charge of the section through Daily Detention List.
- (xxviii) Whenever a reply is expected from the outside office only after a period of threemonths, such cases shall be closed after getting approval from the controlling officerand after making an entry in the Call Book Register and the Current No. in the Personal Register should be rounded off.

 - (d) The entries in the Service Book have been standardised and the instructions issued therefor and published in the Gazette should be scrupulously followed.
 - (e) Check list ordered for settlement of Terminal Benefits published in July 1988-Gazette should be scrupulously followed for 100% settlement.
 - (f) The Typist should maintain the Out-Turn Register in the form prescribed therefor as published in the Gazette along with Typewriter Machine Card in duplicate as laid down in para. 15.17 of Tamil Nadu Electricity Board Office Manual.
 - (g) Economy in usage of stationery should be adopted as detailed in para. 17.07 of Tamil Nadu Electricity Board Office Manual.
 - 3. All the Controlling Officers in charge of the Circles, Division, Sub-divisions etc. are instructed to see that all the provisions contained in Tamil Nadu Electricity Boards Office Manual are implemented in day to day work along with the salient points mentioned in para. 2 above. They should ensure that the provisions are scrupulously followed. Deviation, if any, in implementing the procedures will be viewed very seriously.

The post held by the senior most Superintending Engineer/Mechanical was upgraded as General Superintendent and the incumbent was promoted and posted in that upgraded post. But there is no post of General Superintendent on Electrical or Civil side. In 1991 one post of Chief Engineer/Mechanical was created. Thereby the General Superintendent/Mechanical had got the line of promotion as Chief Engineer/Mechanical where as on the Electrical and civil sides, Superintending Engineers are directly appointed as Chief Engineers. Consequent on the creation of Chief Engineer/Mechanical, the Superintending Engineers of Mechanical division can also go upto the level of Chief Engineers on par with their counterparts in the Electrical and Civil Divisions. Sub: Tamil Nadu Electricity Board—Cases filed in High Court/Civil Court/Labour Court—Deputing of Board employees on date of hearing—Instructions—Issued.

Several cases are now being filed by the Board employees in High Court/Civil Court/Labour Court on matters relating to their service conditions like promotion, transfers, fixation of seniority, etc. Considering the number of cases being attended to by the Standing Counsels/Govt. Advocate in the High Court/Civil Court/Labour Court etc., it is felt necessary that they should be briefed of salient points to be putforth before the referred Courts and also be assisted by deputing the concerned departmental officers with all relevant materials, records, rules, etc. so that the stand of the Board is clearly brought to the notice of Standing Counsels and Government Advocates.

- 2. It is also observed that at present officers dealing with the subject are not being deputed to the respective courts in time to assist the Standing Counsels and Government Advocate. It the materials, records, copies of rules, etc. are given to them on time, they will be in a better position to equip themselves to put-forth the pleas of the Board more effectively. Hence, in future whenever the cases come up for hearing before the courts, the concerned officer conversant with the subject should be deputed to the court on the day prior to the date of hearing for briefing the Standing Counsel/Government Advocate concerned on the stand taken by the Board besides furnishing relevant rules and materials required by them. The officers should be asked to attend the Court on the day of hearing also so that they could furnish any information that may be required by the Standing Counsel/Government Advocate during the course of hearing.
- 3. However, deputation of officials from places outside Madras City to attend the High Court/Civil Courts/Labour Court work may not be resorted to as a routine but should be only based on the importance of the case. The above instruction shall be adhered to strictly.

Rule — 9: Right of Government to withhold or withdraw pension.

- (3) No Judicial proceedings if not instituted while the Government servant was in service, whether before his retirement or during his re-employment, shall be instituted in respect of a cause of action which arose, or in respect of an event which took place, more than four years before such institution.

Note: (2) If an officer against, whom an enquiry is held is unable to satisfactorily account for possession by himself or by any other person on his behalf, e.g. dependants, or pecuniary resources or property disproportionate to his known sources of income, a charge of corruption should be presumed to have been proved against him and the case will come within the purview of this rule. The position is that the term "grave misconduct" used in this rule is wide enough to include corrupt practices. In cases where the charge of corruption is proved only after pension has been sanctioned and it is not therefore possible to invoke the provisions of rule 6, action to withhold or withdraw pension may be taken under this rule. In this connection the provisions of Rules 9(2) and 9(3) are to be noted carefully. In accordance with these provisions the property or pecuniary resources in respect of which the departmental or judicial proceedings are instituted under rule 9 should have been acquired by the person concerned or any other person on his behalf any time within the period of four years before the institution of such proceedings if not instituted while the Officer was on duty either before retirement or during re-employment.

In the Board's Proceedings cited, the scales of pay and allowances of the employees of the-Board were revised with effect from 1-12-92. While fixing the pay in the revised scale on 1-12-92 or on the opted date either by fixation or subsequent increase of pay in the revised scale, the pay of certain groups of employees may croses from a stage of pay in the pre-revised/revised scale, which is less than Rs. 3,500/- to a stage of pay in the Revised scale, which is Rs. 3500/- or more. In such circumstances, impounding of Dearness Allowance as per the orders already inforce will arise.

- 2. A question has been raised whether such impounding of Dearness Allowance has to be done even when the quantum of increase of wages per month due to fixation in Revised Scale is less. than the quantum of the amount to be impounded per month.

Considering the hardship to the employees, who have to pay huge amount from their pockets. as impounded Dearness Allowance, it is hereby ordered that the amount to be impounded for the period from 12/92-4/94 shall be recovered from their future pay in 60 (Sixty) monthly instalments with effect from the pay bill of July'94. For those employees who have less than sixty months for superannuation it will be recovered in higher equal proportionate instalments spread equally over the remaining period of service.

I am to state that the Accountant General in his letter cited has sought for clarification as towhether the share of Life Time Arrears due to deceased son can be paid to his legal heirs. The Accountant General has stated that one of the sons who was eligible to receive a share of life timearrears expired subsequently before receiving his share and a claim has been made by the legal heirs of the son who expired viz. his wife for his share of life time arrears. The Accountant General, Tamil Nadu has also stated that so far as the payment of Death-cum-Retirement Gratuity is concerned the Government of India has held that the share payable to the members of a family who dies or become disqualified before the date of payment, should be distributed equally among the remaining members of the family. However a similar ruling inrespect of payment of life time arrears of family pension has not been issued by the Government of India.

2. In letter No. 4341/Pension/93-7, Finance Department, dated 7-3-94 it was clarified to the Accountant General Tamil Nadu that the share of life time arrears of family pensions due to the deceased son shall be distributed equally among the remaining members of the family. Accordingly, I am to inform you by way of clarification and guidance that where one of the legal heirs of a family pensioner who was eligible to receive a share of life time arrears expired subsequently before receiving his share and a claim has been made by the legal heirs of son who expired, the Life Time Arrears of family pension can be paid to his legal heirs.

ORDER:

The Government have provided power tariff concession for a period of three years to new industries with the intention of attracting establishment of more number of industries in Tamil Nadu. The Government have recently been examining the negative effect of power tariff concession provided to new steel industries. It is noticed that old steel industries could not compete with the new steel Industries, which enjoy tariff concession and, therefore, many of the steel industries close down their industries after their tariff concession period of three years is over.

2. The Government, after careful consideration, have decided that the tariff concession provided to the new industries under High Tension Tariff—I shall be withdrawn in respect of steel industries only, and to issue necessary amendment to the Schedule to the Tamil Nadu Revision of Tariff Rates on Supply of Electrical Energy Act, 1978 (Tamil Nadu Act 1 of 1979).

3. The following Notification will be published in an extra-ordinary issue of the Tamil Nadus Government Gazette dated the Eighteenth May, 1994.

Notification

In exercise of the Powers conferred by Section 4 of the Tamil Nadu Revision of Tariff Rates on Supply of Electrical Energy Act, 1978 (Tamil Nadu Act I of 1979), the Governor of Tamil Nadu hereby makes the following amendment to the Schedule to the said Act.

2. The amendment hereby made shall come into force on the Eighteenth May, 1994.

Amendment

In the said Schedule, in "Part. A—High Tension Supply" under the heading "High Tension Tariff -I", under the sub-heading "Tariff concession for High Tension Industries coming under High Tension -I.", in item (c) after sub-item (1), the following sub-item shall be inserted, namely:—

With refer to your letter cited, the following clarifications:

Points raised SI. No.

- (1) The procedure of assessing the left out services in the previous assessments.
- If it is assessed subsequently later date, the procedure to be adopted for billing/payment etc.

- Whether the previously left over services may be kept unassessed continuously till the issue is settled.
- (4) Action to be taken against the Assessors (who are refusing to do assessment of allotted services in each Cycle, where the allotted No. of services is over and above the norms prescribed.

Points clarified

The left out services of the previous assessments may be assessed in the next Bi-monthly assessment on priority,

If the assessment is made subsequently (once in 4 months or 6 months) it should be ensured that the consumption should be devided by the No. of bi-monthly assessments./the charges assessed accordingly In this connection reference is invited to this office Lr. No. CFC/Rev./CB/F. 5/52/94-dt. 20-4-91 in respect of door locked cases that the procedure outlined holds good for this also.

Priority should be given for the previously left over services unassessed and action to be taken to assess them, so that the burden of the consumers can be reduced.

As per Para-13-C of Annexure-I to B. P. Ms. No. 74, dated 25-8-87 pro-rata wages shall be paid for assessment in excess over the norms for the Cycle. As the Unions have been agreed for assessing the excess over services by the Assessors on payment of pro-rata wages disciplinary action should be taken against those individuals.

(5) The procedure to be adopted to tackle the grievencies of consumers if they approached through consumer protection Council/Court of the local area.

The assessment to be made deviding the total consumption by the bi-monthly and charges to be made accordingly. The consumers may be permitted to pay the amount. based on the bi-monthly assessment left over. If the Assessment is made for 4 months/ 2 bi-monthly assessments, the consumersmay be permitted to pay in two instalments. In the cases of services for which assessment: is made for six months the consumer may be permitted to pay in 3 instalments and so on. By this the consumer will not be put into hardship. However, close monitoring is very essential through instalments register toensure that such instalment payments arepromptly made by the consumers. For suchinstalment no interest is leviable out of the instalments payment is not made on or beforethe due date, interest for belated payment @ 11 per month has to be levied without. any omission.

Sub: Delay in processing of tenders-Regarding.

It is observed that there is considerable delay in processing of tenders leading to cost escalation and other complications. It is also noticed that unnecessarily two part tender system is adopted even for standard and BIS certified items resulting in delay in finalisation of tenders. In this connection the attention of the Chief Engineers is invited to the B.P. (FB) No. 57, Technical Branch dt. 2—4—1990 wherein instructions have been issued to adopt single part tender system for standard BIS certified items.

All Chief Engineers are therefore instructed to ensure that these instructions are scrupulously followed and ensure that the delays in finalisation of tenders are avoided. It is necessary that the tenders are finalised within the initial validity period itself and only in unavoidable circumstances validity extension is sought for.

The State Government while reviewing the achievement of agriculture pumpset connections during 1993-94 under 20 point programme upto the end of November 1993 remarked that proportionate target has not been achieved. REC has pointed out the same thing. Hence, it has been decided that

50% of the pumpset target (ie) 20,000 numbers may be allocated for effecting service under special priority scheme with mere service connection and one pole extension cases simultaneously and the schemes which are normally implemented from October onwards can be taken up straightaway from June 1994 onwards.

The following instructions are issued.

- (1) Out of the target of 40,000 agricultural pumpsets to be energised during 1994-95, 20,000 pumpsets shall be, energised under normal priority and the balance of 20,000 pumpsets under special priority scheme of on line/one pole extension. The district—wise targets already communicated in the memo. cited (5) may be followed.
- (2) The investigation for both mere service and one pole categories may be taken up simulaneously and notices may be issued strictly according to their priority of registration of applications.
- (3) Accordingly, the targets for each Division under the mere service connection (on-line category) and one pole extension shall be 50% of the Division target fixed. In case of shortfall in any of the Division; Superintending Engineers can redistribute the target under this category to other Divisions and in case of shortfall in a Circle, the Chief Engineers/Distribution of the regions can reallocate among circles in their regions without affecting the district targets.
- (4) The notice period for this category shall be 45 (forty-five) days. Notice for reporting readiness shall be issued in such a way that the expiry date for the 45 days shall not go beyond 31—10—94.
- (5) All ready cases under this scheme should be effected supply on or before 28—2—95 and the total number of pumpsets connected shall not exceed the target fixed under this scheme.
- (6) All other instructions issued in the Circular memo, first cited for the implementation of the special programme during 90-91 may be followed for this year's programme also.
- (7) The Chief Engineers/Distribution/are requested to programme the service connections for the agricultural pumpsets such that both the schemes viz. connections coming under special priority envisaged in this Circular memo, as well as connections coming under normal priority are given side by side. The progress of these services may be reported separately to the Superintending Engineer/Rural Electrification & Improvements (Distribution). All pumpsets coming under this special priority scheme shall be effected before 28—2—95 and there shall not be any carryover to next year.
- (8) The Chief Engineers and the Superintending Engineers are requested to take immediate action to implement the above scheme.

Sub: Compensation charges for violation and penal charges for theft cases—Reduction—Regarding.

According to the Terms and Conditions of supply the compensation/penal charges have to be levied as below:

Clause 5.00 : Compensation charges for violation based on the consumption for a period of six

months preceding the date of detection or date of service connection whichever

is less.

Clause 9.00 : Extra levy for theft of energy to be made for a period of 12 months or from the

date of service connection the date of detection whichever is less.

According to Clause 11.0 of the Terms and Conditions, the appellate authorities are Superintending Engineer for LT services and Chief Engineer for HT services. As per clause 13.0 the appellate authority will dispose of the appeal (confirm, modify or set aside the assessment) after due enquiry and has to furnish the reasons leading to the conclusion arrived at by him.

Of late it has been observed that in a number of cases the appellate authorities are modifying the assessment on the lower side without foolproof evidence for the same resulting in loss of revenue to the Board. This also puts the management in an embarassing situation of taking action against the officers at the time of their retirement.

In order to safeguard the interests of the Board, it is instructed that the appellate authority should not normally modify the assessment and wherever the assessment has to be modified then such modification should be based on foolproof evidence and wherever the assessment has to be reduced by 25% or more, then in such cases the reduction in assessment should be done only with the approval of the Chairman.
