#### VII Counting of Military/War Service

In Memo. No. 3670-N1/94-2 dt. 5-3-1994, the Board has adopted the G. O. Ms. No. 903, Finance (Pension) Department dt. 31-12-93 according to which the Military/War service rendered should be counted for pension even to those retired prior to 13-5-1991 and they are eligible to draw consequential arrears with effect from 13-5-1991.

#### VIII. Agricultural Services—Issue of 90 Days Notice to Special Priority Applicants:

In Memo. No. SE/IEMC/EE3/AEE2/AE/FV36/D76/94 dt. 17—3—1994, the Board has ordered that all the wells coming under the Special priority category based on Government Orders and recommended by the authorities of the concerned departments have to be inspected by the AEE/AE before issue of 90 days notice in order to ensure that they are eligible for the Special Priority.

#### IX. Effecting of Additional Load for Agricultural Services coming under SFS:

In B. P. (FB) No, 74, Technical Branch dt. 10—3—1994, the Board has ordered that in respect of additional load in agricultural services under SFS, the estimated cost of extension for the additional load should be collected and supply extended on priority. A sum of Rs.150 per HP per year should also be collected.

#### X, Purchase of Stores-Purchase Preference:

In Circular Memo. No. SE/MMI/EE\$/A3/FSCI&PI/D680/94 dt. 18—3—1994 the Board has communicated Government Letter No. 354/BPE/94-1 dt. 25—2—1994 wherein the Government has exempted the Tamil Nadu Electricity Board from the operation of the orders issued in para 4 (e) of the G. O. Ms. No. 330, Finance (BPE) Department dt. 3—5—1991 subject to that the TNEB should buy only from the registered SSI Units in Tamil Nadu by Open Tender.

## XI. Enhancement of Initial Security Deposit and Change of Nomenclature of Security Deposit:

In B. P. (CH) No. 61, dt. 18-3-1994, the Board has ordered change of the nomenclature of security deposit as current consumption deposit and also revision of initial quantum of current consumption deposit for prospective HT/LT consumers.

#### XII. Revision of Miscellaneous Charges:

In B. P. (FB) No. 94, Technical Branch dt. 30—3—1994 the Board has ordered revision of miscellaneous charges for various categories.

**Explanation:**— In cases of Stoppage of increment, when it cannot be effected, if without cumulative effect, the monetary equivalent of the increments ordered to be withheld and if with cumulative effect, the monetary equivalent to 3 times of his increments ordered to be withheld, may be ordered to be recovered. (In the workmen S.Os)

Stoppage of increment or increments with or without cumulative effect.

**Explanation**: In cases where Stoppage of increment with cumulative effect cannot be effected, the monetary equivalent of three times the increment ordered to be withheld may be ordered to be recovered. If the stoppage of increment is without cumulative effect, the monetary equivalent of the increments ordered to be withheld may be ordered to be recovered. (In the clerical staff S.Os)

- 4. Recovery from pay/wages of the whole or part of any pecuniary loss caused to the Board by the negligence of or breach of orders by the workmen.

I invite attention to the references cited wherein detailed instructions had been issued in regard to the procedure to be followed for processing the proposals for employment assistance to the dependants of Board's employees who die in harness.

- 2. Inspite of these above instructions and guidelines, it is noticed that the proposals are not sent to this office in complete shape. The following discrepancies are noticed in most of the proposals. received from the Superintending Engineers.
  - The date of birth of deceased is not furnished against the column provided in Annexure-II. In the absence of this column, it is not possible to ascertain whether the employee died while in service or after retirement.
  - (ii) The age and educational qualification of the applicant should be furnished only after thorough verification, and genuineness. In doubtful cases the concerned educational authorities may be addressed and ascertained the genuineness of records especially the applicant possess VIII Std. passed or below qualification. It is also noticed that some of the educational qualification certificates produced by the applicants are from un-recognised schools. It should be ascertained and verified, whether the certificates produced by the applicants are issued by the recognised institution.
  - (iii) The designation with official seal of the Enquiry Officer is not furnished.
- 3. I also invite attention to the B.P. (Per.) (Ch.) No. 330 (Adm. Br.) dt. 2-11-93 wherein clear instructions were issued with regard to ascertain the indigent circumstances of the families of deceased Board employees and these instructions contained in the B.P. should be followed scruplously, while sending proposal with the necessary certificate from the Tahsildar regarding the property.
- 4. It is requested to adhere the above instructions strictly and send the proposals in complete shape after observing all conditions.

Sub: Loans and Advances - House Building Advance sanction of loan to Government Servants - Inspection of Construction of Building - Instructions - Issued.

· It has been brought to the notice of the Government that one of the Government employees was sanctioned House Building Advance for construction of house and also an additional advance for its completion. The main advance was sanctioned during 1985 and the additional advance was sanctioned in 1987. The loanee Government Servant is reported to have furnished a completion certificate in 1988. On receipt of some allegations against the individual in regard to misuse of the House Building Advance Sanctioned for construction and for completion, it has been found that the advance has not been utilised for the purpose for which it was sanctioned. According to Rule 5(IV) of the rules relating to grant of advances to Government Servants for building etc., the balance of House Building Advance will be payable when the house has reached roof level, provided the HOD/Collector is satisfied that the development of the area in which the house is built is complete in respect of amenities such as water supply, street lighting, roads, drainage and sewerage. According to Rule 7(a)(i) of the rules relating to sanction of House Building Advance, the construction of the house or enlargement of the living accommodation in the existing house as the case may be shall be carried out in accordance with the approved plan and specifications on the basis of which the amount of advance has been computed and sanctioned and that the HOD/Collector may arrange to have an inspection carried out to verify the correctness of the certificates/reports. Had the disbursing authorities inspected the construction work at appropriate stages, the lapse mentioned above could have been averted.

- 2. All the Collectors/HODs/Disbursing Authorities are therefore requested to arrange for inspection of the construction or enlargement of houses, at appropriate stages by the concerned authorities to ensure that the advance sanctioned to Government Servants is utilised in full for the purpose for which it is sanctioned to them.
- 3. The Collectors/HODs are requested to initiate disciplinary action against the Officers concerned for their failure to inspect the construction of house/enlargement etc. at appropriate stages.
- 4. All the Collectors/HODs are requested to acknowledge receipt of this letter and to send a copy of this letter to all the disbursing authorities in their districts.

I am directed to issue the following clarification regarding the levy and collection of Profession Tax for guidance.

#### (i) LIABILITY TO PAYMENT OF TAX FROM 1.4.92

According to sub-section(3) of section 1 of the Tamil Nadu Tax on Professions, Trades, Callings and Employments Act, 1992, the Act shall be deemed to have come into force on the 1.4.92. As such the payment

#### ii) RECOVERY OF TAX IN MONTHLY INSTALMENTS:

According to rules of the Tamil Nadu Tax on Professions, Trades, Callings and Employments Rules, 1992, the drawing and disbursing Officers shall recover the half-yearly tax in the pay bills of the employees for the month of April or October of every year. According to rules, if the pay of an employee was not drawn during October or April the Profession Tax deduction shall be made as and when the pay of the individual is drawn subsequently. There are no provisions to recover the profession tax in monthly instalments.

## iii) INCLUSION OF HOUSE RENT ALLOWANCE AND CITY COMPENSATORY ALLOWANCE FOR CALCULATING SALARY

According to Section 2(7) of the Tamil Nadu Tax on Professions, Trades, Callings and Employments Act, 1992 'Salary' includes pay or wage, Dearness Allowance and all other remunerations received by any person on regular basis, whether payable in cash or in kind and also includes perquisites and profits in lieu of salary as defined in Section 17 of the Income Tax Act but does not include bonus in any form or gratuity. As regards whether House Rent Allowance and City Compensatory Allowance come under perquisites and profits, as defined under Section 17 of the Income Tax Act, 1961, it is stated that the expression 'Profits in lieu of Salary' as defined in sub-section(3) of Section 17 of the Income Tax Act includes any payments due to or received by an assessee from an employer. The definition in sub-section (3) is a comprehensive one by virtue of which all payments made by an employer to an employee, whether made in pursuance of a legal obligator or voluntarily are brought under the caption 'Profits in lieu of salary'. By virtue of the inclusive definition contained in Section 2(7) of the Tamil Nadu Tax on Professions, Trades, Callings and Employments Act, 1992, House Rent Allowance and City Compensatory Allowance have to be included within the term 'salary' for purpose of collecting profession tax under the said Act.

According to entry I in the schedule to the said Act, salary or wage earners whose monthly salary or wage are Rs.1,500/- and above are liable to pay profession tax for the half year at the minimum and maximum rates specified therein. In view of the said provision the employees of the Board employed in areas covered by the Factories Act 1948 (Central Act LXIII of 1948) with a gross monthly salary or wage of Rs.1,500/- and above are liable to the profession tax and the tax is to be deducted from their salaries or wages as per the provisions of the Tamil Nadu Act 24 of 1992.

In the Board's memo. first cited, it was ordered that House Building Advance should not be sanctioned to a Board employee for the purchase of Plot/Flat/Ready Built House from his/her close relatives. The relations which include close relatives have also been indicated therein.

- 2. The Government, in their letter second cited, have ordered that similar orders issued by the Government in the Government letter dt. 28.7.92 will be applicable from the date of issue of the above orders only (i.e. from 28.7.92 only) and that the House Building Advances sanctioned earlier, but the amount not released and application registered prior to 28.7.92 for purchase of Ready Built House/Flat/Plot from close relatives may be entertained.
- 3. Following the orders of the Government, it is hereby ordered that the orders issued by the Board in the reference first cited will be applicable from the date of issue of the above orders only (i.e. from 28.9.92 only) and that the House Building Advances sanctioned earlier, but the amount not released and applications registered prior to 28.9.92 for purchase of Ready Built House/Flat/Plot from close relatives may be entertained.

#### **Proceedings:**

In the B.P. cited, orders were issued sanctioning medical allowance of Rs.15/- per month to the family pensioners whose spouses died in harness and eligible for reimbursement of medical expenses and the family pensioners wish to draw medical allowance till the normal date of retirement of the deceased employees. Time limit upto 28.2.90 was allowed for exercising the option. It was also ordered in para 4 of B.P. cited, that in respect of future cases of death in harness, the pension sanctioning authorities are directed to obtain the option from the family of the deceased employee for payment of medical allowance and to forward the same along with the pension proposal to be sent to pension sanctioning authorities.

2. In supersession of the orders issued in para 4 of the B.P. cited, the Tamil Nadu Electricity Board directs that in case of death in harness occurring on and after 1.4.94, the family pensioners shall be eligible for medical allowance of Rs.15/- (Rupees fifteen only) per month and they will not be eligible for any medical reimbursement.

In the Board's Proceedings read above, orders were issued among other things that when the staff serving in various offices of the Tamil Nadu Electricity Board Complex were deputed for official work within Madras City, they were eligible to claim actual expenses at the rates specified therein. Subsequently in September'90 the above orders were made applicable to all the employees of the Board serving in various offices situated within Madras City limits. In the reference third cited while issuing orders revising the rates based on the orders of the Government of Tamil Nadu, it was also ordered therein that in future, the employees of the Board who are deputed for official work within Madras City shall be permitted to claim actual expenses of Autorickshaw/Taxi charges prevailing at the time of claim consequent on revision by Government of Tamil Nadu.

I am directed to state that in the order first cited, Government permitted the Government servants, to raise private loans, purely as a temporary and urgent measure, after applying for House Building Advance but before its sanction, subject to the condition that the property should be free from encumbrance and the deed shall be executed as per House Building Advance Rules.

- 2. In the reference 2nd cited, it has been clarified that loans from the institutions like LIC, HDFC or co-operative Housing Societies which lend for Housing purposes cannot be considered as private loans raised as an urgent measure.
- 3. In the reference 3rd cited, the Collector of Madras has requested clarification as to whether House Building Advance can be sanctioned to those applicants who have already availed loans from Can Fin Homes Limited, HDFC, LIC Ind Bank Housing Limited etc.
- 4. It is clarified that House Building Advance may be sanctioned to those Government servants, who raised private loans from financial institutions by mortgaging the house property, prior to the issue of Government instructions, in the reference 2nd cited (i.e. before 3.8.90), subject to the condition that they should release the house property and mortgage it to Government immediately on sanction of House Building Advance by Government, as per House Building Advance Rules.
- 5. This order issues with the concurrence of Finance Department vide its U.O.No.12202/Sal.I/93-1, dt. 27.12.93.

#### ENERGY DEPARTMENT

AMENDMENT TO THE SCHEDULE TO THE TAMIL NADU REVISION OF TARIFF RATES ON SUPPLY OF ELECTRICAL ENERGY ACT.

(G.O.Ms.No.35, Energy(A-2), 1st March 1994, Maasi 17, Srimuga, Thiruvalluvar Aandu-2025.) No.II(2)/EGY/717(g)/94.

In exercise of the powers conferred by section 4 of the Tamil Nadu Revision of Tariff Rates on Supply of Electrical Energy Act, 1978 (Tamil Nadu Act I of 1979), the Governor of Tamil Nadu hereby makes the following amendment to the Schedule to the said Act.

2. The amendment hereby made shall come into force on the 1st March 1994.

#### AMENDMENT.

In the said Act, for the Schedule, the following Schedule shall be substituted, namely:—

#### THE SCHEDULE.

(See section 3)

#### PART A-HIGH TENSION SUPPLY..

#### High Tension Tariff I:

Registered factories, tea estates, textiles, railway tractions, fertilisers, Salem Steel Plant, Heavy Water Plant, Caustic Soda, Calcium Carbide, Aluminium and Potassium Chiorate and all other industrial establishments.

Tariff concession for High Tension Industries coming under High Tension Tariff I.—(a) In the case of new High Tension Industries to be set up in the areas other than the Madras Metropolitan areas, the following concessional tariffs shall be charged for the first three years from the date, the consumer is given service connection under high tension tariff I:—

For the First year	• •	••	60 per cent of the High Tension rates.
For the Second year			70 per cent of the High Tension rates.
For the Third year	•••		80 per cent of the High Tension rates.
For the Fourth year			Full Tariff.

The above concession shall apply to both unit rates and maximum demand charges. This concession shall not however, be applicable to an industry set up before the 3rd May 1989. The Concession shall not also be applicable to a consumer, who utilises power from his own generating units or makes other arrangements for production purposes and utilises the power supplied by the Board for auxillary purposes only:

Provided that the High Tension Industries set up in any area (including industrially under developed area, notified as such by the Government) before the 3rd May 1989 which are availing tariff concessions or reduction under High Tension Tariff I as on the 2nd May 1989, shall continue to avail the said tariff concession or reduction until the expiry of the period of five years from the date the consumer is given service connection under High Tension Tariff I.

Explanation.—For the puropse of Electricity tariff concessions for new industries the term 'new industries' shall mean a new investment by any entrepreneur including by an existing industry in any area other than the Madras Metropolitan areas, provided the assets other than cash, of the existing industry, are not transferred and shown as assets of the new industry.

(aa) The tariff concession shall be applicable to expansion of industry also to be set up in any city, municipality, township or panchayat union limit other than the Madras Metropolitan areas in which the main industry is functioning, provided the assets, other than cash of the existing industry are not transferred and shown as the assets of the expansion:

Provided that the tariff concession shall be applicable only once, to a new industry or an expansion of the industry in the area comprising the satellite town of Maraimalai Nagar New Town developed by the Madras Metropolita Development Authority, irrespective

Provided further that the concession for the expansion of industry shall not be applicable to the existing industry availing the concession for the additional load in the High T ension service for its expanded activity beyond the period of three years or five years, as the case may be, as specified in item (a) and the proviso thereto, respectively.

Explanation.—The term "expansion" shall mean an increase in production which results in an increase of 25 per cent or more in the consumption of electricity by the industry with reference to the highest electricity consumption of such industry in the three completed financial years preceding the application:

- (a) A Low Tension Industry converted into a High Tension Industry is not eligible for the concession.
- (b) New Industry to be set up in the areas other than the Madras Metropolitan areas which will work night shift only and existing industry, which is introducing night shift only between 9-30 p.m. of a day and 5.30 a.m. of the next day, shall be given a further concession of forty percent of the appropriate rate for energy consumed during night shift only for a period of seven months from July to January during the period of five years. This concession shall apply to energy rat arrived at after giving the concession referred to in sub-item (a) for new Industries:

Provided that in respect of those having one day shift and one night shift, the night shift concession shall stand reduced from forty per cent to twenty per cent.

Explanation.—For the purpose of this clause "Existing Industry" means an industry which has not completed five years from the date the consumer is given service connection and which is still eligible to the concessional tariff rate.

- (c) (i) The new industries to be set up in the Madras Metropolitan areas shall not be eligible for any tariff corcessions.
- (ii) If the consumer availing High Tension Supply under this tariff does not for any reasons, utilise the power load for more than thirty days, then the energy utilised in the service for lighting and non-industrial purposes shall be billed under High Tension Tariff VII.
- (iii) In the case of supply under High Tension Tariff-I, the usage of electricity for bonafide purposes of lighting, heating and power loads in the residential quarters within the factory or estate premises shall be metered separately by the Consumer, taking High Tension Supply and paid for to the Board at Low Tension Tariff I. The units so metered shall be deducted from the total number of units registered in the main meter of the High Tension Supply for billing purposes.

#### High Tension Tariff 11:

Recognised educational institutions, hostels run by recognised educational institutions, Government Hospitals, actual places of public worship, orphanages, public libraries, water works, public lighting and such other institutions declared by the Government from time to time.

General provisions applicable to consumers covered under High Tension Tariffs I to VII-

- (i) Any High Tension Supply involving a sanctioned demand above 5,000 KVA plus 2 per cent marginal adjustment shall be given supply only at 33 KV, if available in the area or at EHT Voltage.
- (ii) Time limit to avail supply at 33 KV or EHT Voltage—(a) Category 1.—Existing High Tension Consumers, whose senctioned demand exceeds 5,000 KVA have been given time limit upto 31st August 1985 to avail the supply at the voltage indicated in item (i) above.
- (b) Category 11.—Existing High Tension Consumers whose sanctioned demand is 5,000 KVA or less and who require additional demand by which the total sanctioned demand would exceed 5,000 KVA shall be given the additional demand only after they are ready to avail the supply at the voltage indicated in item (i) above.
- (c) Category III.—New High Tension Consumers requesting supply for a demand above 5,000 KVA shall be given supply only at the voltage indicated in item (i) above.
- (iii) Extra Levy—(a) Category. I—In the case of existing High Tension Consumers whose sanctioned demand exceeds 5,000 KVA and who do not avail supply at the voltage indicated in item (i) within the stipulated period they shall be charged an extra levy of three paise per KWH over and above the normal tariff, for the entire energy consumed.
- (b) Category 11.—The existing High Tension Consumers whose sanctioned demand with the additional demand sanctioned exceeds 5,000 KVA may with the approval of the Board be allowed the additional demand at the high Tension Supply itself for a period not exceeding 12 months from the date of sanction of the additional demand, provided they agree to be charged the extra levy of three paise per KWH over and above the normal tariff for the entire energy consumed till they avail the supply at 33 KV or at EHT voltage as may be applicable.
- (iv) Power Factor/Low Factor Surcharge.—In respect of High Tension Service connections, the average power factor of the consumers installation shall not be less than 0.90 lag. Where the average power factor of High Tension Service Connection is less than the stipulated limit of 0.90 lag the following compensation charges will be levied:—
  - 0.90 lag and below and up to 0.85 .. 1 per cent of the current consumption charges for every reduction of 0.01 in power factor.

  - Below 0.75 ..... 2 per cent of the current comsumption charges for every reduction of 0.01 in power factor from 0.90.

Current consumption charges include the charges of recorded demand and the energy charges at notified tariff rate excluding concessions, if any.

The compensation charges for low power ractor will be levied after three months from the date of coming into effect of this tariff notification.

(v) Billable Demand:

The maximum demand charges for any month and at the point of supply shall be based on the KVA demand recorded in that month or 100 per cent of the sanctioned demand whichever is higher. The above 100 per cent demand charges will be effective from June 1994 monthly reading onwards.

(b) Agriculturists shall be permited to use the water pumped from the well and stored in overhead tanks for bonafide domestic purposes in the farm house. The farm house shall be in close proximity not exceeding 150 feet from the well.

Explanation-II—Extra lighting in agricultural service over the permissible limit shall be charged for, if separately metered as per Low Tension Tariff-IX. If not separately metered on a flate rate of Rs. 10 per month per 40 watts lamp (ordinary), larger wattage of lamps in proportion. #### Proceedings:

In exercise of the powers conferred by section 49 of the Electricity (Supply) Act 1948 (Central Act L IV of 1948) the Tamil Nadu Electricity Board issues the following Amendment to the Terms and Conditions of

supply of Electricity as notified in B.P.Ms.(FB) No.61, (Administrative Branch), dated 24.12.88 and published in part VI sections (b) of the Tamil Nadu Government Gazette dated 1.3.89.

This amendment shall come into force with immediate effect.

#### **AMENDMENT**

"The following shall be included at third paragraph under clause 9.02 of schedule Part-I.

In cases of theft of energy committed by the persons other than Board's consumers, in the event of Temple festival, marriage function and any other occasions which are incidental in nature, the period of theft shall be decided on the basis of periods of existance based on the proof of erection and existance of such loads. The compensation charges shall be levied as per clause 9.03 duly limiting the duration in days for the period of theft to be decided based on the proof of erection and existance of such loads, and at the rates indicated in clause 9.02 - 1 (a) of schedule Part-I of Terms and Conditions of supply of Electricity''.

It is seen from the Monitoring Cell Return DM/M/407 for the period ending January 1994 that there are 30062 services are without meters of which 2 relate to H.T. services and 585 relate to L.T. power services. It is to be informed that in all H.T./L.T. power and commercial services, priority should be given to ensure that the meters are provided immediately and a report sent to this office. Steps should be taken to provide meter in all the services before 31.3.1994. Whenever defects are noticed in the meters they should be attended to on priority and replaced immediately so that the losses could be controlled.

- 2. The above G.O. does not cover the collection of cost of extension for effecting additional load to the agricultural services effected under Self Financing Scheme.
- 3. Accordingly, electrical energy supplied to the Municipal Licencess by the Tamil Nadu Electricity Board will be charged at the revised tariff with effect from 1.4.94 as indicated below.

As per para IV of the General Provisions applicable to consumers covered under High Tension I to VII the average power factor of consumer installation shall not be less than 0.90 lag and compensation charges at the rates indicated in the G.O. will be levied if the power factor is less than the stipulated limit of 0.90 lag with effect from 1—7—94.

As per para (v) General Provisions applicable to consumers covered under High Tension I to VII the maximum demand charges for any month and at the point of supply shall be based on the KVA demand recorded in that month or 100% of the sanctioned demand whichever is higher. The above 100% demand charges will be effective from July' 94 monthly readings onwards.

The above rates are subject to revision and levy of surcharge and other statutory levies that may be enforced from time to time by the Central or State Government.

The Electricity tax on consumption of energy which is to be levied on the new tariff rates. wherever applicable, shall also be levied, collected and remitted to Government.

All the wells coming under special priority category based on some Government orders issued and recommended by the authorities of departments concerned have to be inspected by the Assistant Executive Engineers/Assistant Engineers/Junior Engineers before issue of 90 days notice, in order to ensure that they are eligible for the special priority. If any discrepancy is found, then the matter could be taken up with the authorities of the departments concerned who have recommended the cases for special priority. Supply to such cases can be extended only if they satisfy the conditions for special priority.

Adverting to the above, it is clarified that the orders issued vide Member (Distribution)'s letter no.SE/IEMC/EE3/AEE2/D.801/93/dated. 18/19—11—93 instructing not to effect supply to the agricultural pumpsets situated within 200 metres from the river banks are applicable to all rivers in Tamil Nadu.

P. Suresh Chander Pal, Member (Distribution). Sub: Flattening of load curve-Staggering of weekly holidays to even out the daily peak demand-Instructions to implement the scheme-Issued.

At present there are no restrictions on consumption of Demand and Energy by H.T. Industries. The H.T. Industries, which can afford to have weekly off, are observing the weekly holiday mostly on Sundays only. Consequent to these, the grid is operating without any cushion to meet any exigencies, and the difference in daily peak demand recorded in sundays and other days of the week is also high.

It has therefore become imperative to introduce some sort of effective demand management and hence it is ordered that the scheme of staggering of weekly holidays by H.T. Industries is enforced and implemented forthwith.

The Superintending Engineers of all Electricity Distribution Circles are therefore instructed that the scheme of having each day of the week as the weekly holiday by the different segments of the industries, may be got discussed with the H.T. industrialists in the respective areas and to arrive at a mutually agreed workable plan and to enforce the same at the earliest.

The Superintending Engineers may follow the following guidelines in evolving and implementing the workable plan on staggering of weekly holidays:-

- (i) The intention of the scheme is only to stagger the weekly holidays already observed by the H.T. Industries. Hence, no industry, which is not in the practice of observing weekly holiday already, need be insisted upon to observe weekly holiday now.
- (ii) The ideal plan of the scheme, shall be that the H.T. Industries in each Electricity Distribution Circle are divided into seven groups, with the aggregate Sanctioned Demand of each group being more or less equal, and each such group is asked to observe each day of the week as the weekly holiday. The strategy to be adopted by the Superintending Engineers in grouping the H.T. Industries, either "area-wise" or "feeding substation wise" and in enforcing the scheme, shall be aimed at the above ideal plan, as far as possible, to even out the daily peak demand, without much appreciable "lean" demand on Sundays.
- (iii) In case of continuous process H.T. Industries which may not observe regular weekly holiday presently, but which may afford to have break in their process for any consecutive three or four days in a month, may be persuaded to observe four continuous holidays in a month. If there are more than one such continuous process industries in an Electricity Distribution Circle, they may be asked to observe "four days continuous holiday" in a month in such a way that each of such "four day continuous holiday" is different for each industry and are spread over a month.

The Superintending Engineers of all Electricity Distribution Circles are requested to bestow their personal attention in this regard and start implementing the scheme before the end of April 1994.

The receipt of this memo may be acknowledged and the programme of action to be initiated may be confirmed to the Superintending Engineer/IEMC, Madras.
