The maximum grid demand and consumption during September '94 were 4107 MW on 20—9—'94 and 89,249 MU on 21—9—'94 respectively. The average grid consumption in September '94 was 83,605 MU per day.

### II. Hydro Inflows:

The hydro inflows during September '94 were 443 MU against 209 MU in September '93 and against the ten year average of 272 MU. The total inflows in July to September '94 were 2447 MU against 1572 MU during the same period last year and against the ten year average of 1379 MU.


# SPORTS ACTIVITIES OF TAMIL NADU ELECTRICITY BOARD BALL BADMINTON

Sub: Establishment — Revision of Scales of pay and allowance to employees from 1—12—92—Fixation of pay in certain cases—Clarification issued.

The Superintending Engineer, Purchase and Administration, Ennore Thermal Power Station has raised the following point for clarification:

> "About 250 Regular Work Establishment employees of Ennore Thermal Power Station were appointed to the upgraded post in June '92. Their annual increment in the selection grade of lower post fell on 1—10—92, and they had opted for promotion pay fixation (addition of one notional increment) in the upgraded post also on 1-10-92. Whether in the case of such workers, options for fixation of pay in the Revised Scale on 1-12-92 taking into account their pay as on 30-9-92 may be entertained and their pay fixed accordingly".

- 2. According to regulation 7(i) of the Tamil Nadu Electricity Board Revised Scales of Pay (Workmen) Regulations, 1994, issued in (Permanent) B.P. (FB) No. 5 (SB) dated 25—1—94, an employee may exercise option to remain in the existing scale of pay until the date on which he earns his next increment in the existing scale of pay. An employee who had drawn an increment in the existing scale on 1st October 1992, may also exercise option for pay fixation in the revised scale on 1—12—92 taking into account his present emoluments as on 30—9—92. The term "existing scale" in relation to any post is defined in Regulation 2 (ii) of the Revised Scale of Pay (Workmen) Regulations, 1994, as the scale of pay admissible to such post on the 1st December 1992.
- 3. In view of the provisions in the wage revision order mentioned in para 2 above, the Regular Work Establishment employees mentioned in para 1 above are not entitled to exercise option for fixation of pay in the Revise scale on 1-12-92 taking into account their pay as on 30-9-92, as they had not drawn an increment in the upgraded post held by them on 1--12-92, on the 1st October 1992.

In the Board's Proceedings' first cited, orders were issued that the expenditure towards Ambulance charges incurred by the Board employees and other personnel entitled for free medical concessions may be reimbursed when the patient is conveyed from residence to the hospital on account

of emergency and subject to the condition that the Medical Officer who treated him furnishes a certificate to the effect that the services of an Ambulance Van was quite necessary in conveying the patient to the hospital.

- 2. In the Board's Proceedings second cited, the above concession was extended to cases where a patient is conveyed by Ambulance Van from one hospital to another hospital also subject to the production of a certificate, obtained from the Medical Officer concerned, to the effect that such a conveyance was quite necessary in view of the seriousness of the case.
- 3. The Government have, in their G. O. Ms. No. 142 (Health and Family Welfare Department) dated 28—1—84, issued orders that the Government servants and entitled persons can engage an Ambulance Van as conveyance from Government hospital to residence after discharge in certain specific cases and that the charges incurred by them would be reimbursed subject to the preduction of medical certificate for such necessity.
- 4. The Tamil Nadu Electricity Board, after careful consideration hereby directs that the Board employees and entitled persons can engage an Ambulance Van as conveyance from Government Hospital to residence after discharge in following cases:—
  - (1) Maternity cases where patients are discharged from the Government Hospital on the 3rd or 5th day after delivery;
  - (2) Patients who had major operations;
  - (3) Patients treated for Orthopaedic diseases;
- (4) Patients treated in Cardiology and Neurology Departments of the Government Hospitals. The charges incurred by them will be reimbursed subject to the production of a certificate from the Medical Officer who treats the patient, to the effect that the services of an ambulance van was necessary for conveying the patient from the Government Hospital to residence. The Medical Officer should indicate any one of the cases mentioned above as may be applicable.
  - 5. Receipt of this orders shall be acknowledged in the slip enclosed.

Sub: Establishment—Promotion to higher categories—relinquishment of rights—for promotion by the employees—instructions—issued.

It is seen that whenever promotions and postings are ordered, employees who are posted to other circles are not relieved by the authorities immediately on receipt of reposting orders on some grounds or other. This enables them to bring pressure for modification of allotment which causes

much hardship and dislocation in administration. To avoid such administrative inconveniences, following instructions are issued for strict adherence in the matter:

- (1) Reposting orders shall be issued by the authorities to whom promotees are allotted, within SEVEN DAYS of receipt of allotment order.
- (2) The Officers under whom the promotee is working shall relieve the individuals without waiting for substitutes, Immediately on receipt of reposting orders.
- (3) Promotees shall join at the place of reposting within the joining time allowed.
- (4) Right to relinquish promotion given vest with the employee. In case of such option received, it should be accepted by the appointing authority viz. the Chief Engineer/ Superintending Engineer as the case may be under whom the employee is now working, irrespective of the fact that he is promoted to a higher post and allotted to a different appointing authority, within 15 days under intimation to this branch.
- (5) After the exercise is over or after completion of two months from date of allotment, whichever is earlier the Superintending Engineer/Chief Engineers shall furnish a statement, showing the details of total allottees to their circle, total joined, details of promotees opted for temporary/permanent relinquishment and order, number and date issued for accepting the same.

Sub: Establishment—Temporary relinquishment of rights of promotion—Revokation before expiry period—Consideration.

During discussions, with the Wage Revision Committee during 7/94 and 8/94, the Unions represented that an opportunity may be given to those workmen, who earlier relinquished their rights for promotion temporarily, to revoke the same for considering them for promotion, in view of large number of promotional opportunities provided in the settlement.

2. The matter was examined in detail and it is decided to consider the request as a special case. For this purpose, issuing general circular asking for willingness from relinquished employees, need not be resorted, but it would only be sufficient that the Establishment Section review the three year cases and take out a list of such persons for considering them alongwith others, ignoring their relinquishment. The list of such persons in state cadre may be furnished in separate sheet for each category and sent to this office urgently. In the case of circle cadres, the Superintending Engineers themselves can carry out this concession subject to the employee being found otherwise qualified and suitable.

Sub: Revised work norms—Sections having only one Assessor—Posting of one Inspector of Assessment — Regarding.

As per the revised work norms, in all the distribution sections, one post of Inspector of Assessment has to be suppersed and in its place, one Revenue Supervisor has to be posted. In some of the sections, there may be only one Assessor and one Inspector of Assessment prior to revision of work norms. In these sections, as per the revised work norms there will be only one Revenue Supervisor and one Assessor.

- 2. During discussions held with various unions, the Unions pointed out that in sections where there is one Revenue Supervisor and no Inspector of Assessment asking the Revenue Supervisor to do the Inspector of Assessment's collection work etc. will not be in order. Therefore the Unions requested for giving one post of Inspector of Assessment for such sections.
- 3. After implementation of revised work norms, a number of Inspector of Assessment will be rendered surplus. It has been decided to utilise one such Inspector of Assessment as a temporary measure in such section till such time post of Inspector of Assessment becomes eligible for such sections through growth of service.

The Government of India have revised the rates of depreciation twice effective from 1—4—92 and 1—4—94 onwards vide Gazette Notification dated 23—1—92 and 29—3—94. The Government of India have also increased the rate of return on equity from 10% to 12% for the thermal power stations under NLC with effect from 27—8—93 vide Gazette Notification dated 27—8—93. Based on the above notifications, Southern Regional Electricity Board, Bangalore have constituted a Special Committee to go into the tariff structure and arrive at the generation tariff payable to NLC for their power station II under Stages I and II. A STATE OF THE STA

In the G. O. cited under reference, the Government has issued orders that T. N. E. B. have to provide 10,425 street lights in 2085 A.D. Colonies before 31—3—'95 and the cost of Rs. 3.34 crores has to be borne by the T.N.E.B.

In this regard, the Chief Engineer / Distribution/Coimbatore has informed that the District Collector/Coimbatore has stated that the cost of application, registration charges and Development charges are not payable since the scheme is to be executed by T.N.E.B.

The matter was examined and it is ordered that T.N.E.B. can bear only the cost of L.T. extension fittings and labour charges etc., but the normal cost of application fee and development charges have to be paid only by the consumer.

Hence, it is informed that the registration charges and Development charges for the provision of street lights in A.D. Colonies have to be paid by the applicant only.

The Superintending Engineers were instructed, in the Memorandum under reference cited, to ensure that in all H.T. Services the P.T. circuits are made through and the fuses made dummy.

Subsequently, the Chief Engineer/Trichy had suggested that the P.T. fuses provided in the Metering Sets may be kept in circuit for protection to the P.T. secondary winding and all other P.T. secondary fuses can be made through.

The Superintending Engineer/Periyar Electricity Distribution Circle/Erode has suggested that the fuse protection after the meter at the meter box is preferable.

After examining the above suggestions, it is now instructed that

(a) P.T. fuses in the secondary circuit of the metering set and P.Ts. in Kiosks, RMGs may be made through and fuses made dummy.

and

(b) one set of fuses may continue to be in the P.T. secondary circuit before meter in the meter box which may have fool proof enclosure to prevent malpractices, with proper locking and sealing arrangements. The doors of the metering box can have minimum of two independent sealing provisions.

The above instructions are issued in partial modification to the instructions issued under reference cited. The Superintending Engineers are requested to ensure that (a) & (b) are implemented early.

Sub; Electricity — Change in permitted demand from the date of reading—Instruction—Regarding.

As per Clause 18.02 of Terms and Conditions of Supply, whenever there is change in the sanctioned demand or permitted demand during the course of a month, the meter will be reset and the maximum demand charges will be regulated proportionately for the respective periods.

Based on the above ruling separate readings are taken on the date of change in the permitted load.

In order to make this procedure simplified and avoiding too many readings and resetting the following guidelines are issued.

As far as possible without causing any inconvenience to the consumer the change in the permitted demand may be done on the date of billing reading. Wherever this could not be done, the existing procedure may be continued of permitting the change in demand on any day after taking revised R.T.R.

Sub: Interruption to H.T. consumers during testing/failure of H.T. Metering sets—Representation—Instructions—Issued.

It has been represented by the Tamil Nadu Steel Re-Rollers Council, Salem that as and when the metering set in the H. T. service fails, the same is removed for repairs/replacement causing interruption of power supply to the Re-rollers without any advance intimation to the consumer. Hence, the following guidelines are issued for implementation with immediate effect in respect of all H. T. services.

- (a) Routine inspection/testing of the H. T. metering set may be carried out without causing interruption to the H. T. consumers Advance intimation may be given to the H. T. consumers under proper acknowledgement for the above work if interruption of supply is involved.
- (b) During the time of inspection/testing a defective metering set if it is found that the replacing the defective/failed equipment is necessary, the supply may be made through till a healthy unit is fixed. For the period when supply is made through, computed, consumption may be worked out and billed. The above arrangement may be made even if the replacement of the equipment takes a day or more. As soon as the metering set is made alright, normal arrangement may be restored without any further loss of time.

The H. T. consumers may be informed in advance of the above rectification works if interruption of supply is involved.

#### Proceedings:

Some of the field officers have raised clarification whether the registration fees has to be collected for the temporary supply and for reduction of demand/load in respect of HT/LT services. After careful examination, the following clarifications are issued.

#### I. Registration fee for the temporary supply:

The registration fee for temporary supply may be collected as applicable for L.T. Tariff IX and H. T. service as specified in item 3 and 6 of clause 9.00 of "Registration fees" in B. P. (FB) No. 94, dated 30—3—94.

#### II. Reduction of Load/Demand:

Application/Registration fees as specified in clause 9.00 "Registration fees" at the appropriate rates are also to be collected for reduction of demand in respect of H. T. services and reduction of load in respect of L. T. services.

In accordance with the permanent B. P. 2nd cited above, twelve items of ferrous and non-ferrous materials and condemned vehicles held in stock at various Central Stores are disposed off through open tenders by the Chief Engineer/Materials Management after collecting the details from the Circle Superintending Engineers.

It is seen that the reserve price are being fixed by the Circle survey committee and thereafter approved by the Circle disposal Committee in accordance with the B. P. 1st cited. The reserve price should be fixed based on the condition of materials and the prevailing market conditions.

But large variations are found in the per unit rate of reserve prices fixed from the details furnished by various Superintending Engineers for Centralised disposal.

Therefore the following guidelines are suggested in fixing the reserve price with a view to reduce large variations in the per unit rate:—

While fixing the reserve price for surplus/obsolete/scrap materials condemned vehicles and plant and Machineries etc., the following aspects shall be taken into account.

- (i) Present condition of materials and its susceptibility for deterioration in storage in the open yard etc.
- (ii) Local market conditions.
- (iii) Rates obtained in the previous tender sale/auction for similar materials both at Head Quarters and at Circle level.
- (iv) Utility of the materials.
- (v) Labour involved in transport, retrieval of usable/effective material contents.
- (vi) Handling charges.
- (vii) Availability of such materials in the market and consequential demand.
- (viii) Market price published periodically in the newspapers/IEEMA Circulars for ferrous and non-ferrous materials.

The Chief Engineers/Superintending Engineers are requested to note that these are only broad guidelines based on which the value of materials shall be assessed to fix the reserve price.

The Chief Engineers/Superintending Engineers are requested to ensure that the reserve price is fixed (for the disposable materials) taking into account of the above mentioned aspects in order to avoid large variations.

The Anti Power Theft Squad during the inspection of HT and LT Services has found that the serial number of the numbered seals, provided on the various locations of the metering equipments and meter, are not properly recorded in the consumer's and Board's meter cards on proper acknowledgements by the consumers or their representatives. The following instructions are issued to remedy the situation.

- 2. The serial numbers of the seals provided in the HT/LT metering arrangements should be recorded in the sealing Register with reference to the specific location of the meter viz., top right, left, bottom, KVA M.D., KW, M.D. other metering equipments AB switches and switch gears, etc. without when fail, at the time of effecting the service and as well as at the time of their replacement, as and warranted. Such replacement should be duly authenticated by the Departmental officers concerned and the consumer or his authorised representative with their dated signature/designation etc., against all these entries, without fail.
- 3. The above instructions should be brought to the notice of all the field officers for strict adherence and any lapse in this matter shall be viewed very seriously.

Services where the ordinary lead seals have not yet been replaced by numbered seals though in the Vigilance Cell's Circular Memo. (i) cited above, clear instructions regarding introduction of numbered lead seals have been issued.

- 2. Similarly in a number of services, the Terminal Covers have not been either provided or sealed inspite of specific instructions issued in the Vigilance Cell's Circular Memo. (ii) cited above.
- 3. All the Superintending Engineers/Electricity Distribution Circles are reuqested to carry out the instructions contained in the Circular Memos. cited above on "War Footing" and send a confirmatory report after completing the work before 31—11—94 without fail.
