Sub: Training—Imparting training for Assistant Engineers at entry level and revision of existing procedure—Finalisation of working procedure—Approval—Accorded.

In continuation to the B.P. cited, approval is hereby accorded for the following working procedures to be adopted for training of Assistant Engineers at entry level step by step.

1. After recruitment, the Assistant Engineers will be reporting to allotted Distribution/Generation Circles. The Circles concerned will take care of all establishment matters, Pay & Allowances, etc. pertaining to the individuals during the entire 6 months training period. All formalities for acceptance of joining report, opening of service records, payment of Tour advance etc. will be completed during the first 15 days at circle level.

The name & date of joining of Assistant Engineers should be reported by Superintending Engineers of Circles to Director of Training immediately on joining. The Chief Engineer/Research & Development will issue orders fixing the dates and period of training centres at Madras, Ennore, Madurai and Kuthiraika!medu.

2. The new recruits will undergo training in each of the following centres by rotation: -

1.	Staff Training College/Madras	_	3 weeks
2.	Thermal Training Institute/Madras	_	2 weeks
3.	Transmission and Sub-Station Training Institute/Madurai		3 weeks
4.	Hydro Training Institute/Kuthiraikalmedu	_	2 weeks

The training at Staff Training College will also cover the aspects on the usage of computer for H.T. Billing etc.

The training at Hydro & Thermal Training Institutes will also include visits to a Hydro/Thermal Station.

A transit time of 2 or 3 days will be allowed to trainees for moving from one Institute to another except for movement from Staff Training College to Thermal Training Institute/Madras and vice versa. Training schedule for Staff Training College & Thermal Training Institute should be programmed accordingly.

3. After completion of the training at the above four training institutes, the newly recruited Assistant Engineers will be sent for further training to various fields as detailed below as per the direction of concerned Chief Engineer. The Superintending Engineers/Distribution/Generation Circles etc. will issue necessary orders in advance for the continuance of training, fixing dates duration and place of training and the officers, to whom to report for such training preferably in the following order:—

4. The concerned Superintending Engineers in the field will select a nodal officer in the rank of Assistant Executive Engineer for trainees under their control. Assistant Executive Engineers having aptitude in imparting field training to the newly recruited Assistant Engineers may be chosen as nodal officers. The service of Engineers already trained in Engineering Staff College of India, Hyderabad on "Training for Trainers" vide (Rt) B.P. (Ch.) No. 22 (T.B.) dt. 20—1—94 may also be utilised.

- 5. During the six months training, the newly recruited Assistant Engineers will maintain a diary detailing the datewise training undergone with the field observations made, equipments handled, test procedures studied and study visits made etc. Also, studies have to be conducted as per a work book and recordings made therein by Assistant Engineers during the field training then and there and submitted to the controlling Officers. The training centres and nodal officers will review the individual's diary and work book periodically. The concerned officers under whom the trainees are reporting for training will sign the diary with designation seal for the entire 6 months of training then and there. The report and tour programme will be sent to nodal officers by the trainees.
- 6. Director of Training will prepare and give a well prepared Brochure to all the newly recruited Assistant Engineers detailing completely what the trainees are expected to cover in the 6 months of training.

Final assessment will be done at the Regional Centres at the end of the training programme for 3 days with the following evaluation committee members:—

- 1. Regional Chief Engineers.
- 2. Superintending Engineers concerned.
- 3. One Deputy Director/Training.
- 7. The performance assessment reports given by the four training centres, the diaries and work books will be taken into consideration for final evaluation. The final assessment report of the committee shall be sent to Chief Engineer/Research & Development by Regional Chief Engineers for consolidation of the list of Assistant Engineers who have successfully undergone the training and for sending a report to Chief Engineer/Personnel for taking further action.
 - 8. The Director of Training may arrange for the supply of following:
 - (i) Brochures about the whole training programme.
 - (ii) Diaries (Book for the whole training).
 - (iii) Performance Assessment report forms.
 - (iv) Work book for the field training.
 - (v) Learning sequence forms.

Director of Training will arrange a programme of the above pattern with all Deputy Directors and field officers. Directorate of training may arrange for issue of working instructions for the training programme on the above basis.

9. All Deputy Directors may prepare the course materials, Work books, diary formats etc. well in advance. Deputy Directors may evolve proposals towards expenditure on stationery, course meterials, supply of tea and snacks, payment of honorarium for guest lecturers and get approval well in advance.

2. B. P. Ms. No. 5 dated 25-1-94.

In B. P. Ms. No. 5 dt. 25—1—94, the revised work norms for the Assessors and for the billing Assistants have been ordered along with the wage revision. As there was no mention about payment of prorata wages to Assessors and honororium to Billing Assistants many Superintending Engineers have raised clarifications on the following points:—

As the new works norms have been implemented only during 8/94, 9/94(1) the basis for calculating the excess over norms upto the date of implementation of new norms to the Assessors and billing Assistants and (2) Whether the prorate wages are to be calculated based on the revised scale of pay while norms are based on old pattern.

After careful examination the following instructions are issued:-

1. Assessors

The excess over norms can be calculated based on the old norms upto the date of implementation of revised norms (i.e. upto 31—8—94) After implementation of the revised norms, the excess over yard stick shall be calculated based on the revised norms. In both the cases, for calculating the prorate wages, the pay - D.A. drawn during that particular month shall be taken into account ir-respective of the fact that old norms has been adopted for calculating excess over yardstick.

2. Billing Assistants:

The excess over norms can be calculated based on the old norms upto the date of implementation of revised norms (i.e. upto 31—8—94) After implementation of the revised norms the excess over yard stick shall be calculated based on the revised norms. For calculating honororium payment, the rate of 40 paise/50 paise per service pertaining to leave vacancy/excess over yard stick shall be applicable upto 19th December 1994. As per the orders issued in B.P. No. 121 dt. 20—12—94 the revised single rate of honororium at Re. 1/- per effective service shall be applicable with effect from 20—12—1994.

(Per. O) Department, dated 20-2-1981 addressed to all Secretaries to Government.

Order:

As per ruling 3 under Fundamental Rule 9(6) (b), when a Government servant has compulsorily to wait for orders of postings, such period of waiting shall be treated as duty, and during such period, he shall be eligible to draw the pay plus special pay which he would drawn had he continued in the post he held immediately before the period of compulsory wait or the pay plus special pay which he would draw on taking charge of the new post, whichever is less.

- 2. The Government had occasions to note that the proposals for compulsory wait are not settled immediately. The Public Accounts Committee, in its report for the year 1974—75 with regard to the examination of compulsory wait proposals has observed as below:
 - (i) The posting orders should be issued at the appropriate time.
 - (ii) As far as possible, orders of posting should be finalised atleast a month in advance for which the Heads of Departments should take responsibility.
 - (iii) In cases, where such a recommendation/finalisation could not be done, the proposals should be termed as 'Most Immediate' and personal follow up, in getting orders should be made.
 - (iv) It will be the duty of the Heads of Departments concerned to keep reminding the persons concerned to finalise the compulsory wait proposals time and again.

These observations of the Public Accounts Committee were communicated in the reference read above to all Secretaries to Government for strict adherence.

- 3. Normally officials returning from leave/deputation, transferred from a post, rendered surplus due to the wind up of a post etc., have to wait for orders of postings. In all such cases, it should be possible for the authorities to foresee such contingencies and to decide alternate postings to the officials concerned well in advance. They should realise that each day of delay in giving a posting involves payment of duty pay and allowances to a person who is not discharging any duty for that date.
- 4. Despite the instructions in force, Government have occasion to come across cases of abnormal delay in some cases involving more than 6 months in giving postings to departmental officials. The attention of Secretaries to Government and Heads of Departments is invited to the provisions contained in the Fundamental Rulas and the guidelines issued based on the recommendations of the Public Accounts Committee set out in paras 1 and 2 above and they are requested to ensure that there is no delay in their part in giving postings to Government officials under their control, involving avoidable wasteful expenditure to the Government.

- and (b) 100% Demand charges will be effective from June '94 monthly readings onwards.

In view of the above, the Superintending Engineer/Electricity Distribution Circle are informed that question of adopting proportionate demand charges for June '94 bill does not arise and 100% demand charges has to be charged at notified tariff rate from the date of reading in the last week of May '94 to the last week of June '94 and only the compensation charges for Low Power Factor need be collected at the old rates up to 31—5—94 and at the new rates from 1—6—94 onwards. Wherever bill for June '94 has been issued on proportionate basis they have to be revised as above.

The earlier decision to request the consumer to procure meter or charging the full meter cost even if one component becomes defective was taken due to dearth of meters. However number of consumers have represented that this imposes huge financial committment especially when the Board is not providing meters. The matter was also raised in the recent consumer protection council meeting when the Honourable Minister for Food/Co-operation/Consumer Protection wanted the Board to reconsider the Board's decision.

In the above circumstances, the matter has been reexamined and the Superintending Engineers/ Elecy. Distn. Circles are requested to follow the procedure of preparing the estimate for defective meters that was in force prior to the instructions dated 11—6—93 cited under reference. For preparation of such estimates, the following rates of meter spares may be adopted.

ORDER:

The problems faced by Cinema Theatres consequent on the revision of tariff ordered in the G.O. read above has been engaging the attention of the Government.

- 2. After careful consideration, the Government have decided to restore the status quoante for Cinema Theatres and accordingly issue necessary amendments to the Schedule to the Tamil Nadu Revision of Tariff Rates on Supply of Electrical Energy Act, 1978 (Tamil Nadu Act 1 of 1979).
- 3. The following Notification will be published in an extraordinary issue of the Tamil Nadu Government Gazette dated the Eighteenth January, 1995.

NOTIFICATION

In exercise of the Powers conferred by Section 4 of the Tamil Nadu Revision of Tariff Rates on Supply of Electrical Energy Act, 1978 (Tamil Nadu Act 1 of 1979), the Governor of Tamil Nadu hereby makes the following amendments to the Schedule to the said Act.

2. The amendments hereby made shall come into force on the eighteenth January, 1995.

In the Memorandum cited above, it has been clarified that the Telephone Exchange, P & T Micro Tower, Bakeries, Coffee grinding shops etc. should be charged under L. T. Tariff-IX only.

In the Chairman letter cited, under reference (2) it was informed that the request for application of L.T. Tariff-IV (Industrial tariff) in respect of service connections given to Hotels and Restaurants is not feasible of compliance.

In this connection lot of clarifications regarding the definition of industry has been sought for from the field.

As per G. O. (Ms.) No. 313, P. W. (Electricity) dated 26—2—93 and as per G. O. (Ms.) No. 35. Energy (A2) Department, dated 1—3—94, L.T. Tariff-IV is applicable to the Industries not covered under L.T. Tariff-III.

The definition for Industries is one which buys the raw material and converts it into a usable material examples:—

- (i) Rice mills, Flour Mills and saw mills which carry out only job work and collect the charges for the same have to be charged under L. T. Tariff-IX.
- (ii) In cases where the consumers buy the raw material and convert the same into usable value added material for sale in the market, then such services have to be charged under L. T. Tariff-IV.
- (iii) Similarly in case of Coffee grinding works, when the consumer buys the coffee seeds and utilises the power for grinding coffee seeds for conversion as a value added product and sells it in the market, then the service may be billed under L. T. Tariff-IV.
- (iv) If the service is utilised for carrying out coffee grinding as a job work, on behalf of some other agency and collecting only charges for grinding, then the service should be billed under L.T. Tariff-IX.
- (v) In case of the factories manufacturing and selling Ice, the service may be charged under L.T. Tariff-IV.
- (vi) In regard to Cold Storage Plants, no manufacturing activity as in the case of Industries is being carried out and as such they have to be charged under L. T. Tariff-IX.

The Superintending Engineer's of Distribution Circles are instructed to follow the above procedure.
