

Memorandum (Permanent) No. 14895—Q2/97—2, (Secretariat Branch) dated 2—1—'98

Sub: Pension—Inclusion of name of mentally retarded son in the pension payment order of pensioners—Clarification—Issued.

In (Permanent) B P. (Ch), No. 341 (SB) dated 8—12—94, orders have been issued to the effect that the pension payment orders to be issued in future shall include all the members of the family including the disabled/mentally retarded/handicapped children and prescribing the procedure to be tollowed for inclusion of names of eligible children who have not been included in the pension payment order.

- 2. The above orders have been revised in (Per.) B. P. (Ch) No. 245 (SB), dated 29—8—96 as follows:
 - (i) A pensioner shall furnish to the sanctioning authority concerned a list of the names of eligible children indicating whether any child is handicapped together with an attested copy of the certificate obtained from a Medical Officer of the rank of Civil Surgeon in the case of children suffering from disorder or disability of mind or is physically crippled or disabled so as to render him/her unable to earn a living.
 - (ii) For inclusion of names in the Pension Payment Order, the pension sanctioning authorities after due verification of the list of the names, shall furnish the names of eligible children to the Chief Internal Audit Officer/Board Office Audit Branch with intimation to the pensioner.
 - (iii) A fresh Pension Payment Order based on the sanction accorded by the pension sanctioning authorities shall be issued by the Chief Internal Audit Officer/Board Office Audit Branch in respect of eligible children as and when their turn come up after the death of the pensioner subject to fulfilment of the conditions specified in rule 49 (6) of the Tamil Nadu Pension Rules 1978.
- 3. Now a point has been raised by the Chief Engineer (Distribution)/Chennai Region whether the name of the mentally retarded son of a retired official may be included, following the orders issued in (Per.) B.P. (Ch) No. 341, (SB), dt. 8—12—94 for enjoying the benefits of family pension.
- 4. It is clarified that in the case of existing pensioners inclusion of the names of eligible children including the disabled/mentally retarded/handicapped children of the retired employees could be done duly observing the procedure mentioned in para 2 above.

P. A. Khaja Kaleel Rahman, Secretary, Sub: Anti Power Theft Squad—Theft of Energy cases ended in acquittal—Charges filed beyond the period of limitation—ended in acquittal—Instructions—Issued for strict adherence.

Ref: Circular Memo. No. 45777-VC11/97-1, dated 21-10-97.

It has been brought to the notice that in C.C. No. 296/91,97/90 and 68/92 on the file of the Judicial Magistrate, Sankari the learned Magistrate has acquitted the accused on the following grounds:

 Prosecution has not proved that service connection was in the name of the accused by documentary evidence.

- ii. The charge sheet was filed $2\frac{1}{2}$ years belatedly than the stipulated time in C C. No. 68/92, 7 months after the stipulated time in CC. No. 97/90 and $1\frac{1}{2}$ years belatedly after the stipulated time in C C. No. 296/91.
- 2. In criminal cases the owner of the service connection/enjoyer of the service connection is the accused has to be proved by documentary evidence. Further charge sheet has to be filed within the period of limitation of 3 years. The above aspect was not looked into by the concerned jurisdictional officials. Because of these vital points the cases have ended in acquittal.
- 3. In the Circular Memo. No. 45777/VC11/97—1. dt. 21—10—97 instruction were issued specifically that charge sheet should be filed within the limitation period and monitoring the case effectively for successful prosecution. Besides the Chairman has ordered to fix responsibility on all the officials concerned in case the court delivered judgement against the Board for the foregoing reasons. Inspite of the instructions, the territorial official who have filed FIR in the cases have not pursued the cases effectively.
- 4. The Chief Engineers and Superintending Engineers are informed to issue strict instructions to the officials concerned by reiterating the earlier orders to follow up the criminal cases sincerely in the courts and at police level for successful prosecution of the case. Filing charge sheets in time, production of material evidences in the Court promptly and ensure that during the periodical meetings and reviews the above instructions are insisted properly, so that no failure is found on the part of the board officials.
 - 5. A copy of instructions issued to the effect may be marked to Vigilance Cell.
 - 6. Please acknowledge the receipt of the Circular Memo. in the slip enclosed.

In the Board's Proceedings cited orders were issued extending the scheme of medical reimbursement facility to the Helper/Office Helper (Trainees) appointed during the period from 2—1—94 to 31—12—94 though they have not completed the Prescribed training period of one year on 1—1—95 and the reimbursement claim may be restricted to the amount representing the notional pay and Dearness Allowance as on 1—1—95

- 2. A Superintending Engineer has requested for clarification as to whether the medical reimbursement facility may be extended to those appointed for the period from 1—1—95 to 5-10—95 and the reimbursement claim shall be restricted to the amount representing the notional pay and Dearness Allowance on the date of their regular appointment after completion of six months training period.
- 3. The question of extending the benefits of medical reimbursement facilities to the Office Helper/Helper (Trainees) has been carefully considered. After careful consideration, it is hereby ordered that the scheme of medical reimbursement facility be extended to the Office Helper/Helper (Trainees) appointed during the period from 1—1-95 to 5—10—95. The reimbursement claim shall be restricted to the amount representing notional pay and Dearness Allowance on the date of the regular appointment after completion of six months training period. The Office Helper/Helper (Trainees) appointed on or after 6—10—95 are not eligible for the medical reimbursement facility and they are eligible only for medical allowance.

PONGAL FESTIVAL 1998—Pongal Prize amount to pensioners/family pensioners of the Board—Sanctioned—Orders—Issued.

Proceedings:

The Government of Tamil Nadu, in their G.O. third cited have sanctioned a lumpsum Pongal Prize amount of Rs. 150/- (Rupees one hundred and fifty only) to all pensioners including adhoc pensioners of all categories and family pensioners of Government, subject to certain conditions specified in the above Government Order.

- 2. The Tamil Nadu Electricity Board after careful consideration, has decided to adopt the above orders of the Government to the existing pensioners/family pensioners of the Board also. The Tamil Nadu Electricity Board hereby sanction a tumpsum Pongal prize amount of Rs. 150/- (Rupees one hundred and fifty only) to the existing pensioners and family pensioners of the Board
- 3. The Pongal prize amount will not be admissible to those employees who retire on or after the date of those orders and to the family of these employees who die in harness on or after the date of these orders
 - 4. (i) Pensioners/Family Pensioners of those employees, who were paid Bonus/Lumpsum ex-gratia amount as per the orders issued in the Board's Proceedings cited are not eligible for the Pongai prize amount.
 - (ii) Family Pensioners who have been appointed on compassionate grounds, and who have been paid Bonus/Lumpsum ex-gratia amount for the Accounting Year 1996-97 as applicable to the employees in service will not be eligible for the Pongal prize amount.
- 5. For the above purpose, the pension sanctioning authorities are requested to obtain a Certificate of non-drawal of Bonus/Ex-gratia for the accounting year 1996-97 from the pay disbursing officer who disbursed Bonus/Ex gratia for the accounting year 1996-97 and to forward it along with the application for grant of Pongal prize amount of Rs. 150/- (Rupees one hundred and fifty only) to the Chief Internal Audit Officer/Audit Branch for authorisation of Pongal Prize amount due for 1998 to the nominated branches of the Indian Overseas Bank.

Act the Tamil Nadu Electricity Board, in the B.P. cited, had issued orders for the payment of Interim Relief at 10% (ten percent) of basic pay (excluding personal pay and special pay) as on 30—11—96, subject to a minimum of Rs 200/- (Rupees two hundred only) per month to all the employees, who are in a regular time scale of pay as on 1—12—96, subject to the condition that the interim relief will be fully adjusted against the benefit that may become admissible in the revision of pay and allowances with effect from 1 – 12—96. The Tamil Nadu Electricity Board had adopted the procedure of Single Channel of promotion for RWE categories in Distribution Circles namely, Helper – Wireman/Commercial Assistant — Lineman—Line Inspector/Commercial Inspector—Foreman I Gr. prior to April 1980. Consequenton the creation of a new category of Assistant Commercial Inspector in the settlement entered into with the Unions, the channel of promotion among the RWE categories was modified into two as indicated below:

Wireman	Commercial Assistant
Lineman	Assistant Commercial inspector (new category w.e.f. 29-2-80)

Foreman Grade—I

The Helper, Wireman and Commercial Assistant were given option to choose either of the two channels for further promotion. Such exercise of option was final and irrevokable. This status continued in the subsequent Settlement entered into with Unions on 21—10—85 and 31—7—89.

- 2. In the Settlement entered into with the Unions on 31—12—93/19—1—94, as demanded by the Unions, the Board agreed to abolish the category of Assistant Commercial Inspector, duly creating equal number of posts in the higher category of Commercial Inspector with effect from 1—12—92. Consequent on the abolition of the category of Assistant Commercial Inspector with effect from 1—12—92, the Unions requested for discontinuing the separate Channel of promotion created for the promotion of Commercial Assistant—Assistant Commercial Inspector—Commercial inspector—Foreman I Gr. The following clause was included in the settlement dated 31—12—93/19—1—94:
 - (XI) The following issues raised by the Unions will be discussed and examined separately:—
 - (C) Discontinuing the separate Channel of promotion for Commercial Assistant—Commercial Inspector.
- 3. In pursuance of the above term of Settlement, the Chief Engineer (Personnel) and the Industrial Relations Adviser had discussions with the Unions who were parties to the Settlement and also other Centrally affiliated Unions who were non-parties to the Settlement. The recognised Unions and most of the Unions agreed for the discontinuance of the separate Channel of promotion for Commercial Assistant—Commercial Inspector. Accordingly, orders for re-introduction of Single Channel of promotion for RWE categories in Distribution Circles, were issued in (Per.) B.P. (Ch) No. 106 (SB) dated 9-4-96.
- 4. During 11/96 the Tamil Nadu Electricity Board Vaniga Paniyalargal Sangam, a registered Trade Union, who is a non-signatory to the Settlement dated 31—12—93/19—1—94, filed a W.P. 15168/96 before the High Court, Chennai and also W.M.P. No. 20790/96. While disposing of the said W.M.P., the Hon'ble High Court issued an interim injunction order dated 18—10—96 restraining the Board from imp'ementing the orders issued in B.P. (Ch.) No. 106 (SB) dated 9—4—96, initially for a period of two weeks, subsequently extended it for a further period of four weeks and finally ordered to continue the stay in its order dated 29—11—96 until further orders. The Board in

its Memo. No. 17611/C1/97—1, dated 17—3—97, communicated the above orders to all Chief Engineers/Superintending Engineers for strict adherance. By virtue of the stay granted, the newly sanctioned posts as well as vacancies which have arisen due to retirement/death are kept unfilled in RWE categories in Distribution Circles and promotions have not been given.

- 5. In addition to the above WP, following cases were also filed before the Hon'ble High Court on the above issue:
 - (1) W.P. No. 634 of 1997.
 - (2) W.P. No. 1908 of 1997.
 - (3) W.P. No. 5740/1997.
 - (4) W.M.P. No. 9779/97 and WMP. 9780/97 in WP 15168/96.
- 6. As the pendancy of the cases in the Court is likely to take considerable time for disposal, the recognised Unions and other Centrally affiliated Unions have made several representations to the Board to issue necessary orders for filling up of the workload posts sanctioned and also the consequential vacancies which have arisen due to the retirement/death etc. as per the policy in vogue prior to the issue of orders in B.P. (Ch) No. 106 (SB) dated 9—4—96. The representations were examined in consultation with the Legal Cell and placed before the Full Board.
 - 7. After careful consideration, the Tamil Nadu Electricity Board directs as follows:-
 - (i) The orders issued in (Per) B.P. (Ch) No. 106 (SB) dated 9—4—96 which have been stayed by the Hon'ble High Court of Madras will be kept in abeyance. The seniority list already drawn it any will be kept in abeyance till the Court passes Final orders in the W.P. No. 15168/96.

I am to invite your attention to the references cited and to clarify that the officers provided with Government vehicles are eligible to draw the entitled Daily Allowance for the journeys to places exceeding 8 kms. from the Head Quarters and such tours may be so arranged that they cover more places without frequent return to Head Quarters.

2. I am also to clarify that when the vehicle is under repair the officer is entitled for bus fare only and not other conveyance charges and the claim should accompany a certificate from the Director of Motor Vehicle and Maintenance Department stating that the vehicle of the officer is under repair in the workshop. In respect of those who have already exhausted the fuel quota there is no question of allowing any Travelling Allowance to them as they ought to have completed their tour programme within the ceiling on fuel. As the fuel quota can be regulated restricting to annual ceiling, the officers can plan their tour in such a way to fix their tour programme to cover all places within the overall ceiling.

As per Rule 1 of the Rules to regulate Grant of Advance to Tamil Nadu Electricity Board Employees For Building etc., of Houses, House Building Advance may be sanctioned to employees, whether permanent or non-permanent, if they have rendered, on the date of application for the advance, six years continuous regular service. The provisions of the Tamil Nadu Electricity Board service Regulations specify that service can be reckoned as regular service, when such a service is in a cadre carrying time scale of pay. In the case of Helper (Trainee) and Office Helper (Trainee) initial appointment is not a regular employment carrying a time scale of pay applicable to a class of service in the Board. During the period of training, the trainees are paid consolidated pay only. After the completion of training they are absorbed in regular service carrying regular time scale of pay. In view of the above, Orders were issued in the Board's Memorandum cited, that the period of service rendered as Helper (Trainee) and Office Helper (Trainee) should not be taken into account as regular continuous service for sanction of House Building Advance, Conveyance Advance etc.

- 2. Representations have been received from the Unions for reconsideration of the above decision. The Unions have pointed out that as per existing instruction, Helper (Trainees) and Office Helper (Trainees) are eligible for all the entitlements, and benefits admissible to the newly recruited Helpers/Office Helpers except the scale of pay, viz. they are eligible for leave benefits, grant of festival advance, Night shift allowance etc. Further, their seniority is assigned with reference to the date of joining duty as Helper (Trainee)/Office Helper (Trainee). There were also variations in the period of training from time to time, resulting in Trainees in later batches become eligible for the House Building Advance while their seniors in view of longer period of training do not qualify for the House Building Advance. In view of the above, the Unions have contended that there is justification for counting the period of training for sanction of House Building Advance, Conveyance Advance etc.
- 3. The matter has been carefully considered. It is hereby ordered that the period of service rendered as Helper (Trainee) and Office Helper (Trainee) shall also be taken into account as service for the purpose of sanction of House Building Advance Conveyance Advance etc.

At Virudhunagar 110/33-11 KV, SS, 1 No. 110 KV, 3750 KVA, 250 amps BHEL make OMCB is serving as a Group control breaker. This breaker was commissioned on 13—10—79 and has served for period of 18 years as against a full life period of 25 years.

- (ii) The breaker mechanism has become worn out due to normal wear and tear. The electrical spring charging mechanism is also found defective. When the closing springs are loaded for charging the breaker, the breaker closes automatically even before the closing springs are fully loaded. Thus the breaker gives trouble frequently.
- (iii) The OMCB, being group control circuit breaker, for attending any defect in the breaker, the supply to the entire sub station is switched off. Virudhunagar being district headquarters, uninterrupted supply has to be maintained, which will not be possible with the BHEL OMCB serving as a group control breaker.
- (iv) Moreover, OMCBs have become obsolete now with the advent of SF 6 gas circuit breaker. The manufacturers have dispensed with the production of OMCBs and spaces for the breaker are not available. Hence the defects in the breaker could not be rectified.
- The condemnation proposal for the breaker has already been sanctioned by Superintending Engineer/Kamarajar EDC based on the approval given by Chief Engineer/Distribution/Tirunelveli Region.
- (vi) Hence it is essential that the GC OMCB is replaced by a new 110 KV SF6 breaker which is superior in design, almost maintenance free and has a higher rupturing capacity of 31.5 KA than the existing OMCB.

The reduction of Rs. 9,09 000/- in the estimate cost is due to deletion of 1300 mts. of 3 1/2 x 240 Sq. mm LT cable and 2000 mts. of 3 1/2 x 120 Sq. mm LT cable, because of retention of existing cables to that extent as per committee's recommendation.

The estimate was further processed at Headquarters office through Superintending Engineer/ IEMC and got approved by Chairman. Accordingly the B.P. cited under reference (II) is treated as cancelled and following revised orders are issued.

The Tamil Nadu Elecy. Board approves the revised proposal of the Chief Engineer/Distribution/ Chennai Region for extension of separate LT supply at CLRI staff quarters at Adyar in Chennai Elecy. Distn. Circle (South) at a cost of Rs. 7,67,550/- Gross and Nett chargeable to the Board and Rs. 17,61,000/- Gross and Nett chargeable to the consumer and as per the detailed estimate and report appended to these proceedings.

- 2. The proposal is approved subject to the following conditions.
- (i) The existing LT distribution network including energy meters shall be handed over to TNEB free of cost. Any energy meter found defective during testing shall be replaced by CLRI at their own cost.
- (ii) As the existing LT cables are reported to be laid only 5 years back and loading on the existing feeders are well within limits, existing cables and pillar boxes to the maximum extent possible are considered in the estimate. New cables which are absolutely essential for interconnecting the LT network and back feeding arrangement are only proposed and included in the estimate.
- (iii) M/s. CLRI shall supply the materials or bear the charges for replacement of the LT UG cables when fault occurs for a period of 5 years from the date of taking over by Tamil Nadu Elecy. Board.
- (iv) All the existing energy meters from the residential flats at different floors shall be shifted to the ground floor by M/s. CLRI at their cost. For all the quarters, services will be effected by Tamil Nadu Elecy, Board only at the ground floor by looping the individual meters.
- (v) The cost of distribution transformers, HT switchgear, HT structure and a portion of HT UG cable are chargeable to the Board and the cost of HT cables, LT cables, Pillar boxes and service connection charges are chargeable to CLRI.
- (vi) Any increase in the estimate cost chargeable to the consumer due to increase in quantity of materials, cost esclation of materials etc., at the time of execution shall be collected from the consumer.
- (vii) Necessary land for erection of HT structure, distribution transformer, cables, pillar boxes etc., has to be made available to Tamil Nadu Elecy. Board free of cost by the consumer.
- (viii) The existing LT cable of the consumer feeding staff quarters from their end shall be disconnected.

- 3. The expenditure is chargeable to the following account heads:
- (a) Part—I: TNEB Funds—Chargeable to capital expenditure—Chennai Elecy, Distn. Circle—A/c Code No.14.656.

4. It should be ensured that necessary provision is made available in the budget for the amount chargeable to the Board. The amount chargeable to the consumer shall be collected in one lumpsum before taking up the work.

The Board will exercise the powers of the Telegraph Authority under the provisions of section 42 of the Electricity (Supply) Act, 1948 and shall not be bound by the provisions of sections 12 to 16, 18 and 19 of the Indian Electricity Act, 1910.

M/s. CLRI are at present availing HT supply from 11 KV III Feeder fed off R. A. puram 110/33/11 KV Substation and their quarters are fed by their own distribution transformer. Now since separate LT supply is proposed to be provided, their staff quarters will be fed from TNEB's distribution transformers and the load will be reflected on LT side instead of on HT side and hence the load on 11 KV feeder is the same.

Proceedings:

It has been represented by some of the H.T. consumers who have applied for reduction of load to consider charging the special guarantee amount proportionate to the reduction in demand applied for, by them, since they continue to avail supply for the reduced demand.

The above request has been examined. It is observed that based on the applicant's requirement of demand, Board incurs certain amount of capital expenditure for developing infrastructure facilities for extending supply to them. Because of reduction in load applied for, by the consumer within a period of five years, the agreement executed by the consumer with the Board is not going to be terminated totally but they continue to avail supply for the reduced demand.

It has therefore been decided to amend Clause 13,08 and Clause 13,09 of Terms and Conditions of Supply of Electricity.

Accordingly, in exercise of the powers conferred by Section 49 of the Electricity (Supply) Act, 1948 (Central Act LIV of 1948), the Tamil Nadu Electricity Board issues the following amendment to Terms and Conditions of Supply of Electricity, notified in B.P. Ms. (FB) No 61 dt. 24—12—88 and published in Part-VI Section 3(b) of Tamil Nadu Government Gazette No. 7 dt. 21—2—96 and as amended subsequently.

This amendment shall come into force with immediate effect.

Amendment to Clause 13.08:

After amendment, the clause 13.08 will read as follows:

"In the case of an intending H.T. consumer where the capital cost to be incurred by the Board for extending supply is Rs. 10 akhs or more, the agreement will be for a period of five years with a special guarantee as prescribed in Clause 13.09. This special guarantee is payable only if the agreement gets terminated due to any reason within the period of five years. In respect of H.T. consumers who opt for reduction in demand during the special guarantee period of five years, a revised agreement shall be got executed by the consumer for the load retained after reduction for the remaining period and for also the remaining special guarantee amount payable by the consumer proportionate to the load retained".

Amendment to Clause 13.09:

After amendment, the Clause 13.09 will read as follows :--

"The special guarantee will be equal to

where A = 75% of the capital cost incurred by the Board.

B = Period from date of disconnection to the date of expiry of the 5 years period of agreement (expressed in months).

If the consumer has not availed himself of the supply, B will be equal to 60 months.
