In the B.P. under reference first cited, the instructions were issued to obtain bond prescribing suitable monetary value to serve the Board for atleast 3 years after training. Failure to complete the training satisfactorily within the prescribed period of training will also entitle the Board to recover the fixed pay paid during the training period.

In this connection all the A.Es. of Electrical, Mechanical & Civil had executed the bond while they were at entry level training for six months inclusive of field training given at Training colleges of TNEB.

In some of the cases, the C.Es/S.Es have requested to dispense with execution of Bond citing the B.P.Dated 9.9.91 under ref. (2) cited.

The matter has been referred to the Board for examination for deleting the condition 10 of B.P under reference (1) st cited.

After careful consideration, the Board has decided that the execution of Bond may be continued in the interest of the Board.

In view of the above, the C.Es/S.Es are requested to obtain the bond from the A.Es of Mechanical, Electrical & Civil who have undergone 6 months entry level training in TNEB.

'TU OFFICE-BEARERS CAN'T CLAIM ATTENDANCE WITHOUT WORKING'

Chennai, Feb. 9: The office—bearers of trade unions cannot claim the benefit of attendance without doing work, the Madras High Court has held.

"Working for the union is not the same thing as working in the industry to contribute to the total production and performing the duty attached to the post to which the person is appointed. No. such right is recognised under the provisions of the Industrial Dispute Act", Justice R. Jayasimhababu observed.

The judge was dismissing a writ petition from the Anna Staff Union of the TN Civil Supplies Corporation praying for an interim injunction restraining the corporation from withdrawing the concession to have the benefit of attendance without working.

The main grievance of the union that filed the petition is that the benefits given to other unions has been denied to it.

The TNCSC submitted that no work relief is granted to any of the trade unions operating in the corporation.

The judge observed that this court had time and again said no right can be claimed from the employer on the ground that the workmen had become office—bearers of trade unions. The workmen were employed in an industry to perform their work and claim benefits for work they had not done. The judge also chided the employers for extending such a benefit.

The employers, instead of ensuring that production is maximised and productivity enhanced, has been a party to the wastage of public funds by allowing their employees to claim benefits without doing any work, he said. Ens.

 - (vii) If a pensioner fails to nominate any person or nomination is not valid, the sum under the Tamil Nadu Electricity Board Pensioners' Family Security Fund Scheme shall be paid to all legal heirs irrespective of the fact whether the legal heirs fall within the definition of family or not and shall not lapse to the fund, provided if the nominee dies after the death of the pensioner, but before the payment under the scheme, the lumpsum should be paid to the legal heirs of the nominee and not to the legal heirs of deceased pensioner.

W.M.P.N. 903/98:-

Petition presented to this court to stay the operation of the order of the II respondent in Memo No. 2111/CC 3.1.97–1 dated 14.10.97 pending W.P.No. 637/98 on the file of this court.

ORDER:-

This writ petition and WHP. coming on for orders as to admission on this day upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr. V. Manoharan, advocate for the petitioner herein, the court made the following order:—

Petitioner contends that he has been transferred twice within a space of three months, and that the second transfer is on account of some allegations said to have been made against the petitioner. The first transfer was within the circle. While the second was outside the circle. By the order made on 14.10.1997 i.e. three months ago, petitioner was transferred by the Chief Engineer to a place outside the region, where the petitioner was earlier employed. He was transferred from Kamarajar Electricity Distribution Circle to Tiruvannamalai Electricity Distribution Circle. In the transfer order, it is mentioned that there are allegations against the petitioner. It is open to the administration to deploy the personnel at a place where the administration considers that their services can be well utilised. Changing the location of the employee from one place to another, when allegations have been made, and which allegations the employer considers to be a **Prima facie** credible is a permissible administrative power. It does not cast any sticma nor is it a punishment. There is no loss of emoluments, statue seniority or prospect of promotion.

2. I do not therefore, find any good ground to entertain this writ petition. The same is dismissed consequently, W.M.P.No. 903 of 1998 is dismissed.

FESTIVALADVANCE—Sanction of Festival Advance to pensioners—Procedure for obtaining application from the pensioners—Revised—Orders—Issued.

Proceedings:

In the Board Proceeding first cited orders have been issued for grant of Festival advance to the Board's pensioners, subject to certain conditions. As per the orders, a pensioner, shall apply to the Chief Internal Audit Officer/Board Office Audit Branch, the sanctioning authority for festival advance. The Chief Internal Audit Officer shall advice the Indian Overseas Bank to credit the advance in the Savings Bank Account of the pensioner, besides making entries in both the halves of Pension Payment Order to that effect.

- 2. The Government have in the G.O. fourth cited now issued orders revising the procedure to obtain application from the pensioners for sanction of festival advance. The Tamil Nadu Electricity Board has decided to adopt the said orders of the Government to Board's pensioners. Accordingly, the following orders are issued:—
- (i) The procedure of obtaining application from the pensioners for sanction of festival advance shall be dispensed with, in respect of those who opt for the payment of festival advance regularly every year. In other cases, application for sanction of festival advance is necessary;
- (ii) Option shall be obtained from the pensioners agreeing to draw the festival advance regularly for a particular festival every year along with the monthly pension;
- (iii) In respect of festivals that fall during 1st to 15th day of the month, the festival advance will be paid, along with the pension for the month, immediately preceding the previous month of the festival;
- (a) i.e. If the festival falls between 1st to 15th of October '97, the festival advance shall be paid along with the pension for the month of August '97;
- (b) For the festivals falling after 16th of the month, the festival advance will be paid along with the pension for the previous month;

- (iv) Option once exercised shall be final;
- (v) The procedure of making entry in the Pensioners Half of the Pension Pay Order for sanction of Festival Advance shall be dispensed with, only for those who opt for this scheme;
- (vi) This order shall take effect from the calender year 1998;

and

- (vii) The other conditions governing the sanction of payment and recovery of festival advance shall continue.

Sub: Electricity - Refund of EMD and Development charges in the case of L.T.I. Industrial Applicants who back out - clarification - Regarding.

Ref: SE/Tuticorin's letter No. SE/TEDC/AEE/Dev/ AE/F.Misc./D.04751/98 dated 31.1.98.

With reference to the clarification sought on the refund of EMD and Development charges the following may be adhered to.

In the case of L.T. industrial applications the Development Charges, Meter Caution Deposit, Service Connection charges may be arranged to be collected after reporting of readiness.

In certain cases if the L.T. applicant had remitted Development charges, Meter Caution Deposit, Earnest Money Deposit (EMD) etc. before reporting readiness but subsequently had backed out, then the Development charges and EMD may be refunded after deducting 25% of EMD. But in future only after reporting readiness the Development charges etc. has to be collected.

Sub: Material Accounting - Accounting of Material cost variance - Instruction - issued.

At present, the fast moving materials are covered under Standard Rate system. The standard rate is revised every year after getting proposal from circles.

As per para 2.20 (3) of Annexure V (Procedural matters relating to Accounting transaction) to the Electricity (supply) Annual Accounts Rules 1985, the variance between actual costs and standard rate shall be collected in a separate account called "Material cost variance" - Account 79.110 and 79.120.

Paras 2.21 to 2.23 of the Annexure V to the ESAR 1985 deal with the 'Treatment of Material cost variance'. Based on the provisions contained in these paras, the following accounting procedures are prescribed to account for the material cost variance.

- (i) Wherever the actual cost of material purchased is less than the standard price, the difference may be credited to the Account 56.610 'Reserve for Material cost variance'.
- (ii) When the standard rate is revised to provide the value of existing stock of materials covered under standard rate should be revised debiting stock (22.5) and crediting the Account 56.610. This may be done by Preparing adjustment devoluting on receipt of revised standard rate for all the Materials getting revised upwards. When the standard rate is reduced, a minus devolution may be prepared to reduce the values of stock giving minus credit to Account 56.610.
- (iii) Wherever the actual cost of materials purchased is more than the standard rate, the difference may be debited to Account 79.110 Material cost variance.
- (iv) At the year end, the balance under Account 79.110 and 79.120 may be adjusted against the credit under Account 56.610 to the extent credit is available. The balance debit only should be taken to schedule 15 to be adjusted against Revenue.

The perusal of the Annual Statement of Accounts for 1996-97 revealed that in some circles, there was vast difference between the value of materials stock as per the Balance Sheet and the value of stock as per the inventory Return for the Quarter ended 31.3.'97.

It may therefore be verified and confirmed that value of stock was revised whenever the Standard rates were revised previousely.

Sub: Tenders - Delay in delivery - Liquidated Damages - Contract price - defined.

Ref: CE/Distn/Villupuram's Lr. No. CE/D/VPM/AEE/MM/F.Inspn/D.497/97, Dt. 4.10.97.

In his letter under reference, the Chief Engineer/ Distribution/Villupuram has raised a point for clarification as to whether the L.D. to be levied on the contract price with reference to T.R. No. 10.7 (a) should be only on the ex.factory price of the material or on price including Excise Duty, Sales Tax and other statutory levies, freight and insurance charges for FOR (D) delivery.

The term 'contract price' occuring in T.R. No.10.7 (a) would mean the price arrived at the contract and contracted. And this would include all statutory levies, freight and insurance charges also.

This matter was examined by the Legal Advisor also and after careful consideration, it is hereby clarified that the "Contract Price" in T.R. No. 107 (a) would include Ex-factory price of the material, statutory levies, freight and insurance charges also and that the L.D. should be calculated on this total contract price of the undelivered/belatedly delivered items/materials, that could be adjusted against the 10% S.D. plus 5% balance payment due to the supplier.

In order to get supplementary generation support from the High Tension Industrial Consumers owning Captive Power Generation and also to obtain certain amount of relief in the demand of the Grid, it has been decided by Tamil Nadu Electricity Board to extend certain incentives in the monthly demand charges for those High Tension Consumers who use their Captive Generating sets to the maximum possible extent.

The Tamil Nadu Electricity Board, therefore, directs that incentive in the monthly demand charges as shown in Annexure may be extended to those high tension industrial consumers who utilise their Captive Generation to meet out their demand, subject to the following conditions.

- (i) The above incentive is applicable from 16.3.98 to 15.6.98 and for the billing months of March '98, April '98, May '98 and June '98.
- (ii) The demand taken into account for calculating the incentives i.e. (x minus y) and (x minus z) as indicated in the Annexure shall not exceed the total approved capacity of captive generation. And in case it exceeds, it shall be limited to the total approved capacity of captive generation.
- Superintending Engineers of all Electricity Distribution Circles shall ensure that while the H.T. readings are received in their office, the field Executive Engineers/Assistant Executive Engineers send a certificate along with the meter card that the consumer has run the captive sets during that month.
- (iv) The incentive offered shall not be applicable to those H.T. Industrial Consumers who do not own captive generating sets.
- 2. The Tamil Nadu Electricity Board also directs that approval and ratification of the Government of Tamil Nadu may be obtained separately for the above proposal.

The Government of Tamil Nadu has directed under G.O. cited second above that EnergyAudit for the Industrial Sector and Commercial Establishments with H.T.power consumption shall be mandatory.

The Board after careful examination has directed that the proposal of making EnergyAudit Mandatory as declared by the Government of Tamil Nadu be implemented, vide B.P. cited third above.

Necessary amendment to the Terms and Conditions of Supply of Electricity has already been issued, vide Clause 32 (A) to implement the above B.P.

Now the Board has imposed some punitive measures for non-compliance of energy audit on the erring H.T. consumers vide B.P. (F.B.) No.47 (Technical Branch) Dated: 4.3.98. necessitating amendment to the above Clause.

In Exercise of the powers conferred by Section 49 of the Electricity (Supply) Act, 1948 (Central Act LIV of 1948), the Tamil Nadu Electricity Board issues the following amendment to Terms and Conditions of Supply of Electricity Notified in B.P.Ms. (F.B.)No.61, Dated 24.12.88 and published in Part–VI, Section 3 (b) of Tamil Nadu Government Gazette No. 7, dated 21.2.96 and as amended subsequently.

This amendment shall come into force with immediate effect.

AMENDMENT

The following shall be included as item (iii) under Clause 32 (A) of Terms and Conditions of Supply of Electricity.

For non-compliance of energy audit as directed by Tamil Nadu Electricity Board, the following punitive measures are to be imposed on erring H.T. consumers.

- (a) Warning notice is to be issued to the H.T. consumers to complete energy audit within three months from the due date for submission of reports.
- (b) One percent (1%) of Current Consumption charges (total energy bill) will be levied as penalty for every month for non-submission of energy audit report from the 4th month to the 9th month.
- (c) Two percent (2%) of Current Consumption charges (total energy bill) will be levied as penalty for every month for non–submission of energy audit report from the 10th month to 15th month.
 - (d) Beyond 15th Month, H.T. service will be disconnected for non-fulfilment of the above conditions.

- Accordingly the Districtwise and circlewise Targets have been worked out and furnished in the Annexures. The target for the divisions may be fixed in such a way that the division having the oldest applications gets a substantial higher target.
- 3. Special Priority in extending supply to pumpsets may be given as per Govt. orders in force within the overall target of Electricity Distribution Circles.
- 4. Priority may be given to the parties who have already reported their readiness under normal priority and issue of notices may be regulated to 50% of the target including the number of parties who have already reported their readiness.
- 5. In the case of Revised Self Financing Scheme, the target of 10000 Nos. for those whose estimate cost is less than Rs.50,000/-- and the applicants have to pay Rs.10,000/-- only is alone shown in the Revised Self Financing Scheme category in the Annexure-1.

- 6. The Chief Engineers (Distribution) and Superintending Engineers/Electricity Distribution Circles are requested to adhere to the targets and send monthly progress reports to the Superintending Engineer/Rural Electrification & Improvement (Distribution). Monthly progress reports shall cover the no.of agricultural service connections effected under the following categories.
 - Pumpsets for handicapped, windows, tribals and Ex-Servicemen as per Government orders.
 - (ii) Jeevandhara scheme for scheduled caste/scheduled tribes under National Rural Employment Programme (NREP) and Rural Landless Employment Guarantee Programme (RLEGP).
 - (iii) Restoration of supply to the Agriculturists whose services were disconnected.
 - (iv) Spillover cases of mere service connections/one pole for Special reasons.
 - (v) Normal registration priority.
 - (vi) Droughts Prone Areas Programme (DPAP) well and community wells.
 - (vii) Mere service/one pole category.
 - (viii) Revised Self Financing Scheme.
 - (ix) HVDS Pumpsets for Dharmapuri District.
- 7. In case of any shortfall in achieving the target in any of the circles, the Chief Engineers (Distribution) of the region may reallocate the target to the other circles within the region without affecting the Districtwise targets. Any such modification may be intimated to Superintending Engineer/Rural Electrification and Improvements (Distribution) for information.
- 8. If any new circle/district is formed, the Chief Engineers (Distribution) of the Region may suitably reallocate and fix the target for the bifurcated Circle/District under intimation to the Superintending Engineer/Rural Electrification & Improvements (Distribution).
- 9. The receipt of this Memo. may be acknowledged to the Superintending Engineer/Rural Electrification and Improvements (Distribution).
