

Circular Memo. No. 37475/PI/U I (Audit Branch), Dt. 25-8-'98.

Sub: Employees of TNEB—Grant of Extra-Ordinary Leave to take up employment abroad—collection of Pension Contribution—Regarding.

The employees of the Board desirous of seeking employment abroad, irrespective of categories to which they belong, are permitted to apply and secure employment abroad and the period of absence during employment is being treated as Extra-Ordinary Leave without allowances, upto a period of maximum 5 years.

- 2. It has also been ordered in B.P. (FB) No. 88 dated 24-10-91 that if contribution towards Pension is remitted to the Board, such periods will count for pension.
- 3. The pension contribution due in respect of the Board employees who were granted Extra-Ordinary Leave to secure employment abroad has to be paid annually within fifteen days from the end of each financial year or at the end of the foreign service, if the period on foreign service expires before the end of the financial year and it also attracts interest on delayed payments.
- 4. The Accountant General, while exercising audit, has reported that the contribution towards Leave Salary/Pension in most cases are not remitted according to the instructions in vogue and suggested to issue instructions to all the concerned to communicate the details of the employees going on foreign service/employment abroad, to the Board Office Audit Branch for calculation of Leave Salary Contribution and Pension contribution and watching the remittance.
- 5. In view of the above, while sanctioning the Extra-Ordinary Leave to take up employment abroad/deputation of a Board employee on foreign service, the Head of Office should ensure that the term and conditions of deputation/sanction of Extra-Ordinary Leave specifically provide for recovery of contribution annually within 15 days from the end of the financial year or at the end of the foreign service, if the deputation on foreign service expires before the end of the financial year.
- 6. The Head of Offices are therefore requested to send a statement furnishing cases of foreign service/Extra-Ordinary Leave on employment abroad in the form annexed to this Circular for each half year ending March and September to the Chief Internal Audit Officer.
- 7. Copies of the orders of deputation on foreign service/grant of Extra-Ordinary Leave of personnel to seek employment abroad may be sent to the Board Office Audit Branch. Immediately on relief, the Service Book of the employee may be arranged to be sent along with the term and conditions, for calculation of Pension contribution and making necessary entries therein.

A point has been raised for a Clarification that whether a reference from the Chief Engineer/Personnel has to be made to the C.I.D. (Security) eventhough a clearance from Vigilance Cell/Tamil Nadu Electricity Board has been obtained in respect of the staff and even after their applications for grant of No Objection Certified to obtain Passport are forwarded by the Superintending Engineer/Chief Engineer furnishing the detailes as 'NIL' in column 19 of the format as prescribed in the reference 1 cited.

2. This has been examined and decided that such a reference shall be made by the Chief Engineer/Personnel to the Superintendent of Police Special Branch C.I.D. for a clearance. Accordingly it is clarified that the Chief Engineer/Personnel shall address the Superintendent of Police Special Branch C.I.D., (Security) in respect of the employees and officers being dealt with by him and only after receiving a clear report from Superintendent of Police Special Branch C.I.D., a No. Objection Certificate shall be granted to apply for or renewal of Passport or for undertaking a visit to a foreign country.

Sanction is hereby accorded for the creation of one post of Officer on Special Duty in the scale of pay of Rs. 17600—500—22,100 for a period from the date of assumption of charge by the incumbent and upto 30—9—98 with Head Quarters at Chennai, so as to accommodate the Senior Chief Engineer to be appointed in the post of Member (Generation) and to become familiar with functions and responsibilities of the Member (Generation).

- 2. The post sanctioned in para 1 above shall carry in all previleges attached to the post of Member with a special pay of Rs. 250/- (Rupees two hundred and fifty only).
- 3. The incumbent of the post sanctioned in para 1 above will be eligible to draw the usual pay, Dearness Allowance, House Rent Allowance, City Compensatory A'lowance and other allowance at the rates admissible under the order in force wherever applicable.
- 4. The Pay and Allowances of the post sanctioned in para 1 above will be drawn and disbursed by Under Secretary/Establishment, Board Office Secretariat Branch.

Sub: Tamil Nadu Electricity Board—Workmen/Officers—Revision of Scales of pay, Special pays and allowances with effect from 1—12—1996—further clarifications—Issued.

Ref: (i) (Per) B.P. (FB) No. 58, (Sectt. Br.) dt. 18-7-98.

The attention of the Chief Engineers/Superintending Engineers/other officers of the Board is invited to the references cited. The further points raised are clarified as below:—

SI. No.	Points raised	Clarifications issued

- It is presumed that rates of HRA which were in force from 1—4—93 have to be continued to be applied for the revised pay from 1-12-96 to 31-3-98 also. Whether the above presumption is correct.
- Whether the period of service rendered as Helper (Trainee) may be taken into account for the purpose of allowing service weightage, on the ground that the same has been taken into account for the purpose of sanction of HBA, Conveyance Advance etc.
- Whether the difference of arrears for the encashment of earned leave at credit at the time of retirement for the retired employees may be paid in full for those who retired on or before 30-6-1998 or 50% of the above is to be withheld for payment after 2003.
- 4. Whether the difference of arrears for the encashment of leave on private affairs to those who availed this benefit prior to the issue of Board's (Permanent) B.P. (FB) No. 76, (\$B), dated 11-9-1997 may be paid in full or 50% is to be withheld.
- 5. In case of special pays/allowances being paid on percentage basis (other than those specifically ordered in the B.Ps cited) and in cases of recovery of rent in Board's quarters being made on percentage basts, whether the same percentage may be adopted in the revised scales of pay also.

- The presumption is **not** correct. In the Tamil Nadu Electricity Board Revised (Workmen / Officers) Scales of Pay Regulations 1998, the rates of HRA, special pays and other allowances have been revised only with effect from 1-4-1998 and not with effect from 1-12-96. The quantum of special pay / allowances already drawn in the pre-revised scale of pay requires no revision.
- 2. In the Tamil Nadu Electricity Board Revised Scales of pay (Workmen/Officers) Regulations, 1998, it has been ordered that "a service weightage of one increment for the first 7 (Seven) years of regular completed service which will count for increment....... will be allowed......". Only regular completed service in the time scale of pay will count for increment. Therefore, the service rendered as Trainee should not be counted for the purpose of allowing service weightage.
- Separate instructions will be issued. Till then the difference need not be claimed.

- 5. No. In such cases the payment/recovery should not be made on percentage basis in the revised scales of pay. The quantum already paid/recovered in the pre-revised pay scales shall be continued.

- 6. In para 4 (12) of the "Tamil Nadu Electricity Board Revised Scales of pay Regulations (Workmen/Officers) 1998", it has been mentioned that "the pay of a Board employee who was reverted from a higher post to a lower post prior to 1-12-96 and got repromotion after getting his pay fixed in the lower post under "Tamil Nadu Electricity Board Revised Scales of pay (Workmen / Officers) Regulation 1998" shall be fixed again under SR 33 (b) in the higher post in the revised scales. In all such cases, the restrictive provisions in Note (2) under SR 33 (b) shall not be applicable." Whether such refixation in the higher post should be made in all cases without regard to the individual employee's option for fixation of pay in the promoted post?
- 7. It has been ordered that the existing stipulated period of 10 years for movement to Selection Grade would be reduced to 9 years with effect from 8—7—98. Whether those employees who have completed 9 years or more on 8—7—98 should be moved to Selection Grade on 8—7—98.
- 8. Whether the orders for payment of 50% of arrears in cash and crediting 50% into GPF Account will apply also to part payment of arrears arising out of refixation of pay in the Revised Scale of pay on account of promotion, movement to Selection Grade, revision of special pay / allowances, etc. after coming over to Revised Scale of pay?

6. The Regulation in para 4 (12) of the Tamil Nadu Electricity Board Revised scale of pay (Workmen / Officers) Regulations, 1998 will apply only in cases where an employee draws an increment in the lower post during the period of reversion falling after 1—12—1996, leading to increased fixation of pay in the higher post.

Refixation in such cases shall be made only if any individual opts for such an arrangement.

In cases of employees promoted prior to 1—12—96 and opted for fixation of pay in the promoted post from a date prior to 1—12—96, and who had not exercised any revision of option for fixation of pay in the higher post, his pay in the higher post on the date of repromotion will be what he would have been entitled to in the higher post in the revised scales of pay, but for his reversion.

- 7. Yes. But in the case of employees who have completed 10 years of service prior to 8-7-98, they should be moved to Selection grade on the date of completion of 10 years itself with reference to the then existing orders.
- 8. Yes. The said orders will apply in respect of all cases of payment of arrears pertaining to the period between 30—11—1996, and 1—7—1998, including part-payment of arrears arising out of any kind of refixation of pay/revision of special pay and allowances, etc. after coming over to Revised Scales of pay.

Sub: Health Fund Scheme—Grant of financial assistance/ advance payment to the Board employees under Health Fund Scheme—Union representative participation during 1—7—98 to 30—6—99—Intimation.

In the Board's Proceedings cited, a Committee for section of financial assistance to the employees other than Class I Officers was constituted under the Tamil Nadu Electricity Board Health Fund Scheme. It has been ordered among other things that the Union representative has to be changed annually by rotation among the unions recognised under the Code of Discipline, Centrally Affiliated Unions and Officers' Associations. The tenure for the representation given to the Tamil Nadu Electricity Board Workers Federation in the above committee (i.e. one year from 1—7—97 to 30—6—98) is already over. The next turn comes to the Tamil Nadu Electricity Board Accounts and Excutive Staff Union. The tenure for this Union will be for a period of one year from 1—7—98 to 30—6—99.

2. Accordingly, instead of the Union representation mentioned in para 4 (iv) (b) 5 of the B.P. cited the following shall be the Union representative for one year from 1—7—98 to 30—6—99:-

Sub: PENSION—Tamil Nadu Electricity Board—Revision of pension and pensionary benefits—Payment of arrears—Crediting 50% of arrears in separate account of pensioner/family pensioners—Maintenance of account—Instructions—Issued.

Ref: (Per.) B.P. (Ch.) No. 208, dt. 18-8-98.

In the B.P. cited, orders have been issued revising the pension and pensionary benefits to the pensioners and retiring employees of the Tamil Nadu Electricity Board. The attention of the Chief Internel Audit Officer is in particular invited to para 8 of the B.P. cited and he is directed to issue necessary working instructions and illustrations and ensure expeditious revision and settlement of pension and pensionary benefits in accordance with the orders in the Board's proceedings.

In the B.P. cited, among other things, the following orders have been issued for payment of arrears:-

"From out of the net arrears arrived at 50% (fifty per cent) shall be paid immediately and the balance 50% (fifty per cent) of the arrears shall be paid to pensioners/family pensioners on or after 1—7—2003 with interest as admissible to General Provident Fund. The arrears in respect of employees retired on or after 1—12—1996 who derive fixation of pay and consequential revision of pay, pension and pensionary benefits up to 31-3-1998 shall also be regulated as detailed above."

3. The Chief Internal Audit Officer should inform the individual pensioners/family pensioners of the amount of arrears kept in such a separate account, the account number and the authority who is maintaining the accounts. He should also inform the pensioners family pensioners annually by sending an account slip containing the amount of arrears and interest accrued till the arrears are finally settled. The pensioners/family pensioners should also be informed of the authority (by designation) to whom application should be made for final withdrawal of the amount after the specified period is over.

In the Board's Memo, first cited, instructions were issued to all Branches of Board Office that all Staff proposals (except those covered under work-land settlement) should in the first instance be routed through O&M Cell which is a specialised agency to deal with such matters. Recently, it has been brought to the notice of the Board Level Tender Committee that in a case of major printing work (Green Meter Cards), the Board's Printing Press at Villivakkam was not consulted whether it could undertake the job and limited tenders were floated for the work. The Press, with its newly purchased offset machine could complete the work at a very much cheaper rate and in time as against the rate quoted by the L1 in the limited tender floated. The tender has been deferred by the Tender Committee to examine feasibility of Printing the same at the Board's Press. Tamil Nadu Electricity Board Press also agreed to undertake the work. This will facilitate utilisation of Tamil Nadu Electricity Board's Press more economically and the existing workmen in Press also can be more optimally utilised.

2. Note 3 under Table X (B) of the Board's Tender Regulations stipulates that Printing works costing more than Rs. 10,000/- should be entrusted to Private/Public Printers, only after confirming that the Board's Press is unable to execute the work.

The field Chief Engineers were procuring materials without any, restrictions and thereby the inventory level rose up. Therefore to bring the inventory level under control the powers of field Chief Engineers were restricted.

- 2. In the B.P. (F.B.) No. 230 (TB) dt. 17-10-96 the powers were restricted as below.
- (i) In respect of proprietory materials, emergent requirement of materials or emergent nature of works, single tender system may be adopted. The list of proprietory items will be approved be Board Level Tender Committee.
- (ii) Limited Tender System may be adopted for procurement of materials of value upto Rs. 2 Lakhs per material per annum and execution of works contracts of value upto Rs. 2 Lakhs per item of work by issuing enquiries to all the registered suppliers/contractors.

- 3. With the restrictions imposed as above the field Chief Engineers and Superintending Engineers are facing lot of difficulties in procuring the essential spares for the Generating Stations and Sub-Stations etc. especially during emergencies.
- 4. Therefore a Circular was issued by the Accounts Branch Vide Circular No. DFC/T/X/T/A1/96—1 dt. 30—11—96 through which the Chief Engineers/Distribution were authorised to purchase materials upto Rs. 6 Lakhs per order under open tender System enabling them to procure very essential materials in order to keep up uninterrupted power supply and also to achieve the targets. It was also stated that in case, where the value of P.O. exceeds Rs. 6 Lakhs per material per annum approval of Member (Distribution) may be obtained.
- 5. In 793rd Meeting of the Board held on 15—5—98, the suggestion of Member (Distribution) and Member (Generation) to restore powers to Chief Engineers/Superintending Engineers as per Tender Regulations has been accepted.

In the letter cited under reference, the Superintending Engineer/Erode Electricity Distribution Circle has requested to clarify whether exemption from payment of Electricity Tax. has to be allowed in respect of Hit industrial consumers who got H.T. service connection on or after 15—2—97 after

the out off date stipulated in G.O. (Ms.) No. 17, dated 14-2-97 and not eligible for Tariff Concession as per the G.O. and who have gone to the High Court against the above G.O. and enjoying Tariff Concession as per Interim Orders of the High Court.

The matter has been examined and in this connection the following are stated.

As per G.O. (Ms.) No. 1084, P.W. (VI) Department, dated 30-7-92, the Governor of Tamil Nadu hereby makes an exemption in respect of the Additional Tax payable by any New Industrial Undertaking established in the State of Tamil Nadu, for a period of three years from the date of commencement of the manufacture or production of the Principal product. Accordingly the C.E.I.G. had issued instructions to the Superintending Ingineers of Distribution Circles to send the applications of the Industrialists for the exemption from payment of Electricity Tax to him for his examination and issue of orders. Subsequently based on the representations received from many H.T. Industrial consumers that exemption from the payment of Electricity Tax for their New Industries are not being allowed though the Government have ordered so in July 1992, the procedure was modified and exemption from payment of Electricity Tax is being ellowed by the Superintending Engineers/Distribution Circles concerned as per instructions issued vide B.P. (FB) No. 119, dated 17-6-93.

Accordingly, new H.T. Industries who were granted Tariff Concession by Member (Distribution) after ensuring that the Unit is a New Industry, exemption from payment of Electricity Tax were also allowed by the Superintending Engineers of Distribution Circle. Now, since the Government in G.O. (Ms.) No. 17, dated 14—2—97 has Withdrawn Tariff Concession the fact whether the Unit is a New Industry is not verified and ensured. Without ensuring that the Unit satisfies the condition as for New Industry as stipulated in B.P. (FB) No. 119, dated 17—6—93 it is considered that exemption from payment of Electricity Tax may not be allowed by the SuperIntending Engineers of Distribution Circles.

In view of the above, eventhough. Court has given Interim Orders to allow Tariff Concession to certain H.T. Industries pending disposal of the Writ Petition filed in such cases, it is not correct to allow exemption from payment of Electricity Tax in respect of such Industries without verifying the condition as stipulated in B.P. (FB) No. 119, dated 17-6-93, especially when no such instructions have been issued by Headquarters Office and also the Interim Orders issued in such cases do not mention to allow such Tax exemption.

Further since allowing of exemption from payment of Electricity Tax is loss of Revenue to the Government, the Superintending Engineer/Erode Electricity Distribution Circle is informed not to allow exemption from payment of Electricity Tax in respect of such H.T. Industries who are availing Tariff Concession as per Court Interim Orders. Such H.T. Industrial consumers may be requested to Contact C.E.I.G. further in this matter, for getting exemption from payment of Electricity Tax.

Proceedings:

Based on the recommendations of the TNEB, the Government of Tamil Nadu, has ordered the provision of Electronic Meters in all LT CT services, prescribed that a minimum power factor of 0.85 shall be maintained in all such services and levy of penalty for lower power factors to the consumers connected with LT CT Meter. The Tamil Nadu Electricity Board also directs the following:—

- 1. Electronic Energy Meters with provision to record the MD in KW & Power Factor should be provided in place of the existing electromechanical meters in all the said LT CT services at an approximate cost of Rs. 5.25 crores. In future new LT CT services shall be effected with Electronic meters only.
- 2. Fixed charges of Rs. 1.00 per KW per month should be levied for these consumers for recovery of the meter cost, instead of the present specified rate of fixed charges per service as per Tariff G.O. Ms. No. 115 Energy (A2) dated 19—7—98.
- 3. The load sanction including the lighting load for these LT CT services should be accorded on KW basis instead of HP basis. The maximum KW sanction for LT CT service shall be 112 KW including the lighting load. Whenever the MD is exceeded by the consumer, penalty should be levied as below:
- (a) In case actual recorded demand is upto 112 KW, for every KW excess or part thereof over the sanctioned demand, penalty of 1% of total energy charges alone should be levied.
- (b) In case of actual recorded demand exceeding 112 KW, the penalty should be levied at 1.5% over and above 112 KW and upto 112 KW 1%.
- 4. Penal levy for Low Power Factor for all LT CT services should be levied as per the provision in G.O. Ms. No. 115 Energy (A2) dated 19—7—98.

Such LT CT services will not attract, the provisions of clause 22.02 of the Terms and conditions of supply of Electricity.

In case of actual demand exceeding the sanctioned KW demand occuring more than once in a calendar year and if such exceeded demand is not more than 112 KW, then the existing load sanction of such LT CT services should be revised within one month to the level of exceeding the already sanctioned demand and the necessary charges to be included in the next bill after intimation to the consumer.

In cases where the exceeded demand is more than 112 KW & occurs more than once in a calendar year, the consumer should not exceed the sanctioned demand thereafter of H.T. supply has to be availed within 3 months by the consumer.

Implementation of these orders will be after procurement and supply of necessary Electronic meters.

The Superintending Engineer/IEMC will issue necessary working instructions to implement them.

The Superintending Engineer/IEMC will also arrange for issuance of necessary amendments to the Terms and conditions of supply wherever necessary.
