

At present, the dependants of the deceased and medically invalidated employees of the Board, who are selected to the post of Assessors are appointed as trainees for a period of two years on consolidated wages of Rs.2500/- per month and after completion of successful period of two years, they will be appointed as Regular Assessor.

"The above Writ Petition was disposed of by the High Court on 24.9.2002, which relates to rejection of Petitioner's application for appointment on compassionate grounds. While quashing the order of rejection, the Learned Judge has observed that in similar matters, orders are being passed without giving any reasons. Since the order does not contain any reasons and it is being a non-speaking order, the Learned Judge has set aside the same and remitted the matter back to the Respondents to pass fresh orders within the stipulated time.

- 2) The Learned Judge, while allowing the above case has observed that in future, atleast in similar matters orders will have to be passed which would contain reasons for the conclusion arrived at. The Learned Judge also further observed that a Circular to be issued in this regard to all the Authorities concerned to pass orders hereafter, containing reasons.
- 3) I therefore request that a Circular may be immediately sent to all the concerned Circles, directing them to follow the procedure indicated by the Hon'ble High Court and a copy of the Order passed in the above Writ Petition may also be enclosed along with the Circular for future guidance. It is therefore necessary that necessary immediate action may be taken as per the directions of the Learned Judge."

ORDER

The petitioner prays for the issue of a writ of certiorarified mandamus calling for the records of the second respondent related to Lr.No.013001/22A/Adm.III/A3/F.EMP.Asst./99, dated 3.7.1999 and quash the same.

- 2) Heard the learned counsel for the petitioner and the Standing Counsel for the respondents.
- 3) The order impugned ex facie would show it is non-speaking and demonstrates non-application of mind by the second respondent. The second respondent being an administrative authority has to pass a speaking order, giving reasons as to why he is rejecting the application of the petitioner. The second respondent has to apply his mind and state that whether the petitioner is eligible to be considered or he is entitled to be appointed or not or whether he is ineligible to be considered, before disposing of the application for compassionate appointment. If posts are not vacant as on the date of passing of the order, the respondents should have included the name of the petitioner in a Register to be maintained in this respect and as when the vacancy arises, those persons placed in the Register should be appointed in rotation. Instead, the second respondent has straight away rejected the application by stating 'rejected'. Time and again, this Court has been directing the respondent/Electricity Board to pass a speaking order and assign reasons. Yet, such orders are being repeated. It is unfortunate that the respondent/Electricity Board and its engineer have been passing such orders.
- 4) While quashing the impugned communication dated 3.7.1999 and allowing the Writ Petition, second respondent is directed to reconsider the petitioner's request according to the Electricity Board's Circular. The second respondent shall pass orders within a period of three months from the date of receipt of a copy of this order.
- 5) The first respondent is directed to circulate the directions issued by this court in identical matters from time to time and see that atleast here afterwards, its engineers or subordinates pass speaking order in such matters.
- 6) With the above directions, the Writ Petition is ordered as above. No costs. Consequently, connected W.P.M.P is dismissed.

Proceedings:-

Regulation 92 of the Tamil Nadu Electricity Board Service Regulations prescribes that an Assistant Executive Engineer/Electrical has to serve in any of the special field post for a period of 2 years as Assistant Executive Engineer (or) 4 years as Assistant Engineer/Electrical/Junior Engineer/Electrical I Grade as a pre-requisite condition for their promotion to the post of Executive Engineer/Electrical. The special field includes areas like Generating Stations, Shift/Maintenance in 230/110 K.V.Grid Sub-Station, 230/110 K.V. Lines Maintenance, Meter Relay Test, Special Maintenance, Sub-Station Erection, Transmission Line Construction & Project works.

- 2) The Concept of Special Field was originated early during 1981 in order to motivate the Engineers to opt to serve in Hydro Stations as there was reluctance on the part of Assistant Engineers/Junior Engineers I Grade Electrical and Assistant Executive Engineers/Electrical cadre to serve in Hydro Projects/Stations. As the number of posts of Assistant Executive Engineers in Hydro Station and certain other fields were not adequate to meet the requirements of all the senior incumbents to have special field experience, this facility of covering special experience was extended to the Protection and Communication, Chennai Development Circle, Grid Relay Test, Load Despatch Centre, etc. The regulation was amended from time to time in the references read (i) to (iv) above extending the area of special field. But this condition was relaxed in favour of personnel not possessing required spl. experience to enable them to get the promotion of Executive Engineer during subsequent years.
- 3) During the past two years, persons who have not completed 2 years of Spl. experience as on the crucial date of preparation of panel to the post of Executive Engineer but who had completed the same as on the date of Departmental Promotion Committee meeting were considered for inclusion in the panel.
- 4) Further all the shift posts in Hydro Power Houses have been down graded from Assistant Executive Engineer/Electrical to Assistant Engineer/Electrical and now separate recruitment of about 200 Assistant Engineers specially for Generation Wing has been made. As such adequate number of Engineers are available at all point of time to look after Generation works. The above downgradation and exclusive recruitment made for generation wing have reduced the necessity for posting others to Generation Wing. Further if others are posted in Generation Wing for the objective of acquiring special field experience then it will only replace the already experienced personnel in Generation Wing which may not be beneficial for the efficient operation of the Power Houses. Further such special field experience is not insisted upon in other discipline (i.e.) Mechl. and Civil.
- 5) The Tamil Nadu Electricity Board Engineers Association has been representing frequently for scrapping of the above provision prescribing experience in certain special fields as pre-condition for promotion as Executive Engineers/Electrical and to amend the service regulation suitably.
- 6) The Tamil Nadu Electricity Board after careful examination of the matter directs that the requirement of two years spl.field experience made as pre-requisite in S.R. 92 of Tamil Nadu Electricity Board Service Regulation for Assistant Executive Engineer/Electrical to get eligibility for consideration in the panel for promotion to the post of Executive Engineer/Electrical be deleted. On promotion such persons should be posted in the Spl. field area to the extent possible.

- 7) This order is given effect to in respect of the current panel approved in (Per.) B.P. (Ch.) No.181, (S.B.), dated 6.9.2002. which is in operation.
 - 8) Orders amending the regulation will be issued separately.

Regulations – Tamil Nadu Electricity Board Service Regulations – Rule of Reservation – Ban on de-reservation – Amendments to Regulation 89 of Tamil Nadu Electricity Board Service Regulations – Issued.

In exercise of the powers conferred by Section 79 (c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), the Tamil Nadu Electricity Board hereby makes the following amendment to the Tamil Nadu Electricity Board Service Regulations:-

AMENDMENTS

In the said Regulations,

- (1) in regulation 89, for sub-regulation (c), the following sub-regulation shall be substituted, namely:-
- "(c) For selection for appointment by direct recruitment, there shall be a ban on de-reservation of vacancies reserved for the candidates belonging to any of the Scheduled Castes, Scheduled Tribes, Most Backward Classes and Denotified Communities to be appointed by direct recruitment. But the above ban on dereservation of vacancies shall not be applicable to the vacancies reserved for the Backward Classes (other than Most Backward Classes and Denotified Communities) and therefore if qualified and suitable candidates belonging to any of the Backward Classes (other than Most Backward Classes and Denotified Communities) are not available for appointment the turn, so allotted to them shall lapse and the vacancy shall be filled by the next turn in the order of rotation. If sufficient number of qualified and suitable candidates belonging to any of the Scheduled Castes, Scheduled Tribes, Most Backward Classes and Denotified Communities are not available for selection for appointment for the vacancies reserved for them by direct recruitment in the first attempt for recruitment then a second attempt shall be made for selection of the candidates belonging to the respective communities by direct recruitment in the same recruitment year or as early as possible before the next direct recruitment for selection of candidates against such vacancies. If the required number of candidates belonging

to such communities are not available even then the vacancies for which selection could not be made shall remain unfilled until the next recruitment year treating them as "backlog" vacancies. In the subsequent year when direct recruitment is made for the vacancies of that year (called the current vacancies), the "backlog" vacancies shall also be announced for direct recruitment keeping the vacancies of the particular recruitment year, namely, the current year vacancies and the "backlog" vacancies as two distinct groups, as illustrated in Schedule-V to this Regulations. While in respect of vacancies for the year of recruitment the normal procedure relating to the calculation of vacancies reserved for the candidates belonging to such communities as well as the instructions that not more than fifty percent of the vacancies shall be reserved for Scheduled Castes/Scheduled Tribes Communities and physically handicapped shall apply, selection for appointment for all the "backlog" vacancies reserved for such communities shall be made by the candidates belonging to such communities without any restriction as they belong to distinct group of "backlog" vacancies. The selection for appointment in the next direct recruitment shall be made first for the "backlog" vacancies and then the normal rotation shall be followed:

Provided that in exceptional cases for posts in Class I and II Services for which suitable candidates belonging to the Scheduled Castes, Scheduled Tribes, Most Backward Classes or Denotified Communities are not available against the respective reserved vacancies and the non–filling up of posts causes hardship for running the administration exemption from the ban shall be granted by the Board. The procedure for carrying forward of such vacancies under this regulation shall be as specified in Schedule–V to this regulations."

(2) After Schedule-IV, referred to in Regulation 89 (b) and (bb), the following Schedule shall be added, namely:--

"SCHEDULE-V"

{see Regulation 89 (c)}

The method of carrying forward of vacancies reserved for the Scheduled Castes and Scheduled Tribes candidates by direct recruitment is illustrated below:-

If five vacancies reserved for the candidates belonging to Scheduled Castes and Scheduled Tribes remain unfilled in earlier years and they are carried forward as "backlog" vacancies and fifty new vacancies arise in the year of recruitment of which nine vacancies are to be reserved for the Scheduled Castes and Scheduled Tribes, fifteen vacancies for the Backward Classes, ten vacancies for the Most Backward Classes and Denotified Communities and sixteen vacancies for General Turn following the existing instructions on reservation the number of vacancies to be announced shall be as follows:-

It may be seen from the above that while the vacancies reserved for the Scheduled Castes and Scheduled Tribes which remain unfilled shall be carried forward to the next year of recruitment as "backlog" vacancies the carried forward reservation for the Scheduled Castes and Scheduled Tribes as a result of the filling up of the relevant vacancies after de-reservation shall continue to be operated against "current" vacancies. Proceedings:-

As per the award of Justice Khalid Commission 1st read above and as per the orders issued in the B.Ps. 2,3 and 6 read above, the Contract Labourers engaged in Distribution Circles, General Construction Circle, Thermal Stations, Hydro Stations and Gas Turbine Power Project were absorbed as Helpers on regular basis.

- 2. As the enquiry revealed that some of the Contract Labourers absorbed in the Board as stated in para 1 above have produced bogus educational certificates at the time of their absorption into Board, instructions were issued in the reference 5th cited to the Superintending Engineers to refer the certificates as proof of qualification and age produced by the Contract Labourers absorbed as Helpers to the concerned department to ascertain the genuineness or otherwise of the certificates. In case the certificate produced is proved to be not genuine, the Superintending Engineers were asked to initiate Disciplinary Proceedings against the workman concerned under the provisions of Standing Orders for Non-Clerical Workman of the Board besides lodging criminal complaints against them.
- 3. Based on the above instructions, action were taken by the Superintending Engineers and they imposed the punishment of removal/dismissal from service against such of the workman against whom it has been proved that the certificates produced were not genuine.
- 4. In many cases where the individuals who were placed under suspension, pending initiation of D.P. and in cases where show cause notice indicating the punishment of removal/dismissal from service were issued, the individual workmen have filed Writ Petition in the High Court challenging the orders of suspension charge memo, show cause notice and punishment, as the case may be. Representations have also been received from number of workmen who were dismissed/removed from service, as well as from unions, requesting for imposing lesser punishment, instead of imposing dismissal/removal from service considering the number of years of service put in by them as Contract Labourers and then as Helper/Wireman, as the punishment of dismissal/removal from service is too severe.
- 5. After careful consideration, the Board has decided to cancel the punishment of dismissal/ removal from service imposed by the Superintending Engineers. The Board has also decided that alternative punishment of "reduction of pay to the minimum of scale of pay of the post held on the date of imposing the punishment for a period of 3 years which will operate for future increments" will be sufficient. Consequently the complaint lodged with the police will also be withdrawn. The period of suspension/ absence in these cases shall be regularised as follows:
 - a) If the orders of dismissal/removal from service are already given effect, the period from the date of dismissal/removal from Board's service till the date of re-joining will be regularised as Extra-ordinary leave without pay and allowances.

- b) Where show cause notice/final orders is challenged and stay obtained, and the individual is continuing in service, the period will be treated as duty.
- c) Where the suspension order was challenged and stay obtained and the individuals are continuing in service, in such cases the employees will be reinstated without prejudice to the Disciplinary Proceedings to be initiated and the period will be treated as duty.
- d) Where the employee is under suspension and Disciplinary Proceedings is pending, the employee will be reinstated without prejudice to the Disciplinary Proceedings pending against him. The period of absence will be regularised by sanction of E.L. at credit and the balance as E.O.L. Without pay and allowances. The subsistence allowance already paid will be adjusted for E.L. at credit and balance amount will be recovered in easy instalments.
- 6. Accordingly, the Tamil Nadu Electricity Board hereby passes the following orders.
- a (i) The punishment of removal/dismissal from service imposed by the Superintending Engineers for production of bogus certificate for qualification, age by Contract Labourers absorbed as Helpers shall be cancelled.
- a (ii) In these cases the punishment of dismissal/ removal imposed shall be modified to that of reduction of pay to the minimum of the time scale of pay of the post held on the date of issue of orders for a period of 3 years which will operate for future increments.
 - b) The period of suspension/absence of these workman shall be regularised as detailed in para 5 above.
- 7. The Superintending Engineers are informed that when the School records are found bogus the date of birth indicated in the school records and reckoned earlier for determining the age of the workman cannot hold good. Hence, in these cases the individual workmen may be directed to obtain and produce birth certificates from competent authorities for determining their age. In case there is difficulty to obtain birth certificate, Medical Certificate from the D.M.O. or equivalent rank may be accepted.
- 8. The above orders will strictly apply only to the case of Contract Labourers absorbed as Helpers and who were dismissed/removed from service solely for production of bogus certificate.
- 9. The Superintending Engineers are informed that the orders shall be issued to individual only after obtaining clearance from this office.

- (1) In the M(D)'s Memo. under reference cited above, all Superintending Engineers/Elecy. Distn. Circle have been informed that as per the provisions of the Water (Prevention and Control of Pollution) Act 1974 as amended in 1988 and the Air (Prevention and Control of Pollution) Act 1981 as amended in 1987, Tamil Nadu Pollution Control Board (TNPCB) is empowered to issue directions for closure, prohibition or regulation of any industry and for stoppage of electricity, water supply and other services and whenever the TNPCB request TNEB to render assistance in stopping the power supply, the request may be complied with.
- (2) Further, as per provision made in Terms and Conditions of Supply of Electricity in Clause 28.01 (c), the Board will be entitled to disconnect supply of Electricity without issue of further notice, if a request from TNPCB is received for stoppage of supply of Electricity to the erring industries units for non-observance of provision of section 33 A of the Water (Prevention and Control of Pollution) Act 1974 as amended in 1988 and Section 31A of Air (Prevention and Control of Pollution) Act 1981 as amended in 1987.
- (3) The Chair Person/TNPCB has now informed to Board that there are delays in implementing the direction of TNPCB in disconnecting the power supply which leads to environmental health hazard to the public in the vicinity of erring units and requested that the powers may be delegated to the concerned AEs./ JEs./O&M to disconnect the power supply as and when the request from TNPCB is received to avoid delay.

(4) The request of Chair Person/TNPCB is considered and the following instruction are issued.

When the request from TNPCB is received directly for stoppage of Electricity to the erring L.T. Quality Control Measures to be adopted in T.N.E.B.

- 1. Adequacy of cement and steel need not be insisted for furnishing the same in the M.Book.
- 2. <u>Cement</u>: The Contractor has to make his own arrangements for the procurement of cement of required specifications for the works subject to the followings:
 - a) The Contractor shall procure cement required for the works only from reputed cement factories (main producer or their authorised agents, manufacturing cement to BIS Standard) acceptable to the Engineer-in-charge. The Contractor shall be required to furnish to the Engineer-in-charge bills of payment and cost certificate issued to the manufacturers or their authorised agents to authenticate procurement of quality cement from the approved cement factory.
 - b) The Contractor shall procure in standard packing of 50 Kg. per bag bearing manufacturers name and ISI marking from the authorised manufacturers. The Contractor shall make necessary arrangement at his own cost to the satisfaction of Engineer-in-charge for actual weighment of random sample from the available stock and shall conform with the specification laid down by the Indian Standards Institution as the case may be. Cement shall be got tested for all the tests at his cost including through destructive and non-destructive test materials etc., as directed by the Engineer-in-charge in advance before the use of cement bags. In case test results indicate that the cement arranged by the Contractor does not conform to the relevant Code, the same shall stand rejected and shall be removed from the site by the Contractor at his own cost within a day's time of written order from the Engineer-in-charge to do so.

- c) The employer will furnish air entraining agents and admixtures required to the contractor free of cost at the employer stores. The use of such admixtures and agents shall be made as per the instructions of the Engineer-in-charge. The cost of cartage/storage, handling, batching mixing shall be borne by the contractor and shall be included by him to unit rate tendered for concrete.
- d) The cement shall be brought at site as decided by the Engineer-in-charge for works.
- e) The cement Godown of suitable capacity as decided by the Engineer-in-charge to store shall be constructed by the contractor at site of work, for which no extra payment shall be made. The Contractor shall facilitate inspection of the cement Godown by the Engineer-in-charge at any time.
- f) The contractor shall further at all times satisfy the Engineer-in-charge on demand by production of records and test book or by submission of returns and other proofs as directed that the cement is being used as tested and approved by the Engineer-in-charge for the purpose and the contractor shall at all times, keeps his records up to date and enable the Engineer-in-charge to apply such checks as he may desire.
- g) Cement which has been unduly long in storage with the contractor or alternatively has deteriorated due to inadequate storage and this become unfit for use on the works will be rejected by the Department and no claim will be entertained. The contractor shall forthwith remove from the work area any cement the Engineer-in-charge may disallow for use of work and replace it by cement complying with the relevant Indian Standards.



REPORT TO ACCOMPANY THE ESTIMATE

The power generated from NCTPS is being evacuated at present by 7 Nos. 230 KV lines namely, 230 KV SC line to ETPS, 230 KV SC line to Korattur, 230 KV SC line to Tondiarpet, 230 KV DC line to Sriperumbudur (one circuit LILOed at Gummidipoondi), 230 KV SC line to Gummidipoondi and 230 KV SC line to Mosur.

Chairman in his inspection note dated 7.6.2001 has directed to propose measures to avoid loss of generation at NCTPS due to inadequacies in transmission system. After detailed load flow studies, it is now proposed to strengthen the power evacuation transmission system of NCTPS by erecting a second 230 KV SC line from NCTPS - Mosur on the free limb of the already existing DC towers of the NCTPS - Mosur 230 KV SC line, which is in addition to the already approved proposal of erection of 2nd 230 KV line from NCTPS to Tondiarpet by rerouting of existing NCTPS - Gummidipoondi I feeder.

The following are the major works involved in the proposed system;

- 1. Erection of 230 KV SC line for a route length of 87 Kms. from NCTPS to Mosur 230 KV SS on the free limb of the existing NCTPS - Mosur 230 KV line strung on 230 KV DC towers.
- 2. Extension of 230 KV bays one No.each at NCTPS (Indoor) and Mosur SS.
- 3. Provision of PLCC line equipment one No. each at NCTPS and Mosur SS.
- 4. Erection of 'D' type towers and accessories for two Nos. 400 KV line crossings.

The estimated cost of the proposal works out to Rs.8.51 Crores (G & N).

Adverting to your letter cited it is clarified that the Earnest Money Deposit amount/Demand Draft given by the bidders for scrap tender has to be brought into Board's collection account immediately on receipt, duly remitting into Board's Bank account.

On finalisation of the scrap tender, Earnest Money Deposit received from the unsuccessful tenderer has to be refunded only through cheque after observing the procedure.

Sub: Electricity – Accounting of Released Solid Copper Strandard Copper Conductor and Copper Scrap – Uniform Procedure to be adopted in accounting – Instructions – Issued – Reg.

The S.E./Villupuram has unilaterally instructed to his Circles Stores to account the various sizes of Solid/Strandard Copper conductors in uncodified folios by merging all sizes of conductors which are already individually codified as sizewar as (1) Solid Copper Conductor released all sizes, (2) Strandard Copper Conductors released all sizes and copper scraps (Misc.) stating the reasons that as these copper conductors are not issued back to the field for use and auctioned by Head Quarters as:

- 1. Solid Copper scrap,
- 2. Strandard Copper Scrap and
- 3. Miscellaneous copper scrap without specifying the size of copper.

Further difficulties were also expressed by the S.E. in keeping and operating all sizes separately in stores.

The S.E./Tiruvannamalai (The Regional Copper Release Center) has also sought for approval in accounting of released solid copper sizes and released strandard copper sizes in one folio stating the same reason.

At present 28 Nos. of codified folios are adopted for copper conductors and copper scraps, (viz.312/060 to 312/076, 312/080 to 312/082, 312/085 to 312/091 and 650/070) against which the released solid copper conductors, strandard copper conductors and copper scraps are being accounted.

However, the same are being stacked in the Store Sheds on sizewar, which results in inadequate indoor accommodation and involving laborious manual and clerical works.

While issuing to the auctioneer the solid copper conductor, strandard copper conductor and Misc. copper scraps are being issued without specifying the size of copper as per the rate contract of C.E./MM under B.P. No.95, (Techl.Br.), dated 9.7.2001.

To avoid time consuming process, it is decided that the copper conductor devoluted by the field should be accounted in 3 folios, since the standard rate is also the same for each size.

As such, the S.Es. of all the circles are requested to adopt uniform procedure in accounting the copper conductors as noted below by changing the Code Numbers as follows:

Reliance Industries Limited, Bombay.

- 2. An amount of Rs.87,00,000/- (Rupees Eighty seven lakhs only) has to be remitted by CASH/DEMAND DRAFT by the company, M/s. 4. Validity of this Way Leave Agreement is limited to a period of NINE YEARS, on completion of which Tamil Nadu Electricity Board will have the discretion to continue or terminate or even terminate in the middle without assigning any reason whatsoever therefor.

Annexure

TERMS AND CONDITIONS TO BE INCORPORATED IN THE ARTICLES OF WAY LEAVE AGREEMENT ON A STAMP PAPER OF VALUE OF RS.80.00 WITH THE FOLLOWING CONDITIONS MAY BE EXECUTED BETWEEN CE/NCTPS REPRESENTING THE BOARD AND M/S. RELIANCE INDUSTRIES LTD., THE PETITIONER.

- a) A nominal amount of Rs.87,00,000/- (Rupees Eighty seven lakhs) has to be remitted by the company by cash/DD, as interest free Security Deposit before taking up the work to make good the damages if any that may be caused to the power/communication cables, pipe lines, road portions, structures etc. belonging to Tamil Nadu Electricity Board, refundable fully or partly after adjusting the cost of damages, replacements replenishment etc. as the case may be.
- b) The pipe lines shall be laid well below ground line as per standards or in a separate corridor for which necessary brackets/structures items should be erected to or made good as original conditions respectively.
- c) A nominal way leave charges of Rs.8,30,000 (Rupees Eight lakhs thirty thousand only) per annum be remitted every year before 15th January. An increase of 10% per annum on the way leave charges so levied will be effected every year.
- d) During the laying or maintenance at any time of the pipe lines, the traffic or movement of men, materials either from NCTPS or to NCTPS should not be hindered.
- e) The entire work should be carried out by using only rubber tyred vehicles for conveyance to avoid undue wear & tear of the NCTPS roads.
- f) The company should ensure that there should not be any damages to the Board's property and if it occurs, the same should be rectified at their cost.
- g) In the event of such damages and consequential hindrance to the generation of electricity, such loss of generation has to be compensated at the prevailing maximum borrow unit rate from other source. The compensation as determined by the Engineer of the Board shall be final and binding.
- h) All safety guidelines irrespective of the fact below GL or above GL or at the open yard or at the close proximity of coal handling area should be ensured at their own cost.
- i) The company should maintain pollution free atmosphere as per TNPCB stipulations.
- j) Liability to accidents either to persons or property either loss of limbs or fatal as well as partly or fully respectively, the company shall indemnify TNEB for the same and save the Board from all harms against all actions, suits, claims, demands, costs, liabilities, expenses litigations, compensation and allied cases etc. To this effect, indemnity bond, indemnifying TNEB shall be executed by RIL.
- k) M/s. RIL has to compensate for the loss in generation arising out of any untoward fire accident or any other cause in the pipe line route due to any cause/reason either by miscreants or natural calamity/acts of nature etc.
- I) The loss in generation to be compensated is inclusive of the generation loss arising out of the interruption at NCTPS and the subsequent loss caused in erstwhile thermal and hydro stations of TNEB grid. The compensation amount as determined by the Board's Engineer shall be final and binding.
- m) Board is at liberty to undertake any work along this reach and if situations warrant
 M/s. RIL should modify/reroute their line or structures to suit the needs and interest of
 Board at the cost of M/s.RIL.

- n) If such modifications, rerouting occur, the company should see that the area required by Board should be cleared off and handed over to the Board unconditionally as and when required by the Board.
- o) As the structures near the TNEB entrance gate are going to be fully utilised for the ash
 pipe lines and future expansions, M/s. RIL could shift their pipe line route wherever
 required between the turning point in front of NCTPS main gate and turning point at
 the RIL Terminal without hindrance to TNEB's operations.
- p) The necessary consultancy services towards erection of the pipe line in the entire reach including of buckingham canal, Backwaters has to be borne by M/s. RIL with due consideration of the safety of TNEB structures underlain/overlain/nearby.
- q) The approval from competent authority (i.e.) from the Chief Controller of Explosives on the entire pipe line route along the TNEB boundary/structures has to be furnished by M/s. RIL.
- r) A responsible official with supporting team and tools & plants from M/s. RIL to attend & assist TNEB as an emergent task force to be present during TNEB's day to day maintenance works should be stationed/made available at NCTPS premises permanently, for which the accommodation, office, furniture, etc. have to be made available by M/s. RIL at its cost.
- s) Any other terms and conditions that may be imposed by the TNEB and when the need arises towards mutual safety/security reasons, shall be accepted by M/s. RIL.
- t) The required liaison with EPL, CMWSSB, Highways, Southern Railways, local authorities/local bodies, salt department, salt lessees, IOC, TNEB Distribution Wing and others should be endeavoured by M/s.RIL only.
- u) No pipe line shall be laid or routed through inside NCTPS premises or compound.
- v) Validity of this way leave agreement is limited to a period of 9 (nine) years, on completion of which TNEB will have the discretion to continue or terminate or whatsoever therefor. However, Board can terminate even in the middle without assigning any reasons therefor.
