

In the B.P. under reference 1st cited, approval was accorded for engagement of Engineering Graduates/Technicians (Diploma Holders) as apprentices for the year 2001-02 as detailed below to comply with the requirement of apprentices (Amendment) Act 1973.

- 2. Now, the Director/Board of Apprentice Training/Chennai has requested that the TNEB may engage 1700 apprentices (500 Engineering Graduates + 1200 Diploma Holders inclusive of 743 apprentices under statutory obligation during the year 2002-03.
- 3. After careful consideration, approval has been accorded to select and engage 948 apprentices (296 Engineering Graduate & 652 Technicians (Diploma Holders) as apprentices for the year 2002-03 in TNEB as detailed below.

4. The apprentices are eligible for the stipend as detailed below as per the G.O.I. Gazette Notification G.S.R.375 (E), dated 18.5.2001.

a) Engineering Graduates
 b) Technician (Diploma Holders)
 c) Sandwich Course (Diploma)
 Rs. 1970/- p.m.
 Rs. 1400/- p.m.
 Rs. 1140/- p.m.

Fifty per cent of the stipend paid to the apprentices will be reimbursed by the Government of India. The Board will bear the balance 50% of expenditure incurred towards imparting training to the apprentices.

- 5. Approval is accorded for adopting the procedures as listed below for the selection and engagement of the prospective candidates.
 - Regionwise Quota in respect of various branches of study, which was fixed in accordance
 with the statutory provision prescribed by the Government of India, is indicated in the
 Annexure to this proceedings. This may be communicated to Board of Apprenticeship
 Training, Chennai. Selections shall be made in line with this quota only.
 - II. The eight distribution regions, viz. Chennai (considering Chennai Distribution North Region & Chennai Distribution South Region as one), Vellore, Coimbatore, Trichy, Madurai, Villupuram, Tirunelveli & Erode will be treated as separate entities and they will form the basis for the selection of candidates.
 - III. An Interview Committee consisting of three members, Two from Tamil Nadu Electricity Board and one from BOAT shall be constituted. For Chennai/Distribution/North & South Regions, one each from Chennai Distribution/North & South Regions of Tamil Nadu Electricity Board and third one from BOAT shall be constituted.

This committee shall conduct the interview for the candidates, to whom call letters will be issued directly by the BOAT, Chennai as per the allocation indicated in the Annexure with a request to report at the respective Regional Head Quarters. During the above interview, the overall fitness of the candidates & their certificates will be verified and candidates will be strictly ranked according to marks by the Interview Committee, Such lists will be prepared separately for SC/ST/OC Candidates.

- IV. As a welfare measure, the sons and wards of the Inservice Departmental (Boards) employees will be given preference during selection irrespective of the marks obtained by them subject to a maximum of 10% of the total vacancies in all branches in each region.
- V. (i) The Chief Engineer of the respective regions, (Vellore, Coimbatore, Trichy, Madurai, Villupuram, Tirunelveli & Erode) will arrange for all official machinery, Man Power, Stationery etc. for conducting the interview.
- V (ii) The Chief Engineer/Chennai Distribution North Region will arrange for all official machinery, Man Power, Stationery etc. for conducting the interview. The selected candidates inclusive of reserve candidates will be divided equally among the Chennai/ Distribution/North & South Regions for allotment of circles under their control.

The selection procedures as described above may take one day. If it is not completed in one day the interview committee may sit for the second subsequent day also at the same centre so as to enable to issue orders to the selected candidates as detailed in the following sub paragraph.

- VI. In regard to Technicians, the Chief Engineer concerned may arrange for the preparation of the engagement of Apprenticeship orders immediately, as recommended by the Interview Committee and serve to the candidates and their acknowledgement obtained. The Chief Engineers will be the Competent Authority to the respective Distribution Circles under their jurisdiction. It is also to be made known to the candidates appearing before the Committee that the orders will be issued on the next day of interview. Necessary formats for the issue of apprenticeship orders will be sent by the Director/Training & Development/Chennai.
- VII. As regard the Graduate Apprentices, the Chief Engineers will send the list of successful Candidates, accompanied with all relevant information to Director/Training & Development, Chennai who in turn will issue the formal engagement orders posting them to different functional areas depending upon their requirement.

 - ii) The selected apprentices in the field of Mechanical Engg. may be allotted to the nearby Generating (Thermal/Hydro/GTS) Stations.
 - iii) The selected apprentices in the field of Electrical & Electronics Engg. may be allotted to the Operation Circle @ one candidate per each 230 K.V. Sub station within the region concerned.
 - iv) The selected apprentices in the field of Electrical & Electronics Engg. may be allotted to the Load Despatch & Grid Operation Circle @ two candidates from each region of Chennai/Distribution/North & South.

- 2. After careful consideration, the Chairman / Tamil Nadu Elecy. Board approves the proposal to engage 3 Nos. (three) Technician (Vocational) Apprentices with Medical Laboratory Technology as one of the subjects in the +2 Vocational Group for the year 2002-2003.
- 3. The apprentices are eligible for a stipend of Rs.1,090/- (Rupees One thousand and Ninety only) per month as per the reference under 4th cited above. Fifty per cent of the stipend paid to the apprentices will be reimbursed by the Government of India vide Lr.No.F.No.BAT/SRP/1.031/5255/2000, dated 11.7.2001. As per the first proviso to Rule 8 (iii) of Tamil Nadu Civil Services (Discipline and Appeal) Rules, in cases where the punishment of withholding of increments cannot be given effect to fully, the monetary value equivalent to the amounts of increments ordered to be withheld for the un-expired period of punishment shall be recovered from the persons.

- 2. Further, the Government have come across the following types of cases:-
- i) Where there are no increments to be earned before the date of superannuation of the accused/delinquent officers, in such cases, it is proposed to impose a penalty of withholding increment for the offences, irregularities committed;
- Cases where, after imposition of penalty of withholding increment, the monetary equivalent is recovered from individuals, without any modifications to the original order of punishment; and
- iii) Cases where Accountant General (A&E) indicates the effect of order of punishment on the pension and commutation of pension, notwithstanding the recovery of monetary equivalent of the punishment.
- 3. In order to overcome the above contingent situations as well as to curb the existing practice followed as per Rule 8 (iii) of Tamil Nadu Civil Services (Discipline and Appeal) Rules, the Government have decided to regulate the mode of punishments by issue of necessary amendment to the said Rule.
- 4. Accordingly, the Government in G.O. Ms. No.55, {Personnel and Administrative Reforms (N) Department}, dated 6.6.2002 have issued an amendment to rule 8 in clause (iii) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules.
- 5. The Tamil Nadu Electricity Board has resolved to follow the orders of the Government and to amend the Tamil Nadu Electricity Board Employees' Discipline and Appeal Regulations suitably.
- 6. Accordingly, in exercise of the powers conferred by Section 79 (c) of the Electricity (Supply) Act, 1948 (Central Act 54 of 1948), the Tamil Nadu Electricity Board hereby makes the following amendment to the Tamil Nadu Electricity Board Employees' Discipline and Appeal Regulations:-

It has come to notice of undersigned that some of the officers in Distribution Circles including officers of local Chennai City distribution do not report immediately to this office or concerned officers in Head quarters on the occurrence of electrical accidents to staff/workers/non-departmental persons, fire accidents, failure of equipments, consequential supply interruptions and public agitation. Such information is known only through newspapers the next day. When enquired for details about such incidents after having known through Press, some of the officers are not even aware of such incidents in their area.

This only indicates the lack of interest on the part of the officers or lack of communication between various levels starting from section office to the regional office. These are the matters of public interest which may become sensitive if appropriate action is not taken with the knowledge of higher officers. Officers should be inquisitive to know details of such incidents through proper communication with their subordinates and staff as all such incidents will be known to the local staff at section level. They should take appropriate action promptly so that local matters are not escalated unnecessarily with incorrect information.

Whenever any fatal or non-fatal accident occurs to either departmental or non-departmental person or in case of failure of equipments/lines, fire accidents, public agitation, road roko due to long power interruption to any area or other matters concerning electricity which may likely to be flashed in Press or other media shall be reported to this office through fax or e-mail on the same day.

 - (iii) ascertaining whether the employee continues to be entitled to the benefits provided by the employer in cash and kind being benefits in consideration of which exemption is being granted under this Notification; or

- (iv) ascertaining whether any of the provisions of the Act had been complied with during the period when such provisions were in force in relation to the said factory be empowered to --
 - (a) require the principal or immediate employer to furnish to him such information as he may consider necessary; or

Whenever accommodation is available, it is allotted to staff and officers of Government of India/State Government/Government Undertakings at appropriate tariff fixed in the Board's proceedings cited. Hon'ble Ministers of Government of India, Hon'ble Ministers of all State Governments, Speaker, Deputy Speaker of Tamil Nadu Legislative Assembly, Hon'ble Chief Justice/Hon'ble Judges of the High Court of Madras and persons declared by the Tamil Nadu Electricity Board as Guests of the Board at free of rent.
- 3. Accommodation is also provided to private persons wherever available at a higher tariff. All these allotments are now made Chief Engineers/Superintending Engineers of the Station-in-charge or on the instructions from the Head Quarters.

ii) Staff Pattern and Sanction of Posts:- An additional post of Assessor will be considered for sanction as and when the norms exceed 50% in each of the type of areas such as Municipal Corporations, Municipal Towns and Town Panchayats, Rural and Hills.

- iii) One Revenue Supervisor and minimum of one Assessor will be sanctioned to all the Distribution Sections.
- iv) In Sections, where the total number of services exceeds 3000, one Inspector of Assessment will be sanctioned and where it exceeds 8000, two Inspectors of Assessment will be sanctioned.
- v) Two Inspector of Assessment instead of three in Revenue Branch will be retained till such time computerisation is implemented.
- vi) Two Leave Reserve Assessors for each Division will be sanctioned.
- vii) The existing category of Senior Revenue Supervisors will be abolished.
- viii) PRORATA:- The number of services for pro-rata for Assessors shall not exceed 25% of the norms fixed.
- ix) <u>Promotion</u>:- The promotion vacancies as on 1.1.2002 due to worknorms will be filled-up. With a view to reducing the stagnation without promotion in the categories of Assessor and Inspector of Assessment, the following procedure will be adopted as a one time measure:

Sub: Dearness Allowance - Sanction of Dearness Allowance with effect from 1.10.2002 – Out of 4% increase in Dearness Allowance, 1% of Dearness Allowance amount credited into General Provident Fund Account – Certain Clarifications - Issued.

Ref: G.O.Ms.No.346, Finance (Allowances) Department, dated 21.10.2002.

In the Government Order cited, orders have been issued revising the rate of Dearness Allowance from 45% to 49% with effect from 1.10.2002 to the employees of the State. According to para-4 of the Government Order cited, out of 4% increase in Dearness Allowance, 3% of Dearness Allowance will be paid in Cash and 1% Dearness Allowance increase shall be credited into General Provident Fund account of the employees. Certain doubts have been raised regarding crediting the 1% Dearness Allowance amount into

the General Provident Fund account in respect of the employees whose General Provident Fund subscription have been stopped before 4 months from the date of retirement of GPF account have not yet been opened.

2. The following clarifications are issued on the regulation of Dearness Allowance increase with effect from 1.10.2002 in these cases:-

Points Raised

- 1. In the case of retiring employees, General Provident Fund recovery has been stopped before 4 months of their retirement date. In such cases whether 1% Dearness Allowance increase may also be paid in Cash.
- 2. In the case of temporary employees appointed under Rule 10 (a) (i) of General Rules, there is no General Provident Fund account for them. In such case, how to regulate the 1% Dearness Allowance increase with effect from 1.10.2002.

Clarification issued

In the case of employees whose General Provident Fund account has already been closed or General Provident Fund recovery have been stopped before 4 months from the date of retirement, 1% Dearness Allowance increase amount shall also be paid in Cash.

In such cases, out of 4% increase in Dearness Allwoance with effect from 1.10.2002, 3% of increase Dearness Allowance amount alone shall be claimed and paid in Cash and the remaining 1% of Dearness Allowance increase shall be claimed and credited into their General Provident Fund account after opening of General Provident Fund account of the concerned employees.

The Board Level Tender Committee in its 902nd meeting held on 8.11.2002 has decided in General to issue certain instructions in regard to the followings:

- The samples obtained should be retained and preserved up to the Guarantee period to enable the check measurement of the materials supplied and received at stores for comparing with the approved sample.
- 2) Wherever changes are to be made in the specification "approved by the Board Level Tender Committee for earlier procurement" it shall be brought out separately by explaining the need for the changes and should obtain specific approval of Tender Committee.
- Wherever the tenders are floated for sale of scrap, for value exceeding Rs.10 lakhs, Two-part system of Tender shall be adopted.
- 4) The local SSI Units who have registered with TANSIDCO or NSIC or holding Permanent Registration Certificate from the District Industries Centres of Directorate of Industries and Commerce are exempted from payment of cost of Tender Documents, Earnest Money Deposit and Security Deposit in respect of only those items for which the Registration Certificate has been obtained. Hence, wherever the local SSI units are registered with District Industries Centres of Directorate of Industries and Commerce it should be ensured that (i) they hold Permanent Registration Certificate (ii) the materials are specified in the SSI Certificate for claiming exemption from payment of cost of Tender Documents, Earnest Money Deposit and Security Deposit. Temporary Registration Certificate is not entertained.

All the P.O. placing authorities are requested to adhere the above guidelines.

Generally the domestic and commercial service connections are effected by the Foreman/Line Inspectors and Industrial service connections by the Assistant Engineer and along with Assistant Executive Engineer in cases of load more than 25 KW. In this connection, Vigilance Officer/Trichy has suggested that the signature of the person who actually effects the service connection must be obtained in "Form-C Supplier's Report" of the Test Report, with the following words "supply effected by me" under the signature of the employer to safeguard against any malpractices in this regard.

The suggestion of the Vigilance Cell is considered and following orders are issued.

All Superintending Engineers of Distribution Circles are requested to instruct the Section Officers/ Foreman/Line Inspectors to write as "service is effected by me" in the Test Report, above the space provided for signature of Engineer in-charge of Distribution while signing the Test Report at the time of effecting the service connections. The name of Foreman/Line Inspectors/Section Officer who is effecting service is also to be written in the Test Report clearly to safeguard against any malpractice in effecting the service connections.

The above instructions may be adhered to strictly without any lapse.
