

2. As per the decision taken above, it is hereby ordered that the new staff pattern to each of the dispensaries in Tamil Nadu Electricity Board as prescribed in the Annexure shall be followed in future.

- 3. Consequent on the new staff pattern ordered above, the Chief Engineers/Superintending Engineers concerned are informed that, other posts for medical staff last continued in the Memos. cited except the posts prescribed in the new staff pattern shall be treated as suppressed and the posts for Medical staff previously sanctioned and utilised in Tamil Nadu Electricity Board dispensaries shall not be taken into Account hereafter.

It is noticed that in the printed copies of Tamil Nadu Electricity Board Service Regulations, corrected up to 30.6.2000 issued to all Officers of the Board, the sub-regulation 17 (h) was inadvertently omitted during printing. To re-incorporate the above Regulation 17 (h) in the Tamil Nadu Electricity Board Service Regulations, the following correction is issued:-

Correction

In Regulation 17 of Tamil Nadu Electricity Board Service Regulations, after the sub-Clause (h) under Regulation 17 (gg), the following shall be added:-

"17(h) Whether an employee referred to in clause (f) above is fully exonerated or not, he shall be considered to have been on extension of service for the period from the date of compulsory retirement to the date of termination of the proceedings. During

such an extension of service, the service rights which have accrued to an employee shall freeze at the level reached on the date of compulsory retirement and the salary during that period shall not exceed the pension which has accrued on the date in respect of employees borne on the pension scheme and in respect of other employees, it shall not exceed the pension equivalent of the retirement benefits admissible to them.

- Note-1: When an employee is required to retire, revert or cease to be on leave, on attaining a specified age the day on which he attains that age is reckoned as non-working day and the employee must retire, revert or case to be on leave (as the case may be) with effect from and including that day.
- Note-2: The provisions in this regulation shall not apply to the employees working under the Board on foreign service terms".
- 2. All officers are requested to communicate the above correction to the field officers working under their control and instruct them to get the correction slip pasted in the appropriate place (page 21 of Book) of the copies of Regulations corrected up to 30.6.2000 available with them.

In the Board's Proceedings first and second cited, Orders were issued sanctioning Hydro/Wind Farm Allowance to all field staff up to the level of Executive Engineers and also to other office staff who are actually working in Hydro Areas for more than one year at the rates prescribed subject to certain criteria prescribed thereto from the date of completion of one year of service, first such date being 1.5.94.

- 2. Subsequently, while clarifying certain points raised by the Audit Branch, it was ordered in the reference third cited, among other things, that the persons working in the Hydro Area should have completed one year of service in a particular Hydro Station/Wind Farm Station as the case may be for getting the Hydro Allowance/Wind Farm Allowance.
- 3. In the reference fourth cited, the eligibility criteria of one year of stay for the drawal of Hydro/ Wind Farm Allowance was ordered to be dispensed with, with effect from 1.12.2000 and it was allowed from the date of appointment/joining in the respective Station.
- 4. The Audit Branch, in their Audit Slips No.20 and 26 on the Entitlement Accounts of Superintending Engineer/Generation/Erode, raised an objection in allowing the Hydro Allowance to certain employees who were transferred from one Hydro Station to another Hydro Station on the ground that they have not completed one year of service in one particular Hydro Station relying on the Board's Memo. dated 3.3.97.
- 5. The Superintending Engineer/Generation/Erode has pointed out that the clarification on eligibility criteria issued in Board's Memorandum dated 3.3.97 is against the spirit/contents of the orders issued in Board's proceedings (1) & (2) cited and has requested to issue necessary clarification/Amendment so as to drop the said Audit Objection.

- 6. After careful consideration of the request, it is hereby ordered that the words" in the particular Hydro Station" occurring in para 3 of the Board's Memo.No.57095-N2/96-1, dated 3.3.97 shall be deleted.
- 7. In view of the above modification, the employees of all Hydro/Wind Farm area who have completed one year of service in Hydro/Wind Farm area are eligible to draw Hydro/Wind Farm Allowance with effect from 1.5.94 till 1.12.2000.

Pension – Payment of Family Pension to disabled divorced/widowed daughter of State Government Servant – Orders – Issued.

Order:

In the Government Order second read above, the Government has issued orders sanctioning family pension to parents and divorced/widowed daughter subject to certain conditions. The Government of India in the reference first read above has further extended the benefit of family pension to disabled divorced

daughter/widowed disabled daughter who are crossing the age of 25 years and ordered that if the marriage of the disabled daughter is legally annulled, she would be eligible for family pension for life from the date her marriage stands annulled, subject to the following conditions:-

- 1) (i) Divorce is valid in law.
 - (ii) Divorced daughter comes back to her parental home.
 - (iii) Disability is certified by an appropriate authority as required under the rules.
 - (iv) The requirements regarding submission of the requisite certificates as laid down under rule 54(6) of the CCS (Pension) Rules for becoming eligible to family pension for life shall continue to remain operative.
 - (v) Similarly, the widowed disabled daughter would also be eligible for family pension for life from the date of death of her husband, subject to fulfilment of above mentioned conditions, as applicable in her case.
- 2. The Government after careful examination has decided to adopt the above orders of Government of India in respect of the State Government Servants. Accordingly, the Government issue the following orders:-

Family pension shall be sanctioned to disabled divorced daughter/widowed disabled daughter if the marriage of the disabled daughter is legally annulled for life from the date her marriage stands annulled subject to the following conditions:-

- (i) Divorce is valid in law.
- (ii) Divorced daughter comes back to her parental home.
- (iii) Disability is certified by an appropriate authority as required under the rules.
- (iv) The requirement regarding the requisite certificates as laid down under rule 49(6) of the Tamil Nadu Pension Rules for becoming eligible to family pension for life shall continue to remain operative.
- 3. Similarly, the widowed disabled daughter would also be eligible for family pension for life from the date of death of her husband, subject to fulfilment of above mentioned conditions, as applicable in her case.
 - 4. These orders shall take effect from 30.8.2001.
 - 5. Necessary amendments to the Tamil Nadu Pension Rule 1978 will be issued separately.

In this connection, I am to inform that large number of such persons against whom disciplinary proceeding were instituted for having produced bogus educational certificates were placed under suspension and at the time of final disposal of the disciplinary proceedings in certain case of employees they were imposed with the punishment of dismissal/removal from service. The persons placed under suspension, dismissed or removed from service have challenged the orders of suspension/dismissal/removal from service in the Hon'ble High Court/Madras. During the hearing of these Writ Petitions/Writ Appeals, the Division Bench of the Hon'ble High Court suggested the Board to consider the imposition of lesser punishment, other than, removal/dismissal from service so as to show some leniency to safeguard their livelihood. Accordingly, in deference to the suggestion of the Division Bench of the Hon'ble High Court, the Board has decided to modify the punishment of dismissal/removal from service and also to withdraw the Police complaint lodged against the employees. Pursuant to the orders issued by the Board, modifying the punishment of dismissal/removal the High Court has disposed of the W.Ps./W.As. A copy of relevant extract of orders of High Court is enclosed for reference.
- 3. In view of the above, I request that the complaint lodged against Helpers in respect of whom F.I.R. has been registered and charge sheet have not been filed they may be treated as withdrawn. In respect of cases in which charge sheet have been filed after investigation and cases are pending for trial

before the Court, the fact of such cases may be informed to the Board so as to permit the Assistant Public Prosecutor concerned to withdraw the cases with the consent of the Court.



Nos.2028, 2029 to 2032 of 2003.

In the B.P. under reference cited it has been ordered that in view of creating separate fund insurance Policies to cover the risks of Fire, Flood, Earthquake, marine etc. shall not be taken for the assets in the existing and future Thermal/Hydro Stations, Dredgers, Wind Mills, Wind Farms and also the proposed Gas Turbine Stations and the existing Insurance Policies also shall not be renewed/extended unless the Insurance Cover is insisted for mortgaging or any other specific purpose for which the Insurance cover is compulsory.

However, under item No.3 (iv) and (v) of B.P. cited it has been instructed that insurance may be taken for Storage-cum-Erection Insurance Policy for project and major construction works and Transit Risk Insurance wherever it is necessary.

In the G.O. under reference cited, the Govt. of Tamil Nadu have issued certain guidelines while taking insurance policies as detailed below:

All P.O. placing authorities are instructed that insurance policies need not be taken with Private insurance Companies in respect of the following Tariff Products in view of the fact that the premium rate in respect of the Tariff Products fall within the ceiling fixed by IRDA.

Where the value of Tender exceeds Rs.25 lakhs, in addition to publication of Tender Notice in web-site and Notice Board the Tender Notice shall be sent to the State Tender Bulletin Officer for publication in State Tender Bulletin.

Where the value of the Tender exceeds Rs.10 crores, the Tender Notice shall also be published in Indian Trade Journal in addition to publication of Tender Notice in web-site and Notice Board.

In addition to the above, wherever the value of procurement exceeds Rs.5 lakes and value of works contract exceeds Rs.10 lakes, Tender Notices shall be sent to Chief Engineer/Civil Designs for publication in the Newspapers.

When only one tender is received against Open Tender or Limited Tender, the tender may be opened and finalised as per powers delegated under respective Tender System floated subject to certifying the reasonableness of price quoted by the tenderer.

Sub: Electricity – Formation of Revenue Intelligence Squad at Circle Level to monitor Revenue Collection and allied Works – Instructions – Issued – Reg.

Ref: 1. Memo.No.CFC/DFC/Rev/RIS/AO/CB/E4/591/02, dated 2.5.2002.

2. Memo.No.X/FC/Rev/AO/CB/E4/RIS/591-2002, dated 10.6.2002.

In the reference (1) cited above, Revenue Intelligence Squads have been formed at Regional Levels with one Asst. Accounts Officer, one Accounts Supervisor and one Assistant (Accounts) to inspect the Section Offices to verify whether all the services have been assessed and making field verification for ensuring the accuracy of meter readings with reference to the office records and actual reading at the consumer premises. Similarly the applicability of tariff, Low Consumption in respect of High Consumption Industrial Consumers etc., also to be verified to avoid loss of revenue to the Board. On review of reports received from the Revenue Intelligence Squads, it is seen that the squads have been functioning effectively.

Therefore it has been decided to extend the Revenue Intelligence Squad for each circle instead of region, separately under the control of respective Superintending Engineers/Distribution by dispensing the existing squads at Region Level. This squad will comprise of one Assistant Accounts Officer, one Accounts Supervisor and one Assistant (Accounts) on rotation basis. The squad will be formed from among the existing staff available in the circle Central Office/Revenue Branches by suitable reallocation of work by the Superintending Engineer/Distribution.

The following will be their main functions:-

i. The squad will make a thorough inspection at Section Offices whether all the services have been assessed or not.

- ii. The squad will inspect the consumers' premises at random and verify the consumption pattern with reference to the white meter card and green meter card and the actual readings recorded in the meter.
- iii. Whether correct application of tariff is followed will be checked up.
- iv. The squad will identify the highest current consumption consumers in the section offices and a thorough analysis of the details of the consumers, the collections, remittances, differences if any, and review of current consumption deposit of the respective consumers should be made.
- v. The pro-rata wages claimed by the Assessors may be verified.
- vi. Whether Service Connection Register is maintained in the Section Office properly and the service connections are effected as per rules in the Section Offices. Whether the OTRs are sent to the Revenue Branches in complete shape for (e.g.) in the case of CT meters the multiplication factors are entered correctly.
- vii. To ensure that the new services effected are issued with the initial bill and necessary OTR, sent to the Revenue Branch. The squad has to ensure that the CCD/MCD/ Development charges etc. are collected in proportion to the sanctioned load.
- viii. Whether the defective meters are replaced properly and average consumption charges have been levied as per the terms and conditions of supply. In case of disproportionate increase/decrease in the consumption pattern, the genuineness of the reading, consumption and the healthiness of the meter are to be verified.
- ix. In case of L.T. industrial services, the actual connected load has to be verified with reference to the contracted load.
- x. Whether all the Street Light services are metered?
- xi. Whether the cash collections are properly remitted into the Bank. Whether the dishonoured cheques are properly accounted for and the money collected along with the clerical charges from the consumers.
- xii. Whether the Disconnection/Reconnection register is maintained and whether 100% disconnection is effected in case of non-payment of C.C. charges except local bodies, Government Departments etc.
- xiii. Whether the Tariff revision effected from 16.3.2003 have been implemented and shortfall collected.
- xiv. The squad will check whether there is violation of terms and conditions, like unauthorised extension of supply etc.

The Revenue Intelligence Squad will be visiting the sections as instructed by the Superintending Engineer/Distributions. Consolidated monthly Inspection Report from each circle should be sent by 10th of subsequent month, to the Head quarters with a copy marked to the Chief Engineer/Distri.

The Chief Engineers/Distribution will monitor submission of the report by each Circle to Head quarters within the due date.

The Superintending Engineers of Distn. Circles are instructed to provide a department vehicle, if available, or they are authorised to permit the Asst. Accounts Officer in this squad to engage private vehicle on hire for conducting inspections till the inspection is over and also arrange to pay the bills as per existing procedure for hiring private vehicles.

Sub: Electricity - Payment of current consumption charges by L.T. consumers in collection counters - Difficulties experienced - Voluntary Deposit Scheme by consumers towards advance payment of current consumption charges -Regarding.

Ref: Memo.No.X/CFC/R/AO/R/AS/Instructions/99-1564, dated 28.12.99.

Instructions have been issued under reference cited permitting the consumers to make payment of advance current consumption charges equivalent to one-year assessment wherever the consumers voluntarily come forward to make advance payment. This advance current consumption charges have been adjusted against the future current consumption bills.

In supercession of the orders issued under reference cited, it is instructed as follows:

- 1. The name of the scheme permitting the consumers to make advance payment of Current Consumption Charges is "Voluntary Deposit Scheme".
- 2. The willing consumers can make Voluntary Deposit under this scheme in the Section Offices on any working day.
- 3. The quantum of Deposit may be accepted to cover equivalent to the estimated consumption based on the previous assessment starting from 2 bi-monthly charges to 6 bi-monthly charges or more.
- 4. The willing consumers while making the Deposit amount have to bring the White Meter Card wherein the fact of receipt of Deposit with the quantum of amount with Receipt No./Date is to be indicated duly signed by the Inspector of Assessment/Revenue Supervisor in the Section Office. This Deposit is to be received by the Inspector of Assessment/Revenue Supervisor in his P.R. under the head of current consumption charges (Advance) (23.100).
- (i) A separate Register should be maintained by the Inspector of 5. Assessment/Revenue Supervisor and the details of the Voluntary Deposit amount paid as well as the details of adjustments made in the subsequent assessments by the Assessor, should be noted in the Register by the Inspector of Assessment/Revenue Supervisor in the Section Office based on the details available in the copy of Collection statement furnished by the Assessor.

- (ii) The Inspector of Assessment/Revenue Supervisor should furnish to the Section Officer a list of consumers who have paid the Voluntary Deposit Amount and whose services should not be disconnected. Such a list should accompany the Defaulters' list furnished by the Assessors in order to prevent erroneous disconnection.
- (iii) The Collection statement prepared by the Assessor should furnish the details of adjustments made during subsequent assessments and the balance amount at credit of the consumer or the balance amount to be paid by such consumers for which Pre-receipts should be prepared.
- 6. While doing assessment in such services, the Assessor has to deduct the current consumption charges from the deposit made by the consumers and the balance available is to be entered into the White Meter Card so that the consumer may be able to know the quantum of balance deposit available and to take decision to deposit further or otherwise according to his convenience. Likewise, the fact of adjustment of current consumption charges against the Deposit is to be entered in the Green Meter Card and the Voluntary Deposit Register.
- At the time of preparation of pre-receipts, pre-receipt need not be prepared for the current consumption charges of such services. The amount of assessment has to be furnished in the collection statement duly noting the fact of adjustment against Voluntary Deposit.
- 8. The above transactions under Voluntary Deposit Scheme and adjustment against each assessment have to be accounted for accordingly in the Revenue Branches.
- As the amount paid by the consumers under Voluntary Deposit Scheme is only for adjustment of subsequent current consumption charges payable by the consumers, no interest is payable on the amount remaining at credit.
- 10. Wide publicity on the acceptance of payment of current consumption charges under Voluntary Deposit Scheme may be given through news papers and exhibiting in the Notice Boards of all Section Offices, Sub-Division Offices, Division Offices and collection counters so as to enable the consumers to be aware of such a scheme and make use of it.

Adverting to above the following clarification are issued.

- 1) The certified consolidated statement of excise duty paid by the supplier to Excise Department may be insisted and obtained before releasing the Balance Bill.
- 2) The balance 5%/10% bills should not be passed—for and paid before deciding the price variation claim.
- The purchase order should not be closed before deciding the price variation if provided for in the purchase orders.

4) A clause to that effect is to be provided in all purchase orders.

The purchase orders containing price variation clause should be closed and 5% and 10% bills should be released only after deciding the price variance and any downward trend in the price variance claim is to be recovered in full from the balance bill without fail.

The above guidelines are to be followed for the closure of the purchase orders.
