

அனைத்து தலைமைப் பொறியாளர்கள்/மேற்பார்வைப் பொறியாளர்கள் அலுவலகங்களிலிருந்து அலுவலர்/பணியாளர்களின் பதவி பொறுப்பு காலியிடத்தன்மை குறித்து ஒவ்வொரு திங்களிலும் விவர அறிக்கை நிர்வாகக் கிளையில் பெறப்பட்டு வருகின்றன.

- 2. மேற்படி பதவிகளின் காலியிடத்தன்மை குறித்து சில தலைமைப் பொறியாளா்/மேற்பாா்வைப் பொறியாளா்கள் அலுவலகங்களில் அனுப்பினவக்கப்படும் விவர அறிக்கையில் தலைமைப் பொறியாளா்/ பணியமைப்பு அவா்களின் மூலமாக பதவி உயா்வு/விருப்ப மாறுதல்/நிா்வாக நிமித்தம் காரணமாக மாறுதல்/ஒதுக்கீடு போன்ற காரணங்களால் உரிய அலுவலா்/பணியாளா்களுக்கு அந்தந்த வட்டத்திற்கு மாறுதல் அளிக்கப்படும் நோ்வுகளில் அவைகளை கணக்கில் கொள்ளாமல் காலியிடத்தன்மை குறித்த விவர அறிக்கை அனுப்பி வைக்கப்படுகின்றன எனத் தெரிய வருகிறது.
- 3. இதன் காரணமாக முரண்பாடான காலியிடத்தன்மை விவர அறிக்கையின்படி, நிர்வாகக்கினை மூலமாக பிறப்பிக்கப்படும் மாறுதல் ஆணைகளை நடைமுறைப்படுத்த இயலாததோடு, நிர்வாக இதர நடைமுறைப் பணிகளுக்கு இடையூறு ஏற்படும் நிகழ்வுகள் ஏற்படுகின்றன.
- 4. ஆதலால் இனிவரும் காலங்களில் தலைமைப் பொறியாளர்/பணியமைப்பு அவர்களுக்கு அனைத்து தலைமைப் பொறியாளர்/மேற்பார்வைப் பொறியாளர்கள் அலுவலக மூலமாக அனுப்பிவைக்கப்படும் அலுவலர்/பணியாளர்களின் பதவிகளின் காலியிடத்தன்மை குறித்து விவர அறிக்கைகளை ஒவ்வொரு திங்களிலும் 5-ம் தேதிக்குள் அனுப்பி வைக்கப்பட வேண்டுமென அறிவுறுத்தப்படுகின்றன.

Sub: Remote Hydro/Cavero Allowance-cum-Performance Incentive for employees working in Remote Hydro Stations - Release of the remaining 25% of Performance linked Incentive for the financial year 2002-2003 - Eligibility criteria based on performance of respective Hydro stations - Working instructions - Issued.

In the Board's Proceedings first cited orders were issued sanctioning Remote Hydro/Cavern Allowance cum Performance Incentive to the employees working in Remote Hydro Stations/Kadamparai Power House as mentioned below:-

"75% of the rate of both Remote Hydro Allowance/Cavern Allowance sanctioned shall be paid every month and the remaining 25% shall be linked to the performance of the respective Hydro Stations to be reviewed by a Committee consisting of Accounts Member and Member (Generation) at the end of each financial year".

With reference to the orders mentioned above, the Committee constituted in para(4) of the B.P. cited furnished the following guidelines/general criteria to be adhered to by all Superintending Engineers/ Generation Circles in working out the performance of each station for releasing the balance 25% of the performance linked incentive:-

#### i) THE PLANT AVAILABILITY FACTOR:-

This factor is based on availability of the machine i.e., running or standby condition. As outage hours increases, this factor reduces. This factor will reflect the performance of the station.

- ii) Annual overhaul is a statutory requirement, this period may be excluded for calculating the Plant Availability Factor for incentive purpose. Since R&M is undertaken for life extension and performance improvement, the machine under shutdown for R&M need not be considered for arriving Plant Availability Factor of the respective station. After R&M, the Machine shall be taken as new one.
- iii) Balance 25% incentive may be considered for the stations that maintain minimum of 80% availability factor. Proportionate incentive (Reduction) shall be given for the stations that have less than 80% Plant Availability Factor. Average availability factor of all units in a station shall be considered as station availability factor, based on which incentive is to be worked out.
- iv) The 25% incentive shall be given in full for the employees, who have served more than 200 days in a financial year at a particular Hydro station commencing from Financial year 2002-2003. Proportionate working days shall be calculated for those who join or leave in the middle of the year due to promotion or transfer and they shall be paid proportionately for their duration of service.
- v) For those officers and staff working in SE/Generation Circle Office, stores etc., common to Generation Circle the Average Availability Factor of all the Stations shall be calculated proportionately for considering the payment of this incentive. A Sample working sheet is in Annexure.

- 2. It is therefore instructed that the assessment and collection as per the orders of Tamil Nadu Electricity Regulatory Commission and as per the working instructions issued in the reference 1st cited may be done for Marginal, Small & Large Farmers and Hut consumers.
- 3. The White Meter Cards and Green Meter Cards may be prepared for all Agriculture/Hut services and instructions issued under the heading "General (a) to (q)" under reference 1st cited may be followed. The remaining working instructions issued under reference 1st cited shall hold good. The tariff rate as per the TNERC Tariff Order dt.15.3.2003 for the Hut services may also be displayed in the Notice Board's available in Section Offices and Divisions.
- 4. The Executive Engineers of the respective Division shall arrange to provide the updated data base once in six months to the Revenue Department for making necessary changes in the schedule of beneficiary farmers as directed in para 6 (iv) of the G.O. cited. He shall also send data of rural hut service connection consumers to the Revenue Department as directed in para 6 (v) of the G.O. cited.
- 5. The Assistant Executive Engineer/O&M of the respective sub-division shall hold full responsibility to ensure proper assessment/collection and for co-ordinating with the Revenue authorities in getting the cash support from the Government by the beneficiary consumers in order to make the scheme a success.

Income support scheme to help Marginal and Small Farmers and hut service connection consumers to pay the electricity consumption charges - Procedure for disbursement - Orders - Issued.

#### Order:

According to the tariff schedule issued by the Tamil Nadu Electricity Regulatory Commission, tariff for the power supplied to agriculture consumers is Rs.250 per horse power for non-metered consumers and in the case of metered consumers it is 20 paise per kilo watt hour. In Tamil Nadu 15.2 lakhs Farmers get power supply free of cost from the Tamil Nadu Electricity Board. Among them, 4.56 lakhs farmers are categorised as small farmers and 4.37 lakhs farmers are categorised as Marginal farmers. Farmers having dry land upto 5 acres of wetland upto 2.5 acres are classified as small farmers. Farmers having dry land upto 2.5 acres or wetland upto 1.25 acres are classified as marginal farmers. The remaining are classified as large farmers.

- 2. Subsequent to the announcement of tariff for the agricultural consumers, the Government of Tamil Nadu announced an income support scheme to help the small and marginal farmers to tide over the reduction in net income consequent on payment of power consumption charges. The need for such income support is to protect these farmers i.e. small and marginal from the immediate income shock. The Government of Tamil Nadu therefore announced disbursement of Rs.1000 per year to Marginal and Small Farmers having pumpsets driven by motors upto 3 HP capacity and who have been availing the Free supply of electricity so far. Similarly, the Government announced disbursement of Rs.1250 per year in the case of those Marginal and Small Farmers having pumpsets driven by Motor of 5 HP and above and who have been availing the free supply so far. The Government have also announced that in rural areas Rs.100/- per annum will be provided as cash assistance to the rural hut service connection consumers, who have been availing free supply so far.
- 3. Identification of the Department having field set up for implementation of the scheme and related issues were discussed at a meeting held on 24.6.2003 under the Chairmanship of Development Commissioner and Secretary, Finance. After detailed discussions, it was considered that the Revenue Department could be designated as the implementing Department for disbursing the income support to the Marginal and Small farmers since the Revenue Department has the required basic land holding details and manpower at the Taluk/Village level. Further any representation on the status of a farmer as a marginal/small/large farmer can also be attended to by the Revenue Department since land records are available with them.'
- 4. The Government have also examined various options for disbursing the assistance such as opening of savings bank account with the village post offices. Payment through primary agricultural cooperative societies, sending the cash assistance through money order using the services of the postal department etc. In order to ensure that the income support reaches the beneficiary farmers at their doorstep and without any intermediation, the Government has decided to disburse the assistance through money order via the Postal Department to the beneficiary farmers directly.
- 5. The Government, after careful consideration, direct that the Revenue Department be designated as the implementing department for the disbursement of income support to the small and marginal farmers and rural hut service connection consumers who were availing free supply of electricity earlier.
  - 6. The modalities for disbursement of income support to the farmers will be as follows:-
    - (i) The disbursement of income support be made through Money Order through the Department of Post and Telegraphs to the beneficiary farmers directly as is being done in the case of old age pension, so that the income support will reach the beneficiary farmer at his/her door step.
    - (ii) The income support has to be disbursed twice a year at the rate of Rs.500/-(Rupees five hundred only) per half year to the beneficiary small and marginal farmers who are using pumpsets upto the capacity of 3 HP. The income support shall be disbursed twice a year at the rate of Rs.625/-(Rupees six hundred and twenty five only) per half year to the beneficiary small and marginal farmers having pumpsets of capacity of 5 HP and above.
    - (iii) The Taluk Tahsildars of Revenue Departments shall arrange for sending the assistance through Money Order to the beneficiary farmers once in six months based on the data furnished by the TNEB.
    - (iv) Since the current consumption charges to the TNEB have to be paid by the marginal and small farmers during the second fortnight of September 2003 and thereafter every six months, the money shall be disbursed to the small and marginal farmes in time to facilitate them to pay the current consumption charges to the TNEB within the due dates. The Tamil Nadu Electricity Board will provide the updated database once in six months to the Revenue Department for making necessary changes in the schedule of beneficiary farmers.
    - (v) An income support of Rs.100/- shall be sent to the Rural Hut Service Connection consumers by Money Order once in a year by the Revenue

Department through the Tahsildars based on the data furnished by the TNEB. This will enable the rural hut service connection consumers to make payment in time to the Tamil Nadu Electricity Board. Since the first payment is due in the month of September 2003, the income support has to be sent to the Rural Hut Service connection consumers in time.

7. The expenditure for income support for small and marginal farmers and rural hut service connection consumers shall be debited to the following head of account:-

### 1. Small and Marginal Farmers

"2401-00-Crop Husbandry 800 Other expenditure - JW. Scheme for accelerated irrigation for Small and Marginal Farmers 11 subsidies 02 General subsidy (2401-00-800-JW-1127).

### 2. Rural Hut Service Consumers

"2515-00-Other Rural Development Programmes-102-Community Development-Schemes in the Tenth Five year Plan-II State Plan-KK-Scheme for (Below Poverty Line) Electrification to huts in Rural Areas-09-Grants in Aid-03-Grants for specific schemes" (2515-00-102-KK-0937).

- 8. The Special Commissioner and Commissioner of Revenue Administration is authorised to draw the amount for disbursement to the marginal and small farmers and rural hut service connection consumers.
- 9. The Special Commissioner and Commissioner of Revenue Administration, Disaster Management and Mitigation is requested to issue further instructions wherever necessary and to monitor proper implementation of the scheme.
- 10. This order issues with concurrence of the Finance Department vide its U.O.No.294/DS(CT)/ 2003 dated 22.8,2003.

# 1. OBSERVATION:

It is observed that field Chief Engineers/Superintending Engineers after sanctioning the dismantling estimates for old type of buildings/structures/failed or unused buildings, dispose the retrievable materials through auctioning after spending lot of expenditure and time on dismantling, stacking at stores (by consuming considerable space) assessing the values for auctioning etc. This involves not only wasteful expenditure but also considerable time is taken for each activity. Also there are chances for loss of retrievable materials due to theft or loss of value due to deterioration/corrosion.

# 2. DIRECTION:

To overcome the difficulties, the Chairman has approved the following directives/guidelines.

a) Instead of dismantling and then auctioning the retrievable materials the building is to be auctioned in "as is where is condition".

The Government of Tamil Nadu in the G.O. fifth cited has approved the implementation of Municipal Solid Waste Power Project by M/s. EDL India (Pvt.) Ltd., New Delhi on Build, Own and Operate basis initially with a capacity of upto 10.80 MW per day based on a consumption of 300 to 400 MT of solid waste to be completed in the year beginning 1.4.2005 and the balance of the proposed capacity of 14.85 MW to be completed within six months of the initial project.

The Government has also ordered that the tariff shall start with the rate of Rs.3.87/ KWhr for the first year with a 5% escalation every year for the subsequent 15 years. The first year tariff of Rs.3.87/ KWhr will be applicable for commissioning the initial project during the year from 1.4.2005 to 31.3.2006. Also if the commissioning date falls beyond 31.3.2006, but occurs before 30.9.2006, the tariff applicable for the year 2006-2007 will be Rs.3.87/KWhr and 5% escalation thereafter from the year 2007-2008.

It is also ordered in the G.O. that with regard to sharing of the subsidy amount between the Chennai Municipal Corporation, Tamil Nadu Pollution Control Board and the State Government, separate orders shall issue.

After careful examination, the Board hereby approves (a) the purchase of power from Municipal Solid Waste Power Project at Perungudi at the tariff rate approved by the Government in G.O.No.Ms.60 (MA & WS) dated 18.8.2003 subject to the condition that the net financial commitment of Tamil Nadu Electricity Board is restricted to Board's tariff rate for Co-generation, Bio-mass and Municipal Solid Waste Power Projects, the difference being met by Corporation of Chennai, Tamil Nadu Pollution Control Board and Government of Tamil Nadu as may be decided by the Government as stated in the said G.O. and (b) the final draft of the Power Purchase Agreement format furnished by the project promoter M/s. Instructions were issued in the reference cited that Electricity Tax is to be levied from a fee 2003 as per Tamil Nadu Tax on Consumption or Sale of Electricity Act 2003. As per Rule 8(1) of the Tamil Nadu Tax

on Consumption or Sale of Electricity Rules 2003, "a licensee shall include the tax leviable under the Act as a separate item in the bill of charges for the sale of electricity by him and shall recover the same from the consumer along with his own charges for the sale of such electricity".

Therefore, it is instructed that in respect of L.T. services, the amount of Electricity Tax levied should be shown in the "Remarks Column" of the White Meter Card as a separate item clearly indicating as "Elecy. Tax". The Current Consumption charges in White Meter Card should explicitly show the split up details of Electricity charges + Electricity Tax and the Total Current Consumption charges payable to the Board. While printing and supply of White Meter Cards, a separate column with the provision for indicating Elecy. Tax amount is to be incorporated in future.

Further, the quantum of Electricity Tax levied may also be indicated in the Green Meter Card.

#### Order:-

According to the Tamil Nadu Tax on Consumption or Sale of Electricity Act, 2003 (Tamil Nadu Act 12 of 2003) sale of electricity for agricultural purposes and hut service connections is exempted from electricity tax. Representations from domestic consumers have drawn the attention of the Government for exemption of electricity tax for domestic consumption. The Government, after consideration, have now decided that the entire domestic consumers may also be exempted from levy of electricity tax. Accordingly, the following notification will be published in the Tamil Nadu Government Gazette (Extra ordinary) dt.17.9.2003:-
