Pension - Refixation of Pension / Family Pension with effect from 1.6.1988 - Orders of the Government - Adoption to the Pensioners / Family Pensioners of Tamil Nadu Electricity Board - Orders - Issued.

Proceedings :

The Government of Tamil Nadu in G.O.Ms.No.810, Finance (Pension) Department, dated 9.8.1989 have issued orders, among other things, fixing the pension/family pension with effect from 1.6.1988 for those who retired/died before 1.6.1960 and up to 30.9.1987 whose pension/family pension plus dearness allowance at 608 points per month does not exceed Rs.500/-, by increasing the sum total of the basic pension and the related dearness allowance at 608 points ranging from 60% to 20% and for those whose pension/family pension plus dearness allowance at 608 points exceeds Rs.500/-, by increasing the total sum of basic pension and related dearness allowance at 608 points ranging from 50% to 15%. The said orders of the Government have been adopted by the Board and orders were issued in (Per.) B.P. (Ch.) No.258 (SB) dated 20.9.1989.

2. Now, the Government in G.O. Ms.No.579, Finance (Pension) Department, dated 15.9.2006 have issued orders that in respect of the pensioners/family pensioners who retired/died on or after 1.6.1960 till 31.5.1988 and whose pension/family pension plus dearness allowance at 608 points per month does not exceed Rs.500/- shall be refixed with effect from 1.6.1988 by increasing the sum total of the basic pension and the related dearness allowance at 608 points by 60% and for those whose pension / family pension plus dearness allowance at 608 points exceeds Rs.500/- shall be refixed with effect from 1.6.1988 by increasing the sum total of basic pension and related dearness allowance at 608 points by 50%.

3. The Board has carefully examined the above orders of the Government and has decided to adopt the same in the Board. In pursuance of the above decision, Tamil Nadu Electricity Board hereby directs that in respect of the pensioners / family pensioners who retired / died on or after 1.6.1960 till 31.5.1988 and whose pension / family pension plus dearness allowance at 608 points per month does not exceed Rs.500/- shall be refixed with effect from 1.6.1988 by increasing the sum total of the basic pension and the related dearness allowance at 608 points by 60% and for those whose pension/family pension plus dearness allowance at 608 points exceeds Rs.500/- shall be refixed with effect from 1.6.1988 by increasing the sum total of basic pension and related dearness allowance at 608 points by 50%.

4. The Chief Internal Audit Officer / Board Office Audit Branch shall take necessary action to revise the pension / family pension on receipt of application in the format as in the Annexure.

5. These orders shall take effect from 1st February 2008, pending decision on payment of arrears.

In all Gas Turbine Power Stations, diesel generators are available to meet out the emergency condition during grid disturbance/block out condition, to effect supply to all control circuits and lube oil system to avoid failure of equipments and loss of generation and also for Fire Water pump house which can be used in the case of fire accidents to avoid spreading of fire, failure of equipments and to safeguard human life. Moreover, the diesel generators are operated daily by the operators in charge of shift for 15 to 30 minutes to ensure the healthiness of diesel generator set to meet out the emergency condition. The Superintending Engineers are empowered to procure materials under limited tender up to Rs.1 lakh as per Table-II of (Per.) B.P. (FB) No.10 (Accounts Branch) dated 7.4.2003. But, diesel is not included in the items which can be procured under limited tender system. Further, he has stated that grid disturbance may occur at any time and consumption of diesel will be more during the emergency condition and hence procurement of diesel through purchase order by executing tender process will be time consuming and also at the same time, storage of Petrol/diesel in barrels is not feasible from the safety point of view. Hence, the Chief Engineer/Gas Turbine Schemes has requested

to procure diesel for the diesel generator set by the concerned Superintending Engineers of Kuttalam, Valuthur and Thirumakottai Gas Turbine Power Stations through temporary advance as a special case to meet out the emergency situations during grid disturbance and also in case of fire accidents. The above proposal has been carefully examined and accepted by the Board.

2. Accordingly, the Tamil Nadu Electricity Board hereby directs that powers be delegated to the concerned Superintending Engineers of Gas Turbine Power Stations in Kuttalam, Valuthur and Thirumakottai for the procurement of diesel for the diesel generator sets available in their Gas Turbine Power Stations through temporary advance as a special case, subject to a ceiling of 2,500 liters per annum for each Gas Turbine Power Station in order to meet out the emergency situations during grid disturbance and also in case of fire accidents.

But her request has been rejected by the Superintending Engineer/Mettur Electricity Distribution Circle stating that she has not applied for employment assistance on compassionate grounds within three years period from the date of death of her husband. However, she has represented frequently requesting compassionate appointment stating that due to her poor family circumstances and also she had two male children aged about 17 years and 12 years old at the time of death of her husband and her elder son has committed suicide himself on 20.11.2000 and there is no revenue except the pensionary benefits of her deceased husband. Therefore, she has requested employment assistance to her second son aged about 18 years on 10/2005 and possessing X (failed) qualification.

2. After careful consideration, the Board is hereby approved that the employment assistance on compassionate grounds be provided to Thiru S. Kumar, S/o (Late) C. Sundaram, Helper by relaxation of the condition of submitting the application for providing employment assistance within 3 years in favour of Thiru S. Kumar, S/o (Late) C. Sundaram as a special case and he may be appointed as Helper/Trainee after receipt of satisfactory report from the Superintending Engineer concerned.

3. I therefore request you that as and when the employees who were similarly placed filed the case in the Courts the above orders of the Honourable High Court/Madras may be incorporated in the Counter affidavit to be filed in the Courts, in order to contest the case effectively on behalf of the Board.

O R D E R

This writ petition has been filed by the petitioner seeking for issuance of Writ of certiorari calling for the entire records made in the impugned order of recovery of subsistence allowance in Ku. A.No.N1.P1.5/N1/2/Pa.No.02/05 dated 05.01.2006 passed by the first respondent and to quash the same.

2. The petitioner was a Contract Labour working in the North Thermal Power Station and she was working in that capacity from 1996 onwards. Thereafter, on the State Government having taken a policy decision to abolish the contract labour in the Thermal Power Station, the Board proceedings was issued in B.P. (FB) No.17 dated 28.4.1999. A Committee was constituted to identify the contract labours, who are qualified for absorption in terms of the Board Proceedings. At the time of absorption, it transpires that the petitioner gave false educational certificate stating that she has passed VIIIth Standard examination. This is probably on the belief that she is eligible for further promotion. However, the respondent Board came to know about the production of the false certificate by the petitioner and suspended her by order of 18.10.2001 and framed charges. After conducting an enquiry, show cause notice was given to her proposing to penalty. The petition filed by the petitioner was heard by the division Bench of this Court along with the writ appeals and writ petitions filed by the similarly placed persons and the division Bench of this Court, after hearing the arguments of the writ petitioners, suggested the respondent Board as to the feasibility of imposing lesser punishment to the petitioners therein having regard to the fact that the punishment is disproportionate to the charge and also the fact that Justice Khalid Commission originally recommended absorption of Contract Labour holding that the experience gained by the contract workers can be equated to the educational qualification prescribed by the Board for the post of Helper and in view of the same, this Court also suggested that exemption can be granted in respect of those employees.

3. On the basis of the suggestion made by the Division Bench of this Court, the respondent Board issued Board Proceedings in B.P. (FB) No.27 (Administrative Branch) dated 07.11.2002 wherein it is clearly stated that where an employee is under suspension and Disciplinary Proceedings are pending, the employee

will be reinstated without prejudice to the disciplinary Proceedings pending against him and the period of absence will be regularised by sanction of Earned Leave at credit and the balance as E.O.L. without pay and allowances and if the order of dismissal / removal from service is already given effect, the period from the date of dismissal / removal from service till the date of re-joining will be regularised as Extra-ordinary leave without pay and allowances. It is further stated that the subsistence allowance already paid will be adjusted for Earned Leave at credit and balance amount will be recovered in easy instalments. On the basis of the above proceedings issued by the Board, the Division Bench of this Court disposed of the writ appeal and writ petitions by common judgment dated 18.12.2002 and in paragraph 3 of the judgment, it was observed as follows:

"These two writ appeals and the writ petitions are disposed of in terms of the Board Proceedings and now, the respective appellants and the writ petitioners shall make a representation before the concerned Superintending Engineers for further follow up action, and the cases of the respective writ appellants and the writ petitioners shall be decided in accordance with the conditions enumerated in the above Board Proceedings, which are extracted above. We also make it clear that the concerned superintending Engineers, on being approached by the respective appellants and the writ petitioners, shall afford sufficient opportunity for compliance of the conditions. The arrears of salary, if any, payable, will depend upon the orders to be passed in accordance with the above Board Proceedings." (Emphasis added)

4. It was pursuant to this order, the second respondent obtained a written undertaking from the petitioner for recovering subsistence allowance paid to her pending suspension as her case was considered for reinstatement and she was also reinstated in service on 30.5.2003. It was thereafter, the impugned order dated 05.01.2006 came to be passed wherein the earlier Board Proceedings, as approved by the Division Bench of this Court, was also referred to in the reference column. With reference to the petitioner, it is stated in the impugned order that a recovery of Rs.43,933/- was to be made on instalments running to 78 months (6-1/2 years). It is this order that is sought to be challenged by the petitioner in this writ petition.

5. I have heard the arguments of Mr.S.N. Ravichandran, the learned counsel appearing for the writ petitioner.

6. When questioned as to the legality of the petitioner challenging the impugned order, the learned counsel stated that similar writ petitions have been admitted by this Court and interim order has been granted by other learned Judges. When asked as to why the order of the Division Bench of this Court dated 18.12.2002 was not profiled in the typed set of papers, the learned counsel did not have any answer. Even though in paragraph 5 of the affidavit, a casual reference was made to the order of the Division Bench dated 18.12.2002 in the batch of cases, the learned counsel did not disclose to this Court the nature of hearing held before the Division Bench and the circumstances under which the Board passed the proceedings in B.P. (FB) No.27 dated 07.11.2002 and the approval granted by the Division Bench of this Court. It is a clear case where the petitioner, having availed the benefit in terms of the order of the Division Bench of this Court dated 18.12.2002, got reinstated in service after giving an undertaking in terms of the board proceedings, has the audacity to file another writ petition without any legal basis. The earlier order passed by the Division Bench completely covers the present issue and operates as *res judicata* against the petitioner. There are no legal grounds open to the petitioner to agitate an issue which has already been squarely covered by the discretionary order passed by this court.

7. It is rather unfortunate, the petitioner, who would have been dismissed for the sole reason of producing false educational certificate while entering the service, was saved by the orders of this Court and she must thank that her continuance in service solely due to the efforts taken by the Division Bench of this Court. The Electricity Board, but for the suggestion made by this Court, would not have been under any obligation to issue and Board proceedings to reduce the punishment to the petitioner any other alike persons. But for the orders of this Court, the petitioner would have been standing in the streets without the very employment itself being taken away from her.

8. It is rather unfortunate that the learned counsel for the petitioner choose to file a writ petition not

only for the petitioner but for other similarly placed persons seeking the challenge such orders by raising certain false legal pleas, which are not available to them. It is strange to note tht the petitioner has raised a ground that the impugned order is unconstitutional and violative of her fundamental right and Tamil Nadu Subsistence Allowance Act 1981 and also Standing Orders when her very right to continue in the employment was given due to the intervention made by this Court. It is nothing but greed and aggrandizement that propelled th petitioner and other similarly placed persons to file a writ petition of this nature.

9. When this Court questioned the propriety of the petitioner filing this writ petition, the lerned counsel wought permission to withdraw the writ petition, which may be with a view to save the other writ petitioners in which interim orders have been obtained by him. However, this Court expressed its inability to concede to the request made by the learned counsel for the petitioner and thus has chosen to pronounce the order on merits so tht it should strike a note of warning not only the the petitioner but for the other similarly placed persons also. The writ petiton is devoid of merits and it is a clear abuse of process of Court. The grounds on which the writ petition was filed are all imaginary and cannot stand to the scrutiny of this Court especially in the context of a binding judgment of the Division Bench of this Court.

10. In the light of the above, the writ petition fails and the same shall stand dismissed. Consequently, M.P.No.1 of 2006 also stands dismissed. Even though the petitioner is a last grade worker, but for the act of filing such a frivolous writ petition, she must be mulcted with costs. Hence, a cost of Rs.1000/- is ordered to be paid by the writ petitioner.

COMMON JUDGMENT

(Judgment of the Court, delivered by P. Sathasivam, J.)

The issue raised in the Writ Appeal and the Writ Petitions is one and the same, hence, they are being disposed of by the following Common Judgment.

2. Writ Appeal No.1554 of 2006 is directed against the Order of the learned single Judge, dated 21.09.2006, made in W.P.No.34793 of 2006, in and by which, the learned Judge, after going through the common order of the earlier Division Bench, dated 18.12.2002, passed in W.A. Nos.2454 and 2589 of 2002 etc. Batch and after finding that there is no merit in the claim of the writ petitioner, dismissed her writ petition with costs of Rs.1,000/-.

3. In the Writ Petitions, the petitioners seek to quash para 5(d) of the Board Proceedings, dated 07.11.2002, in B.P. (FB) No.27 (Administrative Branch) as well as the consequential orders for recovery of subsistence allowance and some of them also pray for a direction to the respondents to pay the balance of wages for the period under suspension.

4. According to the Writ Petitioners, they initially joined as Contract Labourers in North Thermal Power Station. Based on the request of several Unions for regular absorption of the workers, who were continuously working in the Board as contract labourers the North Thermal Power Station and other Power Stations decided to absorb those candidates who have completed 480 days of continuous service in two consecutive years. On account of this, the Electricity Board issued B.P. (FB) No.17 dated 28.04.1999 the contract Labourers, who were working in all the four Thermal Stations. The petitioners were identified and, on

27.10.1999, orders were issued for their regular absorption. In the year 2000, the Administration suspended the petitioners on the ground that they submitted bogus certificates at the time of their absorption and, after framing charges, directed them to furnish explanation for the same. The petitioners submitted their explanation and the 2nd respondent, not satisfied with the same, after conducting enquiry, issued show cause notice proposing to impose a punishment of dismissal. Aggrieved by the same, the petitioners filed writ petitions and this Court advised the Board to settle the issue by imposing punishment other than dismissal. Pursuant to the same, the Board issued B.P. No.27 (Administrative Branch), dated 07.11.2002, modifying the order of dismissal as one of stoppage of three increments and reinstating the workers in the starting time scale. Based on the same, the 2nd respondent obtained letters from the petitioners, who consented thereby for recovery of subsistence allowance, and reinstated all of them in service. While so, in 2006, the 2nd respondent issued orders to recover the subsistence allowance paid to them in monthly instalments based on the circular in B.P.No.27 dated 07.11.2002. Contending that both the proceedings are unconstitutional and ultra vires and Standing Orders, the petitioners have filed the above Writ Petitions.

5. Heard Mr.M. Radhakrishnan, learned counsel appearing for the appellant in W.A. No.1554 of 2006 and petitioners in all the Writ Petitions and M/s.M. Vaidyanathan and V. Yamuna Devi for respondents/Electricity Board.

6. The only point for consideration in the Writ Appeal and the Writ Petitions is as to whether the Board is justified in recovering the subsistence allowance paid during the course of disciplinary proceedings.

7. It is not in dispute that the petitioners were absorbed based on the certificates produced by them. The Enquiry conducted by the Board revealed that they submitted bogus certificates and hence they were proceeded against by the Administration. Ultimately, when the Board decided to impose the punishment of dismissal from service, the Division Bench intervened and suggested for a lesser punishment taking into account the factor of proportionality of punishment taking into account the factor of proportionality of punishment and in view of the fact that Justice Khalid Commission had recommended relaxation in educational qualification as also age. Pursuant to the suggestion of the Division Bench, the Electricity Board favourable responded and had issued Board Proceedings vide B.P. (FB) No.27 (Administrative Branch), dated 07.11.2002, in and by which, the cases had been categorised into four for lifting the suspension and also for regularisation. The petitioners are concerned/aggrieved of paragraph No.5(d) of the Board's Proceedings which reads as under:-

"(d) Where the employee is under suspension and Disciplinary Proceedings is pending, the employee will be reinstated without prejudice to the Disciplinary Proceedings pending against him. The period of absence will be regularised by sanction of E.L. at credit and the balance as E.O.L. without pay and allowances. The subsistence allowance already paid will be adjusted for E.L. at credit and balance amount will be recovered in easy instalments."

It is also relevant to mention that the Division Bench, in their order dated 18.12.2002 in W.A.Nos.2454 and 2589 of 2002 etc. Batch, after incorporating all the conditions in the Board Proceedings, dated 07.11.2002, passed the following order:-

"These two writ appeals and the writ petitions are disposed of in terms of the above Board Proceedings and now, the respective appellants and the writ petitioners shall make a representation before the concerned superintending Engineers for further follow up action, and the cases of the respective writ appellants and the writ petitioners shall be decided in accordance with the conditions enumerated in the above Board proceedings, which are extracted above. We also make it clear that the concerned Superintending Engineers, on being approached by the respective appellants and the writ petitioners, shall afford sufficient opportunity for compliance of the conditions. The arrears of salary, if any, payable, will depend upon the orders to be passed in accordance with the above Board proceedings. Consequently, the connected miscellaneous petitions are closed."

8. As rightly pointed out by Mr.M. Vaidhyathan, learned counsel for the Electricity Board, inasmuch as all the terms and conditions in the Board Proceedings have been approved by the Division Bench and the petitioners have also agreed to abide by the conditions, now, those conditions imposed in the said B.P. particularly para 5(d) cannot be faulted with, and, in any event, the same cannot be questioned in a separate proceeding. In other words, according to him, if the petitioners are aggrieved of clause 5(d), the proper course open for them would be to file a Review Petition against the Division Bench Order dated 18.12.2002. We are conscious of the fact that the amount sought to be recovered relates to subsistence allowance that was paid to the petitioners during the course of disciplinary proceedings and that the entire amount might have been spent for their survival. We are also aware of the fact that if any amount is paid under Section 17(b) of the Industrial Disputes Act during the pendency of the proceedings, irrespective of the result, the workman need not repay the amount already received by him. At the same time, it is our duty to mention that no such objection was raised before the Division Bench and even if they say that none appeared for them when the matter was heard/decided by the Division Bench, at least, after getting copy of the Order, they could have moved the Bench for appropriate clarification/orders. As rightly pointed out by the learned single Judge, having benefited of the Board Proceedings which came to be passed on the suggestion of the Division Bench and agreed to repay the amount, the petitioners cannot question either the Board Proceedings or the recovery by filing writ petition. The only course open to the petitioners is to file review petition seeking clarification/modification of the order dated 18.12.2002 made in W.A. Nos.2454 and 2589 of 2002 etc. Batch. We accept the contention of the learned counsel for the Electricity Board.

9. As discussed earlier, the appellant as well as the writ petitioners are free to file Review Petition, if they so desire, seeking review of the order dated 18.12.2002 made in W.A. Nos.2454 and 2589 of 2002 etc. Batch with reference to the conditions imposed in para No.5(d) of the Board Proceedings dated 07.11.2002. It is made clear that the time taken by them in prosecuting the appeal/writ petitions before this Court shall be excluded for the purpose of limitation. Taking note of the fact that the appellant in W.A. No.1554 of 2006 is a lower grade employee, we are of the view that the direction for payment of costs would be a burden for her. Accordingly, we set aside the order for payment of costs in W.P.No.34793 of 2006. Except the above modification, Writ Appeal and Writ Petitions are dismissed with liberty to the appellant/writ petitioners to file Review Petition if they so desire while making it clear that we have not expressed anything on the merits or otherwise of the claims of the parties so as to canvass the same in the Review Petitions to be filed. No costs. Connected Miscellaneous Petitions are closed.

It shall be noted that as per the Central Board of Direct Taxes's said notification e-TDS and e-TCS Returns will not be accepted at the NSDL Centres if the PAN Number of the deductees and collectees are not furnished in the respective returns as per the percentage furnished below.

1.	TDS Return in Form 24Q (TDS on Salary)	95%
2.	TDS Return in Form 26Q (TDS on Other than Salary)	85%
3.	TDS Return in Form 27Q (Tax Collection at Source)	85%

This enhanced percentage is applicable for and from the Returns for the Quarter ending 31.3.2008. This will also be applied to all TDS/TCS Returns for any of the earlier Quarters which are filed on or after 1.4.2008.

The Superintending Engineers are requested to instruct the officers under their control to obtain correct 'PAN' details of all deductee and collectees and quote the same in the TDS/TCS Returns without any omissions.

PRESS RELEASE

All tax deductors / collectors are required to file the TDS/TCS returns in Form No.24Q (for salaries), Form No.26Q (for payments other than salaries) or Form No.27EQ (for TCS). These forms require details of all tax deductions with name and permanent account number (PAN) of parties from whom tax was deducted.

It had earlier been decided that Form No.24Q with less than 90% of PAN data and Form No.26Q & Form NO.27EQ with less than 70% of PAN data will not be accepted for the quarter ending on 30.9.2007 and thereafter.

The said decision has since been reviewed. It has now been decided to enhance the threshold limit for PAN quoting without which TDS/TCS returns will not be accepted. The limit has been enhanced to 95% from 90% in case of Form 24Q and to 85% from 70% in case of Forms 26Q and 27EQ. The enhanced limits will be applicable for and from the quarter ending 31.3.2008. These threshold limits will also apply to all those TDS/ TCS returns, which are filed for any of the earlier quarters on or after 1/4/2008.

Tax deductors and tax collectors are, therefore, advised to obtain correct PAN of all deductees and quote the same in their TDS/TCS returns. Deductees are also advised to furnish their correct PAN with their deductors, failing which they will not only have difficulty in getting credit of TDS/TCS in their income tax assessments but will also face penal proceedings under the Income Tax Act.
