The attention of all Chief Engineers, Superintending Engineers and other officers of Board is invited to the Board's Memo. third and fourth cited, wherein instructions have been issued, to withhold sanctioning of advance incentive increments to the employees of the Board, those who have passed one year B.Com., (Double Degree) course under Distance Education Mode till a clarification is received from the Government and also not to entertain fresh cases.

2. The University of Madras, Directorate of Technical Education, Government (Energy) Department and the University Grants Commission have been consulted with regard to the equivalency of one year B.Com., (Double Degree). The clarifications received from the above authorities have been examined in detail and it has been decided that the One year B.Com., (Double Degree) is not equivalent to regular three years B.Com., degree/Accountancy Junior and Senior Grade.

3. Accordingly, it is hereby ordered that

- i) one year B.Com., (Double Degree) course under Distance Education mode shall not be taken into account for grant of incentive increment/promotion.
- ii) the payment of incentive increment and promotion already been allowed to the employees who have passed one year B.Com., (Double Degree) other than the employees who have obtained stay orders from the Hon'ble High Court shall be recovered and reverted respectively.
- iii) the recovery of incentive increments in respect of the employees who have obtained stay orders from the Hon'ble High Court shall be considered after the outcome of the Court's orders is known.

Loans and Advances - Advance for the purchase of Conveyance - Revision of eligibility criteria by Government - Adoption to Board employees - Orders - Issued.

Proceedings:

In the B.P. first cited, orders were issued among other things, fixing the eligibility criteria for the sanction of quantum of Conveyance Advance for the purchase of Motor Car to the employees of the Tamil Nadu Electricity Board.

2. In the B.P. second cited, orders were also issued for the sanction of quantum of Conveyance Advance towards the purchase of motorized two wheelers, based on the capacity of the engine.

3. The Government in its order 3rd cited, have enhanced the quantum of advance for purchase of Motor Cars and Motorized two wheelers, considering the market prices of Motor vehicles with the eligibility and based on the revision of pay scales to the Government employees.

4. Consequent on the revision of pay scales of the employees of the Board, the Tamil Nadu Electricity Board has also carefully considered to adopt the Government Order in Tamil Nadu Electricity Board and decided to follow the Government Orders, enhancing the ceiling on Conveyance Advance to the employees of Tamil Nadu Electricity Board, subject to all other conditions/orders in force for sanction of Conveyance Advance. Accordingly, the Tamil Nadu Electricity Board directs that the following quantum of advance for the purchase of new Motor Car is enhanced with the eligibility criteria as mentioned against each:-

5. The Tamil Nadu Electricity Board also directs that the Conveyance advance in respect of motorized two wheelers, based on the capacity of the engine, be dispensed with and all the regular employees of the Board in the time scale of pay shall be eligible for a maximum ceiling of Rs.50,000/- (Rupees fifty thousand only) for all categories of motorized two wheelers.

6. These revised orders shall take effect from 1.4.2010, subject to the following conditions:-

- (a) If the actual value of the car or two wheeler purchased is below the ceiling prescribed above, the admissible advance will be restricted to the cost of the vehicle including taxes, registration and insurance.

- (b) As already done in the case of two wheelers, no advance shall be given for the purchase of second hand motor cars.
- (c) The period of recovery of the advance and the other rules and regulations for sanction of Conveyance Advance shall remain unchanged.

Tamil Nadu Electricity Board Service Regulations – Deputation of Board employees on Foreign Service – Prescription of certain norms for deputation and for continuance of deputation of the Board employees – Further orders – Issued.

Proceedings:

In the Government Order read above, Government have issued orders prescribing certain norms for deputation and for continuance of deputation of the Government servants. Out of the conditions prescribed by the Government in the said G.O., the following conditions are already existing in sub-regulation (c) under Regulation 65 of Tamil Nadu Electricity Board Service Regulations:

"(iv) The period of deputation of a Board employee should not exceed three years.

(v) The extension of deputation for the fourth year should be only in exceptional and special circumstances in public interest. Extension of deputation for fourth year shall be sanctioned only by the Board".

2. Now, a question has arisen as to how the period of deputation and the continuance of the deputation of the Board employees to other Departments, be regulated. Therefore, it has been proposed to adopt the other norms prescribed by the Government in the Board suitably. After careful examination, the Board has approved the proposal.

3. Accordingly, the Tamil Nadu Electricity Board issues the following orders together with the existing conditions prescribed in sub-regulation (c) under Regulation 65 of Tamil Nadu Electricity

Board Service Regulations, for deputation and for continuance of deputation period of the Board employees to other Departments:

- (i) While sending Board employees for foreign service or suggesting names for such deputation, selection should be made on the basis of seniority. If a senior could not be deputed, for instance when charges are pending or the senior being unsuitable for deputation, the precise reasons should be recorded in writing by the authority making the selection. When selection is made from a category, persons with not less than 5 years of experience in that category should be considered.
- (ii) If the senior had already been on foreign service, his next junior should be considered for deputation.
- (iii) No Board employee shall be deputed to his native District. The spouse of the Board employee is employed in his Native District is not a ground for deputing him to his Native District.
- (iv) The period of deputation of a Board employee should not exceed three years. This should be strictly followed.
- (v) The extension of deputation for the fourth year should be only in exceptional and special circumstances in public interest. Extension of deputation for fourth year shall be sanctioned only by the Board".
- (vi) No Board employee shall be allowed to be on deputation beyond fourth year on any ground.
- (vii) If no orders sanctioning continuance of deputation beyond the 3 years are received before the expiry of deputation period, the foreign employer shall revert the Board employee to the Board without waiting for any further orders like posting of substitute, etc. The authority which sanctioned the deputation of the Board employee should also take immediate steps to get him reverted.
- (viii) While deputing a Board employee who had been on foreign service, it must be ensured that he has served for a minimum period for 2 years in his parent department on his reversion, before he is again deputed with a view to ensure that he keeps in touch with the main-stream work of the department and also to prevent only a few officers for a department alone being deputed to all the deputation posts.

4. Apart from the above norms, to ensure strict observance of the procedures laid down for deputation of Board employees on foreign service, and to avoid any lapse, it has been decided to prescribe a periodic to watch the return of the Board employees. In the Board's Proceedings first cited orders were issued, sanctioning Remote Hydro/Cavern Allowance-cum-Performance Incentive to the employees working in Remote Hydro Stations/ Kadamparai Power House as mentioned below:-

"75% of the rate of both Remote Hydro Allowance/Cavern Allowance sanctioned shall be paid every month and the remaining 25% shall be linked to the performance of the respective Hydro Stations to be reviewed by a Committee consisting of Accounts Member and Member (Generation) at the end of each financial year."

In the reference third cited, the Chief Engineer (Hydro), Chennai has requested sanction for releasing the remaining 25% of Performance Linked Remote Hydro/Cavern Allowance-cum-Performance Incentive for the year 2008-2009 based on the performance of the Hydro Stations. The request has been examined by the Committee and it has been decided that the guidelines prescribed last year may be followed in toto for the financial year 2008-2009 also.

2. In pursuance of the above decision, it is hereby ordered that the following guidelines/ instructions shall be adhered to in working out the performance of each station for releasing the balance 25% of the Performance Linked Incentive for 2008-2009.

THE PLANT AVAILABILITY FACTOR:-

- i. This factor is based on availability of the machine i.e., running or standby condition. As outage hours increases, this factor reduces. This factor will reflect the performance of the station.
- ii. Annual overhaul is a statutory requirement. This period may be excluded for calculating the Plant Availability Factor for incentive purpose. Since R&M is undertaken for life extension and performance improvement, the machine under shutdown for R&M need not be considered for arriving Plant Availability Factor of the respective station. After R&M, the Machine shall be taken as new one.
- iii. Balance 25% incentive shall be considered for the stations that maintain minimum of 80% availability factor. Proportionate incentive (Reduction) shall be given for the stations that have less than 80% Plant Availability Factor. Average availability factor of all units (whether running or ready standby) in a station shall be considered as station availability factor, based on which incentive is to be worked out.
- iv. The 25% incentive shall be given in full for the employees who have served more than 200 days at a particular Hydro Station during the financial year 2007-2008. Proportionate working days shall be calculated for those who join or leave in the

middle of the year due to promotion or transfer and they shall be paid proportionately for their duration of service.

- v. For those officers and staff working in Superintending Engineer/ Generation Circle Offices, Stores etc., common to Generation Circle, the Average Availability Factor of all the Stations shall be calculated proportionately for considering the payment of this incentive. The Sample working sheet already prescribed in Board's Memo. No.59508/A3/ A32/2003-1, Dated : 4-9-2003 shall be followed for the payment of incentive 2008-2009.

3. In the Board's Proceedings first read above, the powers of Member (Accounts), Tamil Nadu Electricity Board were delegated to the Chief Financial Controller/General and Chief Financial Controller/Revenue, Board Office Accounts Branch. The power relating to the general continuance of posts already sanctioned and in existence for atleast 3 years in respect of all categories in work load and other than work load norms were also delegated to the Chief Financial Controller/General.

2. In Tamil Nadu Electricity Board, various cost cut measures/revenue augmentation are being implemented in the areas wherever possible. It is observed that the post continuance proposals are received from various offices without critical examination of the requirement of posts. Even though the posts which are lying vacant for long years, without reduction of post, continuance is recommended for approval without justification. Hence, the cost cut measures could not be implemented in the continuance proposals. Therefore, to achieve the economy in Human Resource expenditure on other than work load areas, the Chief Financial Controller/General has suggested that the continuance proposals relating to other than work load areas be submitted to Chairman for approval. The suggestion has been accepted.

3. Therefore, it has been decided to amend the (Per.) B.P. (Ch.) No.74 (SB), dated 24.4.2009 suitably. Accordingly, the following amendments are issued to the said Board's Proceedings read above:-

AMENDMENTS

In the said Board's Proceedings in paragraph 2:-

- (1) for the expression "the powers of Member (Accounts)/Tamil Nadu Electricity Board are delegated to the Chief Financial Controller/General and Chief Financial Controller/Revenue, Board Office Accounts Branch" the following expression shall be substituted, namely.

"the powers of Member (Accounts)/Tamil Nadu Electricity Board are delegated to the Chairman, Chief Financial Controller/General and Chief Financial Controller/Revenue Board Office Accounts Branch".

- (2) after the expression "accordingly to their allocation of works as follows", the following sub-heading and expression may be added, namely:-

"Chairman:-

General continuance of posts already sanctioned and in existence for atleast 3 years in respect of all categories in work load and other than work load norms.";

- (3) under the sub-heading "Chief Financial Controller/General" item (v) shall be omitted.

Sub: Income Tax - Rates of Income Tax to be Deducted at Source from "Salaries", 80C Deduction - Assessment Year 2011-12 Financial Year 2010-11 - Certain Amendments made to the Act through Finance Bill 2009 - Communicating of - Reg.

Kindly refer the circular memo cited above wherein the Rates of Income Tax to be deducted at source from the head Income from "Salaries" has been communicated.

Now, the following Amendments are proposed to be made to the provision of Income Tax Act' 1961 through Finance Bill 2010 introduced by the Hon'ble Finance Minister, Govt. of India in Parliament on 26.2.2010.

I. Rate of Income Tax to be Deducted at Source on Salaries.

A. Individual, Hindu undivided family, association of persons, body of individuals, artificial juridical person.

The rates of income-tax in the case of every individual or Hindu undivided family or every

association of persons or body of individuals, whether incorporated or not, or every artificial juridical person referred to in sub-clause (vii) of clause (31) of section 2 of the Income-tax Act (not being a case to which any other Paragraph of this Part applies).

The new rates of income-tax on total income shall be as under:-

Upto Rs.1,60,000/-	Nil.
Rs.1,60,001/- to Rs.5,00,000/-	10 per cent.
Rs.5,00,001/- to Rs.8,00,000/-	20 per cent
Above Rs.8,00,000/-	30 per cent

In the case of every individual, being a woman resident in India, and below the age of sixty-five years at any time during the previous year, the new rates of income-tax on total income in such cases will be as under.

Upto Rs.1,90,000/-	Nil.
Rs.1,90,001/- to Rs.5,00,000/-	10 per cent.
Rs.5,00,001/- to Rs.8,00,000/-	20 per cent
Above Rs.8,00,000/-	30 per cent

In the case of every individual, being a resident in India, who is of the age of sixty-five years or more at any time during the previous year. The new rates of income-tax on total income in such cases will be as under.

Upto Rs.2,40,000/-	Nil.
Rs.2,40,001/- to Rs.5,00,000/-	10 per cent.
Rs.5,00,001/- to Rs.8,00,000/-	20 per cent
Above Rs.8,00,000/-	30 per cent

(1) Surcharge NIL

(2) Education Cess

"Education Cess on Income-tax" and "Secondary and Higher Education Cess on income-tax" shall continue to be levied for the purposes of Union at the rate of two per cent, and one per cent, respectively of income-tax in the cases of deductions on payment of salary.

II. Deduction in respect of Long-Term Infrastructure Bonds

In tune with the policy thrust of promoting investment in the infrastructure sector, it is proposed to insert a new section 80CCF in the Income-tax Act to provide that subscription during the financial year 2010-11 made to long-term infrastructure bonds (as may be notified by the Central Government), to the extent of Rs.20,000, shall be allowed as deduction in computing the income of an individual or a Hindu undivided family. This deduction will be over and above the existing overall limit of tax deduction of savings of upto Rs.1 lakh under section 80C, 80CCC and 80CCD of the Act.

This amendment is proposed to take effect from 1st April, 2011 and will, accordingly, apply in relation to the assessment year 2011-12 (Financial year 2010-11).

III. Deduction in respect of contribution to the Central Government Health Scheme

Under the existing provisions of section 80D, deduction in respect of premium paid towards a health insurance policy upto a maximum of Rs.15,000 is available for self, spouse and dependent

children. A further deduction of Rs.15,000 is also allowed for buying an insurance policy in respect of dependent parents. The deduction is enhanced to Rs.20,000 in both cases if the person insured is of age of 65 years or above.

The Central Government Health Scheme (CGHS) is a medical facility available to serving and retired Government servants. This facility is similar to the facilities available through health insurance policies.

It is therefore, proposed to also allow deduction in respect of any contribution made to CGHS by including such contribution under the provisions of section 80D. The deduction will be limited to the current aggregate as mentioned in the section.

This amendment is proposed to take effect from 1st April, 2011 and will, accordingly, apply in relation to the assessment year 2011-12 and subsequent years. (Financial Year 2010-11).

Instructions for filling out Income Tax Return FORM SARAL-II ITR-1

These instructions are guidelines for filling the particulars in this Return Form. In case of any doubt, please refer to relevant provisions of the Income-tax Act, 1961 and the Income-tax Rules, 1962.

1. Assessment Year for which this Return Form is applicable

This Return Form is applicable for assessment year 2010-2011 only, i.e., it relates to income earned in Financial Year 2009-10.

2. Who can use this Return Form

This Return Form is to be used by an individual whose total income for the assessment year 2010-11 includes:-

- (a) Income from Salary / Pension; or
- (b) Income from One House Property (excluding cases where loss is brought forward from previous years); or
- (c) Income from Other Sources (Excluding Winning from Lottery and Income from Race Horses).

Further, in a case where the income of another person like spouse, minor child, etc. is to be clubbed with the income of the assessee, this Return Form can be used only if the income being clubbed falls into the above income categories.

3. Who cannot use this Return Form

This Return Form should not be used by an individual whose total income for the assessment year 2010-11 includes:-

- (a) Income from more than one house property; or
- (b) Income from Winnings from lottery or income from Race horses; or
- (c) Income under the head "Capital Gains", which are not exempt from tax, e.g., short-term capital gains or long-term capital gains from sale of house, plot, etc.; or
- (d) Income from agriculture in excess of Rs.5,000; or
- (e) Income from Business or Profession.

4. Annexure-less Return Form

No document (including TDS certificate) should be attached to this Return Form. All such documents enclosed with this Return form will be detached and returned to the person filing the return.

5. Manner of filing this Return Form

This Return Form can be filed with the Income Tax Department in any of the following ways:-

- (i) by furnishing the return in a paper form;
- (ii) by furnishing the return electronically under digital signature;
- (iii) by transmitting the data in the return electronically and thereafter submitting the verification of the return in Return Form ITR-V;
- (iv) by furnishing a Bar-coded return.

Where the Return Form is furnished in the manner mentioned at 5(iii), the assessee should print out two copies of Form ITR-V. One copy of ITR-V, duly signed by the assessee, has to be sent by ordinary post to Post Bag No.1, Electronic City Office, Bangaluru-560100 (Karnataka). The other copy may be retained by the assessee for his record.

6. Filling out the acknowledgement

Only one copy of this Return Form is required to be filed. Where the Return Form is furnished in the manner mentioned at 5(i) or at 5(iv), the acknowledgement slip attached with this Return Form should be duly filled.

3. Accordingly, the Tamil Nadu Electricity Board approved the following resolutions, as required by M/s.PFC, New Delhi in respect of implementation of Part-B projects under R-APDRP in Tamil Nadu.

RESOLUTIONS

- (a) In principle approval for (i) availing the financial assistance from the MoP/GoI through M/s.PFC for implementation of the Part-B projects in the eligible towns of Tamil Nadu, (ii) accepting the loan on the terms and conditions specified by M/s.PFC, (iii) authorizing the Chairman/TNEB to accept and agree to said terms and conditions and execute the relevant loan documents/undertakings etc. and (iv) authorizing the Deputy Financial Controller/Resources of TNEB to sign Agreements/Certificates such as Memorandum of Agreement(MoA), Hypothecation Deed, Undertakings & other relevant papers as sought for by M/s.PFC and execute relevant documents and other writings for and on behalf of the Board.

- (b) Approval and ratification of action of the Chairman/TNEB for availing financial assistance of the MoP/Gol for an amount of **Rs.25.98 Crores** (Rupees Twenty five point nine eight crores only) through M/s.PFC in respect of the 10 (Ten) towns sanctioned in the first slot as per Annexure to this Board's Proceedings.

The TNERC order in M.P. Nos.10, 11 & 12 of 2010 is communicated herewith. In this connection, all CEs/D & SEs/EDC are instructed as follows:-

1. Wherever the communication of quota allocation as per the TNERC Suo-Motu Proceedings No.1/2009 was received by the consumers in the end of November 2009 the delay was one month and wherever the intimation was received in the end of December 2009 the delay was two months, in that case, extend the utilization of the banked energy up to 30th April, 2010 or 31st May, 2010 depending on whether the intimation was received by the consumer from the Tamil

Nadu Electricity Board by one month later or two months later.

2. However, the consumers who had availed of the 1/5th of the banked energy (Availed means, the consumer availed the 1/5th of the banked energy on fixing of quota or availed the same by way of adjustment in the billing process already) from November onwards will not be eligible for the extension of banking period. Conversely, if any consumer has been penalized from November onwards for not being able to utilize the 1/5th of banked energy due to the delay in intimation of quota, such penalty shall be reversed (ie. By way of adjustment in billing). The extension of banking period will apply to 1/5th of the banked energy as on 1.11.2009 (If consumer not availed the 1/5th of the banked energy, the same quantum of 1/5th of the energy not availed only be extended as directed by the Hon'ble Commission).

3. A report on complying the same may be sent to CE/Commercial for apprising the action taken to TNERC.

The above M.P.Nos.10, 11 & 12 of 2010 praying for extending the banking period for the year 2009-2010 upto April 2010 and directing the respondents to make payment of a sum of Rs.3.50 per unit for unutilized banked units together with interest came up for final hearing on 29.3.2010. The Commission upon perusing the above petitions and connected records and upon hearing the arguments of both sides passes the following.

Common Order

It transpires from the correspondence produced by the learned counsel for the Tamil Nadu Electricity Board that the earliest intimation of quota to the consumers took place in the end of November 2009 and in some cases the intimation was given as late as end of December 2009. Thus, the Commission's Order was implemented by Tamil Nadu Electricity Board in a time frame of not less than one month and in some cases as late as 2 months. Wherever the communication of quota allocation was received by the consumers in the end of November 2009 the delay was one month and wherever the intimation was received in the end of December 2009 the delay was two months. Therefore it is fair to extend the utilization of the banked energy upto 30th April, 2010 or 31st May, 2010 depending on whether the intimation was received by the consumer from the Tamil Nadu Electricity Board by one month later or two months later. However, the consumers who had availed o the 1/5th of the banked energy from November onwards will not be eligible for the extension of banking period. Conversely, if any consumer has been penalized from November onwards for not being able to utilize the 1/5th of banked energy due to the delay in intimation of quota such penalty shall be reversed. The extension of banking period will apply to 1/5th of the banked energy as on 1.11.2009.

The prayer for encashment at the rate of Rs.3.50 per unit cannot be entertained since the extension of banking period is already granted.

The Commission shall be apprised of the action by the Tamil Nadu Electricity Board in implementing this Order.

With the above directions M.P.Nos.10, 11 & 12 of 2010 are finally disposed off.

I am to enclose a copy of the reference cited and to state that based on the announcement made by the Hon'ble Minister for Agriculture for the welfare of landless poor and the free energization has been utilization by the Agriculture Department in most of the districts. Hence the free energization in the 3 districts as requested by the Executive Director, Tamil Nadu Watershed Development Agency be considered favourably because the poor landless agricultural labourers alone are benefited by the scheme. Moreover disparity in the utilization of the scheme among the districts will cause concern among the farmers, which will defeat the purpose of the scheme.

2. I am also to state that based on the cropping pattern, they have been reclassified as agricultural farmers. Only 63 borewells in the RCWP program and 179 borewells in the NADP program need energisation and they fall in the agricultural category.

3. I am, therefore, to request you to send your remarks on the request of the Executive Director, Tamil Nadu Watershed Development Agency, Chennai.

TAWDEVA is implementing the development of land parcels of 50.00 ac & above in the following two schemes as per the G.O. 3rd, 4th, 5th & 6th cited above.

I. Development of land parcels of 50.00 ac and above under Distribution of Government Wasteland to Landless Poor Agriculture Labour Families (RCWP).

As per the GO 4th cited above, the development of land parcels of 50 ac & above in wastelands is being implemented for the benefit of small and marginal farmers. In most of the districts, free energization by the department of energy is utilized and dovetailed for the development of wastelands. But in some of the districts like Dindigul, Sivagangai, & Thoothukudi districts free energization is yet to be given by the TNEB.

II. Development of land parcels of 50.00 ac and above in private patta dry aldn under National Agriculture Development Programmes (NADP)

As per the GO 5th cited, 62 land parcels have been taken up for the development of horticulture crops. The free energization to those land parcels have not been given by the TNEB, hence there is no provision for free energization to horticulture crops.

Since, provision of free energization is for agriculture crops, those clusters will be converted to development of agriculture clusters instead of horticulture clusters vide reference 7th cited (copy enclosed). These clusters were already approved by the State Level Sanctioning Committee (SLSC) headed by Chief Secretary (Minutes enclosed).

The list of pending clusters for free energization is enclosed in annexure.

We request necessary action may be taken in this regard at the earliest to facilitate the energy department to provide free energization for the development of clusters of 50.00 ac & above under NADP & RCWP.
