In the Settlement dated 18.11.2009 secured with the Unions under Section 12(3) of the Industrial Disputes Act, 1947 on the question of revision of Work allocation and Staff pattern and Revision of scales of Pay and Allowances, a term as indicated below, was included:-

Committee - Bringing Pay parity on par with Government to certain categories, Upgradation of Pay Scales to certain categories, Creation of promotion policy to remove stagnation in promotion and rectification of pay anomaly to seniors consequent on the introduction of Special Grade w.e.f.01.12.2002 - Constitution of Committees to study the Question - Orders - Issued.

Proceedings:

In the Settlement dated 18.11.2009 secured with the Unions under Section 12(3) of the Industrial Disputes Act, 1947 on the question of revision of Work allocation and Staff pattern and Revision of scales of Pay and Allowances, the following terms were included:-

- "7(ii) Pay parity on par with Government in categories of Draughtsman, Head Draughtsman, Staff Nurse, Technical Assistant, Steno-typist, Tester (Chemical), Section Officer/ Secretariat Branch, upgradation of pay scales of certain categories such as Superintendents of Administrative/Technical Branches, Record Clerk etc., and pay anomaly pointed out by Unions/ individual employees will be decided by forming a separate Committee and suitable orders issued thereon.
 - (v) Rectification of pay anomaly to certain seniors resulting in drawal of less pay than the junior arose and continue to exist, consequent on the introduction of Special Grade with effect from 01.12.2002 (i.e.before coming over to the revised scale of pay with effect from 01.12.2007) duly allowing the higher pay as allowed to the Junior in Special Grade scale of pay notionally from the date on which junior drew such higher pay with monetary benefit from 01.12.2007.

- (vii) To remove stagnation in promotion, the Board would like to evolve such promotion policy that every regular employee on time scale of pay, will be assured of three promotions in their entire service. The modalities on this will be discussed and finalized in consultation with the parties.
- 2. The Board has considered the matter and has decided to form a separate committee for considering the pay parity on par with Government to certain categories and to upgrade the scale of pay to certain categories mentioned in para-1 above and also to examine the representations on anomalies, if any, consequent on the implementation of the revised scale of pay and the pay anomaly arose to the seniors due to introduction of Special Grade with effect from 01.12.2002 and to make specific recommendations to the Board, to evolve promotion policy that every employee will be assured of three promotion in their entire service so as to remove stagnation in promotion.
- 3. Accordingly, the Tamil Nadu Electricity Board directs that a committee consisting of the following officers of the Board, be constituted to study the question in depth on the subjects mentioned above and shall submit a Comprehensive Report to the Convener of the Wage Revision Committee:-

The Committee will study the issues in all dimensions including the existing pay, revised pay, work norms, lines of promotion, qualification prescribed, to bring pay parity with Government and for upgradation of scales. The committee shall give adequate justification and the financial commitment for every recommendation. The committee shall make specific recommendation on the representations/anomalies considered by it. The Committee shall submit its report by 31.03.2010.

Travelling Allowance - Re-imbursement of transport charges to employees on Tours at New Delhi and other State Head Quarters outside Tamil Nadu - Orders issued enhancing the transport charges - Amendment to Regulation 39-A of the Tamil Nadu Electricity Board Employees Travelling Allowance Regulations - Issued.

Proceedings:

In the Board's Proceedings read above, orders have been issued, considering the prevailing transport charges and the hardships faced by the officials, who travel by Taxi and Awtowicknets of the control of the control

New Delhi or Other State Head Quarters outside Tamil Nadu for official purposes, that the existing maximum limit prescribed in Regualtion 39-A of TNEB Employees' Travelling Allowance Regulations for Private Taxi and Auto Rickshaw be enhanced from Rs.30/- and Rs.15/- per day to Rs.100/- and Rs.50/- per day, respectively.

- Based on the above orders, it has been proposed to issue suitable amendments to Regulation 39-A of the Tamil Nadu Electricity Bord Employees Travelling Allowance Regulations and the Board has resolved to issue such amendment.
- 3. In G.O. Ms.No.104, Energy (B2) Department, dt.16.12.2009, notification has been issued under the proviso to clause (a) of section 172 of the Electricity Act, 2003 (Central Act 36 of 2003) authorizing the Tamil Nadu Electricity Board to function as State Transmission Utility and a Licensee under the provisions of the said Act for a further period of three months upto 15.3.2010 beyond 15.12.2009. Therefore, the Board constituted under the Electricity (Supply) Act, 1948 (Central Act 54 of 1948) will continue to function as the Transmission Utility and a Licensee and as such it can exercise its administrative function as was done earlier and make regulations providing for the service conditions of the officers and employees of the Board.
- Accordingly, the Tamil Nadu Electricity Board hereby makes the following amendment to the Tamil Nadu Electricity Board Employees Travelling Allowance Regulations:-

AMENDMENT

In the said Regulations, in regulation 39-A, for clause (v), the following clause shall be substituted, namely:-

"(v) The actual transport charges payable shall be limited to a ceiling of Rs.100/- (Rupees one hundred only) per day in the case of transport by Taxi and Rs.50/- (Rupees fifty only) per day in the case of transport by Auto-Rickshaw".

It has come our notice that an organisation operating under various names like Krishi Bikash Shilpa Kendra, Krishi Vikas Shilpa Kendra, Krishi Vikas Silpa Kendra, etc. is misleading the public by claiming to be an organizations of the Government of India engaged in implementation of the Twenty Point Programme (TPP). It is fraudulently issuing appointment letters and identity cards bearing the emblem of Government of India. Copies of various documents issued by these organizations bearing the National Emblem, the phrase "New 20 Points Programme Implementation" "Government of India" and the Order purportedly issued by Late Prime Minister Smt. Indira Gandhi alongwith her photograph, name of Ministry of Agriculture, copies of the appointment letters and Identity Cards issued by them are enclosed for ready reference.

- 2. Various welfare programmes/schemes of GOI covered under TPP are administered by the Central Nodal Ministries & implemented by the State Government / UT Administration. This Ministry has not at any stage authorized any organization to implement the Twenty Point Programme or any part of it, on behalf of this Ministry nor have we provided any financial assistance in this regard.
- 3. Keeping in view the gravity of the matter, kindly instruct all district authorities that if any such organisation or their representatives in your state comes to notice, the matter may be investigated and appropriate action be taken as per law and kindly keep this Ministry informed about the existence of any of such organisation in your state and the action initiated by the state in this regard. For your information I am enclosing copies of letters of Secretary (Agriculture), Government of West Bengal, Dr. Manas Bhulia, MLA, West Bengal and a news item that appeared

in Bardhaman.com for 21st April, 2004. As this organisation (KBSK/KVSK) is defrauding the public, urgent attention is requested.

Sub: Revision of pension - Revised Commutation Table - Revised commuted value of pension to employees who retired between 1.12.2007 and 30.11.2009 - Clarification issued by the Government Adoption to the employees of Tamil Nadu Electricity Board - Orders - Issued.

Ref: 1) (Per.) B.P. (Ch.) No.235 (S.B), dated 1.12.2009.

 From the Finance (Pension) Department, Govt. of Tamil Nadu Lr.No.64902/Finance (Pension) Department/2009-1, dt.24.11.09.

In the Board's Proceedings first cited, orders have been issued revising the pension and pensionary benefits to the pensioners/family pensioners of Tamil Nadu Electricity Board. It was also ordered therein tht the commutation of pension shall be permitted up to the rate of 33 1/3% of basic pension to employees retiring from service on or after 01.06.2009. For calculating commuted value of pension, the revised commutation table given in Annexure-I to the Board's Proceedings first cited shall be followed. It has also been ordered that as the commutation based on the revised pension consequent on revision of scale of pay shall be calculated with reference to the revised limit of 33 1/3% and new commutation Table, the employees retired between 1.12.2007 and 31.5.2009 who are not willing to commute the difference of revised pension with regard to Commutation Table, such employees shall clearly indicate their unwillingness to the Pension Sanctioning Authorities. However, if any employee, who retired in between the above said period, has expressed his willingness for revision of commutation, it will be allowed up to the limit of 33 1/3% only.

2. Now, the Government in their letter second cited have issued certain clarifications in respect of commutation on revised rate of pension. After careful consideration, the Board has decided to adopt the said clarifications to the employees retired between 1.12.2007 and 30.11.2009 with partial modifications. Accordingly, it is hereby ordered that:-

B.B. 2 - Jan. 2010.

- a) in respect of pensioner whose commutation became absolute between the period from 1.12.2007 to 30.11.2009, pre-revised table shall be adopted for payment of commutation of pension based on pre-revised pension.
- the commutation factor in the revised table shall be adopted for commutation of additional amount of pension in case of willing pensioners that has become commutable on account of retrospective revision of pay and consequent revision of pension, (i.e. (1/3rd of revised pension - 40% of Pre-revised Pension) x 12 x factor as per revised table).;
- the revised table shall be adopted for all commutation of pension which become absolute on or after 1.12.2009.
- d) in respect of pensioners who retired between 1.12.2007 and 30.11.2009 the age reckoned for calculation of commuted value of pension at the time of original application for commutation of pension will apply for calculation of commutation value of additional commutable pension;
- e) in respect of pensioners who retired between 01.12.2007 and 30.11.2009 but died before the issue of (P) BP (Ch.) No.235 (SB), dated 1.12.2009 shall not be entitled for revised commutation on additional pension since the additional commutation is based on the option exercised by the pensioner.

BONUS - Adhoc Bonus - Special Adhoc Bonus for the year 2008-09 - Sanction - Orders - Issued.

Read the following:-

- G.O.Ms.No.556, Finance (Allowances) Department, dated 30.12.2008.
- Government of India, Ministry of Finance, Department of Expenditure, New Delhi O.M.No.7/24/2007/E III(A), dated 28.8.2009.

ORDER:

Government has decided to grant Adhoc Bonus equivalent to 30 days emoluments on a base of 30 days a month to all regular and temporary Government employees, employees of Local Bodies and Aided Educational Institutions including teachers on regular time scales of pay for the financial year 2008-2009.

- 2. Employees in Group 'C' and 'D' were hitherto paid Adhoc Bonus equivalent to 30 days emoluments subject to a ceiling of Rs.2,500/- till the year 2007-2008. Government has now decided to enhance the above above ceiling limit to Rs.3,000/-. Accordingly, Government direct that all regular and temporary Government employees who are on regular times scales of pay, employees of Local Bodies and Aided Educational Institutions including teachers on regular time scales of pay in 'C' and 'D' group be paid adhoc bonus equivalent to 30 days emoluments on a base of 30 days a month for the financial year 2008-2009. The Adhoc Bonus shall be computed on the basis of actual emoluments as on 31st March 2009. The amount of adhoc bonus shall be calculated as if monthly emoluments were Rs.3,000/- per month. In respect of those drawing pay in the prerevised / revised scales of pay, the calculation of adhoc bonus shall be based on the emoluments drawn subject to the upper ceiling of Rs.3,000/- (Rupees Three thousnd only) per month. The upper ceiling limit shall be applicable irrespective of whether the emoluments are drawn in the prerevised or revised scales of pay.
- 3. Employees in Groups 'A' & 'B' including those coming under University Grants Commission / All India Council for Technical Eduction / Indian Council of Agricultural Research scales of pay and All India Service Regulations are not covered by the bonus scheme and are not entitled to get any adhoc bonus amount. Government has decided to grant Special Adhoc Bonus to these employees and direct that employees in groups 'A' & 'B' including those on University Grants Commission / All India Council for Technical Education / Indian Council of Agricultural Research scales of pay and All India Service Regulations be paid Special Adhoc Bonus of Rs.1,000/- (Rupees One thousand only).
- 4. The Speical Adhoc Bonus of Rs.1,000/- (Rupees One thousand only) shall also be admissible to full-time and part-time employees paid from contingencies at fixed monthly rates, employees on consolidated pay / special time scale of pay including employees in Nutritious Meal Programme / Integrated Child Nutrition Project (Anganwadi Workers), Mini Anganwadi Workers, Village Assistants on special time scales of pay, Panchayat Assistants / Clerks on special time

scales of pay in Village Panchayats under Rural Development and Panchayat Raj Department, contract employees, temporary Assistants on contract basis, the employees on daily wages and the employees partly worked on daily wages and subsequently brought under regular establishment and worked continuously for atleast 240 days or more during the year 2008-2009.

- Deputationists from the State Government working in Corporations / Boards / Joint Sector companies who are not in receipt of bonus / exgratia payment from the undertakings concerned are eligible for the benefit of Adhoc Bonus / Special Adhoc Bonus.
- The Adhoc Bonus/Special Adhoc Bonus sanctioned in paras 2 to 5 above shall be admissible subject to the conditions prescribed in the annexure to this order.
- 7. The expenditure on Adhoc Bonus/Special Adhoc Bonus shall be debited to the subdetailed head "04 Other Allowances" under the detailed head "01. Salaries" or the detailed head "02. Wages" as the case may be, under the relevant service head of the department concerned.
- 8. The expenditure on Special Adhoc Bonus in respect of temporary Assistants appointed on contract basis in the year 2003 shall be debited to the Detailed / Sub-Detailed head "33 - Payments for Professional and Special Services" "04 - Contract Payment" under the relevant service head of the department concerned.
- Necessary provisions have been made under the relevant heads of account in BE 2009-2010. However, if additional provisions are required, they will be made under the relevant heads of account in RE/FMA 2009-2010 and the required funds may be drawn pending such provision.
- 10. This order issues with the Additional Sanction Ledger No.1391 (One thousand three hundred and ninety one).

NOW THEREFORE, in exercise of the powers conferred on it by Section 181 read with Section 50 of the Electricity Act, 2003 and all other powers onabling it in this behalf, the Tamil Nadu Electricity Regulatory Commission hereby spcifies the following amendments to the Tamil Nadu Electricity Supply Code (hereinafter referred to as the Principal Code), namely:-

- 1. Short title and Commencement:
- (a) This Code may be called the Tamil Nadu Electricity Supply (Amendment) Code, 2009.
- (b) It shall be deemed to have come into force on 15th June 2007, i.e., the date on which the Electricity (Amendment) Act, 2007 came into force.
 - 2. Amendment of Regulation 19 of the Principal Code:

In Regulation 19 of the Principal Code, which reproduces Section 126 of the Act, the following amendments are made:-

- (i) for sub-section (3), the following sub-section shall be substituted, namely:-
- "(3) The person, on whom an order has been served under sub-section (2) shall be entitled to file objections, if any against the provisional assessment before the assessing officer, who shall, after affording a reasonable opportunity of hearing to such person, pass a final order of assessment within thirty days from the date of service of such order of provisional assessment of the electricity charges payable by such person."
 - (ii) the proviso to sub-section (4) shall be omitted.
 - (iii) for sub-section (5), the following sub-section shall be substituted, namely:-
- "(5) If the assessing officer reaches to the conclusion that unauthorized use of electricity has taken place, the assessment shall be made for the entire period during which such unauthorized use of electricity has taken place and if, however, the period during which such unauthorized use of electricity has taken place cannot be ascertained, such period shall be limited to a period of twelve months immediately preceding the date of inspection."
- (iv) in sub-section (6), for the expression "one-and-half times", the expression "twice" shall be substituted.
- (v) for the premises or areas other than those for which the supply of electricity was authorized"

3. Amendment of Regulation 23 of the Principal Code:

In sub-regulation (A) of Regulation 23 of the Principal Code, which reproduces Section 135 of the Act, the following amendments are made:-

- (i) the following sub-sections shall be substituted, namely:-
 - "(1) Section 135 of the Act, which deals with theft of electricity, reads as follows:-
 - (1) Whoever, dishonestly,---
 - (a) taps makes or causes to be made any connection with overhead, underground or under water lines or cables or service wires or service facilities of a licensee or supplier as the case may be; or
 - (b) tampers a meter, installs or uses a tempered meter, current reversing transformer, loop connection or any other device or method which interferes with accurate or proper registration, calibration or metering of electric current or otherwise results in a manner whereby electricity is stolen or wasted, or
 - (c) damages or destroys an electric meter, apparatus, equipment, or wire or causes or allows any of them to be so damaged or destroyed as to interfere with the proper or accurate metering of electricity.
 - (d) uses electricity through a tampered meter, or
 - (e) uses electricity for the purpose other than for which the usage of electricity was authorised.,

so as to abstract or consume or use electricity shall be punishable with imprisonment for a term which may extend to three yers or with fine or with both:

Provided that in a case where the load abstracted, consumed, or used or attempted abstraction or attempted consumption or attempted use:-

- (i) does not exceed 10 kilowatt, the fine imposed on first conviction shall not be less than three times the financial gain on account of such theft of electricity and in the event of second or subsequent conviction the fine imposed shall not be less than six times the financial gain on account of such theft of electricity.
- (ii) exceeds 10 kilowatt, the fine imposed on first conviction shall not be less than three times the financial gain on account of such theft of electricity and in the event of second or subsequent conviction, the sentence shall be imprisonment for a term not less than six months, but which may extend to five years and with fine not less than six times the financial gain on account of such theft of electricity.

Provided further that in the event of second and subsequent convictor of a person where the load abstracted, consumed, or used or attempted abstraction or attempted consumption or attempted use exceeds 10 kilowatt, such person shall also be debarred from getting any supply of electricity for a period which shall not be less than three months but may extend to two years and shall also be debarred from getting supply of electricity for that period from any other source or generating station.

Provided also that if it is proved that any artificial means or means not authorized by the Board or licensee or supplier, as the case may be, exist for the abstraction, consumption or use of

electricity by the consumer, it shall be presumed, until the contrary is proved, that any abstraction, consumption or use of electricity has been dishonestly caused by such consumer.

(1A) Without prejudice to the provisions of this Act, the licensee or supplier, as the case may be, may, upon detection of such theft of electricity, immediately disconnect the supply of electricity.

Provided that only such officer of the licensee or supplier, as authorized for the purpose by the Appropriate Commission or any other officer of the licensee or supplier, as the case may be, of the rank higher than the rank so authorised shall disconnect the supply line of electricity.

Provided further that such officer of the licensee or supplier, as the case may be, shall lodge a complaint in writing relating to the commission of such officers in police station having jurisdiction within twenty four hours from the time of such disconnection;

Provided also that the licensee or supplier, as the case may be, on deposit or payment of the assessed amount or electricity charges in accordance with the provisions of this Act, shall, without prejudice to the obligation to lodge the complaint as referred to in the second proviso to this clause, restore the supply line of electricity within forty-eight hours of such deposit or payemnt."

- (ii) in sub-section (2) of Section 135 of the Act, for the expression "Any officer", the expression "Any officer of the licensee or supplier as the case may be," shall be substituted.
 - 4. Amendment of Form-6 of Appendix of the Principal Code:

In item (7) of Form-6 titled 'Form of Appeal to the prescribed Appellate Authority under Section 127(1) of the Act', for the expression "one third", the expression "half" shall be substituted.
