 - c) He will not request TPDT (triple Pole Double Throw) switching arrangement.
 - d) He will submit the renewal of track permission, NOC from concerned authorities well before expiry of the same and TNEB will not be responsible for the consequences if any, if the consumer fails to produce the renewal of track permission / NOC.
 - e) Once the concerned authority revokes the permission accorded for the pipe lines laid then
 he will not be permitted to transport water through pipeline and he shall not cite the provision
