Sub: Special Pay and allowances - Payment of 20% Special Pay to the Resident Manager/New Delhi - Modification Orders issued.

Ref: 1) Memo. (Per.) No.55264/A3/A32/2010-1, dated:26.8.2010.

 From Resident Manager/New Delhi Lr.No.RM/ND/F2/RM/PSNI/ D159/2010, dated:3.9.2010.

In the Board's Memo. first cited, orders were issued granting Special Pay at the rate of 20% of Basic Pay in the revised pay structure to the Officers and employees in the office of the Resident Manager/Tamil Nadu Electricity Board/New Delhi with effect from date of issue of order i.e. from 26.8.2010.

- The Resident Manager/New Delhi has represented that he is working in Tamil Nadu Electricity Board on deputation and requested to grant 20% of Special Pay with effect from 1.6.2009 granted in line with the staff of Tamil Nadu House/New Delhi. The request has been accepted.

In B.P. Ms. (FB) No.78 (SB) Dated:4.9.1985, orders were issued among other things that the Board's Engineers upto and inclusive of the level of Executive Engineers who acquire P.G. Degree and Ph.D. in Engineering are alone eligible for the incentive increment scheme.

- 2. In Board's Memo. (Per.) No.119600/A3/A32/2001-1, Dated:22.12.2001, instructions were issued that before sanctioning advance increments, it should be verified whether the additional qualification is relevant or beneficial to the Board or covered by orders and also to avoid wrong sanction which are not really intended by the Board. In case of doubts, such cases should be referred to the Secretary/Tamil Nadu Electricity Board for clarification.
- 3. In order to decide the usefulness of the different specialized new courses now offered by the Universities, a Committee was constituted to study the matter viz., whether the Engineering Branches in P.G. and Ph.D. which are relevant to the Board, so as to consider the continuance or otherwise of the incentive increment. Accordingly, the Committee has submitted its report.
  - 4. After careful consideration of the Committee's report, the following orders are issued:-

#### Proceedings:

In the letter read above, the Government have issued certain important consolidated guidelines in respect of the effect of pendency of Vigilance enquiries/charges, effect of punishment and currency of punishments on inclusion of a person in the panel for considering promotion to higher posts. Now, a question has arisen as to whether the said guidelines and amendments issued by the Government may be adopted in the Board, so that it would be very useful to the Departmental Promotion Committees for preparation of panel. The said proposal has been approved by the Board. Accordingly, the Tamil Nadu Electricity Board hereby issues the following guidelines to all the members of the Departmental Promotion Committees for strict adherence:-

## I. EFFECT OF PENDENCY OF VIGILANCE ENQUIRY / CHARGES ON INCLUSION IN A PANEL FOR PROMOTION

SL. NO.	NATURE OF ENQUIRY/ CHARGE	EFFECT
1.	Preliminary of detailed enquiry undertaken by DV& AC/other D.P. authority.	Need not be held against the Officer/employee for inclusion in the panel.
2.	Regular cases/Registered cases by the DV&AC.	Mere registration of cases in courts need not be held against the officer/employee. But, if charge sheet has been filed in the Criminal case, it should be held against the officer / employee.
3.	Trap and Arrest made under the Prevention of Corruption Act by the DV&AC.	It should be treated as a serious offence and held against the Officer/employee.
4.	Enquiry on the recommendation of the Vigilance Commission/ the Vigilance Cell/TNEB.	This will be equivalent to charges framed under Reg.8(b) of TNEB Employees' D&A Regulations and charges framed to impose major penalties for the employees covered under both the sets of Standing Orders. Hence, it should be held against the officer/employee.

#### II. CURRENCY OF PUNISHMENT:

Whenever an officer/employee is undergoing any punishment on the crucial date or on the date of consideration, then irrespective of the time of occurrence of the irregularity, his name should be passed over for that panel. If the currency of punishment continues at the time of subsequent consideration for the next panel(s), he should still be passed over on the grounds that an officer/employee should not be considered for promotion or promoted during the currency of any punishment.

III. It is further clarified that charges framed under Regulation 8(b) of the Tamil Nadu Electricity Board Employees' Discipline and Appeal Regulations and any of the punishments awarded after the crucial date but before actual promotion, shall also be held against the officer/ employee.

#### IV. CENSURE:

The duration of punishment of Censure is one year. If the punishment of Censure is in currency on the Crucial Date or imposed after the crucial date but before actual promotion, the name of the officer/employee should be passed over and his/her name should not be included in that panel/should not be given promotion, as the case may be

Provided, the currency of any punishment imposed on the employees should be reckened as per the clarification issued in the Memo. (Per.) No.56501/A18A/181/2002-1, dt.4.6.2002.

The Government, in the letter read above, have issued certain clarification with regard to payment of family pension to the mentally disabled son. As the Board is following the orders of the Government in respect of pension/pensionary benefits to the pensioners and family pensioners of the Tamil Nadu Electricity Board and after careful consideration of the above clarification, the Board has decided to adopt the same.

2. In the Government Order first read above, Government have issued the following amendments in APPENDIX-I, in Annexure-II, Part-I, under the heading "LEAVE PROCEDURE IN THE CASE OF GOVERNMENT SERVANTS" in rule 9-A to sub-rule (vii) of Fundamental Rules:-

"Provided that the reference to the Medical Board shall not be necessary for grant of Unearned Leave on Medical Certificate in the case of a Government servant who is admitted as an inpatient in a Private Hospital or Nursing Home, which is accredited by the Government under the Tamil Nadu Government Employees Health Fund Scheme, 1991, for the period of treatment and also if the period of leave recommended is co-terminus with the period of treatment, subject to the following conditions, namely:-

a) the Government servant should produce Medical Certificate along with the cse summary of treatment and a copy of the case sheet. If there appears to be any doubt as to the genuineness of the case, the leave sanctioning authority shall refer the same to an Expert Committee or Medical Board along with all connected records for second opinion;

- b) the Government servant is admitted only for treatment and not for diagnosis".
- 2. Subsequently, Government have introduced the New Health Insurance Scheme to the Government servants vide Government Order second read above and the same was adopted to the employees of the Board vide B.P. third read above. Consequent on the introduction of the New Health Insurance Scheme, the Government have issued an amendment to Fundamental Rules, for the expression "Tamil Nadu Health Fund Scheme, 1991" occurs in sub-rule (vii) in rule 9-A in Appendix-I in Annexure-II in Part-1 under the heading "Leave Procedure in the case of Government servants" substituting the expression "New Health Insurance Scheme" vide Government Order Fourth read above.
- 3. The Tamil Nadu Electricity Board Leave Regulations have been framed based on the Fundamental Rules of Government of Tamil Nadu. The amendments issued by the Government to Fundamental Rules have also been adopted by the Board against the relevant Regulations from time to time. The Regulation 34(10-c) of the Tamil Nadu Electricity Board Leave Regulations, is corresponding to sub-rule (vii), in rule 9-A under Fundamental Rule 74, Hence, the amendments issued by the Government to sub-rule (vii) in rule 9-A of Fundamental Rule 74, need to be incorporated in Regulation 34(10-C) of the Tamil Nadu Electricity Board Leave Regulations. After careful examination, the Tamil Nadu Electricity Board has resolved to incorporate the said amendments in Regulation 34(10-C) of the Tamil Nadu Electricity Board Leave Regulations.
- 4. In Government Order (Ms) No.97, Energy (B2) Department, dated 7.10.2010, notification has been issued under the proviso to clause (a) of section 172 of the Electricity Act, 2003 (Central Act 36 of 2003) authorising the Tamil Nadu Electricity Board to function as the State Transmission Utility and Licensee under the provisions of the said Act for a further period of three months beyond the 15th day of September 2010. Therefore, the Board constituted under the Electricity (Supply) Act, 1948 (Central Act 54 of 1948) will continue to function as the State Transmission Utility and a Licensee and as such it can exercise its administrative function as was done earlier and make regulations providing for the service conditions of the employees of the Board.
- Accordingly, the Tamil Nadu Electricity Board hereby makes the following amendments to the Tamil Nadu Electricity Board Leave Regulations:

#### **AMENDMENTS**

In the said Regulations, in sub-regulation (10-C), under Regulation 34, the following proviso shall be added, namely:-

"Provided that the reference to the Medical Board shall not be necessary for grant of Unearned Leave on Medical Certificate in the case of a Board employee who is admitted as an inpatient in a Private Hospital or Nursing Home, which is accredited by the Government under the **New Health Insurance Scheme**, for the period of treatment and also if the period of leave recommended is co-terminus with the period of treatment, subject to the following conditions, namely:-

- the Board employee should produce Medical Certificate along with the case summary of treatment and a copy of the case sheet. If there appears to be any doubt as to the genuineness of the case, the leave sanctioning authority shall refer the same to an Expert Committee or Medical Board along with all connected records for second opinion;
- b) the Board employee is admitted only for treatment and not for diagnosis".

The quantum of Bonus and Ex-gratia payable for the accounting year 2009-10 to the Workmen of the Tamil Nadu Electricity Board covered by the Wage Settlement has been considered and the Hon'ble Minister for Electricity has announced the quantum of Bonus and Ex-gratia in the Press Release Dated: 18.10.2010.

- 2. In pursuance of the above, it is hereby ordered that for the accounting year 2009-10, the Workmen of the Board covered by the Wage Settlement, be paid a Bonus calculated at the rate of 8.33% of the salary or wage earned by them during the said accounting year, subject to and in accordance with the provisions of the Payment of Bonus Act, 1965, as amended from time to time.
- 3. The workmen of the Board (monthly paid and full-time workmen), Helper (Trainees). Office Helper (Trainees) and Assessor (Trainees) appointed on consolidated Salary and also the workmen of the State Government, Central Government and other organisations, who had worked on deputation in the Board, during the accounting year 2009-10 drawing a salary or wage, including those drawing pay exceeding Rs.3,500/- per month, will be eligible for the Bonus sanctioned in para-2 above, as was allowed last year.
- 4. It is also ordered that the workmen of the Board covered by the Wage Settlement and the deputationists, entitled to get Bonus with reference to the orders in paras 2 and 3 above, shall also be paid an Ex-gratia at the rate of 11.67% of the salary or wage earned by them, during the accounting year 2009-10.
- 5. The contract labourers who have been absorbed as Mazdoor, Helper-cum-Meter Reader and Assessor Grade II during the year 2009-10 are eligible only for the Bonus and Ex-gratia in a proportionate manner for the period they had worked as in the above post. They are not eligible for the Ex-gratia of Rs.1,500/- payable to contract labourers.
- 6. Where the salary or wage of a workman entitled to Bonus exceeds Rs.3,500/- (Rupees Three thousand and five hundred only) per mensem, the Bonus payable to such workman shall be calculated as if his salary or wage is Rs.3,500/- (Rupees Three thousand and five hundred only). The maximum Bonus amount payable shall be Rs.3,499/- only.
  - 7. Salary or wage for the purpose of payment of Bonus will include the following:-
  - (a) Basic Pay-Leave Salary;
  - (b) Grade Pay;
  - (c) All classes of special pay (including Short hand and Typewriting Special Pay);
  - (d) Personal Pay;
  - (e) Additional Pay for additional charge;
  - (f) Additional days wage paid for work on National Holidays and Festival Holidays;
  - (g) Dearness Allowance;
  - (h) Personal Compensatory Allowance given for protecting loss of pay; and
  - Deputation Allowance.

The term 'Salary' or 'Wage' will not include Interim Relief, over-time pay and allowances and any pay and allowance other than those mentioned from (a) to (i) above. Salary or Wage for the leave surrendered by an employee during 2009-10 should not be taken into account for computation of Bonus.

- 8. All the workmen, who had worked in the establishment for not less than thirty working days in the accounting year 2009-10, are entitled to the payment of Bonus.
- 9. The maximum Ex-gratia amount payable shall be Rs.4,901/- (Rupees Four thousand nine hundred and one only). This Ex-gratia will be reduced on actual basis if a workman had not worked on all the working days in the accounting year 2009-10 as per the provisions of section 13 of the Payment of Bonus Act, 1965.
- 10. The Bonus and Ex-gratia payable to Workman shall also be calculated, as if his/her salary or wage is Rs.3,500/- (Rupees Three thousand and five hundred only) per mensem. Under this method, the maximum Bonus and Ex-gratia amount payable shall be Rs.3,499/- and Rs.4,901/- respectively. The maximum of Bonus and Ex-gratia payable to a Workman shall not exceed Rs.8,400/- (Rupees Eight thousand and four hundred only) for the full year.
- 11. The Board also directs that the workman, who is now under suspension, but was on duty during the accounting year 2009-10, also be paid Bonus for the year 2009-10 subject to the conditions mentioned above.
- 12. If, during any part of the accounting year 2009-10, a workman covered by the Wage Settlement was promoted to officer category, shall also be paid the Bonus in a proportionate manner for the period he had worked in the workmen category.
- 13. The workman covered by the Wage Settlement, who had worked in the accounting year 2009-10 fully or partly but had retired or died subsequently shall be paid the Bonus fully or proportionately, as the case may be.
- 14. The expenditure on the payment of Bonus shall be debitable to "Tamil Nadu Electricity Board Funds - Revenue Expenses - Account No.75.501" and the expenditure on the payment of Ex-gratia shall be debitable to "Account No.75.502".
- The Tamil Nadu Electricity Board also directs that the Bonus payment for the year 2009-10 should be disbursed to all the eligible employees on 20-10-2010.

Sub: Recovery of excess amount disbursed on account of Audit objection -Instructions to follow the Principles of Natural Justice - Regarding.

Ref: 1) Order of the High Court dated:30.10.2009 in the W.P.No.2423-2425/2008.

- Government letter No.72411/Finance (PGC) Department, dated:17.2.2010 addressed to the Accountant General.
- From the Accountant General D.O.Letter No.AG (A&E) Legal Cell/WP.2423, 2424, 2425/2008, 1790/71471, dated:29.3.2010.

The Accountant General in his inspection note for the year 2004-05 has pointed out that Thiru.M.Sivaprakasam's pension was wrongly fixed at Rs.2910/- instead of Rs.2181/-, Thiru. M. Ganesan's pension was wrongly fixed at Rs.3757/- instead of Rs.2772/- and Thiru.L.N. Srinivsan's pension was fixed at Rs.3637/- instead f Rs.2762/- with effect from 01.04.1999 and the excess payment made to the individuals has been recovered from their pensionary benefits from July 2004 to April 2006. Aggrieved by this the individuals filed W.P.No.2423 to 2425/2008 and the Hon'ble High Court in its order dated:30.10.2009 has held that the amount has been recovered from the petitioners without any notice to them which can only be said to be an arbitrary exercise of power as opposed to the well established canons of justice especially in violation of the principles of natural justice. Accordingly the Hon'ble High Court has set aside the recovery orders on the Accountant General and directed to repay the amount already recovered, the petitioners. The Hon'ble High Court has also advised the Accountant General to revise the pensionary benefits of the petitioners after giving notice and sufficient opportunity to the petitioners. Government in the letter second referred based on the order of High Court has asked the Accountant General to revise the pension of the petitioners as per rules after giving notice and sufficient opportunity.

- 2. The Accountant General in the letter third referred above has pointed out that in a few cases even the reduction of pension has been struck down by the High Court applying the principles of natural justice. The recovery of excess paid amount on account of incorrect fixation of pay / pension not due to the misrepresentation of the individuals, but effected later on detection during audit, doesn't stand the test of judicial scrutiny in view of the pronouncement of the Suprement Court in the case of Syed Abdul Quadir and others Vs. State of Bihar. Besides, the Accountant General has stated that if the reduction of the benefits based on admissible pay as per rule 30 "Emoluments" of Tamil Nadu Pension Rule-1978 is quashed it would undermine the authority of the Accountant General who is the designated Audit Officer for the purpose of Tamil Nadu Pension Rules. The Accountant General has therefore stressed the Government for a need to devise a suitable mechanism by which fixation of pay made in respect of a Government servant is subject to audit check within a reasonable time so as to avoid huge loss to the state exchequer when the recovery is over turned. The Accountant General has also stated that mandatory provisions may also have to be made in the Tamil Nadu Pension Rules to ensure the authority of the Accountant General to refix the pay and pension while finalizing the pension proposals.
- Government after careful examination of the suggestion of the Accountant General, in detail has observed that in various cases, the courts held the view that the excess amount paid was not because of any misrepresentation or fraud on the part of the Government Servant/pensioner and they have no knowledge that the amount being paid to them was more than what they are entitled to., In this connection it may be stated that the recovery made based on audit at a later date is not on the ground that the pay fixed is by fraud or misrepresentation with their knowledge etc. It is the primary function of the internal audit wings to find out the erroneous fixation. The order of the courts made the audit wings of the Government redundant, Further, the various orders of the courts in this regard, embolder wrong fixation, not worrying about recovery in future since the recovery can be shielded under the umbrella of the court orders. Even though recovery has been quashed by Hon'ble High Courts, I am to state that there are decided cases in which recovery has been upheld. In Union of India Vs. Sujatha Vedachalam (2000(9) SCC 187) the Hon'ble Supreme Court did not bar the recovery of excess pay, but directed recovery in easy installments. Similarly in Government of India & others Vs. Col. (Retired) B.J. Akkara (Transfer case (Civil) No.72 of 2004) it has been held that the petitioners who have obtained orders of interim stay have been receiving excess pension even after the clarification contained in the circular dated: 11.9.2001 and that they are bound to refund the excess received after 11.9.2001. Hence it is a settle principle that a decision in a case is a precedent on its own facts and each case presents its own features. The only thing in a decision that is binding on a party is the principle upon which the case is decided as held by Hon'ble Supreme Court in Oriental insurance Co. Ltd. Vs. Smt. Rajkumari & Others (case No. Appeal (Civil) 5209 of 2007).
- 4. The Accountant General has stressed the Government for a need to devise suitable mechanism by which fixation of pay made in respect of the Government servants is subject to audit check with in a reasonable time so as to avoid huge loss to the State exchequer when the recovery is over turned. Subjecting the pay fixation of Government Servants to 100% audit check not feasible as it requires parallel establishment setup of audit wing. As suggested by the Accountant General a mechanism has to be evolved. In the meantime, Government directs that whenever wrong fixation is noticed responsibility should be fixed on the persons concerned for such wrong fixation and applying the principle of natural justice the recovery should be made only after giving due notice and sufficient opportunity to the individuals. Government also emphasise that fixing responsibility for the erroneous fixation is primary important and action should be taken against the persons responsible for such erroneous fixation. Further, in this respect attention may also be invited to the clarification issued by the Government of India in the U.O.No.728 EV(A), dated 7.2.78 wherein the pensioners relief is not covered by the Pensioners' Act and hence there is no objection to the recovery of Government dues to the entire extent of Pensioner's relief. Accordingly, the Government in G.O. (MS) No.702 Finance (Pension) Department, dated 7.10.88 has directed that Government dues including overpayment of

pension/Family Pension can be recovered from Dearness Allowance/ Additional Dearness Allowance on Pension / Family Pension without the consent of the Pensioner/Family Pensioner.

The Honourable Supreme Court of India has directed that no unauthourised constructions shall be carried out or permitted in the name of Temple, Church, Mosque, Gurudwara etc., on public streets, public parks or public places in Special Leave petition No. 8519 of 2006.

 A policy on Removal/Relocation/Regularisation of encroachments in public places, by the way of temple/Mosque/Church/Gurudwara etc., has been formulated by Government and communicated vide G.O.Ms.NO. 437, Revenue Department dated 13.09.2010.

Hence all Chief Engineer/Distribution Region and Superintending Engineer/EDC are hereby instructed,

- i. not to effect service connection to the religious structures (Temple, Church, Mosque, Gurudwara etc.) on public streets, public parks or public places.
- ii to disconnect the existing service connections given to the religious structures (Temple, Church, Mosque, Gurudwara etc.) on public streets, public parks or public places, while carrying out eviction of unauthorized religious structures by eviction authorities.

Hence all CEs & SEs are instructured to strictly adhere to the above instruction scrupulously and any lapses noticed in this regard will be viewed seriously. - 2.2. The details of pending applications in each Region, expected No. of eligible cases under for "Oneline/One Pole" category, MInor Extension category and Major Extension Category are enclosed. (Annexure. I).
- 2.3. It is expected that around 49,150 applications under "Online/One Pole" category, 1,12,025 applications under minor extension category and 57,325 applications under major extension category will be eligible for the total application of 2,18,500 registered upto 31.3.2000.

- 2.4. Necessary 30 days notice may be issued to all the normal priority applications as per the registration seniority for the applications registered upto 31.3.2000. The 30 days notice format is also enclosed (Annexure.II).
- 2.5. Simultaneously, field inspections may be carried out to find out eligible "Online/One Pole category".
- 3.0. Once the eligible "Online/One pole applicant" has been identified, necessary estimates may be prepared, got sanctioned and work orders prepared / issued. Once the party entered readiness, the supply may be effected with meters immediately.
