The need to have a consolidated data base of all court cases involving Board and its officials was felt very much. In the reference cited, a clarification has been issued to the effect that whether in a Preliminary Enquiry or Detailed Enquiry conducted by the Directorate of Vigilance and Anti-Corruption, it is proposed to drop further action even before framing charges against the official concerned, it is necessary for the Competent Authority to issue an order for dropping of further action and communicate the same to the Director of Vigilance and Anti-Corruption and also to the individual concerned.

2. Now, it has been decided by the Government that if orders are passed for dropping further action even before framing of charges or calling for explanation against the official concerned, such orders of dropping action may be communicated only to Director of Vigilance and Anti-Corruption. This order need not be communicated to the individual concerned. However, in cases where detailed enquiry is made, any order dropping further action should be communicated to Director of Vigilance and Anti-Corruption and also to the individual.

In the Circular Memo, first cited, instructions have been issued to the effect that the subordinate offices should address their references only to the concerned branch of Board viz. Secretariat Branch, Administrative Branch, Technical Branch, Accounts Branch or Audit Branch, as the case may be, and such branch concerned will examine the issue with reference to the rules and regulations and the previous papers, if any, in the first instance. If there is any point on which the advice of the Legal Cell is required, such branch concerned should obtain the orders of the officer incharge and then refer the matter to the Legal Cell. Thereupon, the Legal Cell will render its opinion to the branch concerned for further action and the branch will communicate the decisions/instructions to the subordinate office concerned. However, the said instructions does not bar the subordinate offices to send references directly to Legal Cell seeking approval of counter affidavit, written statement, etc. to be filed in Courts, seeking opinion to file appeal, etc. against the orders of lower Courts and seeking permission to engage advocates on behalf of the Board. In short, crux of the said circular, inter-alia, has been that the subordinate offices should not, in general, directly address any reference (except the above mentioned) to the Legal Cell and the same has been reiterated in Legal Cell letter second cited.

2. However, very often, the subordinate offices are making references to Legal Cell directly without sending such references to the branch concerned of the Board; without mentioning the rules, regulations, instructions, orders, etc. in force; and with bereft of even factual particulars. Further, some of the said branches of the Board are also issuing directions to the subordinate offices to directly address the Legal Cell for opinion and to take further action accordingly. The aforesaid actions of the subordiante offices and branches of the Board are not only contrary to the Chairman 's Circular Memo., first cited it causes

day-to-day difficulties to the Legal Cell in discharging the assigned actual duties. In order to mitigate the situation and in order to maintain quality and quantity of work at each level, the very concept of issuing such instructions/orders is to be honoured in letter and spirit. Accordingly, it is hereby informed that the cases referred to the Legal Cell not in conformity with the said instructions will not be entertained and therefore it is requested by Legal Cell that all officials concerned may bestow their personal attention to honour the aforesiad instructions, for better implementation and result. This will facilitate the offices/ officers in all level to maintain absolute time discipline and save man power and curtail unnecssary expenditure caused to the Board.

 Therefore, I am to request you to follow the instructions issued in the Circular Memo. first cited scrupulously. I am also to request you to circulate this instructions to all the officers/offices under your control for strict adherence.

In the reference 1 cited, the Central Board of Direct Taxes Circular regarding deduction of income tax at source on payment of "Salaries" was communicated. And vide reference 2 above, the time, mode and rates of deduction, deposit of tax to Government accounts, issue of Certificate of tax deduction at source etc. were communicated.

Of late, it is noticed that, in many of the circles the provisions of the IT Act with reference to Tax Deduction at Source (TDS) on payment of "Salaries" has not been duly complied with.

 Income Tax has to be arrived on the computed salary of the employee as mentioned in Para 6 of the circular cited in reference 1. The income tax as arrived should be deducted every month in equal installments. However while arriving the computed income under the head salaries a statement of income tax workings may be obtained from the concerned individual for verification of savings etc.

 It should be ensured that the proof for savings under Chapter VIA is furnished before the end of the financial year.

 As per section 201(1) and 201(1A) of the Income Tax Act, the person required to deduct tax, does not deduct, or does not pay, or after deducting fails to pay, the whole or any part of the tax, as required under this Act, then such person shall be deemed to be assessee in default and shall be liable to pay simple interest.

- At 1% for every month or part of a month on the amount of such tax from the date on which such tax was deductible to the date on which such tax is deducted; and
- At 1¹/₂% for every month or part of a month on the amount of such tax from the date on which such tax was deducted to the date on which such tax is actually paid.
- Hence responsibility is fixed with Pay Drawing and Disbursing Officers and penalty should be avoided at any cost.

 Hence the various provisions of the Income Tax 1961, with reference to deduction of tax at source on payment of "Salaries" may strictly be adhered to and Compliance report may be sent to this office before 15.10.2010.

In the letter under reference 3rd cited the Principle Secretary to Government, Finance (Salaries) Department, Government of Tamil Nadu have issued clarification to Rules 29 (2) (d) (iv) of the Tamil Nadu Transparency in Tender Rules 2000 which has been reproduced as below:

 As per the provision of Rule 29(2) (d) (iii) of Tamil Nadu Transparency in Tenders Rules 2000, "in a tender where all the tenderers are from within the State of Tamil Nadu, or where all the tenderers are from outside the State of Tamil Nadu, the sales tax shall be included for the evaluation of the price".

 As per the provision of Rules 29(2) (d) (iv) of the above Rules, "in a tender where all the tenderers are from within the State of Tamil Nadu as well as from outside the State of Tamil Nadu, the sales tax shall be excluded for the evaluation of the price".

 In the G.O. first cited above, it has been notified that the term "Sales Tax" in the above provisions shall be the sales tax levied under the Tamil Nadu General Sales Tax Act 1959 (Tamil Nadu Act 1 of 1959).

4. The Government has notified the implementation of Tamil Nadu Value Added Tax Act in the Extra-ordinary Gazette Publication NO.348, dated 15.12.2006. As per section 87 of the said Act, reference to "Tamil Nadu General Sales Tax" or Tamil Nadu Additional Sales Tax Act" in any Act, or in any rule, Notification, Proceeding order or other instrument made or issued under the Act shall be construed as reference to "Tamil Nadu Value Added Tax".

 The term Tamil Nadu General Sales Tax occurring under Sub-Rule 2(d) (iii) and (iv) of Rule 29 of Tamil Nadu Transparency in Tenders Rules 2000, shall therefore with effect from 1.1.2007 refer to the Value Added Tax levied under Tamil Nadu Value Added Tax Act 2006 (Tamil Nadu Act No.32 of 2006).

In the Minutes of BLTC meeting cited under reference it has been directed that the commercial conditions stipulated in TNEB Tenders like financial liability and arbitration may be studied further. After such study, the following instructions are issued:-

 In regard to financial turnover criteria, it is reiterated that the existing practice of 25% of the estimated value of tender in any one of the immediately proceeding 3 financial years for ensuring the financial liability/financial soundness of the bidder may continue to be stipulated.

(a) In regard to stipulation of arbitration clause for referring any dispute arising in respect of any contract, it has been observed that arbitration as a dispute settlement machanism may not be suitable in view of huge cost involved by way of expenses to the arbitration proceedings. Further, in the arbitration proceedings, the aggrieved party is entitled to file appeal before the competent court for the reasons specified in Sec.34 of the Arbitration and Conciliation Act 1996, as a result subsequently petitions are filed before the competent Courts seeking to set aside such awards.

(b) Hence it has been decided that existing clause for jurisdiction for the legal proceedings may be continue to be stipulated in the tender documents. The necessary undertaking towards jurisdiction for Legal Proceedings may also be obtained in non-judicial stamp paper of appropriate value along with the offer.

(c) All Tender Inviting Authorities are requested to adhere to the guidelines as above and to incorporate in the tender documents appropriately.

 The Quota is to be fixed and intimated to the consumer for the TNEB supplied power (D & H) and the evening peak hour energy and demand quota only.

 Procurement through Open access will be treated as an additionality. The ceiling, up to which a consumer can utilize power including the TNEB quota demand, captive power and third party purchase would be the sanctioned demand.

 There would be no need for advance declaration by the consumer for the wheeling of captive power as stipulated in SMP No.1 of 2009 or procurement of third party power as stipulated in the Interim order dated 17.8.2010, communicated in Memo.No.CE/Comml/EE/DSM/AEE1/F.R&C/ D.332/2010, dt.28.8.2010.

6. The equivalent demand brought in by the consumer from captive and third party sources should be subtracted from the maximum demand recorded by the meter of the consumer. Balance would be the demand actually supplied by the TNEB. If this figure exceeds the quota demand of the TNEB, the consumer would be liable to pay excess demand charges at the rates stipulated in the order of the Commission in M.P. No.42 of 2008.

 Similarly, the energy brought in from captive and third party sources would be subtracted from the total energy consumed by the consumer. The balance would be deemed to be the energy actually supplied by the TNEB. If this quantum exceeds the energy quota of the TNEB, the consumer would be liable to pay excess energy charges at the rates stipulated in the order of the Commission in M.P.No.42 of 2008.

 The need for advance declaration of the consumer for procurement of power through open access is dispensed with.

 The consumer shall not exceed demand/energy quota fixed for the TNEB power for any reasons, either due to outage of generator of their supplier or short supply from their supplier, etc., it is their responsibility to monitor this with their generator.

10. This order shall come into force from 17.8.2010.

It is therefore instructed that all the street light fittings and for official buildings, that is being procured should be provided with energy efficient tube lights and electronic chokes in order to reduce the energy consumption.

Providing new mercury/sodium vapour lamp should be avoided in future.
