 Extract from the minutes of the 18th meeting of the TANGEDCO held on 18.10.2011.

Proceedings:

In the Board Proceedings No.7 (Adm.Branch), dated 06.07.2011, approval was accorded for engagement of 80 squads, each comprising 5 Ex-Servicemen to inspect the Service Connections and detect the theft of energy which involves an expenditure of Rs.88,15,788/- per month, for a period of 4 months from the date of engagement of those teams. After 4 months, based on their performance, further continuance shall be considered.

M/s.TEXCO has requested to enhance the contract period by one (1) year as 4 months being too short period.

The TANGEDCO after careful consideration ratified the order of the Board for having engaged the Ex-Servicemen deployed by M/s. TEXCO for a period of one year as against the period of 4 months, approved by the Board vide item No.22 of 14th Board meeting held on 25.06.2011.

Also the TANGEDCO directs that the performance of the Special Squads of Ex-Servicemen should be reviewed critically and the target should be a minimum ten times of their expenditure. Performance report of the Squads should be placed before the Board on monthly basis.

Initially 25 number of squads comprising of Ex-Servicemen to be deployed by TEXCO shall be engaged to detect theft of energy in 25 Electricity Distribution circles. The list of 25 EDC's are enclosed.

- 3. Enquiry was conducted by the Executive Engineer/O&M/Palacode that the allegation made against the individual was true and further investigations disclosed that the Educational Certificate was lost and however his date of birth was declared as 05.01.1938 as per the School Certificate. D.P. was initiated against the individual as per clause 30 (XXVII) of TNEB standing orders for non-clerical workmen, since it had been proved that, Thiru. N. Natarajan had given false information at the time of joining into Board's Service.
- 4. The Superintending Engineer/Dharmapuri Electricity Distribution Circle relieved Thiru. N. Natarajan, Line Inspector on 18.10.2001 by issuing show case notice to the above individual informing that, as per School records, his date of birth is 05.01.1938, his date of superannuation falls on 31.01.1996 D.P. had also been initiated and a punishment of postponement of next increment for 3 years with cumulative effect was also awarded to the individual.
- 5. In the light of the Supreme Court Judgement in the case of Kailash Singh Vs. - State of Bihar (2005) (13) SCC 576 held recovery sought to be made from the Salary of the employee on the ground of alleged overstay in service on the basis of age assessed or considered despite the fact that the employee has worked during the period or alleged over stay could not be made. Hence, the pay and allowances already paid to the employee during the period beyond the date of his Superannuation (i.e.) from 01.02.1996 to 18.10.2001, need not be recovered. However the period rendered beyond the Superannuation may be treated as re-employment by the Board.
 - After careful consideration the Board is hereby ordered that,

In the Legal Cell letter under reference first cited, various instructions and guidelines issued from time to time in the matter of filing and defending of cases were compiled and forwarded to all the Chief Engineers and Superintending Engineers for adherence.

- 2. In the Circular Memo. under reference second cited, specific instructions have been issued, inter-alia, for maintenance and furnishing of connected records to the Courts/Regulatory Commissions; maintenance of a separate record/Diary for each case indicating every development of the case; and ensuring entrustment of the cases to suitable officials who are capable of rendering all assistance to the Standing Counsel/Counsel on Record to facilitate smooth conducting and proper adjudication of the cases.
- 3. While so, the Secretary, Tamil Nadu Electricity Regulatory Commission in his letter under reference third cited communicated the observations of the Commission in a particular case heard on 03.11.2011, wherein the Commission after taking a serious view of the delay in filing counter affidavit despite granting adequate time of four weeks to the TANGEDCO and the tendency to file the counter affidavit belatedly without filing a petition in time praying the Commission to extend the time limit held that it is an unacceptable one and is to be deprecated in strongest terms. Further, instances have come to notice that the officials, in some occasions, in the habit of not properly briefing the Standing Counsel concerned and, at times, briefing minutes before the actual hearing of the case.
- 4. The Regulatory Commission is a statutory body and an adjudicator under the Electricity Act, 2003. As observed by the Commission, the non-filing of counter affidavit in time or filing the same belatedly without praying to grant further time to file counter in advance are, no doubt, very serious issues and the same ought <u>not</u> to have been practiced.
- 5. The cases filed before the Regulatory Commission(s) generally involves policy, pure technical/accounting issues, issues affecting adversely the exchequer of the Corportions substantially, etc. Considering the same and also in view of the adverse financial position being experienced of late by the Corporations, the Head of the Department concerned or the officer concerned of the Circle/Region/Branch are hereby directed to personally ensure that the Standing Counsel/Counsel on Record/any expert engaged to present the case are properly/adequately briefed with complete details required for the case at the time of handing over of the brief history of the case, para-war remarks to the petition filed against the Corporation together with the connected records, so as to ensure the interest of the Corporations, to enable such Counsel to present the case more effectively and enable the Commission to adjudicate the issue in its proper perspective. Any deviation or dereliction on the part of the officials noticed in this regard will be viewed seriously.
- The Standing Counsels of the Corporations are also requested to extend full co-operation to the officials and to ensure effective adjudication of the case accordingly.
