Proceedings:

In the Board's Proceedings first read above, orders were issued to create a new category in Class-IV, Division-II RWE Cadre to be designated as Part-time Conservancy Workers for permanent absorption of the then existing Part-time Sweepers/Scavengers by fixing the working hours for the said worker as two hours from 8.00 a.m. to 10.00 a.m. or according to the convenience of the office concerned which should not exceed two hours a day; that the pay of Part-time Conservancy workers shall be fixing in a new time scale of pay of Rs. 120-5-170-10-320 as applicable to the employees under the nutritious Noon-Meal Scheme in Government of Tamil Nadu. In the Boards Proceedings second read above, orders were issued that the scale of pay of Rs.120-5-170-10-320 shall be revised to Rs.600-10-700-20-1100 with retrospective effect from 20.3.1997 and orders were also issued for absorption of all Contingent workers, who have completed 480 days of continuos service in 24 Calendar months in a phased manner commencing from 1.1.1998 onwards. However, the orders issued in the Board's Proceedings first read above, revising the scale of pay were cancelled vide Board's Proceedings third read above, and the quantum of consolidated payment payable to Part-time Conservancy workers was enhanced from Rs.120/- to Rs.250/- with retrospective effect from 20.3.1997 and for creation of a new cadre to be designated as Part-time Conservancy Workers in the scale of pay of Rs.600-10-700-20-1100 but by restricting the area/offices to be cleaned to Central Office and Division Office where the Revenue Branches is also situated in the same premises. In the said Board's Proceedings third read above, a policy decision was also taken not to engage a regular Part-time Consevancy Workers in those places like Section Offices on the ground that the area to be cleaned etc. is meagre and in those places the system of employing Contingent Conservancy Workers is adequate.

2. While so, WP.No.10777/2003, came to be filed challenging the orders issued in Board's Proceedings third read above mainly on the ground that the same were issued without issue of 9(A) notice under the Industrial Disputes Act - 1947. The Division Bench of the Hon'ble High Court/Madras heard the said WP.No.10777/2003 and by order, dated 18.8.2007 allowed the said Writ Petition. Against the above orders of the Division Bench of the High Court, the Board had filed SLP(C) No.10611/2008 in the Supreme Court/New Delhi and it was taken up as Civil Appeal No.9438/

2010. The Supreme Court/ new Delhi by its Order dated 26.10.2010 made in Ca.No.9438/2010 (arising out of SLP(C) No.10611/2008), though declined to interfere with the said order of the High Court dated 18.8.2007, passed a modified orders restricting the period for entitlement to regular time scale of pay. The relevant portion of the order is extracted below:-

".......However, the respondents Wript Petitioners will not be entitle to the scale of pay of Rs.600-1100 with dearness allowances with effect from 14.10.1998 but are entitled to the same with effect from the date of filing of the Writ Petition. The impugned order to this limited extent shall stand modified. The appeal is disposed of with no order as to costs.".

Thereafter, the Petitioner in W.P.No.10777 of 2003, has filed Contempt Petition No.675/2011 before the Hon'ble High Court/Madras and, on 22.6.2011, the Hon'ble High Court has inter - alia, passed an interim order directing the Board to comply the order within three weeks.

3. Therefore, the above orders of the Hon'ble High Court/Madras as modified by the Hon'ble Supreme Court of India was considered by the Board of Directors of the TANGEDCO in its 15th Meeting held on 27.7.2011 and resolved to create 3316 and 2330 numbers of posts of Part Time Conservancy Workers retrospectively from 4.4.2003 and 15.10.2005 respectively and to grant regular time scale of pay at Rs.600-10-700-20-1100 with D.A. with retrospective effect from 4.4.2003 or any other subsequent date as per eligibility/entitlement and for pay of arrers to them accordingly.

The persons numbering 169 covered by the aforesaid Writ Petitions had undergone apprenticeship training in TANGEDCO but were not appointed on preferential basis among other thing in view of the Hon'ble Supreme Courts decisions in P.Arul and others Vs.TNEB. The Hon'ble High Court order dated 07.12.2010 disposed the said W.P's declaring that the directions issued by the Division Bench of this Court by Judgement dated 16.11.2010 in W.A.Nos.1596 of 2010 shall be applicable to the members of the petitioner's Sangam in W.P.No.3605 of 2000 and also to the petitioners in W.P.No5757 of 2000 and the same shall be carried out.

2. In the Writ Petitions filed by Tvl.V.Palanimuthu and D.Venkatesan in W.P.Nos.4218 & 4219 of 2009, the Hon'ble High Court by orders dated 11.12.2009 has, interalia, directed the Tamil Nadu Electricity Board / respondent therein (now Tamil Nadu Generation and Distribution Corporation Limited) to appoint the said petitioners as Helper. The Writ Appeals filed there against in W.A.Nos.1597 and 1596 of 2010 were dismissed by a common order dated 16.11.2010. Therefore, Special Leave Petitions have been filed before the Hon'ble Supreme Court of India in SLP Civil CC Nos.10211 and 10212 of 2011. Meanwhile, Contempt Petition Nos.354 and 355 of 2011 were moved before the Hon'ble High Court/Madras. Hence, subject to the outcome of the SLP's they were appointed as Helper (Trainee) in Regular Work Establishment category on Temporary basis for a period of two years under regulation 106 of the TANGEDCO Service Regulation for a consolidated wages of Rs.3250/- per month. The case of 169 persons are similar to the cases of the said Tvl.V.Palanimuthu and D.Venkatesan.

- 3. In the meanwhile, the petitioners in W.P.Nos.3605 and 5757 of 2000 have filed Contempt Petitions in C.P.Nos.1115 and 1116 of 2011. In the said circumstances, a proposal to appoint 169 persons covered by the orders in W.P.Nos.3605 and 5757 of 2000, as was done in the cases of TvI.V.Palanimuthu and D.Venkatesan was placed before the Board for its consideration and the Board considered the proposal and accorded its approval for the same.
- 4. Accordingly, 169 persons covered by W.P.Nos.3605 and 5757 of 2000 shall be provisionally be appointed to the post of Helper (Trainee) in Regular work Establishment category on temporary basis in the Tamil Nadu Generation and Distribution Corporation Limited for a period of two years under regulation 106 of the Tamil Nadu Electricity Board Service Regulation and for a consolidated wages of Rs.3250/- (Rupees Three thousand two hundred and fifty only) per month.
- It is made clear that the appointment is subject to withdrawal, annulment or cancellation, as the case may be, based on the result of the interim order/final order in the said Special Leave Petitions without any prior notice whatsoever.

Non-Provincialised service, Consolidated Pay, Honorarium and Daily Wages basis on or after 01.01.1961 and absorbed in regular service before 01.04.2003, shall be counted for pensionary benefits along with regular service, subject to the following conditions:-

- a) The service rendered in Non-Provincialised service, Consolidated Pay, Honorarium and Daily Wages basis shall be in a job involving in whole employment in Government Department. (1997) 00032//AT 945 Vd
- b) The service rendered shall be on Consolidated Pay, Honorarium or Daily Wages paid on monthly basis and subsequently absorbed in regular service under the State Government.
 - c) The service rendered in Non-Provincialised service, Consolidated Pay, Honorarium or Daily Wages basis shall be followed by absorption in regular service before 01.04.2003 without a break.

Subsequently, in Letter No.52717/Finance (Pension) Department/2009-1, dated 23.10.2009, the Government have clarified that wherever there was break in service before their absorption in regular service before 01.04.2003, the same shall be specifically condoned by the orders of the Head of Departments, in which the employees were regularly absorbed and such period of break, shall not count for the purpose of pensionary benefits.

2. Generally, the TANGEDCO (erstwhile Tamil Nadu Electricity Board) has been adopting the orders issued by the Government from time to time in connection with Pension and Pensionary benefits to the Pensioners/Family Pensioners. 1. Date and tenure of Appointment

The Standing Counsel shall hold office with effect from the date of assuming charge, to till his/her resignation is accepted or appointment is terminated by the TANGEDCO/TANTRANSCO/TNEB Ltd., (hereafter called as Corporation).

2. Duties and responsibilities

- To advise the Corporation including its subordinate offices on all legal matters as and when required;
- To draw up, settle, revise and scrutinise draft agreements, all other deeds, contract documents, tenders, conveyance, lease etc, pertaining to the Corporation as and when required;
- iii) To appear on behalf of the Corporation in all cases before the High Court/ Madras and its Bench at Madurai and before Arbitrators, Labour Courts, Tribunals and Commissions, Fora and in such of those cases in the Mofussil where they are specifically instructed by the Corporation to appear;
- iv) To prepare Plaints, Written Statements, Affidavits, Counter Affidavits, Grounds of Appeal etc. and to do all the incidential works pertaining to the cases of the Corporation in which he/she appear on behalf of the Corporation;
- To perform such other duties of legal nature as may be instructed by the Corporation from time to time;

Hence all Chief Engineers/Distribution/Region and all Superintending Engineers/ EDC are hereby informed the following:

i) The procedure for compensation has already been communicated to all Chief Engineers/Distribution/Regions vide minutes of the Chief Engineers/Distribution/ Region meeting held on 11.4.2008 for taking necessary action.

- ii) Compensation shall be paid to the affected consumers after a detailed study on case to case basis by concerned Chief Engineers/Distribution/Region based on the claim made by the individual consumer, if the delay is due to Licensee for non-compliance of standards specified for various service areas in regulation 21 of DSOP.
- iii) Effective steps shall be taken to achieve and maintain the Standards of Performance as per the TNERC norms.

- 1.0) In the above memo. cited under reference (i), instruction for dealing with the requests of litigant consumers for new service, addition or reduction of demand were issued in order to avoid delay in processing as follows: "for new HT Service, conversion of LTCT Services into HT Services, Additional demand and Reduction of demand that may be received from the consumer who have filed cases against any of the Board's claim such as levy of E-Tax, Peak Hour Energy Charges, withdrawal of Tariff Concession, bill revision etc. and obtained Interim Orders from the respective Courts, except theft of energy at their end as per the powers delegated in the TNEB Manual Volume-II, Appendix-I, in order to avoid delay in processing of HT applications. All other cases not falling under the above said instructions may be referred to Head Quarters for orders".
- 2.0) The above instructions were being followed hitherto. In the proposals seeking instructions for processing the requests of the litigant consumers, it is observed that.
 - (i) Multiple Suits have been filed against the Board's claims in the same service.
 - (ii) Interim Orders have been obtained from the Courts in respect of even the genuine/regular claims of the Board.
 - (iii) There has been inordinate delay in vacating the Stay already granted against the Board's claims.
 - (iv) Stays are being obtained from Higher Courts in spite of the rulings in favour of the Board in the lower Courts.
 - (v) The arrears claimed by the Board are
 - a) either being linked with matters relating to amendment of Electricity Act which require considerable time for disposal or
 - b) are being linked to batch cases which are already under subjudice although their nature and content warrant individual disposal.

- (iv) The Interim Orders do not clearly spell out the stay in collection of arrears.
- 3.0) All the above have led not only to delay in realisation of Board's revenue but also in ambiguity in adopting the Court Orders. The legal impediments have led to difficulty in adhering to the regulations stipulated in the Code. Huge amount of arrers are involved in most of the cases and their non-realisation have an adverse effect on the already deteriorating financial position of the Board.
- 4.0) Although the verdict of the courts is to be honoured, it also has to be ensured that,
 - (i) The regulations stipulated in TNE Supply Code are being adhered to
 - (ii) Revenue due to the Board is realised and
 - (iii) Avoid habitual fraudsters from taking shelter under ambiguous court orders.
- 5.0) Huge amount due to TANGEDCO is being kept as arrears arising due to the legal binding, the stay obtained against payment of dues in cases of theft of energy, malpractice, peak hour penalty etc. These amounts are not being considered as pending arrears at time of processing the request of the consumer order various heads. Due to the time involved in settling the suits which are open for disposal at the higher Courts, the realisation of arrears could be delayed or even made void.
 - 6.0) In order to realise the amount, the following instructions are issued.
- 6.1) To demand and collect the arrears due to the Board in accordance with regulation (17) Sub-Regulation (8), Regulation 17 Sub-Regulation 9(a) and Regulation (5) Sub-Regulation (2) clause (iv) of Tamil Nadu Electricity Supply Code and Regulation 27(1) of Tamil Nadu Electricity Distribution Code before processing the requests of the consumer for

- 6.2) If there is stay for collection of the amount due, then special efforts should be taken immediately to vacate the stay by filing stay vacate petition along with early hearing petition to list out the case and to file counter, if not already filed by the officers concerned and to closely pursue the Board's Standing Counsel until the stay is vacated to realise the amount. Otherwise the officers concerned will be held responsible for any delay in vacating the said stay orders.

50 MW Bagasse based co-generation plant of M/s.Empee Sugars and Chemicals Limited at Idaikal Village, Ambasamuthram, Tirunelveli District has been commissioned on 28.4.2010 and power is being exported to the TNEB (now TANTRANSCO)'s grid. Based on the request made by the company vide ref(1), approval has been accorded vide ref(2) for supplying 75% of power to be exported to the grid, to the third party users under Intra State Open Access System and for supplying balance 25% of power to the TNEB (now TANGEDCO). Accordingly, the company has entered in to an Energy Purchase Agreement with the TNEB (now TANGEDCO) on 18.9.2009. As per the above Energy Purchase Agreement, 25% of the entire energy exported to TANTRANSCO's grid is to be considered for payment at the rate as per the agreement rate.

But the company has claimed power purchase bills for the period from May 2010 to October 2010 for 100% power exported to grid, which is against the agreed terms of the agreement.

Based on the above request, the TANGEDCO in its 11th Board meeting held on 4.5.2011, has approved the following:

"To consider the power exported in excess over the 25% of the power exported to grid from the 50 MW Bagasse based co-generation plant at Idaikal Village, Ambasamuthram Taluk, Tirunelveli District for the period from May 2010 to October 2010, for making payment at the lowest rate among the UI, Exchange and PPA rate on arriving the actual amount payable.

It may be stated that as per EPA, any excess energy over and above the contracted quantum fed into the grid, is unauthorized injection of power which account be accounted for payment. The company has been permitted to sell their 25% of the energy to be exported, to the TNEB (now TANGEDCO); instead, they have claimed illegally the bills for 100% power injected into the Board's grid without getting prior Board's approval in writing. Citing this as a precedent, number of similar claims are being received by the TANGEDCO. Under the critical financial condition of TANGEDCO and in view of more number of such illegal claims for the power exported in excess over the committed power, it was proposed to regulate payment strictly as per EPA

entered with the respective co-generalon plant. Accordingly, it has been proposed to recover the payments already made to M/s. Empee Sugars and Chemicals Limited for the power in excess over the 25% of the power injected into the grid, on the ground that there is no legal obligation on the part of TNEB (now TANGEDCO) to make such payment for the non committed power.

"Permitting the generating companies of the bagasse based co-generation plants and the Bio mass power plants to go for third party sale of power under Short Term Intra State Open Access system by keeping the existing Power Purchase Agreements/ Energy Purchase Agreements in abeyance.

Subsequently, the Board in its 920th meeting held on 31.12.2008 has resolved to permit the sugar mil Co-generation plants to go for third party sale of power generated form supplemental coal during the crushing season 2008-09 under Short Term Intra State Open Access system with the condition that the entire component of bagasse based power shall continue to be supplied to the board at the prevailing rate under existing PPA and the additional power generated from supplement coal shall be allowed for third party sale.

Board has also resolved to permit the generators of sugar mill co-generation plants to go for third party sale of power generated during non-crushing season by using coal under Short Term Intra State Open Access system.

Further, the proposal for permitting the Biomass power generators to go for third party sale of power with 100% power exported to Grid under Short Term Intra State Open Access system by keeping the existing EPA's executed between Board and generators in abeyance was approved by the Board on circulation on 16.3.2009.

Based on the above Board's decision, some of the generating companies of the Biomass power plants and Bagasse based co-generation plants have got approval for third party sale of power under Indra State Open Access system.

All the above power generators have entered into Power Purchase Agreements/ Energy Purchase Agreements with the TANGEDCO. As per the above agreements, the generating companies are bound to supply entire power exported, to the TANGEDCO only.
