During the Distribution Review meeting held on 14.2.13 in the Head quarters by the CMD/TANGEDCO with all the CE's/Distribution and SE's/EDC, the discussions on the problems arising in effecting agricultural service connections due to way leave, legal or law and order problems was discussed and the following are decided.

"In case problems in extending supply to the agricultural ready parties, arise due to way leave, legal or law and order problems, SE's are permitted to proceed further to give service connection to the other ready parties as per seniority".

After careful examination, the following instructions are issued.

- The SEs/EDC are empowered to overlook the priority in effecting service connection to the subsequent ready parties as per seniority, in case of problems that arises due to way leave, legal or law and order problems apart from the cases involving pending court cases and pending approval from DOT/Railway crossings alone communicated in the instructions issued vide ref (2) and (3).
- In case of Way leave problem the concerned area should be inspected and genuineness should be ascertained and certified by the section officer.
- 30 days notice should be issued to the individual by the concerned section officer for arranging alternate way leave with acceptance to bear the revised additional estimate cost in accordance with the Distribution code.
- 4. This notice shall be delivered to the party who has signed the readiness and acknowledgement obtained. Date and time of inspection should be specified in the inspection report by the section officer.

- 5. In case if it is found possible either by the party or by the department that service may be effected by rerouting, after getting concurrence for additional expenditure, necessary estimate may be prepared for rerouting. In that situation apart from the concurrence of the party for revised estimate, along with the consent of other parties if any along the revised route should be obtained and furnished by the applicant. After receiving the revised estimate the AEE/Concerned should inspect the area before recommending the same for getting approval of competent authority.
- 6. In the event of any objection for revised way leave (or) subsequent objection to the consent given by the party, a fifteen days notice to be issued from the AEE concerned to the party for solving the problems.
- 7. After expiry of the above said period, and if party could not resolve, a fifteen days notice should be issued from the EE concerned stating that if objection is not cleared within the stipulated period, his priority may have to be overlooked and subsequent ready parties in the section concerned will be effected with Agricultural service connection till the objection is cleared. The notice shall be served through Registered post.
- After expiry of notice period, the EE/O&M concerned shall send the proposal to SE/EDC concerned for approval with all the details for overlooking the priority.
- In the event of law and order problem in effecting service to the party, the party has to clear the problem and necessary NOC has to be produced by him from the RDO concerned for effecting supply.

All the Procedures in para 1 to 8 mentioned above should be followed for legal or law and order problems also.

- 10. Finally the SE/EDC will issued 7 days notice to the party concerned stating that his priority will be overlooked if objection or legal or law and order problem, as the case may be, is not cleared within the stipulated period. The notice shall be issued through the concerned AE's office to the party or representative of the party and acknowledgement obtained.
- 11. Thereafter SEs/EDC may accord approval to overlook such cases and to effect service to the subsequent ready parties and a letter shall be sent to the party referring all the correspondences to the effect that his priority has been overlooked temporarily in view of the objections etc and his inability to arrange for alternate way leave. The party may also be informed that once the way leave (or) legal or law & order problems are cleared his seniority will be restored and service could be effected to the party on priority.

Selections shall be made in line with the following norms/quota as in force now and as per the latest amendment / supplement notification, if any, by the Chief Engineers of Distribution Region viz., Chennai North (for North & South Region), Vellore, Coimbatore, Trichy, Madurai, Villupuram, Tirunelveli, Erode & Chief Engineer / Gas Turbine Schemes / Chennai.
 - (i) Ratio of SC apprentices to the total apprentices :1: 6
 - (ii) Ratio of ST apprentices to total apprentices :1: 20
 - (iii) As per the latest recommendations of {
 Central Apprenticeship Council, reservation to }
 be given for physically handicapped candidates } : 3.0%
 irrespective of the marks obtained by them in }
 all branches in each region. }
- (iv) As per the Govt of India notification "Supplement to Apprenticeship Rules 1992, The Apprentices (Amendment) Act 2007 (Act No 36 of 2007), 27% reservation is to be given for OBC candidates.
- (v) As a welfare measure, the sons and daughters of the TANGEDCO/ TANTRANSCO employees in service / retired will be given preference during selection irrespective of the marks obtained by them subject to a maximum of 10% of the total vacancies in all branches in each region.
- (vi) All other clauses come under the category of open competition. Additional Annexures- 2A & 2B with the overall breakup details of the total number of Apprentices for selection under various categories (SC/ST/OBC/PH & OC) for the various disciplines of engineering as per the norms/rules in force is provided as an example to follow during selection of the candidates at the time of interview for each region in consultation with the member of BOAT present.

- (II) An Interview Committee shall be constituted with 3 members, one each from TANGEDCO and TANTRANSCO in the level of Superintending Engineers and one from Board of Apprenticeship Training (BOAT). In the committee to be constituted by the Chief Engineer, Distribution (North) Region, Chennai, one member from North Region and one member from South Region shall be represented. For Generation circle to be constituted by the Chief Engineer / Gas Turbine Schemes / Chennai, One Superintending Engineer from Thermal / Gas Turbine Stations and One Superintending Engineer from Hydro area shall be the members.
- (III) This committee shall conduct the interview for the candidates, to whom call letters will be issued directly by the BOAT, Chennai as per the allocation indicated in the Annexure 3 & 4 with a request to report at the respective Regional Head Quarters. During the above interview, the overall fitness of the candidates & their certificates shall be 100% verified and candidates shall be strictly ranked according to marks by the Interview Committee. Such lists will be prepared separately for SC/ST/OBC/OC Candidates.
- (IV) The Chief Engineer of the respective Distribution regions & CE/GTS, will arrange for all official machinery, man power, stationery etc. for conducting the interview.
- (V) The dates for conducting interview and the norms to be adopted for selection of graduate and diploma apprentices will be communicated by Board of Apprentice Training(Southern Region) well in advance
- (VI) In the case of Graduate & Diploma apprentices, the Chief Engineer / Distribution Region concerned and Chief Engineer/ GTS shall issue Engagement order as Apprentice Trainee as recommended by interview committee to the selected candidate by obtaining proper acknowledgement, on the next day of the interview. The Chief Engineers indicated shall be the competent authority to issue order as per the allotment to the various Wings / Substations / Generating stations as given in Annexure 5 & 6.
- (VII) While issuing the "reposting orders" to the apprentices the Superintending Engineers concerned are responsible to fill up the contract Registration form to be sent directly to the Director/BOAT that the individual has reported for duty. Their date of joining may be taken as the date for the commencement of apprenticeship training.
- (VIII) The date of joining of Graduate / Diploma apprentice has to be reported to BOAT by the Superintending Engineers concerned and they have to follow up for obtaining the Registration card / number of the apprentice. The Registration card/ number may be obtained from BOAT early within a maximum of three months from the date of joining.
- (IX) The Superintending Engineers concerned are requested to claim the 50% reimbursement amount from BOAT for Graduate and Diploma apprentices for the entire circle instead from the Division offices now in practice. 50% reimbursement amount claim from BOAT may be followed up regularly by the Superintending Engineer concerned for the realization of the same into TANGEDCO / TANTRANSCO account without fail and the same shall be reviewed by the Chief Engineers concerned every month for avoiding any lapses.

With reference to your letter in the reference 3rd cited, requesting clarification on the definition of Special and Multi-storeyed Buildings, the following clarification is furnished:

It is clarified that the Basement Floor + Stilt Floor not treated as floors for the purpose of calculating number of floors. Hence, two floors means Ground Floor + First floor or Stilt parking floor + two floors irrespective of provision of Basement floor. It is further clarified that in some cases, the applicant opt for part of the regular floor and part of stilt floor parking at the ground floor level. In such cases, the ordinary building with reference to number of floors consist of ground floor, (in Ground Floor level will be stilt for parking and part will be for habitable use) first floor and second floor (Part) over the area of stilt floor (part) at the ground floor level. Thus, the applicants are permitted to construct the second floor part only on the portion approved as stilt floor (part). As long as the building conforms to this profile, it is considered as an ordinary building. For easy reference, it is further suggested that the profile of the building should be sent whether any part of the building exceeds Ground Floor + First Floor or stilt Floor + 2 Floors.

Relating to industrial buildings, it is to be clarified that insistence of Completion Certificate for issue of service connections was introduced based on the High Court Order which stipulates that all the special buildings of residential and commercial and Multi storied building should be provided service connections only on obtaining completion Certificate. This order does not cover industrial building. While incorporating this provisions as part of Development Regulations in the 2nd Master Plan, the same is adopted. As per the Development Regulations (5), Completion Certificate required to be obtained Special Buildings, Group development and Multi-stores building. Industrial building irrespective of height not exceeding 15.25 mtrs. or number of floors not exceeding GF+3 floors or stilt floor + 4 floors is not considered as Special Building.

It is clarified that for the buildings approved as an ordinary building by the Local Bodies, Completion Certificate need not be insisted for providing service connections, as of now, as the Local Bodies do not issue Completion Certificate for the ordinary buildings issued by them.

HP make Thin client machines are available in Collection Centres established under Project BEST Phase I in all Regions. The R-APDRP (covered under Project BEST Phase - I) includes 700 Nos. of Project BEST Collection centres. Each Collection Centre comprises of 3 or 4 Nos. of Thin Client machines along with 9 pin Epson Printers and 1 No. local server for LT Billing.

The Thin Client PCs available in the section office are presently working on Customized Linux 1.2 Operating system (RedHat Flavour) including Mozilla Firefox 2.0 browser.

The Linux version 1.2 OS (RedHat flavour) and Mozilla firefox browser of version 2.0 are embedded into the IDE-Flash EPROM to enable security aspect and to prevent user from working with other unauthorized Operating System and browser settings. The Thin client PCs supplied under Phase - I are having IDE - FLASH EPROM of 64 MB capacity and those supplied under Phase - II are having IDE flash EPROm of 512 MB capacity.

In the Minutes of meeting held among RAPDRP ITIA and TANGEDCO officials on 20.11.2012, the ITIA has proposed to carryout the following:

"To test and create a Proof of Concept (POC) for the current thin client environment for ensuring the feasibility of the integration of the thin client with the R-APDRP module at HQ and further at Pudupalayam".

In response, M/s. Navayuga Infotech Pvt. Ltd, ITIA requested vide letter dated 23.12.2012 to provide the existing Thin Client system with the "Mozilla Browser version 4 or Higher".

The initial observations made while accessing the MBC Web Module (Meter, Billing & Collection Module) being developed at M/s. Navayuga Info Tech Ltd's remote office, through the existing Thin Client PC are furnished below:

- (1) Environment (64 MB Flash drive): Thin Client PC provided with thin client linux 1.2 version with Mozilla fire fox 2.0 embedded in 64 MB flash drive:
 - · Supporting Bar code Reader
- "Add Payment record" is not working in the bill payment interface since HTML
 5 tags are not supporting with the Mozilla fire fox 2.0 browser.
- Since the printing is based on Applet, which requires JRE Plugin, the receipt printing is not working.
- (2) Environment (512 MB flash drive): Thin Client PC provided with linux 1.2 version with Mozilla firefox 2.0 and JRE 1.4 embedded in 512 MB flash drive and the following are observed:
 - Supporting Bar code Reader
- "Add Payment record" is not working in the bill payment interface since the HTML 5 tags are not supporting with the Mozilla fire fox 2.0 browser.
- Since the printing is based on Applet, which requires JRE Plugin 1.7, the receipt printing is not working.
- (3) Environment (40 GB IDE Hard disk): Thin Client PC provided with the 40 GB IDE Harddisk loaded with RHEL 5.0 Operating System, Mozilla Fire Fox 17.0 version with JRE 1.7 Plug and the following are observed:
 - · Supporting Bar code Reader and tested OK.
 - All the collection functions are working well.
 - Receipt printing tested satisfactorily.
 - Collection reports are generated, tested and viewed in PDF.

The detailed report furnished by M/s. Navayuga Infotech Pvt Ltd is enclosed vide dated 23.1.12 is enclosed in the annexure.

From the above it may be seen that the Thin Client PCs with RHEL 5 with Mozilla Firefox 17.0 version and with JRE plugin 1.7 is required for enabling the MBC module of RAPDRP.

However the above environment could not created in a 512 MB IDE Flash EPROM, since the strip down version of RHEL 5 flavour OS needs minimum 200 MB, B.B. - 5 (Mar. 2013)

the Mozilla Browser version 17.0 needs 20 MB and the JRE plugin requires 45 MB. However, Considering the future scalability, 1 GB EPROM is preferable than 512 MB EPROM, so that any future requirement could be achieved easily without changing the Hardware.
