TANGEDCO - Bonus and Ex-gratia to Workmen of TANGEDCO for the year 2014-2015 - Orders - Issued.

PROCEEDINGS:

The quantum of Bonus and Ex-gratia payable for the financial year 2014-2015 to the Workmen of the TANGEDCO covered by the Wage Settlement has been considered in consultation with the Government. The Hon'ble Chief Minister has announced the decision of the Government for payment of Bonus and Ex-Gratia to the eligible employees of TANGEDCO in the Press Note No.120, Dated :01.11.2015. In the letter second cited, the Government have also accorded concurrence for the payment of Bonus and Ex-gratia to the employees of the TANGEDCO.

- 2. In pursuance of the above, it is hereby ordered that for the financial year 2014-2015, the Workmen of the TANGEDCO covered by the Wage Settlement, be paid a Bonus calculated at the rate of 8.33% of the salary or wage earned by them during the said financial year, subject to and in accordance with the provisions of the Payment of Bonus Act, 1965, as amended.
- 3. The workmen of the TANGEDCO (monthly paid and full-time workmen), Helper (Trainees), Office Helper (Trainees), Assessors (Trainees) and Mazdoor (Trainees) appointed on consolidated Salary and also the workmen of the State Government, Central Government and other organisations, who had worked on deputation in the Board, during the financial year 2014-2015 drawing a salary or wage, including those drawing pay exceeding Rs.3,500/- per month, pay exceeding Rs.3,500/- per month, will be eligible for the Bonus sanctioned in para-2 above, as was allowed last year.
- 4. The Part-time Sweepers and Sanitary workers who are getting the time scale of pay during the financial year 2014-2015, drawing the salary or wage, will also be eligible for the Bonus sanctioned in para-2 above.
- 5. It is also ordered that the workmen of the Board covered by the Wage Settlement and the deputationists, entitled to get Bonus with reference to the orders in paras 2,3 and 4 above, shall also be paid an Ex-gratia at the rate of 11.67% of the salary or wage earned by them, during the financial year 2014-2015.
- 6. The contract labourers who have been absorbed as Mazdoor (Trainee), during the year 2014-2015 are eligible only for the Bonus and Ex-gratia in a proportionate manner for the period they had worked in the above post. They are not eligible for the Ex-gratia of Rs.2,000/- payable to contract labourers.

16. The TANGEDCO also directs that the Bonus payment for the year 2014-2015 should be disbursed to all the eligible employees on 03.11.2015.

PROCEEDINGS:

The issue of payment of ex-gratia for the year 2014-2015 to the Contract Labourers have been considered and accordingly, the Honourable Chief Minister has announced the payment of ex-gratia to the Contract Labourers who are engaged directly in TANGEDCO for the year 2014-2015.

- 2) Accordingly, it has been decided that
- (A) The 7 Contract Labourers (Annexure A) engaged directly by the Board (now TANGEDCO) on need basis @ Rs.250/- per day as per the orders issued from O/o Chief Engineer/Personnel and based on the Court orders and also as per list furnished by the Superintending Engineers as called for in this office letter cited under reference and are working for one year in 2014-2015 and also continuously till date without break in service (not exceeding 3 months) shall be paid ex-gratia for the year 2014-2015.
- (B) The 45 Number of persons (Annexure-B) who were directly engaged as Contract Labourers on need basis @ Rs.250/- per day and subsequently absorbed into Board's (now TANGEDCO) Service in various categories during/after March 2015 without break in service (not exceeding 3 months) shall be paid ex-gratia for the year 2014-2015.
- 3) In pursuance of the above, it is hereby ordered that the persons mentioned in para (2) above shall be paid ex-gratia of Rs.2000/-(Rupees two thousands only) for the year 2014-2015. The ex-gratia payment shall be paid on 03.11.2015.
- 4) The Superintending Engineers are strictly informed that accountability will be fixed on the officers for non-compliance of these orders and in case the payment is made to any ineligible persons, responsibility will be fixed on the officers concerned. If any discrepancies are found regarding the eligibility/identity towards the payment of ex-gratia, the same must be got clarified from this office before payment to the concerned individual.

Sub: Establishment - Additional Charge arrangements - Appointment of Class-III officials to hold additional charge of another posts in Class II service - Certain instructions - Issued.

The Additional Charge Allowance was allowed to the officials in Class-I, II and III services for the first 5 months. On and from 03.10.2011, the said restriction was relaxed and orders have been issued that the Additional Charge Allowance shall be sanctioned only to the Class-I and II officers irrespective of the duration of the charge held by them - vide Proceedings second cited. As such, the officials in Class-III service are eligible for sanction of Additional Charge Allowance only for the first 5 months. Instances have come to the notice that certain Class-III officials who held additional charge of posts in Class-II service beyond 5 months, have requested sanction of Additional Charge Allowance for the period beyond 5 moths, which is not in conformity with the existing orders. In order to avoid such claims, the following instructions are issued to all the Competent Authorities who are empowered to make additional charge arrangement:-

i. While appointing the officials in Class-III service to hold additional charge of a higher post in higher class of service, it should be specifically mentioned in the appointment order that those officials shall be eligible for sanction of Additional Charge Allowance only for the first five months period irrespective of the duration of the Additional Charge and no claim for sanction of Additional Charge Allowance beyond the eligible period shall be entertained under any circumstances.

The Superintending Engineer/Chennai Electricity Distribution Circle/ North/Chennai has stated that many key improvement works such as establishment of improved cash collection centers, improvement of switch yards, formation of PSC Yard, improvement works in SS, rectification of structural damages in control Room buildings are going on/taken up in the SS of Tiruvottiyur High Road, R.K.Nagar, Tondiarpet, OHP, Toll Gate, Stanley and Royapuram and ongoing and upcoming works now being handled by the civil wing and their significance in the context of safety, security and in generating revenue for the Board. It is suggested that the method 4 is the better method as it is the fool proof method of payment which avoid any controversy arises from the applicant regarding the payment reconciliation. And also this method eliminates the submission of on-line generated application form along with copy of the bank challan and further validation of application form by the administrative wing. To proceed in the method 4, minimum of 15 days is required by the bank on receipt of TANGEDCO requirement. However, any method as suggested by CE/Personnel will be adopted in the software.

The requirements for all the process should be provided by administration wing time to time with development process to ensure the completion of software without any delay. The testing of the above steps should be performed by the administrative wing to ensure all the business process meeting the TANGEDCO proceedings, rules, regulations and G.Os for the recruitment of various categories are in-corporated in the software.
