Pension – Sanction of further instalments of Dearness Allowance to the Exgratia beneficiaries of TANGEDCO – Orders – Issued.

PROCEEDINGS:

In the proceedings first read above, order have been issued sanctioning Dearness Allowance at the rate of 237% to the Contributory Provident Fund/Non-pensionable establishment beneficiaries of TANGEDCO who are in receipt of Exgratia payment of Rs.645/- per month plus Dearness Exgratia with effect from 04.06.2013. The Government of Tamil Nadu, in the G.O. second read above, have issued orders sanctioning Dearness Allowance to the Exgratia beneficiaries with effect from 01.07.2016 and 01.01.2017. After careful consideration of the orders of the Government, it has been decided to adopt the same.

2. Accordingly, it is hereby ordered that the Dearness Allowance to the Exgratia

beneficiaries of TANGEDCO, be enhanced with effect from 01.07.2016 and 01.01.2017, at the rates mentioned below:-

Date from which payable	Revised rate of Dearness Allowance (per month)
1 st July, 2016	248%
1 st January, 2017	256%

ORDER:

In para 3 of the Government order read above, among others, it has been ordered that the disciplinary cases of the pensioners who belong to State service alone be sent to the Government and other cases shall be dealt with by the Heads of the Department concerned.

2. Based on the above said Government Order, the following amendment is made to Rule-9 of Tamil Nadu Pension Rules, 1978 and accordingly the following Notification will be published in the **Tamil Nadu Government Gazette, Extraordinary, dated: 12.08.2013.**

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Pension Rules, 1978:-

AMENDMENTS

In the said Rules, in rule 9,-

(1) in the marginal heading, "for the expression "Government", the expression "competent authority" shall be substituted;

(2) in sub-rule (1),-

(3) in clause (a),-

(i) for the expression "The Government reserve to themselves", the expression "The competent authority reserves to itself" shall be substituted;

(ii) for the first proviso, the following proviso shall be substituted, namely:-

"Provided that before passing an order under this clause, if the pensioner does not agree to such withholding or withdrawal of the pension, the Tamil Nadu Public Service Commission shall be consulted by the Government. In respect of pensioners who belonged to service other than the State Service, the Head of the Department concerned shall refer the case to the Government and the Government, after consulting the Tamil Nadu Public Service Commission, shall intimate the views of the

Commission to the Head of the Department concerned for issue of final orders. The Tamil Nadu Public service Commission need not be consulted in cases where the pensioner agrees to withholding or withdrawal of the pension but a copy of the orders passed by the competent authority in such cases shall be sent to the said Commission".

(b) in clause (b),-

(i) for the expression

"the government shall also have the right of ordering recovery", the expression "the competent authority shall also have the right of ordering recovery" shall be substituted:

(ii) for the proviso, the following proviso shall be substituted, namely:-

"Provided that before passing an order under this clause, the Tamil Nadu Public Service Commission shall be consulted by the Government in respect of pensioners belonged to State Service and in respect of pensioners who belonged to service other than State Service, the Head of the Department concerned, after arriving at the amount of recovery, shall refer the case to the Government and the Government, after consulting the Tamil Nadu Public Service Commission shall intimate the views of the Commission to the Head of the Department concerned for issue of final orders":

(2) in sub rule(2),-

(a) in clause (a), for the proviso, the following proviso shall be substituted, namely:-

"Provided that where the departmental proceedings are instituted by an authority subordinate to the Government, that authority shall submit a report recording its findings to the Government in case of pensioners who belonged to the State Service;

(b) in clause (b), in sub-clause (i), the expression "in respect of pensioners who belonged to State Service" shall be added at the end;

(2) in sub-rule (5), for the expression "Where the Government decide", the expression "Where the competent authority decides" shall be substituted;

(3) after sub-rule (6), the following sub-rule shall be added, namely:-

"(7) For the purpose of this rule, the term 'competent authority' shall mean the Government in respect of the pensioners who belonged to State Service and the Head of the Department concerned in respect of other pensioner,"

ABSTRACT

Public Services - proviso under rule 9 (1) (b) of the Tamil Nadu Pension Rules, 1978 - Omitted - Instructions - Issued.

ORDER

As per the amendment issued in the Government Order read above, rule 9 (1) (a) of the Tamil Nadu Pension Rules, 1978, empowers the competent authority to reserve themselves the right of withholding or withdrawing a pension or part thereof as a measure of penalty, against the proven charges. The proviso stipulated under Rule 9 (1) (a) of the Tamil Nadu Pension Rules, 1978, is as follows:-

“Provided that before passing an order under this clause, if the pensioner does not agree to such withholding or withdrawal of the pension, the Tamil Nadu Public Service Commission shall be consulted.....

..... The Tamil Nadu Public Service Commission need not be consulted in cases where the pensioner agrees to withholding or withdrawal of the pension.....”

2. As per the amendment issued in the government Order read above, rule 9 (1) (b) of the Tamil Nadu Pension Rules, 1978, empowers the Competent Authority, the right of ordering recovery from the Pension / Death cum Retirement Gratuity of the whole or part of the pecuniary loss caused by such grave misconduct or negligence. The proviso stipulated under Rule 9 (1) (b) of the Tamil Nadu Pension Rules, 1978, is as follows:-

“Provided that before passing an order under this clause, the Tamil Nadu Public Service Commission shall be consulted by the Government in respect of pensioners belonged to State Service and in respect of the pensioners who belonged to service other than State Service, the Head of the Department concerned, after arriving at the amount of recovery, shall refer the case to the Government and the Government, after consulting the Tamil Nadu Public Service Commission shall intimate the views of the Commission to the Head of the Department concerned for issue of final orders”.

3. Instances have been brought to the notice of the Government that when a pensioner agrees to the proposed penalty under rule 9 (1) (a) of the Tamil Nadu Pension Rules, 1978, there is no need to consult Tamil Nadu Public Service Commission as instructed under the proviso of the said rule. But for exercising the right of the competent authority to effect the recovery of loss from the pension, Tamil Nadu Public Service Commission is being consulted as laid down under the proviso to rule 9 (1) (b) of the Tamil Nadu Pension Rules, 1978. The said repugnancy forcing the competent authority to compulsorily consult Tamil Nadu Public Service Commission with respect to the component of recovery of loss, even in cases where the pensioner agrees to the proposed penalty.

4. In rule 9 (1) (b) of the Tamil Nadu Pension Rules, 1978 itself it has been laid down that **it is the right of the Competent Authority** for ordering recovery from Pension or Death cum Retirement Gratuity of the whole or part of the pecuniary loss caused by such grave misconduct or negligence, since such recovery is not of the character of penalty.

5. There is no provision available in the Tamil Nadu Public Service Commission Regulations, 1954 for seeking its views when the competent authority takes action for ordering a recovery of pecuniary loss from Pension or Death cum Retirement Gratuity. Thus the proviso under rule 9 (1) (b) of the Tamil Nadu Pension Rules,

1978, has not also been validated under sand Tamil Nadu Public Service Commission regulation, 1954.

6. The Government after due examination in the light of the above context, have decided to omit the proviso made under rule 9 (1) (b) of the Tamil Nadu Pension Rules, 1978, and ordered accordingly.

7. Necessary amendment to the Tamil Nadu Pension Rules, 1978 will be issued separately by the Finance Department.

8. This order issues with the concurrence of the Finance Department in U.O.No.298, Finance (Pension) Department, dated 23.01.2017.

PROCEEDINGS:

In the reference first cited orders were issued allowing to move Special Grade to certain employees of Board for whom there is no promotional opportunity on completion of twenty years of service in the same post.

2. In the reference second and third cited, orders were issued allowing one increment equal to 3% of basic pay including grade Pay on movement to Selection Grade/Special Grade with effect from 01.12.2007. Subsequently, in the reference fourth and fifth cited, orders were issued granting an additional increment to the employees @ 3% of pay plus Grade Pay during Revision of Wages in 2011 on the date of movement to Selection Grade/Special Grade based on the orders of the Government of Tamil Nadu.

3. As per the existing orders, the employees of TANGEDCO are entitled to rectification of pay anomaly, on par with their juniors promoted after movement to Selection Grade by grant of one increment @ 3%. In the reference sixth cited, orders have been issued by the Government among other things for rectification of pay anomaly to the seniors on par with their juniors who were promoted after movement to Selection Grade/Special Grade by obtaining an additional increment @3% (i.e., 3+3=6%).

4. Based on the orders issued by Government in the reference sixth cited, the same was adopted in TANGEDCO and orders were issued only to the cases of Selection Grade anomaly in the reference seventh cited.

5. The Unions have demanded to allow rectification of pay anomaly to the seniors arising due to the junior moved to Special Grade and promoted to higher post and draw higher pay when the senior was promoted without moving to Special Grade and draw lesser pay and also the anomaly ordered in G.O. (Ms) No.25, P&AR (FR.IV) Department dated 23.03.2015 for grant of additional increment.

6. After careful examination, it is hereby ordered that the pay anomaly to the seniors who were promoted to higher post without movement to Special Grade in the lower post and draw less pay be rectified on par with their juniors promoted after movement to Special Grade and draw more pay as per the conditions laid down in Selection Grade anomaly. The rectification of pay anomaly to the seniors on par with the juniors who were promoted after movement to special grade by obtaining an additional increment @ 3% as ordered in the reference sixth cited arising on or after 01.12.2007 be made applicable to the seniors notionally with effect from 01.12.2007 and monetary benefit from 01.04.2013.

PROCEEDINGS:

There have been various instructions issued in the past in regard to the procedure for disposal of request transfers of the employees of the Board. These have been reviewed to improve the administration. Now a committee has been constituted vide reference 1 to consolidate all the request transfer guidelines issued so far and to make necessary modifications to suit for present service conditions superseding all existing guidelines. Accordingly the committee has submitted its reports which have been approved and the following request transfer guidelines are hereby ordered for immediate implementation from the date of issuance of this order.

2. The authority to whom the Board has delegated Powers to effect the type of transfer and area of transfer is as per Annexure.

3. The list of vacancy should be made available category wise Region/Circle/ Division wise and updated before 5th of the every month by the concerned Officers.

4. (a) The Chief Engineer/Personnel based on the application received will issue

circle allotment to the transferred Assistant Executive Engineers to the Chief Engineer concerned and in other categories of Assistant Engineers and below to the SEs concerned. While issuing allotment order by Chief Engineer/Personnel to the Chief Engineer/Superintending Engineer concerned, Chief Engineer/Personnel will attach copy of request transfer application along with the allotment order, so as to consider the place preferred by the applicant with in circle as per RT Guidelines by Chief Engineer/Superintending Engineer while issuing reposting order.

(b) In the categories of Regular Work Establishment upto the level of Special Grade Foreman, the Superintending Engineer shall intimate the allotment of the transferred candidates to the division, for issuing reposting orders within Division, by the Executive Engineer concerned, along with the copy of RT application, Performance report and service particulars to Executive Engineers concerned, so as to consider the place preferred by applicant with in division as per RT guidelines by Executive Engineer, while issuing reposting order.

(c) The RT application received within the Circle in respect of Provincial and RWE categories should be operated by Chief Engineers/Superintending Engineers/ Executive Engineers concerned, only after allotment issued by the Chief Engineers / Personnel, in respect of provincial category and Superintending Engineers in respect of RWE categories, by following the guidelines mentioned in the Para(7).

5. (a) Request for transfer can be accepted only to places where vacancies exist/will arise. Requests from employees shall be made only to a particular place and not to a particular post.

(b) No Employee has any right to expect consideration of such requests unless his or her work and conduct have been satisfactory.

(c) If there is any reason or special circumstances by which the transfer of the applicant to the requested place will be detrimental to the interest of the Board, the transfer should not be done.

6. The period of registering request transfer applications by the employees will be from 1st to 20th January and from 1st to 15th July in a year.

(a) Request for a transfer to a Place/Station with in 25kms in respect of State seniority Categories shall not be entertained.

(b) Request for a transfer to a Place/Station with in 8kms in respect of Circle Seniority Categories (RWE) shall not be entertained.

(c) The above distance criteria of 25/8 kms for requesting the transfer shall not be insisted when an employee applies RTA from inter units of Head Quarters, Generation, Distribution, Operation, Transmission and Project wing.

7. For ordering request transfers, the following conditions shall be scrupulously observed:-

(a) (i) Eligibility of transfer will arise only after completion of one year as on 20th of January or 15th of July as the case may be on duty in the present Station/ Present Post.

(ii) The one year on duty period shall not include the period spent on UEL on MC, EL, EOL w/o P&A and UEL on Private Affairs.

(iii) The work and conduct of the employee should be satisfactory.

b) In respect of provincial category, where more than one person seeking transfer to a place, either with in the Circle or Outside Circle are qualified for consideration, preference will be given to the person who has served for the shortest

period on duty (Continuously or in different spells) in the place to which transfer is sought. In case of provincial cadres promoted out of Regular Work Establishment Cadres, the service put in under provincial cadre alone will be taken into account for this purpose.

c) If under clause (b) above, more than one person is available within the Circle/Outside the Circle or the same length of service in the place of his/her choice, then preference will be given to the one who has served the longest period on duty in the present place.

d) In respect of RWE category, where more than one person seeking transfer to a particular place within circle/within division are qualified for consideration, preference will be given to the person who has served for a shortest period on duty in all categories (Continuously or in different spells) in the place to which transfer is sought.

e) If under clause (d), above more than one person is available with no service or the same length of service in all categories in the place of his/her choice, then preference will be given to the one who has served the longest period on duty in the present place.

8) (i) In respect of transfer made based on the report of vigilance cell, the employee shall not be posted back within 2 years to the same Circle/Division on request without getting the clearance from the Vigilance Cell. After the end of 2 years on duty period no need to refer vigilance cell. The period of two years on duty shall be reckoned from the date of joining of the employee in the new post, which shall not include the period spent on Unearned Leave on Medical Certificate, Earned Leave, Extra Ordinary Leave without Pay and allowance and Unearned Leave on Private Affairs.

(ii) The above ban on 're-transfer' will apply at the level of unit at which transfer has been suggested i.e., if transfer outside a circle has been ordered, he should not be posted back to the same circle for 2 years. But, there is no bar for his re-transfer to another Circle subject to, keeping in mind any order for posting to a non-sensitive post. The above instructions will equally apply to Regular Work Establishment categories whose transfer is operated within the circle. In such cases, the Regular Work Establishment worker should not be posted back to the same Division/Sub-Division for 2 years.

9) The condition of one year of stay on duty in a place specified in para 7(a) (i) above should be insisted upon with a view to avoid dislocation of work in the office by frequent transfers and in order to ensure that the employees concerned really settle down in their jobs and apply themselves to their work instead of seeking transfer as soon as they join the post to escape responsibility. The stipulation of one year on duty in a station for considering request transfers cannot be dispensed with, in the interest of administration except in the following cases where the condition of one year stay on duty is not insisted upon.

- (I) In the cases of employees who were/are to be transferred to other stations due to shifting of headquarters in which cases the services rendered in the same office in new headquarters and the old headquarters shall be taken into account for reckoning the one year of service on duty.
- (II) In the cases of re-transfer of the Regular Work Establishment workmen and workmen borne on Circle seniority transferred due to surplus who are not liable for transfer outside the Circle but for the surplus.

- (III) In the case of employees transferred on administrative grounds (other than on adverse reports) before completion of one year in a particular station/stations, the service rendered in the previous stations shall also be counted for reckoning the one year minimum stay on duty.

10. The transfers once made by the competent officers should not normally be modified/cancelled by them. If it is proposed to be modified/cancelled, the prior approval of the next higher officer should be obtained giving full justification. If any modification/cancellation to earlier transfer order is considered necessary in the case of transfers ordered by the Chief Engineers, the proposal may be sent to the Chief Engineer/Personnel for obtaining orders from the competent authority.

11) As and when a vacancy arises in a particular place, all the registered request transfer application by the appropriate officers, who are competent to effect transfers for that place will be considered based on the above on comparative merits keeping in mind the following aspects:

- (i) The length of previous service of the applicant in the Circle/Place and Division/Place to which transfer is sought by Provincial/RWE.
- (ii) The length of service of the applicant in his present place/post.
- (iii) Grounds on which the transfer is sought.
- (iv) Need for avoidance of dislocation of work in the present office of the applicant.
- (v) Circumstances in which the applicant was posted to his present station.
- (vi) Suitability of the applicant for work in the post where vacancy exists.
- (vii) Whether free from DP/ undergoing punishment/ Vigilance enquiry.
- (viii) Other administrative interests.

12) (i) the Request Transfer Application Registered from 1st to 20th January of a year will be valid upto 30th of June of that year. The RT application registered between 1st to 15th July will be valid up to 31st December of that year only.

(ii) Fresh Request transfer Application should be registered from 1st to 20th January and from 1st to 15th of July every year.

13) Requests for transfer will not be entertained from persons who are already under orders of transfer to some other Circle/Division.

14) (i) Request for transfer should be only to a particular Circle/Station for the employees applying from other circles. Request for transfer to a particular post will be summarily rejected without being registered.

(ii) Request for transfer should be only to a particular Station for the employees applying within the circles. Request for transfer to a particular post will be summarily rejected without being registered.

(iii) In respect of RWE category seeking Division to Division transfer the request transfer application should be only to a particular Division/Place. In case of RWE staff seeking transfer to a particular place with in Division, request for transfer should be only for the station and the request for a particular post will be summarily rejected without being registered.

15) The Superintending Engineers concerned should send the Performance report of the eligible applicant to the Administrative Branch within 10 days i.e. from 21st Jan to 30th Jan and from 16th July to 25th July without waiting for a reference from the Administrative Branch, failing which the authorities concerned are responsible for non-consideration of registered RTA, if any.

16) Priority will be given for the request transfer in the following cases:-

- (i) Applicant affected by the chronic disease.
- (ii) Applicant having mentally Challenged Child.
- (iii) Physically Challenged employee, having disability more than 50%.
- (iv) To the person working in Hydel Station in Hill area.
 - (a) 3 years service in the Hydel station at less than 1000 meters above sea level.
 - (b) 2 years service in the Hydel station at more than 1000 meters above sea level.

17) Preference will be given for Spouse case.

18) Mutual transfer based on Request Transfer Application should not be considered by the Chief Engineers/Superintending Engineers/Executive Engineers.

Remarks:

1) The Request Transfer being operated now by Regional Chief Engineers within their region without seniority for initial level category (Mazdoor/Helper) and with seniority for above initial category of RWE cadre will continue to be considered as per the guidelines in Memo.No.132962/7/IR1(4)/Adm.Br./86-6, dated: 18.04.1986 and Memo.No.132962/7/I.R.1(4)/86-7,(Adm.Br.) dated: 08.09.1986.

2) While considering Administrative Transfer the instruction issued in Administrative Branch Memo.No.074266/IR 1 (3)-96-1 (Adm.Br.) dated: 19.06.1996 be taken in to account.

The statement showing the Maximum Inventory level fixed for the circles during the year 2017-2018, is enclosed herewith for strict adherence. The actual inventory level in the circles should not be allowed to exceed the level now fixed at any point of time during the year 2017-2018.

2.0 Excess inventory results in unnecessary locking up of Board's money and other associated costs such as interest cost, inventory carrying cost, obsolescence etc. At the same time it should also be ensure that required materials for effecting new service connection, for executing budgeted T&D programmes, for routine maintenance work etc, are made available at Stores so as to complete the works in time.

3.0 Further, in view of the tight financial conditions prevailing in the Board, the Superintending Engineers and the Chief Engineers are requested to ensure that all efforts are taken to control the inventory and to keep it within the prescribed level, by adhering to the following.

- i. To be more cost conscious in inventory management.
- ii. By regulating the P.Os and delivery schedules to suit the work schedule requirement, the inventory may be kept for minimum period in Stores. Wherever necessary, the delivery can be rescheduled after getting the approval of the Competent Authority. The concept of "Just in Time" (JIT) inventory management can be achieved over a period, so that the inventory cost gets considerably reduced.
- iii. Scraps and empties must be disposed off then and there and money realized to Board's account without delay.
- iv. Periodical review and inspection of Stores by the Superintending Engineers/ Chief Engineers and other inspecting officers may be ensure to keep constant watch over the inventory level and to ensure that the level is maintained within the limit prescribed/. The materials arrived in Stores should be taken into stock immediately for beneficial use and should not wait for more than 3 days for want of check measurements etc.
- v. Maximum Inventory level fixed should not be taken as an authorization to keep the inventory at that level.
- vi. The Superintending Engineers/ Chief Engineers may bestow their personal attention on the usage IMS package and the various output reports designed in the programme to control the inventory.

4.0 The maximum inventory level should not exceed the limit prescribed during 2017-2018 under any circumstances and any proposal for ratification of the excess stock held in the circles will not be entertained.

Sub : Income-Tax – Certain amendments made to the Act through Finance Bill 2017- Rates of Income Tax to be deducted at source from salaries and charts for Deduction (TDS) and collection (TCS) of Tax during the Financial Year 2017-2018 Communication of - Regarding.

Ref : 1) Circular Letter No.CFC/GL/FC/FC/ACCTS/DFC/TAXATION/D.60/2016, dated 22.06.2016.

2) Finance Bill 2017.

Kindly refer the Circular cited above, wherein Rates of Income Tax to be deducted at Source from Salaries and the Charts for TDS and TCS during the Financial Year 2016-2017 have been communicated.

Now, the following amendments are made to the Provision of Income Tax Act 1961 through Finance Bill 2017.

I. Rate of Income Tax to be deducted at source on Salaries.

The basic exemption limit is Rs.2.5 Lakh as previously communicated for the Financial Year 2016-2017 for the Individual other than Senior Citizen and the rate of Income Tax is as furnished below.

(a) Surcharge : Nil

(b) Education Cess : Education Cess on Income Tax and Secondary and Higher Education Cess on Income-Tax shall Continue to be levied at the rate of two per cent and one percent respectively of income-tax in the case of deduction on payment of salary.

II. Rate of Income Tax in case of certain individuals (u/s 87A)

From assessment year 2014-2015 (Financial Year 2013-2014) onwards, under

section 87A an assessee whose total income does not exceed five lakh rupees shall be entitled to a deduction from the amount of income tax on the total income (computed before allowing this rebate), an amount equal to the amount of income-tax payable on the total income for the assessment year or an amount of two thousand rupees, whichever is less. Further, the rebate allowable under this section has been increased to Rs.5,000/- in Financial Year 2016-2017.

Now, the rebate under section 87A Rs.2,500/- will not be available if the total income (taxable income) of the resident individual exceeds Rs.3,50,000/- during the Financial Year 2017-2018 (Assessment Year 2018-2019).

III. Deduction u/s.80CCE

The aggregate Deduction under sections 80C, 80CCC, 80CCD(1), has remain unchanged, i.e.1.5 Lakh.

IV. Disallowance of Capital expenditure under Section 35 AD on cash payment

Under the existing provisions, revenue expenditure incurred in cash exceeding Rs.20,000/- (in the case of payment to a transport contractor, it is Rs.35,000) is not allowable as deduction as per Section 40A(3) (a few exceptions are given by rule 6DD). However, there is no provision to disallow the capital expenditure incurred in cash. To check cash payment for acquiring a capital asset, sections 35AD and 43(1) have been amended with effect from the assessment year 2018-2019 as follows:

(1) Any expenditure in respect of which payment (or aggregate of payments made to a person in a day) otherwise than by an account payee cheque/draft/use of electronic clearing system through a bank account, exceeds Rs.10,000/- no deduction shall be allowed in respect of such payment under section 35AD.

(2) Where an assessee incurs any expenditure for acquisition of any asset in respect which a payment (or aggregate of payments made to person in a day), otherwise than by an account payee cheque/draft/use of electronic clearing system through a bank account, exceeds Rs.10,000/- such payment shall be ignored for the purposes of determination of "actual cost" of such asset. Consequently, one cannot claim depreciation/additional depreciation under section 32 and investment allowance under section 32 AD pertaining to such payment. Moreover, such expenditure will not be considered for the purpose of section 50(1) (iii)/(2). In order to disincentivise cash transactions, section 40A(3) has been amended with effect from the assessment year 2018-2019. The monetary limit of cash payment of Rs.20,000 has been reduced to Rs.10,000 (there is no change in the monetary limit pertaining to cash payment of Rs.35,000 to transport contractors). Consequently, any expenditure in respect of which payment (or aggregate of payments made to a person in a day), otherwise than by an account payee cheque/draft/use of electronic clearing system through a bank account, exceeds Rs. 10,000, no deduction shall be allowed in respect of such payment under sections 30 to 37.

Amendment to section 40A(3A) - Section 40A(3A) is applicable if the tax payer had claimed a deduction in respect of an expenditure in any of the earlier years. Payment pertaining to the expenditure is made during the current year. If during the current year, the payment (or aggregate payments made to a person in a day) otherwise than by an account payee cheque/draft, exceeds Rs.20,000, the payment so made shall be deemed as business income for the current year. This monetary limit has been reduced to Rs.10,000 from the assessment year 2018-2019. Consequently, payments pertaining to earlier years in excess of Rs.10,000 should be made by an account payee cheque/draft/use of electronic clearing system through a

bank account. Otherwise, such payment shall be treated as business income of the year in which payment is made.

V. AMENDMENT TO SECTION 206 CC

In order to strengthen the PAN mechanism, section 206CC has been inserted with effect from April 1, 2017. The provisions of Section 206CC are given below:

Tax collection at higher rate - Collectee shall furnish his PAN to the person responsible for collecting such tax at source. If PAN is not intimated, tax shall be collected at twice the normal rate or at the rate of 5 percent, whichever is higher.

PAN to be quoted in all correspondence - The collectee shall furnish his PAN to the Collector (TANGEDCO) and both shall indicate the same in all correspondence, bills and vouchers exchanged between them.

Invalid Pan - Where the PAN provided by the collectee is invalid or it does not belong to the collectee, it shall be deemed that PAN has not been furnished to the collector.

Not applicable if collectee is non-resident - The above provisions of section 206CC shall not apply in the case of a non-resident collectee who does not have any permanent establishment in India.

COLLECTION OF TAX AT SOURCE [SECTION 206C]

[In respect of collection of tax from buyer or licensee or lessee during the financial year 2017-2018]

Section 206C(1) provides that, every person being a seller shall, at the time of debiting of the amount payable by the buyer to the account of the buyer or at the time of receipt of such amount from buyer, whichever is earlier, collect from the buyer of any goods of the nature specified in column (2) of the Table on page 383, a sum equal to the percentage specified in column (3) of the said Table, of such amount as income-tax as increased by a surcharge at the rate in force and also additional surcharge on the aggregate of I.T. & S.C.⁴⁰².

Section 206C(1C) provides that, every person, who grants a lease or a licence or enters into a contract or otherwise transfers any right or interest in any parking lot or toll plaza or mine or quarry⁴⁰³, to another person, other than a public sector company (hereafter referred to as "licensee or lessee") for the use of such parking lot or toll plaza or mine or quarry⁴⁰³ for the purpose of business shall, at the time of debiting of the amount payable by the licensee or lessee to the account of the licensee or lessee or at the time of receipt of such amount from the licensee or lessee, whichever is earlier, collect from the licensee or lessee of any such licence, contract or lease, a sum equal to 2% of such amount as income-tax it may be noted that, S.C. and also addl. S.C. on the aggregate of I.T. & S.C., if any, is not collectable from licensee or lessee who is a domestic company or any other person who is resident in India [Vide clause 2(8) & proviso to clause 2(11)/2(12) of the Finance Bill, 2017 as passed by the both Houses of Parliament].

Provisions of section 206C(ID) & 206C(1E) are omitted w.e.f. 01.04.2017 by the Finance Bill, 2017 as passed by the both Houses of Parliament, refer item (8) on page 47.

Section 206C(IF)^{403a} provides that, seller of a motor vehicle, value exceeding Rs.10,00,000 has to collect from the buyer, a sum equal to 1% of the sale consideration as income-tax. Buyer is defined to mean a person who obtains in any sale of a motor vehicle referred to in section 206C(1F)

The amount so collected u/s.206C(1)/206C(1C)/206C(IF) shall be paid to the credit of the Central Government within 1 week⁴⁰⁴ from the last day of the month in which collection is made [vide Rule 37CA(2)]. Person collecting the tax is required to prepare quarterly statement in the prescribed Form No.27EQ⁴⁰⁵ to be delivered to the Director General of Income-tax (Systems) [DGIS] or the person authorised by the DGIS, on or before 15.7.2017, 15.10.2017, 15.1.2018 & 15.5.2018, in respect of quarter ending on 30.6.2017, 30.9.2017, 31.12.2017 & 31.3.2018, respectively [Proviso to section 206C(3) read with rule 31AA(1)/(2)]. Credit for tax so collected will be given to buyer or licensee or lessee on the basis of a certificate (Form No.27D) given by the person collecting tax [Section 206C(5)]. If the person responsible for collecting the tax u/s.206C, fails to collect the tax or after collecting the tax fails to pay it to the credit of the Central Government within period specified, then, he/it shall be liable to pay simple interest at the rate of 1% per month or part thereof on the amount of such tax from the date on which tax was collectable to the date on which the tax was actually paid and such interest shall be paid before furnishing the quarterly statement for each quarter in accordance with section 206C(3) [Section 206C(7)]. In addition, the said person is liable to pay the tax to the credit of the Central Government even though he/it has failed to collect the tax [Section 206C(6)]. Further, section 276BB provides that, if a person fails to pay to the credit of the Central Government the tax collected by him under the provisions of section 206C, he shall be punishable with rigorous imprisonment for a term which shall not be less than 3 months but which may extend to 7 years and with fine. Every person collecting tax u/s.206C, shall, within the time prescribed in the Rule 114A has to apply to the AO for allotment of tax deduction and collection account number in Form 49B (in duplicate) [Section 203A].

It is noticed that one bogus adjustment bill arised on one HT consumer at Tirunelveli Circle.

It has been reported by SE/EDC/Tirunelveli, the monthly third party allotment statement of one generator has been received through official delivery through the generation end of Tuticorin EDC and subsequently Tuticorin EDC has informed that the statement of generator for the month of 04/2017 and 05/2017 are fake stements. It is also noticed that due to the above, the shortfall arises to Rs.48.79 lakhs. This kind of adjustment based on fake statements may prevail in other circles also.

Hence to avoid these kind of malpractices the SE/EDCs concerned are instructed to adopt the following:-

a) The HT consumer shall be insisted to obtain NOC from Generator end EDC also;

b) The EDCs should confirm the third party allotment statement of the generator with the **Open Access Approval available in the SLDC web portal** before billing;

c) Necessary training may be given to HT billing staff at Regional level to ensure correct billing practices are adopted; and

d) To make necessary arrangement to audit the HT billing by BOAB immediately i.e., before the next billing.

In this connection, the SE/EDCs concerned are strictly instructed to ensure the correctness of the allotment statement received before billing each month and the compliance report on the above may be sent to CFC/Revenue.

Administrative approval was accorded for printing and supply of 1,20,000 nos. wall calendars for the year 2017 (in the same pattern and design of wall calendar 2016) to all the employees and offices of TANGEDCO, TRANTRANSCO and TNEB Ltd.

B.B.5 (June 17)

by using 1500 reams of paper at an estimates cost of Rs.28,92,000/- including material and labour cost.

In view of protecting the environment by way of reduction in cutting trees for manufacture of papers, it has been decided to reduce the calendar size without compromising on any of the existing features such as clarity, quality of paper, contents, etc.

The present calendar size 585 mm x 455 mm is to be decreased to 420 mm x 297 mm (A3 size) thereby saving about 750 reams of 80 GSM white radiant print paper of size 58.5 cm x 91 cm.

The recurring benefits to the environment due to the decrease in size of the wall calendar are:

- (i) Saving of 45 trees from being cut every year for paper manufacturing.
- (ii) Saving of 51.76 lakh litres of water per year (324 litres water required for manufacture of 1 kg paper).
- (iii) 972 kg of CO₂ is prevented from entering into the environment (as the same is absorbed by these 45 trees) per year.

The new calendar is easy for handling and the print on the same is equally legible. The comparison of cost involved and savings expected (in respect of paper cost and labour changes) for 1,20,000 calendars in A3 size paper is tabulated below:

The following are the additional benefits to TANGEDCO in reducing the calendar size:

- (i) Reduction in volume of printing ink to be used.
- (ii) Reduction in the expenditure to be incurred (charges based on weight) on account of dispatch through paid services (viz. packing, loading / unloading, transport charges to the transport agent's office and destination TNEB office).
- (iii) Reduction in the cost to be incurred on account of no. of plates and embossing charges
- (iv) Reduction in electrical energy consumption as the running hours of the printing machine gets reduced.

Considering the benefit to the environment, cost reduction and compactness, the size of the wall calendar for 2018 shall be reduced from 585 mm x 455 mm to 420 mm x 297 mm (A3 size) with the slogan "SAVE PAPER, SAVE TREES, SAVE THE EARTH". All other existing features such as clarity, quality of paper, contents, etc. shall be maintained.

1. Considering the public interest in large, it has been decided to introduce one day service connection scheme in respect of LT Domestic and Commercial categories (other than special and multi-storeyed buildings) which fall under mere service connection, involves erection of underground service connection cables and no extension or improvement works from the TANGEDCO side.

2. Under the scheme, the Domestic and Commercial buildings which require low tension electricity service connections should be within 100 feet from the electricity mains of TANGEDCO and if so, the electricity service connection can be effected on the same day or a maximum time of 48 hours in cases which involve road cut for laying of underground service connection cable.

3. The applicants of the Domestic/Commercial service connections can apply either through online (www.tangedco.gov.in) or in person at the section offices of the TANGEDCO. The applicants have to fill the application form and enclose / upload (as the case may be) the self certified scanned copy of anyone of the following documents:

- i) Certified copy of proof of ownership such as sale deed/partition deed/gift settlement/allotment letter/computer patta/ownership certificate issued by revenue department officials/court judgment or recent property tax receipt.

(or)

- ii) In the case joint property, certified copies of proof of ownership such as legal heir certificate along with parent documents specified in note (i) above and consent letters from co-owners. If consent letter is not produced, an indemnity bond with enhanced security deposit.

(or)

- iii) If the applicant is not the owner, consent letter from owner in Form No.5 or valid proof of occupancy and indemnity bond in Form No.6

4. The applicants of the Domestic/Commercial service connections have to ensure the uploading of valid documents in complete shape before making online payments. If the documents uploaded by the applicants are not in complete shape, the application would be listed for cancellation manually by the concerned authority with intimation to the applicant through notice/e-mail/SMS etc. However, the section officer shall follow the procedure prescribed in the references (2) and (3) before cancelling the application.

5. Due care shall be taken by the concerned section officer before cancelling the applications. In case of cancellation of the applications, the entire amount except

registration charges should be returned to the applicants by the concerned Section Officer with the prior approval from the Superintending Engineer concerned.

6. In case of applications received in person at the section offices, the section officers should guide the applicants in submitting the applications in proper shape.

7. In this regard, the following instructions are issued:

1. To avoid delay in effecting service connections, the concerned Section Officers are empowered to sanction the estimates in respect of the mere service connections pertain to the LT Domestic and Commercial categories which involves erection of service lines and no extension or improvement works from the TANGEDCO side. Further, the concerned section officers are empowered to draw the rolling stock meters without the counter signature of the Assistant Executive Engineers in the requisition forms.
2. In this regard, working instruction for drawal of rolling stock meters and other related issues is enclosed in the Annexure A. Further, a register of rolling stock of meters should be maintained as prescribed in Annexure B.
3. If the buildings (other than special and multi-storeyed buildings) which require LT Domestic or Commercial service connections come under the mere service category, the service connections shall be extended on the same day and whereas, in the places where underground service connection cable is to be laid which involves road cut, a time period of 48 hours may be taken for effecting service connections. For other categories of services, which involves extension or improvement works, the time schedule prescribed in the DSOP Regulation may be followed.
4. For online application filing of LT Domestic and Commercial service connections, the procedure as prescribed in the references (2) and (3) cited shall be followed, except that if the service connections fall under mere service category, the service connections may be extended on the same day of within 48 hours as the case may be.
5. Only the miscellaneous charges fixed by the Hon'ble TNERC such as Registration charges, Service Connection charges, Meter Caution Deposit, Development Charges and Initial Current Consumption Deposit shall be collected at the time of registering the applications in respect of LT Domestic and Commercial connections even when the service connections involve extension. The details of the present miscellaneous charges as approved by the Hon'ble TNERC vide M.P. 41 of 2003 are as below:

Note:- * The kW rate mentioned above is meant for demand applied/ sanctioned and not the connected load.

6. The applicants shall pay the above charges at the time of registering the application in the TANGEDCO office or through online application itself. In case of three phase Domestic and Commercial service connections, it is sufficient that the applicants can pay the above miscellaneous charges only for 4 kw demand at the time of registering the application and avail the service connections.
7. The estimate charges and miscellaneous charges (for the demand applied over and above 4 kw in respect of three phase Domestic / Commercial Service connections) if any are due from the consumers, the same shall be collected in the first Current Consumption (CC) bill and this fact has to be intimated to the intending consumer through notice / e-mail / SMS etc.
8. The Chief Engineer/Material Management and the Chief Engineers of the Distribution Regions shall take necessary action that the underground service connection cables and other service connection materials should be available in the stores for effecting service connections without any delay. The section officers shall not insist the intending consumers to provide the underground service connection cable or pay the cost of the cable in addition to the estimate cost. Further, the section officer shall maintain necessary service connection materials, meters, etc. so as to effect the service connections without any delay.
9. The scheme of 'one day service connection' has to be monitored on a daily basis and the Executive Engineers/Superintending Engineers concerned will be held responsible if there is any let up. Further, a wide publicity shall be given to this scheme by the Superintending Engineers/EDCs.
10. The Superintending Engineers/Commercial is the nodal officer for monitoring the 'One day connection Scheme'. The Superintending Engineer/Commercial shall also furnish report such as the details of the service connections effected, pending, etc. to the CMD/TANGEDCO once in three days.
11. The Executive Assistant to the Director (Distribution) shall also coordinate with the Distribution Circles for better reach out of this scheme among the general public and to monitor the progress of implementation of the scheme.
12. There are some complaints that the intending consumers are insisted to supply the underground service connection cable or asked to pay for the same for effecting service connections. In case of such complaints, the intending consumers can give complaints to the Director General of Police / Vigilance / TANGEDCO through Email: adgp@tnebnet.org, Phone No. 044-28520416, FAX No. 044-28520749.
13. The complaints received in the office of the Director General of Police / Vigilance shall be investigated by the vigilance wing and appropriate disciplinary action will be taken against the erring official. A copy of the complaint will be sent to the Superintending Engineer concerned. The Superintending Engineer concerned shall send the action taken report on the complaints to the Superintending Engineer/ Commercial, who in turn shall put up the consolidated report on the complaints along with the action taken to the CMD/TANGEDCO once in fortnight.

8. In view of the above, all the Chief Engineers/Distribution Regions are instructed to fix the responsibility to the concerned Superintending Engineers of the EDCs to strictly follow the above instruction by the field officers under their control for effecting

LT Domestic and Commercial service connections (other than special and multi-storeyed buildings) applied through either in person or through online.

9. This scheme of 'one day service connection' will come into effect from 01-07-2017 and any lapses in this regard, will be viewed seriously.

Annexure – A (Working Instructions)

1. The Applications received either through online or in person received by the section officer in the morning between 8 AM to 10 AM can be considered for effecting service connections on the same day or within 48 hours as the case may be. Applications received after 10 AM will be considered in the next day.

2. The Section Officers invariably make themselves available in the section office during the above timings to process the applications received from the intending consumers.

3. After through scrutiny of the documents, the concerned section officer should accept the necessary service connections and other charges for the respective service connection and PR issued to the applicant in respect of the service connections applications received in person. In respect of the service connection applications received through online, the applicant may pay the entire charge as prescribed in the instructions at the time of registering the application itself. The estimate charges if any other than the miscellaneous charges fixed by the Hon'ble TNERC shall be collected in the first Current Consumption (CC) bill from the consumers and this fact has to be intimated to the intending consumer through notice / E-mail / SMS etc.

4. A meter of suitable capacity from the rolling stock of meters exclusively maintained for this purpose may be issued and the service connection effected if all the details are satisfactory with reference to the declaration of the applicant and TNE Distribution Code.

5. Simultaneously, arrangements are to be made to recoup the meter for effecting the service and taken in to account in the "Register of rolling stock of meters" as per Annexure-B.

6. The fact of effecting service connection should be entered in the service connection register with all details and the fact that the service has been under "one day supply scheme" is to be specifically recorded in the service connection register.

7. A report of details of service effected may be furnished to the concerned Assistant Executive Engineer every two days to have a proper check on the services effected and to know the details of service connections activity in his sub-divisions. The concerned Assistant Executive Engineer should check the register of 'one day service connections' every week and make entries there and also check the rolling stock. The concerned Assistant Engineer is immediately answerable to him for any flaw in dealing with the 'one day service connection applications.

8. If the service connection could not be effected for non fulfillment of application, the concerned section officer will inform the applicant through notice/e-mail/SMS etc. stating the reasons for not effecting the service connection.

9. While effecting supply if the service connection involves extension of lines, the supply should not be effected and the application transferred to extension category

and processed suitably and the time schedule prescribed in the DSOP Regulation may be followed. The fact may also be intimated to the applicant through notice/e-mail/SMS etc.

10. It is the responsibility of the concerned section officer to ensure that the meter under stock of this scheme is not allowed to be exhausted and the meter should be recouped as far as possible.

11. For the above scheme, a rolling stock of meters as detailed below could be maintained in each section:

12. The estimate for keeping the rolling stock will be sanctioned by the Superintending Engineers concerned and it is a onetime sanction. Meters from this rolling stock should not be used for any purpose in the distribution.

13. Rolling stock of meter should be drawn and kept at the section office. It is the personal responsibility of the section officer to keep the rolling stock account properly to avoid any misuse.

14. The Assistant Executive Engineers should check frequently to ensure that the meters on rolling stock are properly used and scheme is implemented effectively.

15. This scheme has to be monitored on a daily basis and the Executive Engineer & the Superintending Engineer concerned will be held responsible for any let up in this issue.

16. In case of online application, after effecting service connection, a print out of the application along with relevant documents, test report, etc. shall be submitted to the Office of the Executive Engineer (Revenue Branch) for record purposes.

The above working instructions may be scrupulously followed in up keeping the image of the TANGEDCO among the general public in effecting LT Domestic and Commercial mere service connections (other than special and multi-storeyed buildings) in the same day or with 48 hours as the case may be upon receipt of the applications.

Based on the Announcement made by the Hon'ble Minister for Electricity in the Assembly, on 19.6.17, TANGEDCO shall implement a pilot scheme jointly by the Agricultural Engineering Department and TANGEDCO for provision of 1000 Nos. Standalone (off grid) Solar water pumping system of 5/7.5/10 HP capacity each, to the farmers in the state for irrigation use, at an estimated cost of Rs.15 crores, to be incurred by TANGEDCO.

2. The scheme shall be implemented with the financial assistance of MNRE/ GoI, and GoTN. The proposed subsidy pattern is as below;

GoTN subsidy (AgriDept)	40%
TANGEDCO contribution	30% (subsidy restricted to 5 HP only)
MNRE subsidy	20%
Farmers contribution	10%

3. Farmers who are already provided with free electricity by TANGEDCO can participate in this scheme if they relinquish their free electricity provided by TANGEDCO. TANGEDCO would provide subsidy, only to the farmers who are willing to relinquish their free electricity application registered already and the same shall be treated as cancelled.

4. Those farmers who want to continue with free electricity provided by TANGEDCO are not eligible for this scheme.

5. Implementation procedure:

a) The Solar pump programme shall be implemented jointly by Agricultural Engineering Department (AED), GoTN as per the MNRE GoI guidelines/letter dt.02.06.2017, in coordination with Planning and NCES wing of TANGEDCO. The beneficiaries/eligible farmers, shall be identified jointly by TANGEDCO / Agricultural Engineering Department, in an appropriate manner.

b) Farmers who are already provided with free electricity by TANGEDCO can participate if they relinquish the free power. Further, the subsidy is eligible to the farmers who are willing to relinquish their free electricity application registered already and their applications shall be cancelled thereafter.

c) The Agricultural Engineering Department shall evolve the total project cost and award the works of installation of solar pumps as per the tender norms of GoTN/ MNRE, GoI. Further, the Agricultural Engineering Department shall carry out techno

feasibility survey for suitability of site, based on factors such as depth of bore well/ open well, pumping water level, required shade free area for erection of solar panels etc.,

d) The TANGEDCO contrition shall be handed over to the Agricultural Engineering Department.
