TANGEDCO - Wearing of Photo Identity Cards compulsorily by the Sub: TANGEDCO, TANTRANSCO & TNEB Ltd. employees - Instructions -

Reiterated – Orders – Issued.

In the reference fifth cited, the Secretary to Government, P&AR (A), Department, Secretariat, Chennai, has stated that the Government of Tamil Nadu have issued orders/instructions to all Heads of Departments so as to emphasize that all the Government Servant, shall wear photo identity card compulsorily during office hours without fail. Even though orders/instructions have been issued, it is learnt that some of the departments have not followed the instructions scrupulously.

- 2. The Hon' ble High Court of Madras in its Judgment dated 16.07.2018 in W/P.No.15640/2018, has directed to ensure that all officers and employees of the Government of Tamil Nadu, particularly, those dealing with the public are provided with photo identity card, within 60 days from date, if the same has not already been done and also ensure that rule regarding wearing of photo identity cards is strictly enforced and action should be taken against those flouting the rules. Hence, requested all the Head of Departments/District Collectors to issue necessary instructions to war photo identity card without fail during office hours by the employees.
- 3. In the references first to fourth cited various instructions were issued to employees of the erstwhile TNEB, now TANGEDCO/TANTRANSCO/TNEB Ltd. to produce the identity card as and when requested by the security officers.
- 4. In view of the Hon'ble High Court of Madras Judgment, all the Chief Engineers/ Superintending Engineers/Head of Departments are hereby directed to give suitable instructions to the sub-ordinate officers under their control to instruct all employees to wear photo identity card during office hours without fail.
 - 5. The above instructions should be adhered to strictly.

TANGEDCO - Union - Tamil Nadu Electricity Worker's Sub: Federation – Deduction of Bonus donation from the salary of the willing members of the union - Orders - Issued.

In the Board's Proceedings first cited, orders were issued for deduction of Annual Union Subscription and donation from the salary of the willing employees of the Union/Association, who make the specific request before the Board in this regard and the first of such deduction will be made from the salary for month of May 2007 payable in June 2007.

- 2. In the Board's Proceedings second cited, detailed guidelines were issued for deduction of Annual Union subscription and donation from the salary of the willing employees. In the standard terms and conditions annexed to the Board's proceedings, it has been ordered that subscription shall be deducted from the pay bill for May payable in June and donation shall be deducted from the pay bill for November payable in December every year.
- 3. The Tamil Nadu Electricity Worker's Federation have requested for inclusion of the scheme for the first time and have requested to deduct Bonus donation of Rs.500/-from the salary of their union members for the month of November 2018 payable in December 2018 onwards.
- 4. The request has been examined and accepted. Accordingly, it is hereby ordered that TANGEDCO to deduct a sum of Rs.500/- towards Bonus donation from the willing members of Tamil Nadu Electricity Worker's Federation, who made specific written authorization. The above Bonus donation shall be deducted from the pay bill for the month of November 2018 payable in December 2018 onwards.
- 5. The annual subscription and donation shall be made in the Account Head: -44:463 Tamil Nadu Electricity Worker's Federation.

In view of the change made by the Government in the composition of Senior Law Officers of the Government of Tamil Nadu, it is hereby ordered that the cases of the TANGEDCO/TANTRANSCO hitherto entrusted to Thiru C.Manishankhar, the then Ld.AAG-IV shall be entrusted to Thiru P.H.Arvind Pandian, Ld.AAG-II forthwith and the Chief Engineers/Chief Financial Controllers shall ensure the same.

- 2. All officers of the TANGEDCO/TANTRANSCO shall ensure that the fee bills of the Senior Law Officers and Senior Advocates engaged for TANGEDCO/TANTRANSCO cases are sanctioned and paid within a month of receipt of the fee bills as per the orders in (Per) CMD TANGEDCO Proceedings No.177 (SB) dated 27.09.2018 (effective from 28.05.2018) or as per the then existing procedure, as the case may be.

The pending bills of Senior Law Officers of the Government of Tamil Nadu including that of Thiru P.H.Arvind Pandian, Ld.AAG-II, for the years 2012-2016 when the was LD.AAG-V, and Thiru C.Manishankhar, then Ld.AAG-IV, for the year 2016-2018, which are yet to be sanctioned and paid, shall be processed for sanction and payment at once without any further delay.

ABSTRACT

Public Services – Involvement of Government servants in criminal cases which are in no way connected with the discharge of the official duties – Placing under Suspension Amendment to guidelines – Orders – Issued.

Personnel and Administrative Reforms (N) Department

G.O.(Ms) No.120

G.O.(Ms) No.124, Personnel and Administrative Reforms (N) Department, dated 22.02.1983.

ORDER:

In the Government Order read above, while emphasising the need and circumstances for pursuing simultaneous departmental action, when the criminal case for the official misconduct of Government servant is pending in the Court of Law, instructions were also issued in taking decision on initiation of departmental disciplinary action and placing the Government servants under suspension when a criminal case which is in no way connected with the official duties is pending.

- 2. As the said instructions were issued in 1983, the disciplinary authorities from various quarters raised doubt, as to whether it is mandatory to place the Government servants under suspension while allegations/complaints are received of First information Report is filed for criminal offences alleged to have been committed by them in private capacity.
- 3. As indicated in the Government Order read above, placing of Government servants under suspension is to serve as a provision available to the disciplinary authorities to the exercised within the scope of their discretion A Government servant should be placed under suspension only if his continuance in office will be clearly

detrimental to the public interest. The aspects to be borne in mind by the disciplinary authority while exercising the discretionary power to place such Government servants under suspension would relate to the circumstance of the incident nature of complaint, gravity of offence, seriousness of the charge, stage of the criminal case etc,

4. The Government have examined the issue in detail and decided that <u>para 2(i)</u> of the G.O.(Ms) No.124, Personnel and Administrative Reforms (N) Department, dt.22.02.1983 shall be substituted with the following instruction and order accordingly:-

"When a criminal case is filed solely on the on the criminal offence alleged to have been committed by the Government servant, which is in no way connected with the discharge of his official duties, the disciplinary authority may suspend such Government servant, by exercising the discretionary power, only if his continuance in office will be clearly detrimental to the public interest and in the circumstances which would really warrant suspension, depending upon, the circumstance of the incident, nature of the complaint, gravity of the offence, seriousness of the charge, stage of the case, etc., Once, the criminal case is disposed of by the Court of Law, the competent authority may initiate action against such delinquent officer either under rule 17 (c) (i) (1) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules or under rule 9 (1) (a) of the Tamil Nadu Pension Rules, 1978, as the case may be".

<u>Para 2 (ii)</u> of the G.O.(Ms) No.124, Personnel and Administrative Reforms (N) Department, dated 22.02.1983, holds good, as it is.

PROCEEDINGS:

In the Board's Proceedings first read above, based on the orders of the Government of Tamil Nadu, orders were issued to the effect that the maximum qualifying service be reduced from 33 years to 30 years to become eligible for full pension by a Board employee after retirement. It was also ordered therein that pension be determined based on 50% of average emoluments drawn during the last 10 months of service rendered or 50% of pay last drawn by the Board employee, whichever is higher. The said orders were applicable for the retirees of the Board on or after 01.07.1996.

- 2. In the Government order second read above, orders have been issued for implementation of the judgement of the Hon'ble Supreme Court of India dated 08.07.2014 made in Civil Appeal No.6116 of 2014 @ Special Leave Petition (C) No.22870/2007) that the benefit of the maximum qualifying service being reduced from 33 years to 30 years to become eligible for full pension shall also be extended to those who had retired between 01.10.1979 and 01.07.1996.
- 3. The TANGEDCO is following the orders of the Government in respect of Pension and Pensionery benefits to its Pensioners/Family Pensioners. The Pensioners' Association have represented for adoption of the orders of the Government to the Pensioners of the Corporation.

- 4. The TANGEDCO after careful consideration has decided to adopt the said orders of the Government of Tamil Nadu and ordered for extending the benefit of reduction of maximum qualifying service from 33 years to 30 years to become eligible for full pension to those who retired from service between 01.10.1979 and 01.07.1996.
- 5. In the case of employees who retired between 01.10.1979 and 01.07.1996 and those who had not rendered maximum qualifying service of 33 years to become eligible for full pension/enhanced family pension at the level of full pension to their advantage, such Pensioner/Family Pensioner may apply to the Pension Sanctioning authority concerned where the employee last served who is competent to process and forward pension proposal to the Chief Internal Audit Officer/Audit Branch, Chennai in the prescribed form as in Annexure appended to this order in triplicate. In case of Pensioners who have died, the life time arrears shall be paid to the legal heirs on their claim. For this purpose, the legal heir shall apply through proper channel for revision of pension/enhanced family pension along with Death Certificate and relevant documents.
- 6. On receipt of application in triplicate, the Pension sanctioning authority shall verify the net qualifying service already certified, at the time of initial sanction of pension and shall forward the application to the Chief Internal Audit Officer/Audit Branch for authorizing the revised entitled pension and enhance family pension as ordered in the B.P.Ms.No. 6 (SB) dated 13.01.1988, (Per) B.P. (Ch) No.208 (SB), dated 18.08.1998, (Per) BP (FB) No.2, dated 01.02.2008, (Per) BP (Ch) No.235 (SB) dated 01.12.2009, (Per) CMD TANGEDCO Proceedings No.71, (SB) dated 22.02.2014, (Per) CMD TANGEDCO Proceedings No.72, (SB) dated 22.02.2014 and (Per) CMD TANGEDCO Proceedings No.52, (SB) dated 02.03.2018. It is also directed that the relevant records furnished by the Pensioners/Family Pensioner/Legal heirs may be admitted in the event of non availability of records in the concerned offices.

PROCEEDINGS:

In the G.O. read above, among other things orders have been issued that the voluntary contribution of one day's salary of the Government Employees and Teacher to the Chief Minister's Public Relief Fund towards the relief and rehabilitation measures being taken in the Districts of Tamil Nadu affected due to cyclonic storm "GAJA" be deducted from their pay bill for the month of November and December 2018. All the major unions have also expressed their willingness of their members to contribute one day's salary to the cyclonic storm "GAJA". Hence, the TANGEDCO has decided to adopt the above Government order.

- 2. All the pay drawing Officers are authorized to recover one day salary/more than one day salary on gross basis from the salary for the month of November or December 2018 by following procedure be followed to facilitate the contributions made by the employees of TANGEDCO, TANTRANSCO and TNEB Ltd.
 - i) Any employee willing to voluntarily contribute One day's salary to the Chief Minister's Public Relief Fund towards the relief and rehabilitation measures being taken in the Districts of Tamil Nadu, affected due to cyclonic storm "GAJA" shall give his/her consent in writing to the concerned Drawing and Disbursing Officers.
 - ii) The Drawing and Disbursing Officers shall make use of the provisions in the Web Pay roll application for calculating one day's/more than one day's salary in the pay bill for the month of November or December 2018.
 - iii) Recovery shall be made straight from the Pay Bills. PROCEEDINGS:

Extensive damages were caused to the electrical distribution network in Nagapattinam, Tiruvarur, Thanjavur and Pudukottai Districts due to Cyclone "Gaja" on 16th November 2018.

In these districts, the power lines, poles and Distribution Transformer of distribution network were snapped due to high wind speed as the uprooted trees fell on the electrical network lines and structure. The HT/LT Lines, Distribution transformers and other substation equipments have got damaged.

For restoration of power supply, workers, RWE staff and officials from Andhra Pradesh, Telangana, Kerala, Karnataka and Neyveli Lignite Corporation Ltd. (NLC) were also engaged in addition to the officers and staff of TANGEDCO due to the emergency nature and huge volume of work involved. The works for restoration of power supply started since 16th November 2018 onwards under extraordinary weather conditions.

The restoration works are being carried out with the help of the officers and staff of TANGEDCO, labourers other than TANGEDCO Staff, workers, RWE staff and officials from Andhra Pradesh, Telangana, Kerala, Karnataka and NLC on war footing without break round the clock.

Considering the huge volume of the work being carried out at the field, approval is accorded for the following.

- i) Necessary food, tea, snacks, water, transportation and accommodation should be arranged to all the workers, RWE staff and officials from Andhra Pradesh, Telangana, Kerala, Karnataka and NLC involved in the power restoration works.
- ii) Pocket expenses of Rs.100/- Per person per day shall be paid to the workers and RWE staff from Andhra Pradesh, Telangana, Kerala, Karnataka and NLC engaged for the power restoration works.
- iii) Wages per day shall be paid to the officials from Andhra Pradesh, Telangana, Kerala, Karnataka and NLC engaged for the rectification works is as follows:
 - a) Officials in the rank of EE's and above = Rs.3000/- Per day
 - b) Officials in the rank of AE/AEE = Rs.2000/- Per day
- iv) Wage of Rs.1000/- per day shall be paid to the RWE Staff from Andhra Pradesh, Telangana, Kerala, Karnataka and NLC engaged for the rectification works.
- v) Wage of Rs.1000/- per day shall be paid to the workers from Andhra Pradesh, Telangana, Kerala, Karnataka and NLC engaged for the rectification works.

Sub: Gaja Cyclone – Certain EDCs affected by Severe Cyclone and Heavy Rainfall – Granting Extension of time up to 30.11.2018 for payment of LT CC Charges by Consumers – Instructions – Issued-Regarding.

Ref: CMD TANGEDCO Note Order dated 16.11.2018.

The Gaja Cyclone had hit the Nagapattinam, Tanjavur, Tiruvarur, Pudukottai, Ramnad, Dindigul, Theni and Sivaganai Circles with heavy rainfall and affected the normal life of people living in those areas. Some of the TANGEDCO Consumers are affected due to the impact of Cyclone accompanied by Heavy Rainfall and hence may not be in position to pay their LT CC Charges in time.

- 2.0) Hence, considering the difficulties faced by the people of above stated EDCs, it is suggested that the LT Consumers of these Circles whose due date falls on 15.11.2018 to 25.11.2018 may be granted extension of time up to 30.11.2018 to make the payment of their LT CC Charges without BPSC and DC RC fees.

Kindly refer the above letters, wherein the detailed guidelines were issued for engaging consultancy services in order to rectify the TDS defaults prevailing in various TANs of the Circles and to avoid Tax demand in TDS viz. 24Q (Salary), 26Q(Other than Salary) 27EQ (TCS). It was repeatedly requested to meticulously monitor the rectification progress so as to push forward the issue.

In the reference (9) cited above, a comparative chart on the TDS default as on 13.06.2018 and 05.05.2018 have been communicated and TAN-wise rectification status were called for. But the status report has not yet been received from many regions and the demands have increased for few Regions. The remarks on status of report and default as on 16.11.2018 are furnished below:-

It is seen from the Aggregated TDS compliance report as on 16.11.2018, most of the TANs have shown sluggish progress in TDS default rectification and increase of demand. The TAN-wise outstanding report of demand is enclosed.

While reviewing the Compliance report received from the Regions, it is seen that some of TANs are not available in the Aggregated TDS compliance report which was downloaded from TRACES. Hence, it is requested to comfirm whether all the TANs of the Region is available in the TAN-wise report attached, the left out TANs may be informed to Head Quarters.

Further, the increase in TDS default amount is due to defaults occurring in TDS returns of Financial Year 2017-2018 and I & II Quarter of the Financial Year 2018-2019 in many TANs. It is requested to advise the Superintending Engineers under your control to instruct the Officers/Staff who are dealing with TDS return filing to take utmost care while filing e-TDS returns and review the TDS defaults in their Circle on <u>quarterly basis</u>. The CPC – Income Tax Office (TDS) issues notice demanding interest, short deduction, late fees etc. on each filing of the TDS return. The Officer/Staff may be instructed to monitor such notice and take action for correcting the defaults intimated in the notice.

It is requested to instruct the Superintending Engineer for sending the list of TANs in which all the TDS rectification work is completed and only Interest and Late filing fee is due to be paid for belated remittance of Income Tax and Late filing of TDS returns. The

report is required for getting approval for payment of Interest on Belated remittance of TDS u/s.201 since it is a statutory liability and to address Income Tax Department for getting waiver for Late filing fee u/s.234E and Interest theron u/s.220(2) from Head Quarters side. The proposal on Interest due and Penalty for late filing may be sent to Head Quarters for taking final decision/approval.

The details of demand in the TDS returns for each TAN is available in www.tdscpc.gov.in. It is hereby informed that such Interest/penalty for any non-compliance of TDS provisions shall not be borne by TANGEDCO from 01.04.2018. Hence, the Staff/Officer may be instructed to watch the demands from 01.04.2018 and take corrective actions otherwise the same will be recovered from the concerned Staff/Officer who is responsible for non-compliance. The Year-wise, TAN-wise pending TDS default statement is enclosed.

Besides, as per the approval of CMD/ TANGEDCO, the Chief Engineer are requested to arrange to include one training session (for a duration of 2 to 3 hours) on the importance of timely filing of TDS returns and monitoring the TDS defaults in all existing training programmes covering all the Drawing and Disbursing Officers in the Circles through the Training Centers located at various Regions of TANGEDCO. Such training may also be extended to TANTRANSCO Drawing and Disbursing Officers and their Staff.

It is requested once again to take effective steps for rectification of huge defaults in an expedited manner and also furnish the TAN-wise progress on rectification of TDS defaults as on 31.10.2018 to Head Quarters on or before 05.12.2018 without fail as the progress is monitored by the Statutory Auditors who are insisting to make provision for TDS demands as on 31.03.2018.

TANGEDCO intends to implement Smart Meters with AMI (Advance Metering Infrastructure) system under Chennai Smart City Schemes in T.Nagar under Area Based Development (ABD). On mixed/hybrid communication technology. It is intended to adopt RF mesh network for thickly populated areas and Cellular network (GPRS/3G/4G) for areas with scattered population.

A Proposal covering 1.27 lakh consumers was submitted to Chennai Smart City Ltd. (CSCL) on 17.09.2018 for an amount of Rs.112.75 Crores. TANGEDCO Presented its case at the 6th Smart City High Powered Project Sanctioning Committee (HPPSC) meeting held in the Old Conference Hall, Secretariat on 12.10.2018 at 5.00 PM under the Chairmanship of Additional Chief Secretary to Government, Finance Department, GoTN.

In continuation, M/s. CSCL has communicated the minutes of the HPPSC meeting stating that the Committee, in respect of above, has approved the project cost of Rs.86 crore subject to the condition specified in the appraisal report.

Project Scope:

The project scope for AMI solution for Implementing Smart meters shall comprise of design, supply, installation, commissioning, integration and maintenance of the AMI system in T.Nagar area under Smart City program covering around 1.41 lakhs consumers. The original proposal submitted and approved is for 1.27 Lakh Consumers. However, taking into consideration the Consumer growth, the total Consumers have been revised now to 1.41 Lakhs as per field statistics. Accordingly, revised detailed estimate has been evolved as per Annexure-II

The Major components involved are:

- 1. Smart Meters, DCUs (RF), Modems (HT, DTs, Ring Fencing), DCUs (Substations).
- 2. Network connectivity.
- 3. IT Hardware and Software for TANGEDCO Data Centre/Chennai and DRC at Madurai.

The revised detailed estimate works out to Rs.118 crores (excluding taxes) as per Annexure-II. As only Rs.86 crores has been approved by HPPSC, GoTN., the remaining amount shall be borne by TANGEDCO since, CSCL has instructed that the project cost over and above Rs.86 Crores (as a grant) shall be met From the TANGEDCO funds. Further, TUFIDCO during the meeting has stated that (i) the consumer count should not be reduced below 1.27 lakh consumers. (ii) Energy Audit can be carried out for the whole pilot area.
