TANGEDCO – Allowances – Sanction of VIP Special Allowance to the drivers who are driving the VIP vehicles – Revised – Orders – Issued.

PROCEEDINGS:

In the Board's Proceedings first read above, orders were issued for sanctioning of VIP Special pay to those drivers who are driving vehicles of VIP's under the control of Chief Public Relation Officer including the driver attached to the Chairman's Car and other 5 VIP vehicles.

2. In the Board's Proceedings second read above, revised orders were issued sanctioning VIP special pay to the drivers who are driving the VIP vehicles for the following officers:

- 1. Chairman
- 2. Accounts Member
- 3. Member (Distribution)
- 4. Member (Generation)
- 5. Secretary
- 6. Chief Financial Controller
- 7. Chief Engineer/Personnel
- 8. Chief Engineer/Planning

3. In the Board's Proceedings third read above, orders were issued for constitution of committee to re-examine and review the eligibility of VIP special pay being paid to the drivers at present with the following members:

1. The Secretary/TANGEDCO (Chairman of the committee)

- 2. The Chief Engineer/Personnel
- 3. The Chief Financial Controller/General/TANGEDCO

The committee has examined in detail and recommended the VIP special allowance instead of VIP Special Pay to the drivers who are driving for VIP's vehicles.

4. After careful consideration, the TANGEDCO hereby ordered that the VIP special allowance shall be sanctioned to the drivers who are driving the vehicles of the following VIPs/Officers:

- 1. Honb'le Minister for Electricity
- 2. Honb'le Minister for Fisheries
- 3. Chairman cum Managing Director/TANGEDCO/TANTRANSCO/TNEB Limited
- 4. Former Chairman cum Managing Director
- 5. Joint Managing Director/ TANGEDCO/TANTRANSCO
- 6. Managing Director/TANTRANSCO
- 7. Director/Distribution

8. Director/Generation

9. Director/Finance (TANGEDCO)

10. Director/Transmission Project

11. Director/Finance (TANTRANSCO)

12. Director/Operation

13. Director (Projects)

14. Secretary/TANGEDCO

15. Legal Advisor

16. VIP Pool (only one driver utilized in the office of Chief Public Relations Officer)

5. The TANGEDCO also ordered that the drivers of VIP vehicles shall be sanctioned **VIP special allowance instead of VIP special pay** on par with other allowances at **flat rate basis** and if the driver driving the VIP vehicle is transferred (or) deputed to the other offices (or) any other departments, the VIP special allowance should be stopped immediately.

6. Further it is ordered that the drivers who were driving the vehicles in Enforcement and Flying Squad shall be sanctioned only **Vigilance Special Allowance instead of Vigilance Special Pay.**

7. Any new proposal for sanction VIP special allowance to any driver who is driving vehicles apart from the above list shall be referred to the Secretary/TANGEDCO for considering the same by the committee for approval of the Chairman cum Managing Director.

8. This order will take effect from 01.08.2019.

Report to accompany TANGEDCO Proceedings:

Announcement has been made by the Hon'ble minister of Electricity, Prohibition and Excise in the Tamil Nadu Legislative Assembly on 04.07.2019 to implement of Video Conferencing facility for TANGEDCO and TANTRANSCO offices to improve communication between Head Office, all 9 Distribution Regional Offices and 44 Distribution Circle offices at an estimated cost of Rs.2 Crores.

In this context, the following are stated:

- 1. Installation of Video Conferencing System (VCS) facility between the Project site and the TANGEDCO Head Qtrs. Was included as one of the components in the scope of the Project for the establishment of 2x800 MW Uppur Supercritical Thermal Power Project awarded to M/s.BHEL,
- 2. However, based on the approval of the CMD, the scope of the VCS facility was extended to connect the other project sites at NCTPP-Stage-III, Ennore SEZ and Udangudi as the VCS was capable of connecting 20 users from 20 different places simultaneously.
- 3. Based on the above, the CE/Projects vide letter dated 26.04.2019 has requested for the installation of Multi Point Control Unit (Server hardware for VCS) and associated hardware etc., temporarily at the server room under the control of CE/IT for testing and pre-commissioning works.
- 4. The Hon'ble Minister of Electricity, Prohibition and Excise has inaugurated the Video-Conferencing facility between Appadurai Hall and the project sites at Ennore SEZ and the NCTPP-Stage-III, on 18.06.2019 & 24.06.2019.
- 5. In line with this, the following further are detailed.
 - for conducting IT training programmes to the officers across the TANGEDCO and TANTRANSCO offices, a pilot study has been successfully carried out in the Cuddalore, Udumalpet circle offices by deploying cameras in both the ends by using web based online video conferencing software tools such as Cisco Webex, Skype, GoToMeeting through our existing connectivity with a focus to reduce the recurring cost and in order to facilitate the officers to attend meeting through Laptop or Mobile devices even during travel or camp duty,
 - to make use of the available Video Conferencing infrastructure and servers procured by the Project wing, for extending the facility to the 9 Nos. Regional offices and 44 Nos. Circle offices of the distribution wing by availing additional licenses and end point equipments like camera monitor, speakers, etc., at the proposed locations in such a way to cater 20 audiences and 10 audiences in the Regional and Circle offices respectively.
 - On the Head quarters end, as there might be a need for concurrent video conferencing session in the future or the top management, 2 Nos. VC locations suggested in the Head Quarters (which would also act as redundant system in case of any failure in the HQ VC). The Chief Engineer/Civil Design may be requested to arrange the space, furniture and infrastructure to accommodate 20 audiences for each VC in the Head Quarters.
 - At the Regional Office and Circle Office ends, necessary infrastructures like Video conferencing hall, network connectivity, Air Conditioners, Furniture, etc., may be arranged by the concerned Regional Chief Engineers/ Superintending Engineers under their respective powers.

- In order to technically superior, robust VC system, it is suggested to frame an external committee comprising of IIT Madras, M/s.NIC, Anna University, M/s.CDAC for preparing technical specification, evaluation and resolution of any technical issues, by incurring an expenditure towards honorarium of Rs.2000/- per person per sitting.
- In the mean while, the Hon'ble Minister of Electricity has made an announcement in the Assembly that in order to improve communication between Head Quarters offices and the field Offices, video conferencing facility will be established connecting the Head Office, all 9 Distribution Regional Offices and 44 Distribution Circle offices at an estimated cost of Rs.2 Crores.

REPORT TO ACCOMPANY THE ESTIMATE

This proposal envisages for enhancement of 400/110 kV Inter Connecting Transformer (ICT) capacity from 2x200 MVA to 3x200 MVA at Alamathy 400/230-110 KV Substation in Chennai/North Operation Circle of Chennai/North Region at an estimated cost of Rs.1841.07 Lakhs (Gross) and (Nett).

NEED:

The existing 400 kV/230-110 kV Substation at Alamathy is being fed by the eight 400KV Feeders namely NTECL Vallur 400 kV Feeders 1&2, NCTPS Stage II 400 kV Feeders 1&2, Sunguvarchathram 400 kV Feeders 1&2 and Thiruvalam 400 kV Feeders 1&2. Alamathy 400/230-110kV Substation was commissioned on 25/05/2006.

2.2 The Alamathy 400 KV SS is a critical substation feeding the load centers of Chennai urban and sub urban area. At present eight 230 kV feeders and seven 110 KV feeder are emanating from this substation and provision of one more 110KV feeder namely Papparampakkam feeder has been sanctioned. The railway traction load has also been connected with the 110kV feeders of Alamathy 400 KV substation.

Avadi town which is being fed from Alamathy 400 kV SS is now declared as corporation. Also the Tamilnadu Government has recently announced the establishment of an IT park near Avadi, which will further lead to a substantial increase in the load growth.

2.3 The existing 2 Nos 400/110 kV ICTs have reached peak demand of 167 MW and 157 MW and are catering to the loads of seven 110kV feeders. The load growth is at an exponential rate in the above 110 KV feeders. It is evident that both the 200 MVA ICT's have exceeded 75% of their full load capacity.

It is not possible to feed the loads with one transformer in the event of preventive maintenance and breakdown maintenance since the 400/110 kV ICT's have reached a peak of more than 75% of their capacity.

2.4 In the event of preventive maintenance and breakdown maintenance at Manali 400/230-110 kV substation, 110 KV supply from Alamathy 400/110 kV substation is being extended upto Puzhal, Mathur 110 kV substations. After the commissioning of 110 KV Alamathy - Thiruninravoor feeder, 110 KV supply has also been extended to Kakkalur SS with a load of 70 MW during the peak hours. The proposed third ICT will also be helpful in accommodating a part of other 110 KV SS loads in the event of emergency or shut down. Sufficient space for erection of additional one number 400/110 kV ICT is available.

2.5 The strengthening of 400 KV and 110 KV buses at Alamathy 400 KV SS does not arise, since the above 400 KV and 110 KV buses are strung by Quad moos conductor.

The current carrying capacities of the 400 KV and 110KV buses are sufficient even after the introduction of 3^{rd} 200 MVA, 400/110 KV ICT.

2.6 In the Load flow study report, it has been suggested to enhance the capacity of 400/110 kV ICT from 2x200 MVA to 3x200 MVA at Alamathy 400/230-110 kV SS. Further, in the 2nd meeting of the Southern Region Standing Committee on Transmission (SRSCT) conducted by CEA on 10/06/2019, the proposal for providing third 400/110kV 200 MVA ICT has been approved.

2.7 Under the above circumstances, in order to increase the operational flexibility and also to meet the existing loads and future load growth, it has been proposed to enhance the 400/110 kV ICT capacity at Alamathy 400/230-110 kV SS from 2x200 MVA to 3x200 MVA.

3. Details of work:

Erection of 1 No.200 MVA 400/110 kV ICT with its associated switchgears and auxiliaries.

4. Estimated cost:

4.1 The estimated cost works out to Rs.1841.07 Lakhs (Gross) and (Nett) and the estimate is based on the TANTRANSCO cost data for the year 2019-2020. The rate for oil sump is based on the rate furnished by the field. The detailed estimate is annexed.
