Following the orders issued by the Government first read above, in the Proceedings second and third read above, among others, orders were issued fixing the eligibility criteria for sanction of quantum of Conveyance Advance for the purchase of Motor Car/Motorized two wheeler and enhancement of monetary limit at the rate of 5% over the previous years to the officials/employees of TNEB Limited and its entities.

2. The Government of Tamil Nadu in their orders fourth read above, issued orders enhancing the quantum of advance for purchase of Motor Cars and Motorized two wheelers considering as one of the better methods of increasing the consumption in the economy.

3. The adoption of the orders fourth read above, in TNEB Limited and its entities has been considered and resolved to adopt the said benefits, subject to all other conditions/orders in force for sanction of Conveyance Advance. Accordingly, it is hereby ordered that the following quantum of advance for the purchase of new Motor Cars is enhanced with the eligibility criteria as mentioned against each: -

Level 28 and above (Pay Band 4 and above) & All India Service Officers	Rs.14 lakhs
Level 21 to Level 27 (Pay Band 3)	Rs.10 lakhs

4. In respect of motorized two wheelers, the existing distinctions based on the capacity of the engine be hereby dispensed with and all officials/employees in time scale of pay shall be eligible for a uniform maximum ceiling of Rs.1,00,000/- (Rupees One Lakh only) for all categories of motorized two wheelers.

5. The revised norms issued above will be subject to the following conditions:

- If the actual value of the car or two wheeler purchased is below the ceilings prescribed above, the admissible advance, will be restricted to the cost of the vehicle including taxes, registration and insurance.
- As already done in the case of two-wheelers, no advance shall be given for the purchase of second hand motor cars.
- The revised ceilings prescribed above are applicable for the year 2020-2021. For every subsequent year, the ceiling shall be automatically enhanced by 5% over the previous year.

- ii) Rs.12,50,000/- (Twenty Lakhs and Fifty Thousand only) for enlargement/ improvement of existing living accommodation (within the overall ceiling of Rupees Twenty Five Lakhs)

2. The Government in the orders third read above, issued orders enhancing the ceiling limit towards House Building Advance from Rs.25,00,000/- (Rupees Twenty Five Lakhs only) to Rs.40,00,000/- (Rupees Forty Lakhs only) subject to certain condition thereon.

3. The adopting of the Government orders third read above, for the officials/ employees of TNEB Limited and its entities has been considered and resolved to adopt the said benefits, subject to all other conditions/orders in force for sanction of House Building Advance. Accordingly, it is hereby ordered that the existing ceiling of the House Building Advance be enhanced as follows:-

Partly for purchase of land and partly for construction of a house thereon, or for construction of a house or for purchase of Ready Build House/Flat from Rs.25,00,000/- to 40,00,000/- (Rupees Forty Lakhs only) to the officials/employees of the TNEB Limited and its entities.

4. The enhanced ceiling of House Building Advance will come into force with effect from the date of issue of this order. iv) In respect of enlargement/improvement of existing living accommodation, the ceiling shall be 50% of the overall ceiling limit of Rs.40,00,000/-.

All other conditions/orders in force shall be followed for sanction of the House Building Advance.

1. The CMD/TANGEDCO has approved the online application filing of name transfer in respect of LT service connections through TANGEDCO Web Portal applicable to entire Tamil Nadu.

2. To make the name transfer process simple and to avoid time delay, it has been decided that section officer himself may receive the online applications for name transfer in respect of all tariff categories and effect the name transfer.

3. In this connection, the simplified procedure to be adopted of name transfer of LT service connections is give below for implementation:

The applicant seeking Name Transfer shall submit the following:

- a. **Name Transfer due to sale/partition/settlement/gift of the premises, etc.**

- i) Buyer/Transferee shall apply online along with Undertaking by Buyer/Transferee (Form-4) and consent letter by Seller/Transferor (Form-2).
- ii) In case Seller/Transferor is not available, the Buyer shall apply online along with the recent Property Tax receipt along with Undertaking by Buyer/Transferee (Form-4). In case of non-availability of property tax receipt, then, only one document mentioned in the TN Electricity Supply code shall be obtained. More than one document need not be insisted.

**b. Name Transfer due to death**

- i) The applicant shall apply online along with recent property tax receipt, Undertaking as per Form-4 and Indemnity bond as per Form-3.
- ii) On receipt of soft copies of applications and supporting documents through web and on payment of necessary charges, name transfer should be effected by the section officer concerned based on the documents furnished by the applicant immediately on the same day.

4. The process flow of name transfer is detailed below:

1. The applicant has to fill the required details such as name of the applicant, address, mobile No., e-mail id, Name of the present owner of the service connection, service connection number, etc.
2. An OTP/message would be received in earlier registered mobile number (for that particular connection) and the new mobile number registered for further processing of name transfer.
3. The Applicant has to furnish the Aadhar No. as Identity Proof. In case Aadhar card is not available, then other ID Proof such as PAN card, Ration Card, Diving License has to be furnished.
4. On submission of the application, 'Acknowledgement Form' would be generated along with the 'Application Reference Number'. Web links to print the submitted application form and 'Acknowledgement Form' would be provided in the portal.
5. Subsequent to submission of the application, the charges for name transfer shall be paid by the applicant through the TANGEDCO URL <https://www.tnebnet.org/awp/login> immediately.
6. On receipt of soft copies of applications and supporting documents through we and on payment of necessary charges, name transfer should be effected by the section officer concerned based on the documents furnished by the applicant immediately on the same day and the name transfer shall be communicated to the applicant with the following conditions:

*"As per your application for name transfer of the service connection No..... Tariff..... Now standing in the name of Thiru.....(Name of the old owner of the service connection) of.....(address of the service connection) is hereby transferred in your name Thiru.....(applicant name) with the existing current consumption deposit of Rs.....with effect from..... (Date of name transfer).*

*Necessary white meter card in your name Thiru.....(applicant name) shall be obtained in the collection centre at.....(Place of the collection centre of the concerned section)*

*The order issued is for the purpose of name transfer of the electricity service connection only and it should not be cited as a legal document or for any other purpose. All the future bills will be issued in your name with effect from the date of this order.*

*You shall be asked to furnish the additional documents, if required in connection with the name transfer on later date, failing which the name transfer order will be cancelled and will be reverted to the original name.*

*Please note that the undersigned shall have full rights to cancel the above name transfer order at any time if it is proved that any of the records produced by you in connection with this name transfer is found to be false”.*

7. Subsequently, the documents furnished by the applicant would be scrutinized by the section officer concerned within 3 working days from the date of effecting name transfer. If any discrepancies are noticed, then the details would be entered in the system by the section officer concerned and a notice would be generated to intimate (through notice/e-mail/SMS etc.) the applicant about defects immediately. The applicant shall also be informed that if the required documents are not re-submitted within the 7 working days from the date of receipt of intimation about defects, the name transfer order will be cancelled and the name transfer of the service connection will be reverted to the original name.
  8. The defective application received through the web would be listed for editing and uploading of relevant documents by the web portal user using the application reference number. However, if the documents are not re-submitted within the 7 working days, the name transfer order will be cancelled and reverted to the original name with due intimation to the applicant through notice/e-mail/SMS etc.
  9. The soft of the connected papers along with the name transfer order will be sent to the Revenue Branch for record and to obtain necessary signature of the Executive Engineer concerned in the LT agreement forms wherever required through online mode.
  10. The section officer concerned who effect name transfer shall ensure that all the dues of the TANGEDCO pertain to the service connection such as previous dues pertaining to the service connection if any, fresh security deposit if applicable, ACCD, etc. is collected before effecting the name transfer.
  11. The entire process of verification of the name transfer shall be completed within 7 days from the date of receipt of complete online application in complete shape along with payment of applicable charges.
  12. RTR need not be taken by the section officer while effecting Name transfer since there is no provision in the TNE Supply Code to obtain the same.

Online application filing in respect of HT application was implemented in TANGEDCO vide reference (1) cited above and subsequently mandated from 15.07.2017 vide reference (2) cited. Now to facilitate Ease of Doing Business, to encourage rapid Industrial growth, as well as to avoid delay in effecting supply and to achieve consumer satisfaction, the applications are being applied through the TANGEDCO Web portal as well as Single Window Portal. The revised process flow to be adopted for handling the New Service/Additional/Reduction of load applications in respect of HT Service is given below:

### **STAGE 1: Application Submission**

1. The applicant has to open the TANGEDCO's web-portal ([www.tangedco.gov.in](http://www.tangedco.gov.in)) or login through the State Government's Single Window portal ([www.easybusiness.tn.gov.in](http://www.easybusiness.tn.gov.in)) for e-filing the HT application.
2. The applicant has to fill in the required details in Form 4 prescribed by TNERC, (Enclosures as per the amended TNERC notification) upload the supporting self attested documents as prescribed in the Tamil Nadu Electricity Distribution Code. The photo and the signature of the applicant shall be scanned and uploaded and the application e-submitted through the web portal.

On e-submission, an application reference number will be generated which contains the information of Region code, HT CODE (909), Circle code, date of application and time stamp and a mail shall be sent to the applicant informing that the application has been acknowledged.

3. Hard copies of the documents shall not be insisted.

### **STAGE 2: Queries raised on the application**

The application along with the documents uploaded through web portal have to be scrutinized by the circle office at this stage. After due scrutiny, queries (if any) may be raised at this stage. Query may be single or multiple but the queries shall be raised only once within 7 working days from the date of (Acknowledgement) receipt of application (Intimation by mail to applicant). No query can be raised after 7 days. If no query is raised within 7 working days then automatically the application will be deemed to be verified and accepted.

### **STAGE 3: Application Resubmission**

The applicant has to resubmit the application through web portal after rectification of discrepancies. The last date for resubmission of application will be seven working days from the last date of query raising period (7 working days). If the applicant fails to reply within this due date or queries not rectified, then the application shall be cancelled, and the applicant shall be intimated suitably.

### **STAGE 4: Inspection to be intimated to the Applicant.**

The application can be marked as verified and accepted.

An intimation mail will be sent to the applicant at this stage automatically. Inspection shall be carried out within 3 working days from the date of acceptance of application.

Probable date of inspection should be intimated to the applicant through mail for inspection of site and verification of metering point.

If the distance from the metering point is not within the norms for New/ Additional/Reduction in demand applications, a mail should be sent to the applicant for rectification of metering point.

In Inspection screen the only option to be selected is "Is prior approval of Head Quarters required" with drop down provisions.

The application shall be placed in "Put on Hold Condition" for the following cases only,

- a. If the consumer opts for higher levels of voltages for demands less than that specified.

- b. Critical issues based on Court order.
- c. Policy Decision.
- d. Others please specify.

If option selected is 'NO', then demand (Registration and EMD Charges) shall be raised automatically. If option select is 'YES' then the demand shall be raised only on submission of approval. The application shall not be placed on Hold condition without any valid/Genuine reason.

#### **STAGE 5: Demand for Application Registration Charges and EMD**

On exceeding 3 working days, the application will be deemed to have been inspected and a demand notice will be generated in the portal for payment of application Registration Charges and EMD charges. An intimation mail will be generated and sent to the applicant.

#### **STAGE 6: Registration and EMD charges payment**

- The Registration and Earnest Money Deposit (EMD) charge should be paid by the applicant within 15 days from the date of issue of demand notice.
- On payment of above charges, the HT applicant will be registered on the same day and the registration No will be intimated to the applicant through E.Mail. The facility for the on-line payment of the charges towards the HT New Service Connection application has been enabled through Indian Overseas Bank and Tamil Nadu Mercantile Bank at present. As and when this facility is extended to other banks, the same may be availed by the HT applicants of all categories.
- The probable date of effecting of supply shall be defined based on the nature of works as per TNERC Distribution Standards of Performance (DSOP).
- Necessary load sanction and administrative approval should be initiated at this stage as per norms.
- No extension of time for payment of Registration fee and EMD charges shall be allowed.
- If the Registration fee and EMD is not paid within 15 days, the application would become null and void automatically and intimation sent to the applicant. The applicant has to submit a new application through on line again.
- For EHT application, a intimation mail will be sent to CE/Planning &RC.

#### **STAGE 7: Estimate preparation/Load sanction/Administrative/Technical sanction**

The Administrative Approval/Load sanction/Technical sanction shall be issued within 15 days from the date of Registration.

The feasibility study report shall accompany with the estimate sanction.

#### **STAGE 8: Demand for Estimate Charges**

After estimate sanction, the demand (Amount auto generated, Fixed cost on demand and estimate charges if any) shall be raised for the payment of estimate charges and other applicable charges. An email intimation displaying the details of demand will be sent to the applicant. The HT agreement shall be uploaded by the applicant and the same shall be downloaded and uploaded by DFC duly signed by the SE/EDC concerned. The estimate charges and other miscellaneous charges should be paid/agreement executed within 15 days from the date of intimation on payment of charges and the signed agreement shall be made available before moved to the next stage of processing.

#### **STAGE 9: Estimate charges – time extension for payment**

The Superintending Engineer/Gobi EDC vide reference cited has sought clarification on assessing the demand in respect of group housing applications constructed with asbestos roofing.

2. In this connection, the following points are to be considered:

- a) Instruction was issued vide (Per) (CMD) TANGEDCO Proceedings No.481 Dated 11.09.2017 to assess the demand of the group housing project. Further, instruction was issued vide Memo No.CE/Coml/SE/EE3/AEE3 / F.Online Appln./FLM-CM/8/2020, Dated 08.12.2020 for classifying the group housing applications. As per the above instruction, minimum 4 Nos. applications (services) were classified under 'Group Housing Category' and the 'Group Housing Category' applications between 4 to 20 Nos. will be listed in the AE user and more than 20 Nos. will be listed in the EE user.
- b) In certain cases of Group housing, the requirements for each dwelling units varies from 2 kilowatts to 15 kilowatts. In the LT billing module in respect of group application, minimum allowed load as per the above proceeding is considered and based on that the development charges is calculated. The development charges calculated is not proportionate to the load requirements and consumers have protested fro excess levying of development charges. In the clarifications sought by the SE/Gobi EDC, the group houses are small with asbestos roofing and the power requirement is only in the range of 2 kilowatt to 5 kilowatt for each house.
- c) In this connection, it is to be noted that in order to get land for establishment of sub-station and to follow uniform methodology of adoption, TANGEDCO Proceedings was issued vide (Per) (CMD) TANGEDCO Proceedings No.481 Dated 11.09.2017 for demand calculation of group housing project. The above Proceeding was issued mainly for getting land for establishment of sub-station inside the premises when the total demand exceeds 5 MVA.
- d) Further, instruction was also issued vide Memo No.CE/Comml/SE/Comml/EE3/AEE3/F.Group Housing/D.35/2018, Dated 06.02.2018 exempting the Slum Clearance Board of Government of Tamil Nadu from the applicability of the above proceeding in calculating the demand of their housing project since occupants of the group housing of the slum clearance buildings would not have the electrical appliances to the effect mentioned in the above proceeding.

3. In view of the above, the field officials are hereby instructed that the TANGEDCO Proceeding need not be considered for demand calculation in respect of group housing applications pertain to the small houses with asbestos/thatched/metal sheet roofing and /or when the total floor area of the building is less than 900 SQM (If the total floor area of the building is 900 SQM and above and/or if the total demand of the building exceeds 112 kW, the applicant has to provide space for erecting DT). The field officials in the above cases may assess the correctness of the demand furnished by the applicant depending upon the site conditions.

Towards Ease of Doing Business (EoDB) for Business Reform Action Plan (BRAP 2020), the Department of Promotion for Industry and Internal Trade (DPIIT) has asked states to integrate the starting process of Mutation with registration process and allow intimation of mutation as soon as the deed is registered (including land records Office, ULBs, Utilities) so as to comply with one of reform Point No.78 out of 13 Nos Reform Points with respect to TANGEDCO. The Reform Point is reproduced below,

**“Reform 78:** Publish an online dashboard available in public domain updated regularly (weekly/fortnightly/monthly) for application submission & approvals for mutation (at land records, utilities, ULBs). The dashboard should clearly highlight the number of mutations done and the time taken for approval (Mean/ Median)”.

With regard to the above, the following are Stated :

(i) As per the online provision made in the Inspector General of Registration (IGR) Department, it is informed that on Completion of property registration transaction, the property registration details will be shared to the TANGEDCO portal based on the consent of the Owner of the property for effecting name transfer. (ii) To comply with the Name Transfer requirements by TANGEDCO, necessary changes to TANGEDCO’s online systems is to be made to take in details from Inspector General of Registration (IGR) and to provide a service for name transfer process. (iii) Till making online provision for Name Transfer, the following are informed for effecting Name transfer after property Registration is over.

(1) Since, sending complete Registration documents by the IGR to departments will require more server and infrastructure (size is more), the details on the nature of document alone will be shared to TANGEDCO portal and No physical documents is shared. Hence TANGEDCO will receive only the nature of document on property Registration. Till making online provision for Name Transfer, the date from IGRS could not be processed through Online.

(2) However, as a temporary measure in order to comply with the Reform Points in EoDB, to effect Name transfer for the requests received from IGR, the following procedure shall be followed till making Online provision of Name transfer so as to comply with the Reform points in Ease of Doing Business (EoDB).

(i) Online dashboard will be displayed in TANGEDCO website.

(ii) All the Chief Engineer's and Superintending Engineers are requested to follow the procedure stipulated below

(a) To Process the Name Transfer applications received from the IGR department, based on the validation of Consumer number for both (HT and LT) through offline mode till provision of implementation of Online system for processing of Name transfer applications.

(b) Hence, the details with respect to HT consumer (based on validation) will be linked to Superintending Engineer/EDC's (User) concerned and the details with respect to LT consumer (based on validation) will be linked to the Assistant Engineer/ Section Office (User) concerned.

(3) Upon receipt of the details, the applicant (present owner of the property as per IGR report) shall be intimated to furnish the application along with the required fees for effecting name transfer. Being a Name Transfer based on sale deed, no additional documents shall be insisted from the purchaser/applicant other than the details as received from IGR. However, any outstanding dues in the above service connection shall be collected. Any queries raised on the application and the status of application shall be made known to the applicant.

(4) Name transfer shall be effected only for the service which stands in "LIVE" condition. The existing procedures (offline) for effecting Name Transfer shall be followed as per the existing procedures in vogue and instructions issued time to time in this regard.
