TANGEDCO – Secretariat Branch – Pensioners/Family Pensioners – Furnishing of Life Certificate, Non-employment Certificate and Non-remarriage/Non-marriage Certificate by the Pensioners/Family Pensioners – Exemption from Annual Mustering Process for the year 2021 as a special case due to Covid-19 – Orders issued by the Government of Tamil Nadu – Adoption in TANGEDCO – Orders – Issued.

PROCEEDINGS:

Based on the orders of the Government of Tamil Nadu, orders were issued allowing the pensioners/family pensioners to give their Life Certificate at any time during the months of "July, August and September" "every year" for annual mustering instead of "April, May and June" to the Pension Disbursing Office concerned – vide Proceedings first read above. If any pensioner including family pensioner fails to do so, the Pension Disbursing Authority shall call for the personal appearance in October and pension/family pension will be stopped from November onwards for those pensioners including family pensioners who neither appear directly for mustering nor furnish life certificate. The payment of pension/family pension/exgratia will resume only

on production of the said certificates or the pensioner appearing in person before the Chief Internal Audit Officer or the respective Regional Deputy Chief Internal Audit Officer.

- 2. Further, based on the orders issued by the Government, orders were issued exempting the "Annual Mustering Process" for the year 2020, as a special case due to Covid-19 considering the extra-ordinary circumstances imposed by the Covid-19 Pandemic and the fact that pensioners/family pensioners/Exgratia beneficiaries, being senior citizens, fall among the most vulnerable category with respect to risk of exposure to Covid-19.
- 3. Subsequently, based on the clarifications issued by the Government, orders were issued in the Memo third read above that both the **personal appearance** of pensioners/family pensioners as well as **furnishing** of **Life Certificate**, were exempted from **Annual Mustering Process** for the **year 2020**.
- 4. In the Government Order fourth read above, the Government have issued orders to accord temporary exemption of the Annual Mustering Process including furnishing of Life Certificate for the year 2021 as a special case, considering the current pandemic situation in respect of the pensioners/family pensioners of Government of Tamil Nadu. The same has been considered for adoption in TANGEDCO.
- 5. Accordingly, it is hereby ordered that the pensioners/family pensioners and exgratia beneficiaries of TANGEDCO, be temporarily exempted from Annual mustering Process including furnishing of Life Certificate for the year 2021 as a special case, considering the current pandemic situation.
