In view of the second wave of COVID-19 and lock down since 10.05.2021 4:00 A.M to 24.05.2021 04:00 A.M, considering the difficulties faced by the LT consumers of TANGEDCO, it was instructed to provisionally adopt previous month billing (PMC billing) (i.e. amount based on May 2019/March 2021, as the case may be) vide ref (i) cited for all LT services whose reading date fall during the above period.
