Recruitment – Appointment of Thiru K.Ramalingam as Field Assistant (Trainee) in Direct Recruitment 2016-2018 based on the orders of the Hon'ble High court of Madras and Supreme Court of India by relaxing upper age limit as a special case - Orders – Issued.

PROCEEDINGS

In the proceedings first read above, orders have been issued for Direct Recruitment of 900 posts of Field Assistant (Trainee) along with other posts. Accordingly Notification No.1/2016 Dated 28.02.2016 have been issued inviting applications through Open market, wherein the maximum age limit have been specified as 35 for SC/SC(A)/ST, 32 for BC/MBC/DC/BCM & 30 for others as per regulation 91 (2) (C) and age relaxation have been given to those who have obtained higher than the minimum general educational qualification as per 91 (2) (d) of Service Regulation.

- 2. Meanwhile several writ petitions were filed seeking relaxation of upper age limit and to allow them to participate in the competitive written Examination to the post of Field Assistant (Trainee). In the said cases the Hob'ble High Court have ordered to allow them to appear for competitive written Examination subject to the outcome of Writ Petitions/Writ appeals. As per the said orders the petitioners were allowed to appear in the competitive written examination and further selection process. The selection to the post of Field Assistant was made as per the merit of the marks in competitive written Examination, interview and academic marks and as per the rule of reservation (Roster system). The orders of selection to the selected candidates were issued on 29.01.2018. However, the selection in respect of 6 candidates including Thiru K.Ramalingam (One of the petitioner in W.A.No.1045 of 2016) who were allowed to appear for the competitive written Examination as per the interim orders even though have reached the Zone of selection were withheld subject to the outcome of Writ Petition and Writ Appeal.
- 3. In this regard, the Hon'ble High Court of Madras in its judgment Dated 10.01.2020 in the W.A.No.1045 of 2016 has directed TANGEDCO to issue appointment order in favour of Thiru K.Ramalingam, S/o.M.Kulanthaivelu and the Hon'ble Court among other things has ordered as follows:

"In view of the peculiar circumstances of the case, we have exercised our extraordinary jurisdiction under Article 226 of the Constitution of India and such direction will not, in any way, affect the merits of the contentions which may be raised by the respondents Corporation in such other cases and will not act as a precedent for such other cases at all.

4. Further, SLP (C) No.4680 of 2016 filed by the TANGEDCO against the W.A.No.1045 of 2016 was dismissed by the Hon'ble Supreme Court on 05.07.2021 stating that the Hon'ble High Court in the peculiar facts and circumstances of the case has directed to issue appointment order to Thiru K.Ramalingam by exercising its discretionary jurisdiction.

5. Accordingly a proposal was placed in this regard, approval is accorded to appoint Thiru K.Ramalingam, S/o Kulanthaivellu, as Field Assistant (Trainee) as a special case by relaxing he upper age limit as per the order of the Hon'ble High Court of Madras made in Writ Appeal No.1045 of 2016 and later justified by the Hon'ble Supreme Court order in Special Leave petition (Civil) No(S).4680/2021. Further, this case cannot be treated as a precedent as per the orders of the Hon'ble High Court.

PROCEEDINGS

In his letter read above, the Director (Generation)/TANGEDCO has stated that the NCTPS-II, Turbine Maintenance division and Ash handling division are under the control of Superintending Engineer/Mechanical Maintenance-II and they are two major critical zone where enormous and heavy volume of works are involved. Turbine Maintenance is a core division without which the plant could not run and Ash handling division is completely involved with environment, safety, health and evacuation of ash is a tedious task which has to be continuously carried out, failing which the generation could not be carried out. Hence, he has requested to approve for reallocation of works (duties and responsibilities) of the following areas on the basis of mutual work load sharing for better administration and ease of maintenance works since Boiler & Turbine coming under single head will prove to perform better control than distributed workloads. As such, there will not be any financial implication over this.

- 1. Turbine Maintenance division presently under Superintending Engineer/ Mechanical-II circle reallocated to Superintending Engineer/Mechanical-I Circle.
- 2. Areas from Intel gate of ESP ducts to outlet gate of ESP ducts presently under Mechanical-I Circle reallocated to Mechanical-II Circle in addition to the Ash evacuation system being looked after
- 3. Areas related to APH & ECO hoppers reallocated to Mechanical-II Circle.
- 2. The Direction (Generation)/TANGEDCO has, further, suggested that, in order to have effective control, performance and administration, Executive Engineer/Electrical post now looking after Turbine Maintenance Division and transferred to Office of the Superintending Engineer/Mechanical-I Circle may be re-designated as Executive Engineer/Mechanical. Instead one number Executive Engineer/Mechanical/Generation (Shift)/NCTPS-II post may be re-designated as Executive Engineer/Electrical/Generation (Shift). In fine, he has requested to issue suitable orders in this regard.

3. The above proposal has been examined in detail and it has been decided to accept the same. Accordingly, it is hereby ordered that the following reallocation of works between office of the Superintending Engineer/Mechanical-I Circle/NCTPS-II and the Office of the Superintending Engineer/Mechanical-II Circle/NCTPS-II.

The quantum of Bonus and Ex-gratia payable for the financial year **2020-2021** to the Workmen of the TANGEDCO covered by the Wage Settlement has been considered in consultation with Government. The ceiling limit for Rs.3,500/- payment of Bonus and Ex-gratia has been enhanced to Rs.7,000/- as per the Revised Bonus Act, 2015. In the Government Order second read above, the Government have accorded sanction for payment of Bonus and Ex-gratia to the employees of the State Public Sector Undertakings.

- 2. In pursuance of the above Government Order, it is hereby ordered that the workmen of the TANGEDCO covered by the Wage Settlement, be paid a Bonus calculated at the rate of 8.33% of the salary (or) wage earned by them during the financial year **2020-2021**, subject to and in accordance with the provisions of the Payment of Bonus Act, 1965 and as amended under the revised Bonus Act, 2015.
- 3. The workmen of the TANGEDCO (monthly paid and full-time workmen), Helper (Trainees), Office Helper (Trainees), Assessors (Trainees), Mazdoor (Trainees) appointed with the time scale of pay and Gangman (Trainee) appointed on consolidated wages and also the workmen of the State Government, Central Government and other organizations, who had worked with Board on deputation during the financial year **2020-2021** drawing a salary (or) wage, including those drawing pay exceeding Rs.21,000/-per month, will be eligible for the Bonus sanctioned in para-2 above.
- 4. The Part-time Sweepers and Sanitary workers who are getting the time scale of pay during the financial year **2020-2021**, drawing the salary (or) wage, are also eligible for the Bonus sanctioned in para-2 above.
- 5. It is also ordered that the workmen of the Board covered by the Wage Settlement and the deputationists, entitled to get Bonus with reference to the orders in paras 2,3 and 4 above, shall also be paid an Ex-gratia at the rate of 1.67% of the salary (or) wage earned by them, during the financial year **2020-2021**.
- 6. The contract labourers who have been absorbed as Mazdoor (Trainee), during the year **2020-2021** are eligible only for the Bonus and Ex-gratia in a proportionate manner for the period they had worked in the above post. Further, where the salary (or) wage of a workman entitled to Bonus exceeds Rs.7,000/- (Rupees Seven thousand only) per mensem, the Bonus payable to such workman shall be calculated as if his salary (or) wage is Rs.7,000/- (Rupees Seven thousand only). The maximum Bonus amount payable shall be Rs.6,997/- (Rupees Six thousand Nine hundred and ninety seven only).
 - Salary (or) wage for the purpose of payment of Bonus will include the following:

- (a) Basic Pay-Leave SalarY;
- (b) Dearness Pay;
- (c) All classes of special pay (including Short hand and Typewriting Special Pay);
- (d) Personal Pay;
- (e) Additional Pay for additional charge;
- (f) Additional days wage paid for work on National Holidays and Festival Holidays;
- (g) Dearness Allowance;
- (h) Personal Compensatory Allowance given for protecting loss of pay; and
- (i) Deputation Allowance.

The term 'Salary' or 'Wage' will not include Interim Relief, over-time pay and allowances and any pay and allowance other than those mentioned from (a) to (i) above. Salary (or) Wage for the leave surrendered by an employee during **2020-2021** should not be taken into account for computation of Bonus.

- 8. All the workmen, who had worked in the establishment for not less than thirty working days in the financial year **2020-2021**, are entitled to the payment of Bonus.
- 9. The Ex-gratia amount payable shall be Rs.1,403/- (Rupees One thousand Four hundred and three only). This Ex-gratia will be reduced on actual basis if a workman had not worked on all the working days in the financial year **2020-2021** as per the provisions of Section 13 of the Payment of Bonus Act, 1965 and amended in Revised Bonus Act, 2015.
- 10. The Bonus and Ex-gratia payable to Workman shall also be calculated, as if his/her salary (or) wage is Rs.7,000/- (Rupees Seven thousand only) per mensem. Under this method, the Bonus and Ex-gratia amount payable shall be Rs.6,997/- and Rs.1,403/- respectively. The Bonus and Ex-gratia payable to a Workman shall not exceed R.8,400/- (Rupees Eight thousand and Four hundred only) for the full year.
- 11. The TANGEDCO also directs that the workman, who is now under suspension, but was on duty during the financial year **2020-2021**, also be paid Bonus for the year 2020-2021 subject to the conditions mentioned above.
- 12. If, during any part of the financial year **2020-2021**, a workman covered by the Wage Settlement was promoted to officer category, he/she shall also be paid the Bonus in a proportionate manner for the period he/she had worked in the workmen category.
- 13. The workman covered by the Wage Settlement, who had worked in the financial year **2020-2021** fully (or) partly, but had retired (or) died subsequently shall be paid the Bonus fully (or) proportionately, as the case may be to the legal heir of the deceased.
- 14. The expenditure on the payment of Bonus shall be debitable to the following head of account. "TANGEDCO Funds-Revenue Expenses Account No.75.501" and the expenditure on the payment of Ex-gratia shall be debitable to "Account No.75.502".
- 15. The TANGEDCO also directs that the Bonus payment for the year **2020-2021** should be disbursed immediately by cashless mode of Electronic Clearance System (ECS) to all the eligible employees of TANGEDCO on **29.10.2021**.

- 1.0 Hon'ble TNERC has issued certain amendments in Tamilnadu Electricity Supply code in regulation 5, in sub regulation (3) and the same has been published in Tamil Nadu Government Gazette No.32 Dated 05.08.2020 in respect of Shifting of agriculture service connection.
- 2.0 In this regard, following instructions are issued in respect of shifting of agriculture service connection.

A. Salient features of TNERC amendment:

- Shifting of an existing agricultural service connection may be permitted within TANGEDCO jurisdiction.
- The charges of dismantling in the existing location and erection in the newly proposed location towards shifting shall be borne by the consumer under Deposit Contribution works (DCW) basis.
- Shifting is permissible after one year from the date of effecting the service connection in the existing location or from the date of previous shifting if any.
- The applicant should have ownership in the well and service connection in the existing location and the ownership of the well in the proposed location.
- The well at the existing location owned by co-owner(s) should be having separate service connection(s). If the well at existing location is owned by co-owners, but not having separate service connection(s), the consent of co-owner shall be obtained and enclosed with the application.
- The well and service in the original location should be owned by the applicant(s) on the date of application and they should continue to be owned by the applicant(s) till the date of shifting the service to new location.
- Shifting of service shall be considered irrespective of reasons put forth by the consumer.
- Shifting of service shall be considered even if the well/bore ceased to exist in present location.
- Shifting of service shall be considered even if the land alone is sold for non agricultural purpose, retaining well and service.

B. Competent authority to approve the shifting proposal:

- If shifting is within the Circle Approval to be accorded by the concerned SE/EDC irrespective of Shifting within the Section/Sub-Division/Division.
- If shifting is within the Region Approval to be accorded by concerned Chief Engineers/Distribution.
- If shifting is from one Region to another Region Approval to be accorded by the Director/Distribution.
- 3.0 All the relevant documents to be obtained and verified before processing the application.

- 4.0 Shifting estimate to be prepared under DCW category for the Agriculture service connection shifting from existing location to the proposed location after observing all the standard procedures existing in vogue.
- 5.0 It should be ensured that no court case/dispute/any arrears are pending before effecting the shifting.
