

**MEDICAL ATTENDANCE—Reimbursement of Medical expenses—Countersignature of Civil Surgeon—Raising the ceiling on claims from "One month's Basic Pay" to "One month's Basic Pay and Dearness Allowance"—Orders issued.**

**Proceedings :**

The Government of Tamil Nadu have ordered that the present criterion of "One month's Basic Pay" for the production of a Certificate from a Civil Surgeon/Specialist be enhanced to "One month's Basic Pay and Dearness Allowance."

2. The Government have also issued the following clarifications :—

- (i) Whenever the sanctioning authority ask the individuals to obtain a certificate from the Civil Surgeons/Specialist for having exceeded one month's Basic Pay, it is enough that the Certificate is Countersigned by the Civil Surgeon/Specialist. While Countersigning, it is enough that the personal seal of the Civil Surgeon/Specialist is affixed in the Essentiality Certificate.
- (ii) If the claims pertaining to the previous year are sanctioned in the subsequent year, the individual need not be asked to obtain a Certificate from the Civil Surgeon/Specialist. However, the question of insisting on the production of the Certificates from a Civil Surgeon/Specialist arises when the total claims in the subsequent year exceeds one month's Basic Pay of the claimant.
- (iii) It is not necessary to ask the individual to obtain a Certificate from the Civil Surgeon/Specialist from where the Authorised Medical Attendant is working. The Civil Surgeon/Specialist can be attached to any Government Medical Institutions.

3. The Tamil Nadu Electricity Board has decided to adopt the above Government Order and hereby directs that the present criterion of "One month's Basic Pay" for production of a Certificate from a Civil Surgeon/Specialist for claiming medical re-imbursment in excess of one month's Basic Pay be enhanced to "One month's Basic Pay and Dearness Allowance" in respect of the employees of the Board also.

4. The clarifications issued by the Government and mentioned in para-2 above also will be applicable to the employees of the Tamil Nadu Electricity Board.

5. The Orders in the Board's Memoranda No. 28250/B2/78-1, dt. 28—7—78 and No. 47900-B2/78-1, dt. 15—11—78 will stand modified accordingly.

6. The Orders will take effect from the date of these Proceedings.
