MEDICAL AID - Constitution of a Fund to render grant/loan assistance to employees of T.N.E.B. and their dependant family members for Surgery/Treatment - Orders issued.

PROCEEDINGS :

In the G.O. first cited, the Government of Tamil Nadu have constituted a Fund known as "Government Employees Health Fund" to provide a measure of relief by way of grant/loan to the Government employees struck by major ailment so as to enable them to undertake surgery/treatment like Coronary bye-pass surgery and renal transplantation. In the G.O. second cited, the scheme has been extended to the dependant family members of the Government Employees and the quantum of assistance has also been increased. Following the orders of the Government, the Tamil Nadu Electricity Board has decided to constitute a 'Tamil Nadu Electricity Board Employees Health Fund' to provide similar relief to the employees of the Tamil Nadu Electricity Board and their dependant family members struck by major ailment and who require treatment/surgery.

2. This fund will be utilised to extend grants/loans for major remedies/surgeries which cannot be undertaken in Government Hospitals. Each employee of the Board will contribute a sum of Rs.5/- per annum. The Tamil Nadu Electricity Board will extend a contribution of Rs.10,00,000/- (Rupees ten lakhs only) per annum to build up the Fund. The Tamil Nadu Electricity Board, accordingly, sanctions Rs.10,00,000/- (Rupees ten lakhs only) towards its contribution to the Tamil Nadu Electricity Board Employees Health Fund.

3. The annual subscription of Rs.5/- from each employee for the year 1993-1994 will be recovered from their salaries for the month of May 1993. The annual subscription will be recovered from the salary for June in subsequent years.

4. The Chief Financial Controller will administer the scheme in the foregoing paragraph. The transactions will be subjected to audit by the Chief Internal Audit Officer and to cost audit by the Accountant General/Residential Audit Officer, Tamil Nadu Electricity Board.

5. (a) The annual subscription of Rs. 5/- recovered every year and Board's contribution of Rs. 10,00,000/- besides the recoveries from the beneficiaries shall be credited to a new Head of account, viz. 57-165-Tamil Nadu Electricity Board Employees Health Fund (Receipts)

(b) The Board's contribution to the Fund shall be debited to a New Head of Account, viz. 75-713 Board's contribution to Tamil Nadu Electricity Board Employees Health Fund.

(c) Sanction of the assistance to the employees of the Board for their/their dependant family members' surgery/treatment shall be debited under viz. 57-165 Tamil Nadu Electricity Board Employees Health Fund (out go)

(d) Sanction of loan to the employees of the Board under this scheme shall be debited to Loans and Advances account Code No. 27-108.

6. The Chief Financial Controller shall be the estimating, reconciling and the controlling authority for the Head of account.

7. No schedules need be attached to pay bills for the deduction made nor separate accounts maintained therefor.

8. An entry shall be made in the Service Book of an employee to whom assistance is sanctioned, specifying the amount and recovery schedule (in the case of the loan)

9. The pay drawing officer's will be responsible for prompt recovery of subscription. The details of collection indicating the No. of persons from whom recoveries are made, the total amount collected with a certificate that subscriptions have been collected from all employees under his control shall be sent to the Chief Financial Controller by the Heads of Office.

10. The regulations framed for administering the scheme are appended to this order.

11. The regulations governing the fund shall be reviewed by the Board with reference to the facilities available in the Government Medical Institutions from time to time.
