PROCEEDINGS:

In the Board's Proceedings first cited, the Board has sanctioned the medical allowance of Rs.15/- p.m. in lieu of medical reimbursement scheme to the Board employees who wish to opt out of medical reimbursement scheme. This order came into force with effect from 1.9.89. In the reference third cited the rate of Medical Allowance was enhanced from Rs.15/- p.m. to Rs.30/-p.m. with effect from 1.4.94.

2. The Government have now enhanced the rate of Medical allowance from Rs.30/-p.m. to Rs.50/-p.m. with effect from 1.12.95 in their G.O. Ms. No. 927 (Salaries) Department dated. 14.12.95 with the usual condition that the existing Government servants who wish to opt for the medical allowance should exercise their option within a period of one month from the date of issue of these orders and that option once exercised will be final.

3. The Tamil Nadu Electricity Board after careful consideration, directs that the medical allowance of Rs.30/- per month be enhanced to Rs.50/- (Rupees Fifty only) per month with effect from 1-12-95. The existing employees of the Board who wish to opt for the medical allowance, should exercise their option within a period of one month from the date of issue of these orders. Option once exercised will be final.

4. The receipt of this B.P. should be acknowledged.


