PROCEEDINGS:

Following the Orders of the Government, the Board  
constituted a fund called "Tamil Nadu Electricity Board  
Pensioners' Health Fund" to provide financial assistance to  
the pensioners of the Board for undergoing the following  
surgery/treatments:-

- i) Open Heart Surgery.
  - ii) Renal Transplant.
  - iii) Cancer.
  - iv) Eye Surgery.
2. To this fund, a sum of Rs.5/- per annum was collected  
from pensioners and an equal amount was provided, as Board's  
contribution. A financial assistance of Rs.25,000/- or 75%  
of the actual cost of the treatment whichever is less was  
sanctioned to the pensioners to undergo the above surgery/  
treatment.
3. The subscription was later increased from Rs.5/- to  
Rs.10/- per annum without increasing the financial assistance.  
The Pensioners' Associations/Unions have represented for the  
enhancement of the financial assistance from Rs.25,000/- to  
Rs.50,000/- on par with Government of Tamil Nadu.
4. The Government in their G.O.Ms. No.587, Finance  
(Pension) Department dt. 9.10.98 have increased the contribu-  
tion towards Pensioners' Health Fund from Rs.10/- per annum  
to Rs.5/- per month from 1.10.1998.

5. The Tamil Nadu Electricity Board, after careful consideration, hereby directs that the annual subscription of Rs.10/- per annum towards contribution to the Tamil Nadu Electricity Board Pensioners Health Fund Scheme be enhanced to Rs.5/- (Rupees five only) per month and that the quantum of assistance be increased from Rs.25,000/- to Rs.50,000/- or 75% of the actual cost of treatment whichever is less, for undergoing special surgery/treatment with all other conditions stipulated in the earlier orders.

6. These orders shall take effect from the date of issue of orders. The enhanced subscription (i.e.) Rs.5/- per month will be recovered from the pensioners from the month of November 1999 by the Chief Internal Audit Officer/Board Office Audit Branch.
