PROCEEDINGS:

In the Board's Proceedings first read above, Orders were issued constituting the 'Tamil Nadu Electricity Board Health Fund' to provide financial assistance to the employees of the Board and their dependent family members, when they are affected with major ailments.

2. In the Board's Proceedings second read above, orders were issued enhancing the financial assistance from Rupees fifty thousand to Rupees one lakh or 75% of the actual cost of specialised advanced surgery/treatment whichever is less.

3. In the Board's Proceedings third read above, orders were issued constituting two committees (Committee I for Class I Officers and Committee II for other than Class I Officers) headed by Accounts Member so as to facilitate the proper sanction of the grant.

4. In the Board's Proceedings fourth read above, Orders have been issued for classification of specialised advanced surgeries/treatments including specialised eye surgeries/treatments under broad based groups.

5. In the Government Order fifth cited, the Government have directed that in respect of specialised advanced eye surgery/treatment, the maximum limit for sanction of financial assistance (for both eyes) under the Tamil Nadu Government Employees Health Fund Scheme shall be fixed at Rupees thirty thousand or 75% of the actual cost whichever is lower. The Tamil Nadu Electricity Board has decided to adopt the above orders of the Government to the Board.

6. Accordingly, the Tamil Nadu Electricity Board hereby directs that the maximum quantum of financial assistance of Rs. 30,000/- (Rupees thirty thousand only) or 75% of the actual cost whichever is less be sanctioned under Tamil Nadu Electricity Board Employees Health Fund Scheme 1993, in respect of following specialised advanced eye surgery/treatment (for both eyes) to the employees of the Board:

Specialised advanced Eye surgery/treatment:

- a) Surgery for detachment of Retina.
- b) Vitrectomy.
- c) Keratoplasty (Corneal Grafting)
- d) Laser treatment - Krypton Laser, Dye Laser, Argon Laser, Photo Coagulation.
- e) Linear Accelerator Therapy (for senile Macular Degeneration Tumour).

7. There shall be no change in the other existing rules and conditions.

8. This order shall take effect from the date of issue.

9. Receipt of these Board Proceedings shall be acknowledged.
