PROCEEDINGS:

1. In the Board's Proceedings second cited, orders were issued increasing the subscription from Rs.5/- per annum to Rs.30/- per annum to Health Fund Scheme and also for enhancing the Board's contribution from Rs.10 lakhs to Rs.25 lakhs or equal to the employees' contribution, whichever is less.

2. As large number of applications are being received from the serving employees of the Board for the grant of financial assistance, the total sum of subscription and Board's contribution are not sufficient to meet out the requirement. The Health Fund Scheme, which is helping the employees to get financial assistance for their ailments substantially, should render timely help. Hence, it was suggested to enhance the present subscription from Rs.30/- per annum to Rs.100/- per annum. Accordingly, discussions were held with all the Unions/Associations for the enhancement of annual subscription and most of them have agreed for the enhancement of the amount from Rs.30/- to Rs.100/- per annum.

3. The Board, after careful examination, approves the proposal of enhancement of subscription and directs as follows:-

- i) that the present recovery of annual subscription from an employee of the Board towards Health Fund Scheme be enhanced from Rs.30/- to Rs.100/- (Rupees one hundred only) per annum from the year 2001.
- ii) that the recovery of the balance subscription of Rs.70/- (over and above Rs.30/- already collected in June 2001) be recovered in two equal instalments from the salary of the employees for November 2001 and December 2001.

- iii) that the annual subscription of Rs.100/- shall be recovered from the salary of the employees for June in subsequent years.

4. There shall be no change in the procedure of collection of annual subscription ordered in the Board Proceedings first cited.

5. Receipt of this Board Proceedings shall be acknowledged.
