Sub: Health Fund Scheme - Subscription collected from the employees - Further instructions - Issued.

In the Memorandum cited, inter alia, it has been ordered that the annual subscription of Rs.100/- shall be recovered from the salary of the employees in the month of June.

2. In order to sanction financial assistance immediately to the employees who seek financial assistance under Health Fund Scheme, it has been decided in the Health Fund Scheme Committee Meeting held on 30.8.2003, to collect the annual subscription at the rate of Rs.100/- per annum on first April of every year instead of June.

3. Accordingly, it is hereby ordered that in future, annual subscription shall be recovered in the month of April of every year and recovery shall be effected from their pay in the month of March of every year payable on first April.

4. All Chief Engineers/Superintending Engineers shall send the fact of recovery to the Chief Financial Controller, Tamil Nadu Electricity Board before the end of April of every year.
