Memorandum (Permanent) No.11840/A17/A172/2006-10, dated 6.11.2007.

Sub: Medical Attendance Rules – Countersignature of bills by the Medical Officers attached to Primary Health Centres – Authorisation issued by the Government – Adoption in Tamil Nadu Electricity Board – Orders – Issued.

Ref: Board's Circular Memo.11840/A17/A172/2006-7, dated 16.5.2007.

In the Circular Memo. under reference, it has been instructed that the recovery, being made based on the audit objection from the employees, who have submitted medical reimbursement bills countersigned by the Medical Officers of Primary Health Centres, be withheld till a final decision is taken in the matter.

2. On scrutiny, it is found that the Government in its Memo. No.24051/H3/65-5, dated 27.5.1965, have already issued orders, authorizing the Medical Officers of Primary Health Centres to certify the medical reimbursement claims for reimbursement. Hence, it has now been decided to adopt the Government orders in the Tamil Nadu Electricity Board also.

3. Accordingly, it is hereby ordered that the Medical claims, preferred by the Board employees for reimbursement, obtaining countersignatures of the Medical Officers in Primary Health Centres may also be accepted as is being done in the case of other Government Medical Officers/Authorised Medical Attendants and wherever recovery has already been made based on the Audit Objection, the amount of medical reimbursement be claimed again and paid to the employees concerned.

4. The receipt of the Memorandum should be acknowledged.
