PROCEEDINGS:

Based on the orders of the Government, the Tamil Nadu Electricity Board implemented the New Health Insurance Scheme to the employees of Tamil Nadu Electricity Board and their family members with provision to avail assistance upto Rupees two lakhs with effect from 11.6.2008 and is in operation for the block period of four years upto 10-6-2012.

2) In the Government Order second cited, orders have been issued for providing health care assistance to the Government employees and their eligible family members for the period from 11-6-2012 to 30.6.2012 by making interim arrangements till the implementation of New Health Insurance Scheme, 2012 from 1.7.2012. It has also been ordered to other institutions already covered under the New Health Insurance Scheme 2008-2012 extend this health care assistance to their employees during the interim period from 11-6-2012 to 30.6.2012 from their own funds.

3) Based on the orders of the Government, Tamil Nadu Generation and Distribution Corporation Ltd. after careful consideration hereby accords sanction for providing health care assistance to Tamil Nadu Generation and Distribution Corporation Ltd. employees and their eligible family members for the period from 11-6-2012 to 30-6-2012 with the following arrangements:-

- 1) The TANGEDCO employees shall submit claims for reimbursement of medical expenses for the approved surgeries/treatment through proper channel as per the format prescribed in the Annexure-I to this order along with Discharge summary and original bills/vouchers and also one set of xerox copy to the sanctioning authority.

- 2) The forwarding authority shall process the applications submitted by the employees and forward the same to Secretariat Branch/Tamil Nadu Generation and Distribution Corporation Ltd., Chennai-2.
- 3) On receipt of application from the forwarding authority, the sanctioning authority has forwarded the same to Director of Medical Education for obtaining remarks and scrutinize the amount already availed under New Health Insurance Scheme for the block year 2008-2012 through the existing database with the Director of Medical Education/Joint Director of Health Services so that the total assistance under the scheme shall not exceed Rupees two lakh from 11-6-2008 till 30.6.2012.
- 4) After obtaining the remarks of Director of Medical Education/Joint Director of Health Services, the amount authorized by them shall be sanctioned by using necessary proceedings as per the format prescribed by sanctioning authority.
- 5) The list of diseases, treatment/surgeries and hospitals which were already approved for the New Health Insurance Scheme for the block year 2008-2012 shall be adopted. B
- 6) The maximum coverage shall be allowed upto Rupees Two Lakh per employee and their eligible Family Members including the amount already availed under New Health Insurance Scheme for the block year 2008-2012 so that the total assistance under the scheme shall not exceed Rupees Two Lakh from 11-06-2008 till 30-06-2012. C
