Based on the orders of the Government, in the TANGEDCO Proceedings first cited, orders have been issued for implementation of New Health Insurance Scheme, 2012 for the employees of the TANGEDCO.

2. In continuation of the instructions issued in the reference first cited, the following clarifications also communicated to all Chief Engineers/Superintending Engineers and Pay Drawing Officers.

- i) The enrolment of Government employees under the New Health Insurance Scheme, 2012 shall be compulsory even though the Employees spouse is working in Central Government, Only in those cases wherein both husband and wife are employed under the State Government/Board the employee's contribution shall be received from younger of the two.
- ii) As per the reference 5th cited, the New Health Insurance Scheme subscription has to be recovered from the employees who are under suspension till the normal date of retirement. In cases of continued suspension beyond the normal date of retirement, the recovery has to be stopped.
