In the reference, first cited, the Government have issued orders, for implementing New Health Insurance Scheme 2012, for provision of Health Care Assistance to the employees of Government Department. Based on this order, the TANGEDCO in its proceedings second cited, have issued orders implementing New Health Insurance Scheme' 2012 for the employees of TANGEDCO.

2. In the said order it has been instructed that the employees and their eligible family members for assistance shall get admitted in any of the approved hospitals which was annexed in the (Per.) CMD / TANGEDCO proceedings No.194 (SB) dated 1.8.2012.

3. Previously, when the Star Health Insurance Scheme was in existence, many claims sent to TANGEDCO for approval and it is observed that some of the claims have been made for the treatment taken at in the unapproved Hospitals and the same was not considered.

4. Accordingly it is hereby instructed that all pay drawing officers should follow the instructions as detailed below :-

- a) New Health Insurance Scheme cards must be issued to all the employees who are working under their control.

- b) To ensure that the employees should take treatment in the approved Hospitals only by using the United India Insurance Identity Card.
- c) Not to claim medical expenses under Medical Attendance Rules for the treatment taken in the unapproved hospitals for diseases covered under the New Health Insurance Scheme.
