#### NEW HEALTH INSURANCE SCHEME, 2012

Minutes of the meeting conducted by the Commissioner of Treasuries and Accounts at 11 am and 3 pm on 8.7.2013 with the Representatives of all Organizations (Public Sector Undertakings, Local Bodies, Statutory Boards and Universities), MDIndia (TPA) Pvt. Ltd.

The following points were discussed with respect to the implementation of NHIS 2012.

The New Health Insurance Scheme, 2012 is being implemented through United India Insurance Company Limited from 01-07-2012 to provide health care assistance to the employees of Government, Local Bodies, Public Sector Undertakings, Statutory Boards and State Government Universities, etc., including their eligible family members.

#### Payment of annual premium

The Commissioner of Treasuries and Accounts has instructed the Organizations which have not yet remitted the Annual Premium for the First year (2012-2013) to complete the payment of Annual Premium on or before 15-07-2013 and all Organizations to complete payment of Second year Premium (2013-2014) on or before 26-07-2013 without fail and to inform this office immediately along with a copy of the challan. The Completion certificate as on 30<sup>th</sup> June has to be submitted after the completion of payment for the respective year.

#### Issue of Identity Cards

The following Organizations provided the details of non receipt of ID cards by their employees and requested for issuance of ID cards to the rest of the employees immediately.

#### Grievance Redressal Wechanism

The Organizations were instructed that any grievances arising out of the New Health Insurance Scheme, 2012 shall be placed for a decision of the District Level Empowered Committee headed by the District Collector having the Joint Director of Medical and Rural Health Services Department and the District Treasury Officer as members. An appeal made against the decision of the District Level Committee may be preferred by the employees to the State Level Committee headed by the Commissioner of Treasuries and Accounts and having the Director of Medical and Rural Health Services as Member Secretary and an Official representative nominated by the Insurance Company as members. The issues that are unresolved in the State Level Committee shall be referred within fifteen days to a High Level Committee comprising of the Secretary of Government, Finance (Salaries) department, Secretary to Government, Health and Family welfare department and the Representative of the Insurance Company nominated for the purpose.

#### Website Updation (Data Correction tool, grievance lodging, etc)

The latest updation made in the website 'www.tnnhis2012.com' was explained in detail by MD India representatives. This included the inclusion of network hospitals, approved procedure, FAQs, important G.Os, link with Facebook and the database updations/ correction tool in the website. The Third Party Administrator (MD India) circulated a handout consisting the contact number, key points on correction tool etc (in Annexure II) to all participants.

#### General

- The participants were provided information about NHIS 2012 in general, the mode of payment, the networked hospitals, approved procedures etc and a handout enclosed in Annexure I was distributed to them.
- The reimbursement for the Interim Period (From 11.6.2012 to 30.6.2012) has to be met out of the own funds of the Organizations.
- The ID cards of the employees who have retired/died in harness/ terminated from service have to be returned to the respective District Coordinators by the Pay Drawing Officers without fail.
- Since this scheme provides 'CASHLESS FACILITY' no amount has to be paid as advance by the employees to the hospitals for availing treatment.

The meeting was concluded with a note to make prompt payment of premium within the due date, to educate and motivate the staff to update the database, to share the feedback on the scheme with the Commissioner of Treasuries and Accounts and to offer suggestions to enhance the quality of service of the Scheme.
