Sub: New Health Insurance Scheme, 2012 – Eligibility of employees on consolidated pay for a three year period (Mazdoor Trainees) for coverage under New Health Insurance Scheme, 2012 - Orders – Issued.

In the Government Order first cited, orders have been issued for implementation of the New Health Insurance Scheme, 2012 to provide health care assistance to the Employees of Government Departments, Public Sector Undertakings, Statutory Boards, Local Bodies, State Government Universities, Willing State Government Organisations/Institutions and their eligible Family Members with provision to avail assistance upto Rupees Four Lakh for a block of four years commencing from 1.7.2012 to 30.6.2016.

- Based on the orders of the Government TANGEDCO also implemented the New Health Insurance Scheme, 2012 for the eligible employees of TANGEDCO vide (Per.) CMD TANGEDCO Proceedings No.194, (SB) dt.1.8.2012.
- 3. In the Government Letter fourth cited it is clarified that Mazdoor Trainees of TANGEDCO working in regular time scale posts but drawing consolidated pay for a three (3) year period shall be made eligible for coverage under New Health Insurance Scheme, 2012. In continuation of the orders issued in the reference 2nd cited, it is hereby ordered that:
 - i) The enrolment of the MazdoorTrainees under the New Health Insurance Scheme, 2012 shall be

compulsory. The monthly subscription under the New Health Insurance Scheme, 2012 will be Rs.150/- per month and recovery shall commence from the salary for the month of October 2013 onwards.



- ii) The Mazdoor Trainees and their eligible family members are covered under New Health Insurance Scheme ,2012
 - iii) The following family members of the Mazdoor Trainees shall be covered under the New Health Insurance Scheme , 2012 .
 - Legal spouse of the employee;
 - b. Children of the employee-till they get employed or married or attain the age of 25 years whichever is earlier and dependent on the employee.
 - the parents of the Employee, in the case of unmarried employee until the employee gets married.
- iv) Under the Scheme, in respect of legal spouse cases the total assistance for the Family will be limited to Rupees four lakhs only and the employee's contribution shall be recovered either from Husband or from wife who is younger in age i.e. younger of the two.
- v) The employees and their eligible family members shall avail assistance upto the limit of Rupees four lakh in a block of four years commencing from 1.7.2012 to 30.6.2016 on a <u>CASHLESS</u> model for the approved treatments and surgeries in the hospitals approved by the Insurance Company/ Third Party Administrator under this scheme. The benefit will be on a floater basis i.e. the total coverage upto Rupees four lakh can be availed of individually or collectively by the Employees and their eligible Family Members during the said block period with no restriction on the number of times of availing.

- 4. The pay drawing officers are requested to distribute the enclosed Annexure – VII to the Mazdoor Trainees and requested to furnish the latest details of himself/herself and their eligible family members along with the recent <u>passport size</u> photographs in the prescribed form distributed to them.
- 5. The pay drawing officers are requested to collect the filled in forms from the Mazdoor Trainees under their control and verify, countersign and hand it over to the District Co-ordinators of TPA-MD India Health Care Services (TPA) Pvt. Ltd. In Chennal District, all the pay drawing offices are instructed to handover the filled in forms to A17 Section / Secretariat Branch for issue of Insurance Identity Cards.
 - 6. The receipt of the Memo (Per.) shall be acknowledged.
