Reimbursement of expenditure in case of accidents  
to the officers / staff of TANGEDCO & TANTRANSCO -  
Instructions issued - Regarding.

In Board's proceedings first cited orders have already been issued to reimburse the entire cost of expenditure to the employees / officers of TANGEDCO & TANTRANSCO who met with an accident and suffer injury due to accident while performing his duties or while travelling from his residence to office to perform the duty or while returning from office to his residence after performing his duty by the Corporation without any reduction.

2. As far as the (Electrical / Mechanical) accident is concerned, immediate and urgent treatment is required in order to safeguard the life of the employees / officers. In Case of emergency conditions the employees / officers will not be in a position to pay the medical expenses to the Hospital.

3. It is observed that some of the hospitals have refused to admit the employees without advance payment in case of accidents. Since the accident is an emergency one, the employees are not in a position to pay the amount to the hospital authorities. However the Board is reimbursing the entire amount to the employees who met with an accident .

4. Accordingly, it is hereby instructed to follow the instructions as detailed below:-

- a) The Executive Engineers concerned shall give a letter to the hospital authorities concerned to the effect that the entire medical expenses incurred for the treatment of departmental accident to the officers / staffs who met with an Electrical / Mechanical accidents while on duty will be reimbursed by the TANGEDCO.
- b) The Executive Engineers may also convey the hospital authorities to render continuous treatment without insisting on the payment of bills.

5. The receipt of the memorandum should be acknowledged.
